





Baseball Draft Makes the Minor Leagues Hustle

By HENRY L. FARRELL (United Press Sports Editor) NEW YORK, Feb. 26.-Owners of NEW YORK, Feb. 26.—Owners of minor league clubs insist that it would not be practical and would not be good business for them to agree to a restoration of the old draft agreement by which the major leagues were entitled to the best of the minor league players, for the nominal draft price.

Club owners naturally consider business first and there is much to support their argument that it would not be a sound financial move to allow a major league club to draw a star player and pay \$5,000 for him when the same player might be sold

on the open market for \$50,000. Minor league managers, however, are more inclined to look at the practical side because they are paid to develop a winning team and their salary depends entirely upon the de-gree of success they meet with. During the recent baseball meet-

ings here, some very interesting opinions on the drafts as its affects, the playing standard of the mino leagues were voiced by a former minor league manager, one of the best in the business, who is now af filiated with a prominent major league club.

"I have had my own ideas in the past," he said, "but as my employer was not in favor of the draft, it would have been inconsistent and, at the same time, unwise for me to express my views to the contrary.


"I have always felt, and I feel now, that the draft was a fine thing for baseball and that it made the minor leagues because it inspired the play-er to hustle. You can have good baseball only when the players do






