2. That said ordinance shall provide for the submission to the qual-ified voters the following amendments to the Charter:

PROPOSED AMENDMENT NO. 3:

Amend Article IV of the Charter by adding a new section to be numbered Section 3, which shall be and read as follows:

"Section 3. The City Commission shall have the power, when in its discretion it deem expedient and necessary, and at any regular meeting, to pass an ordinance or ordinances authorizing the issuance of interest bearing time warrants, with or without interest coupons, not to exceed in amount \$25,000.00 at any one time, for the purposes for which bonds are authorized to be issued under this Charter, such warrants to bear interest authorized to be issued under this Charter, such warrants to bear interest not to exceed six per cent per annum, payable annually or semi-annually, and to mature at such times, and to be payable at such places, as may be fixed by the City Commission: but before any such warrants shall be issued or sold, they shall be submitted to and approved by the Attorney General of this State and registered in the office of the Comptroller of the State of Texas. 


