**Collier Shook Hands With Mrs. Robertson,** Then Calmly Turned to Killing Her Child

Determined to defend her good name against the attacks made upon her character by the slayer of her son, a mere boy, Mrs. Hattie Robertson late Monday afternoon carried her point she was taken before the jury on an ambulance stretcher. And there, sobbing out her recital of the merciless shooting down of her youthful son Elzie, the grief-stricken mother, corroborated by reputable neighbors and officers of the law, did "clear her good name," incidentally reciting to tearful jurors how Collier calmly shook her hand, then coolly turned to the unarmed boy beside her, shot him down and continued to fire shots into his prone, dying body

#### "TURN IT OVER"-

"Turn it over, Frank, so she can see he's dead." These were the words addressed to former Mayor Collier by his wife, after she had calmly witnessed the murder of her daughter's young hus-band. The killer's wife was re-ferring to the still body on the ground—she wanted to make sure the grief-stricken mother would know that Collier's bullets had done their horrible work well.

### **MAY SUSPEND SENTENCE**

By United Press. WICHITA FALLS, March 24-Frank Collier, former 'mayor of Wichita Falls, may be found guil-ty of murder or manslaughter in connection with the slaying of Elzie Robertson, his 19-year-old son-in-law, according to the jury charge prepared by Judge P. A. Martin for formal presentation at the opening of the afternoon ses-

The charge sets out that if, in the opinion of the jury, Collier deliberately murdered his son-inlaw, the verdict of murder with penalty of five years to life im-prisonment or the death penalty may be meted out. If, on the other hand, it is the belief of the jury that the former mayor's mind was inflamed by his wife's statement that Mary Frances was seduced by young Robertson be-fore their margine. Calling fore their marriage Collier may be held guilty of manslaughter, punishable by imprisonment of from two to five years. It is also discretion-ry with the jury to recommend a suspended sentence in the event of a manslaughter verdict, the charge said.
