Twin City officials hear economic presentation

Twin City officials, along with those from Portales and Clovis, attended a presentation on economic development Monday night at the Farwell Community Center.

Twenty-eight city officials and those involved in economic development programs participated. The presentation was given by Jonathan Krebs, manager of economic development for Southwestern Public Service.

The meeting was an outgrowth of a discussion at last month's Farwell City Council meeting when the topic of development was raised. Jim Martin, manager of the SPS office in Clovis, was at the session and volunteered to help put on a presentation.

Among those present were Texico Mayor John R. Hadley, Texico Chamber of Commerce Secretary Ann Cooper, Farwell City Clerk Janie Bowery and Farwell Councilmen Martin Kube, Curtis Smith, Elizabeth Phillips and Ysleta Kittrell.

After the meeting, some of the Farwell councilmen indicated that they might call a meeting of various Farwell groups, such as the Chamber of Commerce and Farwell Development Corp., to discuss economic development.

The purpose of the Monday meet-

ing was to hear an explanation of how economic development occurs. It noted that large cities have different goals than small towns.

Among the points that Krebs made were:

--If Farwell were to seek new firms, it should concentrate on businesses that employ from 5 to 10 people.

--Farwell and Texico should embrace Triad, the area industrial group.

--Communities need educated labor forces to handle jobs that open, like computers.

--Questionnaires should be sent to residents to get their views on economic development. What kinds of businesses would they like to see? Is more housing needed? What kind?

--It would be good if Farwell had an industrial site ready in case a prospect for Clovis or Portales would prefer to locate in Texas.

Also at the meeting, Don Williams, president of Farwell Development, noted how Farwell's main street has gone downhill. He suggested improving the thoroughfare as a project.

Krebs also noted how some folks say, "We like it the way it is; we don't want change." Krebs said towns are always changing, and the economy changes daily.

"I enjoy reading the Tribune and know a lot of old-timers still living there. My aunt Mrs. Ebb Randol still lives there. I grew up in Texico and my dad had a store - Osborne Mercantile Store - in Farwell. He also ran an elevator and was a grain buyer.

"I married and in 1941 moved to Lynwood. I have lived here ever since. I knew the "Hop" Grahams, Andersons and all the old-timers."

Hard-boiled eggs

A.B. (Dutch) Bell came to the Texico-Farwell area with his family in 1907.

His family moved from Petersburg, Ind. when he was one. The family moved by train with all their goods. They bought a farm six miles south of Texico. Over the years there were 12 children in all.

They lived in a large dugout. They had no electricity, just coal oil lamps and woodburning stoves. They raised row crops, cows, horses and had an orchard.

He attended Locust Grove school, which only had one room. Bell also attended the Pleasant Hill school. He walked to school sometimes, and rode on a spotted mule other times. While in school he played some

baseball. Bell said, "I really didn't have much time for what sports they had." Both he and his wife picked cotton a lot instead of attending school.

Ethlene Bell came to Texico from Crosby County. She lived in Texas until 12 years of age. She lived in Colorado for two years and then came back to Farwell in 1929

She lived with her aunt from Dickens, and rode horseback to school.

She said, "I carried hard-boiled eggs in my pockets. It was a good way to keep my hands warm. When I rode in a buggy, we used heated bricks to keep our feet warm." In January 1934, the Bells mar-

ried. They farmed for awhile, and Bell

ran a truck for farmers. He drove a Model A Ford. He also worked as a carpenter and mechanic. For about two or three years, he worked at Henderson Elevators, loading trucks and moving sacks.

They moved to Hereford and lived on a ranch for a short time, then went to Colorado. They kept their milk in the watering trough and raised chickens. They had an icebox that you had to buy ice for.

They came back to Texico. They really liked the area. They've been in Texico since 1945.



They moved into a small house not far from where they live now in Texico in 1945. It had one bedroom, bath, kitchen and living room for seven of them. They raised chickens, cows and cured their own meat.

Five children have been raised by the Bells: Katherine of Austin; Weldon of Longmont, Colo.; Carol of Portales; Merlene of Texico and Darlene of Portales, - twins.

When the twins started to school, Mrs. Bell started to work at the Texico cafeteria in 1954.

Mrs. Bell retired as cafeteria supervisor in 1985. Upon retiring she received a plaque from the school. She was head cook 21 years.

She has seen three generations of children go through the school.


Bell was custodian for the Texico schools from 1957 to 1971, when he retired.


They both enjoy riding horses, bike riding and Mrs. Bell enjoys embroidery.

Changing careers

is not unusual

Editor's note: This article begins a periodic series by John Grigsby, Farwell school superintendent, on education.

Recent studies show that the average citizen will change careers (not jobs) three times during their working lifetime. We are rapidly changing from a mineral-oriented state to a technological manufacturing state. Thus, students must be more adaptable, flexible and versatile in order to cope with drastic

career changes. Most of the future openings will be in the service and trade sectors. According to the new studies, many of the specific jobs which will be "targeted" in the next decade including nursing, truck drivers, delivery persons, housekeepers, (commercial and domestic) child care workers, mechanics, repairmen, cooks, waiters, cashiers, sales clerks and restaurant managers. Other fast growing occupations will involve paralegal workers, computer specialists, technicians and engineers concentrating on computers and electronics. (Continued on Page 2)

Brewer Class issues checks

The Brewer Class Distribution Project began issuing 54,647 checks totalling \$3,094,366.87 representing payment of claims for a share of \$75.5 million in settlement funds received in the New Mexico Natural Gas Antitrust Litigation.

Texico is included in these payments.

"There are two types of claims," stated Anthony C. Leonard, Class Manager. "The first is from people who did not receive a check in our first mailing last fall and who believed they were included in the Brewer Class. The second type of claim is from persons who did receive a check in the mailing last fall but who had lived at other eligible service addresses not covered by that check."

The claims checks complete the first half of the Brewer Class distribution which, with the checks mailed last fall, totals \$30.5 million. The Brewer Class includes single meter residential customers of Gas Company of New Mexico who had purchased natural gas at any time from July, 1976 through March, 1984. Payments to each member are calculated based on the amount of gas purchased during that period.

After the completion of the claims check mailing, which is expected to take about a week, the Distribution Office will handle inquiries relating to the claims checks.

Students will receive specific training for "targeted areas." (as determined by state-wide and regional plans) State vocational funding will not be based on the number of students in the program, but on the number of students trained to actually go into that specific field as a paid worker.

Consideration is also being given to force schools to open this training for all persons -- including those not currently enrolled in school.

It is ironic that schools will be expected to give students jobspecific training during an era that people will change occupations several times. To accomplish this seeming contradictory task, schools must also emphasize critical thinking and research skills. In so doing, we can assist students in coping with a mandatory or voluntary career change.

The job for schools will be extremely difficult, but with proper planning and prioritizing, these new goals can be met.

Adding to this dilemma are the rapid technological changes requiring considerable initial investment in equipment, plus the need for continual upgrading of this equipment and training in keeping with the technological advances.

As you can see, we are on the "cutting edge" of a very interesting era in education.







Mrs. Scott is a Farwell resident.



Some musicians have years of professional training, while others have found their talent by "Listening and picking." Performers include housewives, secretaries, farmers, ranchers, and businessmen.



Fannin and his army surrender to a Mexican force

1836: THURSDAY, MARCH 17. In a marathon session that lasted until 4 o'clock this morning, the Convention meeting in Washington-on-the-Brazos completed its work on a Constitution for the Republic of Texas, and elected members of an ad interim government to lead the country until the Constitution is ratified.

President Burnet, a former impresario, said in a brief inaugural address: 'The Alamo has fallen! The gallant few who so long sustained it have yielded to the over-whelming power of numbers; and if our intelligence be correct, they have perished not in vain! The ferocious tyrant has purchased his triumph over one little band of heroes at a costly price; and a few more such victories would bring down speedy ruin upon himself."

The Convention failed to ratify the loans made by the commissioners in New Orleans at the beginning of this year, and authorized President Burnet to handle the matter. The Convention then adjourned sine die. According to Colonel William F. Gray, who attended the sessions, "The members are now dispersing in all directions, with haste and in confusion. A general panic seems to have seized them. Their families are exposed and defenseless, and thousands are moving off to the east."

1836: SUNDAY, MARCH 20. Colonel J.W. Fannin and the entire Texian army under him, consisting of almost 400 men, today surrendered to a Mexican force more than twice that size, headed by General Jose Urrea. They have been fighting for two days in an open area about a mile south of Coleto Creek, on the road between Goliad and Victoria.

It is understood that the terms of surrender are most honorable. The Texians will be treated as prisoners of war, and their private property will be respected, except that side arms must be given up. They will be sent to the port of Copano, and from there they will be shipped to the United States within eight days. The agreement was drawn up in both English and Spanish, and signed by both commanding officers. The prisoners were then marched to Goliad, where they arrived at sunset today. A large number of wounded Texians, including Colonel



Fannin, are still en route.

Colonel Fannin was ordered by General Sam Houston as long ago as March 11 to destroy the La Bahia fort at Goliad and fall back to Victoria "as soon as practicable." He delayed for a number of reasons, and finally set out yesterday morning after a scouting party on the previous day had engaged a unit of the advancing enemy forces. In that incident, the enemy made a precipitate retreat, thus seeming to confirm Fannin's conviction that they would not dare to attack him during the march to Victoria.

Yesterday morning scouts reported that the Victoria road was clear, and Fannin ordered the La Bahia fort dismantled. He set out with his artillery, which considerably hampered the progress. It was especially difficult to cross the San Antonio River and drag the cannon up the muddy banks, and they were delayed there until after 10 o'clock.

When they were still about a mile from Coleto Creek, they were set upon by some 350 cavalry, followed

The wounded Texians were in great agony because of lack of water, and after consulting with his officers, Fannin decided that they could not be kept alive unless they were capitulated. He was himself wounded. The Texians raised a white flag, and an honorable surrender was negotiated.

General Houston is currently encamped on the west bank of the Colorado River, near Beason's place. His recruits are increasing daily. "In a few days," he reports, "my force will be highly repectable." General Houston admits that during the past few days "I have found the darkest hours of my life! My excitement has been so great that for 48 hours I have not eat an ounce nor have I slept." Yet he som them one at a time.

remains optimistic. "We can raise 3,000 men in Texas," he answers, "and 1,500 can defeat all that Santa Anna can send to the Colorado."

1840: THURSDAY, MARCH 19. In an unexpected battle that broke out in the Council House at San Antonio today between Texians and Comanche Indians assembled there for a conference, 35 Indians were killed, and seven Texians. In addition, eight Indians were wounded, and 27 Indian women and children and two old men were taken prisoner. The Texians suffered eight wounded.

Various Comanche tribes had been invited by the Texas government to send representatives to San Antonio to discuss peace terms. The Comanches have frequently attacked outlying homesteads, killing the men and taking women and children prisoners. Last January Texians were surprised when three Comanche chiefs rode into San Antonio as representatives of a general council of Comanche bands, and demanded a meeting to negotiate a treaty.

The meeting was arranged for today. The Comanches were requested, and they agreed, to bring with them all of their white prisoners and permit them to be ransomed by the Texians. However, when the Indians assembled, they had with them only one white prisoner, a young girl named Matilda Lockhart. She was terribly emaciated, the flesh burned from her nostrils apparently by live coals, and her body covered with bruises. Sobbing, she informed the Texians that the Indians were holding 15 other women in the hills outside San Antonio, and were planning to ran-

The Texian delegation, headed by Hugh McLeod and William G. Cooke, was outraged. Supported by three companies of infantry under Colonel William S. Fisher, they demanded that the other white captives be brought in, and stated that they were determined to hold the Indians in the Council House captive until then. There were some 70 Indians assembled, incuding 12 chiefs, plus the women and children. A fierce battle broke out, in which most of the Indians were killed.

Both Texians and the Comanches have expressed extreme anger at

what they consider to be the other's violation of a truce. It is understood that the Comanches, in retaliation, have tortured 10 or 12 of their prisoners to death. They are now expected to increase the raids they have been conducting, and perhaps even to launch large-scale attacks on Texas communities.

by an infantry force of 1,000 or 1,200. They were caught in the open, unable to reach Coleto Creek, where there was water, and woods would have provided a good screen for Texian sharpshooters. A fierce battle ensued, from 1 p.m. until after dark. The Texians used their cannon with great effectiveness, but being without water for cooling, they soon became too hot to use. The Mexicans had no cannon. With the Texians lack of cover, they lost seven killed plus several mortally wounded, and some 60 badly wounded. The enemy's loss is thought to be about five times greater.

The Texians spent last night building a breastwork of earth, carts, wagons and packs. They did not try to fall back because they did not have a way to move the wounded. They still felt confident of victory. However, during the night General Urrea was reinforced from Bexar with 500 men under Colonel Morelos, and three pieces of artillery.

This morning the enemy commenced fire with the artillery. Since they did not venture to bring it within range of the Texian rifles, it did not inflict many casualties, but broke up the breastwork, which was intened only to withstand rifle fire.



Loans encourage water conservation

Funds from a new state-backed low interest loan program should be available by mid-April to Texas famers who wish to improve the efficiency of their irrigation application and distribution systems.

State funds obtainable through a two-year pilot loan program under the Agricultural Water Conservation Program are aimed at encouraging conservation of water in irrigated agriculture. The program is administered through the Texas Water Development Board, which will loan money to soil and water conservation districts and underground water conservation districts throughout the state. These districts will, in turn, make loans to individual producers.

Loan funds will be released when the Water Development Board approves its rules governing loan applications to the Board. Draft rules have been submitted to the Texas Register for publication and public review, and, after a 30-day review period, the rules will go before the Water Development Board for final consideration and adoption. If adopted, the Water Development Board's rules will go into effect after a 20-day waiting period.

Soil and water conservation districts and underground water conservation districts can then apply for and receive loans from the Water Development Board. The High Plains Underground Water Conservation District No. 1 has already applied to the Water Development Board for an initial loan of \$1 million.

Districts applying for loans from the Water Development Board are

1985 farm receipts steady in Texas but income down

Texas farmers sold about the same level of agricultural commodities in 1985 as a year earlier, but net income continued to decline.

Cash receipts from the sale of farm and ranch products totaled about \$10.1 billion last year according to estimates by the Texas Agricultural Extension Service of the Texas A&M University System. At the same time, net income dropped to about \$1.4 billion, down from just over \$2 billion in 1984.

responsible for setting up rules governing their loan procedures to individual producers. These rules must, however, comply with the Water Development Board's rules, so district rules can not be completed until the Water Development Board rules are finalized. Proposed High Plains Water District rules have been submitted to the Water Development Board for review and comment. Final rules are expected to be considered by the District's Board of Directors at their regular March Board of Director's meeting.

Under proposed Water Development Board requirements, only irrigation water application and distribution systems are eligible for loan funds. Equipment, materials, contractor services and installation costs eligible for loans include systems such as low energy precision application (LEPA) sprinkler systems, low pressure drip irri-

gation systems and pipelines. Furrow dikers are also eligible, as well as flow meters and other flow measuring devices. Additionally, loans may be granted for soil moisture monitoring equipment such as tensionmeters and gypsum blocks, and for computer software when it is used to monitore irrigation applications.

Water Development Board funds will be loaned to districts at fixed interest rates. The rates will be set according to the lowest amount listed on the bond buyer index, a tax exempt bond market, during the six months prior to the month the loan is made. However, the interest rate will not exceed 12 percent and is

expected to be about 9 or 10 percent. Water Development Board loans to districts must be repaid within ten years.

Water Development Board rules limit district-made loans to producers to 80 percent of the purchase price of capital items and 50 percent of labor costs for installation or for purchase of nonrecoverable items. Funds from the program may only be used for equipment which will be operated on land that has been irrigated for at least two of the previous six years.

Other Water Development Board rules require that districts disburse loaned funds to producers within 120 days if all previously loaned funds have been committed. Singlecounty districts may borrow up to \$300,000 under the same conditions.

Individual producer loans under this program are guaranteed by the state. Should a default occur, the state will cover 50 percent of any unrecoverable loss, with the lender district assuming responsibility for the remaining 50 percent.

Under draft provisions of the High Plains Water District's rules for District loans, primarily individual producers will be eligible to apply for loans. However, partnerships and corporations are eligible for loans as well.

Irrigation application systems eligible under Water District rules include LEPA sprinkler systems, low pressure sprinkler systems, low pressure drip irrigation systems, surge flow valves, modification equipment for converting high pressure sprinkler systems to low pressure dropline systems and soil moisture monitoring equipment. Eligible irrigation delivery equipment includes underground and aboveground pipelines, in-line flow meters and other flow measuring devices. Moisture retention equipment such as furrow dikers also qualify for loans.

The High Plains Water District plans to charge its borrowers the same interest rate that it pays to the Water Development Board. Additionally, one-time service fee of 2.5 percent of the loan amount will be required. These fees will be paid either up-front in a point system, or in installments throughout the term of the loan.



"With a strong livestock and crop base, the future for Texas agriculture is favorable when compared to other states," Anderson emphasizes. "Agriculture is one of the most important industries in Texas as it provides jobs for more than 20 percent of the state's work force. Including all agribusiness phases, agricultural production added some \$32 billion in economic activity to the state in 1985.

March is designated as Poison Prevention Awareness Month. Therefore, this would be the appropriate time for all of us to review poison prevention safety.

Most accidental poisonings occur in the home. The average household contains a vast array of potentially harmful products such as cleaning products, pesticides, nail polish, paint, shoe polish, and of course over-the-counter and prescription medications.

Young children are the most likely candidates to accidentally ingest these products, as two-thirds of all poisonings occur in children under the age of six. Poisoning in children usually occurs while an adult is using the product, and is distracted, leaving the child alone with the product.

What can you do to prevent your children from becoming the victim of an accidental poisoning? Here are some suggestions from the American Association of Poison Control Centers.

1. Keep medicines, household

cleaners, chemicals and other potentially poisonous substances well out of the child's reach and sight. Don't leave your child alone with such a substance when you are using it-even for a few seconds.

2. Keep the phone numbers of your local poison control center and doctor near the phone, and make sure the entire family knows when they should be called. (Tx: 1-800-392-8548, N.M.: 1-800-432-6866.

3. Store poisonous substances in their original packages, not in food or_beverage containers.

4. Check the toxicity of household plants before you buy. And be certain that philodendron, poinsettia, deiffenbachia or English ivy are well out of your child's reach.

5. Teach your children to stay away from liquor cabinets, storage areas and medicine cabinets. Use child-proof locks.

6. Read all medication labels carefully. Remember, any drug taken in overdose can be toxic. Dosage instructions should be followed. If you are unsure about directions, call your pharmacist or doctor.

7. Use medications that come in child-resistant packaging.

8. Never try to coax your toddler into taking a medicine by calling it "candy."

9. Flush unused portions of medicines down the toilet. Throwing them in the trash creates a possibility for accidental poisoning.

10. Always keep a bottle of syrup of ipecac on hand in case of an accidental poisoning. Contact your local poison center before using ipecac.

Above all, if your child does ingest a poison, remain calm. Call the poison control center, or your physician. They will want to know the following information: Your name and phone number, the age of the patient, the name of the product and ingredients, the amount ingested if known, what time the poisoning occured, and any current symptoms.


