In every part of the county the insect population seems to be on the increase. Greenbugs and corn leaf aphids have been building up for the last 30 days. Although the greenbugs are not as thick as in past years, I have found several fields with large populations of the aphids. Corn leaf aphids are heavy enough in some fields to cause honey dew formation on the plants. 




