I recall the discussions back in 1984 during the City Council sessions about the need to get rid of those ugly eyesores that were hazards to the community. Only then, could businesses possibly be induced to come there.

So the council worked at it. And their attorney, Duane Hamar, worked at it. And their city clerk, Marie Christian, worked at it. And Realtor Charlotte Pierce worked at it. And the owners of the properties along the highway worked at it. And the results are successful.

So often we hear politicians talk of "meeting the needs." It sure is nice when you see government officials not only talk, but roll up their shirtsleeves and get to work.

You've got to start somewhere and the Texico officials undertook the proper spadework to get the ball rolling. That's the job of good government.

What has happened here can be summed up as government in action -- not government inaction.

I enjoyed seeing the excellent turnout for last week's Twin City Neighborhood Watch meeting. It again shows when people are interested, they are willing to take time to come to a meeting.

I hope that concern is a sign to Twin City government officials. I hope the City Councils work with the Watch chairmen -- Frances Kube and Peggy Sudderth in Farwell and Ann Cooper in Texico - on setting up a good program.

The way I see it, block captains are the necessary tools for operating this type of program. Since Farwell has had a Watch program in the past, it appears that Mrs. Kube and Mrs. Sudderth will be able to reinstitute it within a short time. Texico's starting from scratch will

probably take more time. And how did all this come about? It all began when one solitary person, Colleen Stover, went to a Farwell City Council meeting to complain about increasing crime

Once again, this shows the importance of every individual in a democracy. The next time you think 'aw, there's nothing I can do; I'm just one person," then remember Mrs. Stover.



# Mayor's race placed on Farwell ballot

The Farwell City Council voted Monday to place a mayoral contest on the April 5 ballot.

Current Mayor Walter Kaltwasser announced last month that he would be resigning his post April 5. There is one more year left on his term.

The council had a choice to make. It could either pick one of its own members to serve as mayor until next year's election, or it could put the post on this year's ballot.

During the February registration period, two persons filed for the mayoral post, should the council vote in that direction. They were Chris Gikas and Cecil Rundell.

Thus, Monday's Council decision means that Gikas and Rundell will be listed on the spring ballot as mayoral candidates.. Rundell operates Cecil's Texaco Station in Farwell. Gikas retired as chairman of the Department of Art and Art Education at Eastern University in 1984 and now is co-owner of Twin Oaks Psi Design in Farwell.

Three council posts are open and the three incumbents are the only candidates - Martin Kube, Elizabeth Phillips and Fred Chandler.

In other business, John Getz, a member of the Texico-Farwell Lions Club, presented the council with the flag contest entries. The club, as a Sesquicentennial project, had a contest to recommend a city flag for Farwell. The contest winner was Sonny Kelm.

Getz said more than three hours were spent viewing the more than 100 entries and a dozen people participated in helping select the top entries. It was done on a point system, with Kelm's entry the

Kelm's entry was in red, white and blue, and featured the Farwell city seal and the words "In God We Trust."

The council voted to adopt Kelm's entry as the official Farwell city flag. Mrs. Phillips abstained since many of her Farwell Junior High students had entered the contest.

Farwell Fire Chief Joel White asked the city to pay for the insurance policy for the fire department's meeting hall, due to the department's limited budget. The council agreed.

Farwell Chamber of Commerce **Executive Secretary Dutch Quickel** asked the council why Farwell had not paid its dues to Triad, the area governmental unit supporting industry and business. The dues are





# King and 15 of his command executed

1836: WEDNESDAY, MARCH 16. An ad interim government for the Republic of Texas was organized today in a series of executive ordinances approved by the Convention now in session at Washington-onthe-Brazos, preliminary to the final consideration of a Constitution. It sets up a President, Vice President, Secretaries of State, War, Navy, and Treasury, and an Attorney General, with "full, ample and plenary powers to do all and every thing which is contemplated to be done by the general Congress of the people," except for legislative and judicial acts.

After the convention adjourned its afternoon session, it met again spontaneous this evening after supper, to hear news of the Mexican invasion from San Felipe, and is still in session. They also worked late last night in another spontaneous session after news arrived yesterday of the fall of the Alamo.

News of the Alamo came in two express messages from General Sam Houston, sent from Gonzales last Friday and Sunday. It was confirmed this morning without a doubt. Yesterday, only a half hour before General Houston's messages, word had arrived from Columbia that the Mexicans had been repulsed. Until recently, many at the Convention thought that the Alamo would be reinforced by Colonel J.W. Fannin and his 350 men now at Goliad. "It is believed the Alamo is safe," said one a short time ago.

There has been much excitement since the news arrived, and during the night there were frequent false alarms of approaching enemy troops.

1836: WEDNESDAY, MARCH 16: Captain Amon B. King and some 15 of his command were executed today near Refugio by direct order of General Jose Urrea, commander of a large Mexican army moving north from Matamoros. They were captured yesterday morning after their powder had become wet and useless when they forded the Mission River the previous day.

Captain King was dispatched from Goliad by Colonel J.W. Fannin on March 10 to rescue some stranded families and bring back supplies. He succeeded in getting the families into the mission of Nuestra Senora del Refugio, but was surrounded and held there by a group of local Mexican rancheros. He got word out to Fannin, who sent Colonel William Ward with the Georgia Battalion to his rescue. The siege was raised on Sunday afternoon, March 13.

Although King was ordered back to Goliad, he insisted first on punishing the rancheros, and this led to his capture by Urrea's troops yesterday. They were marched eight miles back to Refugio, and were then being led out to be shot when a Mexican officer from Germany heard the German language being spoken by some of the prisoners. He marched them back and liberated those who spoke German, as well as some others.

### Chandler speaks on farm programs

\*\*\*\*\*\*\*\*\*\* again led out today, and this time they were shot. A traveller who reached Goliad reports that he saw the bodies "stripped of their garments, denied the privilege of burial, and left as food for the loathsome vulture and the ravenous wolf."

General Urrea left Matamoros on February 17 with about 1,000 men, including 320 infantry, 330 cavalry, and one 4-pound cannon. He apparently had full intelligence of the Texian troops assembled for the proposed invasion of Matamoros, consisting of some 480 men under Colonel Fannin at Goliad, and 97 under Dr. James Grant at San Patricio. Grant started with 200, but lost many of his men for various reasons, mostly dissatisfaction with his command.

The two officers were having difficulties determining how to move their forces some 200 miles southward to Matamoros, over the barren land known to the Mexicans as El Desierto Muerto, the dead desert, and to the Americans as the Wild Horse Desert, because of the wild mustangs there. Colonel Fannin originally hoped to obtain ships to move his army, but was unable to do so. He then requested Grant's contingent to round up as many of the wild horses as possible.

Grant and Major Robert Morris of the New Orleans Greys led some 50 men into the desert for this purpose, and to confiscate any horses they could find on the few Mexican ranchos in the area. Some 40 or more remained at San Patricio under Colonel Frank Johnson. On the night of February 27, the San Patricio contingent was surprised by Urrea's troops and all were killed, except for Johnson and one other man, who managed to escape toward Goliad.

The Mexicans were fully aware of Grant and Morris' contingent, and set out to find them. They were located on March 2 at a creek called Agua Dulce, surrounded, and all were killed except three who escaped.

General Urrea is now said to be approaching Goliad, where Fannin has been strengthening the La Bahia fort, which he has renamed Fort Defiance. However, he is under orders from General Sam Houston to blow up the fort and fall back to Victoria, taking with him such artillery as he can move, and sinking the rest in the river. The order says: "The immediate advance of the enemy may be confidently expected, as well as a rise of high

water. Prompt movements are therefore highly important.' Colonel Fannin is delaying execution of the order until the return of Colonel Ward and Captain King; word of the disasters which have befallen them has not yet reached

General Houston has been headquartered at Gonzales, but fell back to the Colorado River yesterday after receiving word that the enemy was approaching. He burned Gonzales to the ground. His force at present consists only of about 374 untrained men, many without guns or without ammunition, and with only about two days' provisions. However, new recruits are joining daily, coming in from all over the United States. He is convinced that "by falling back, Texas can rally and defeat any force that can ome against her." He believes that Santa Anna himself has probably returned to Mexico, and laments the fact that the Alamo was not blown up as he directed in his order of January 17. "It was prevented by the expedition upon Matamoros,' he says, "the author of all our misfortunes."

# \$127,500 awarded to

A federal jury Tuesday awarded \$127,500 damages to two plaintiffs in a civil rights trial charging Bovina and Parmer County officials with misconduct, according to the Amarillo Daily News.

The News said the damages were awarded to Carrie Melear, and Willie Stewart, both of Bovina.

Defendants are Parmer County Pct. 3 Justice of the Peace Wayne Spears, then Parmer County Sheriff's Deputy Ron Avirett, then Bovina Police Chief Rodney Bachman and then Bovina Police Officer Mel Clark.

Bovina and Parmer County, originally defendants, were removed from the suit Monday when the judge approved dismissal motions by their attorneys.

At first, the jury had awarded damages to two other plantiffs, Eusebio Salazar and Craig Pearson but these awards were nullified for legal reasons.

The jury's decision still must be approved by the judge. Also, the jury was asked to decide percent of blame for constitutional violations with regard to each of the defendants. This was:

For violations of Mrs. Melear's rights: Spears, 60 percent; Bachman, 30 percent; Avirett, 9 percent, and Clark, 1 percent.


