





**\$**75,000,000 TO BE

STRENGTHEN CHURCH WORK

Special Effort of Denomination Along General Lines Will Be Enlarged And Made Stronger As Result Of This Campaign.

Every general interest fostered by Southern Baptists will be strengthened and enlarged through the success of the Baptist 75 Million Campaign which is now well under way, and which will reach its climax in the final drive to. secure this sum in cash and subscrip tions during the eight days of November 30 to December 7. A period of five years will be provided for the final payment of these subscriptions but for the campaign to succeed, the sum of \$75,000,000 must be subscribed within the eight days. Many have expressed the belief that the subscriptions will run to \$100.000.000.


