I need your help

Folks, today's column is an important one for you to read since I need some help from our longtime residents. And even if you weren't around 60 years ago, perhaps you have a relative who was.

Here's the situation: Coming up in September will be

the State Line Tribune's Diamond Jubilee - our 75th Anniversary. We plan to make the Sept. 5 issue really special.

For example, it will center around an oral history of the Twin Cities: we will reproduce many of the features we've been running on longtime area residents.

We've also contacted local historians who will be helping. Don MacAlvay came by the office last week with a couple of really interesting articles about the good, old days. And Hugh Mosely stopped by with information about the newspaper's founders, the B.F. Fears family.

Last week, I met with Abie Crume (the former Allie Blanche, daughter of Hop Graham) in Hereford. She will be writing a special article about her tenure working at the Tribune in the 1930s when she was the first female linotype operator in the whole area.

In addition, Harold Carpenter of Oklahoma Lane will be providing us with a history of that important area, and John Getz will be writing about his years of ownership.

So I believe we have made a good start at compiling information for this special commemorative issue. Now for the problem:

Back in 1940, a fellow working at the Tribune was told to burn some old papers. Inadvertantly, he burned all the papers ever printed until that point. So there is virtually no history of the Tribune available before 1940.

Looking around the Tribune office, I have been able to find eight copies of the Tribune, Texico Trumpet and Farwell Times between 1907 and 1923. That's it.

So question No. 1: If you have any copies of the Tribune before 1940, I'd like to borrow them so I can reproduce them in our special issue. This would show how the newspaper has changed over the years,

In checking into the ownership of the Tribune over the 75 years, here is what I have found:

1911 - 1922 -- B.F. Fears. 1922-23 - Autry brothers.

1923-24 -- R.B Boyle.

1914-26 -- Stanley Sigler. 1926-1965 -- Graham Family (Hop

and Sonny).

1965-1984 -- John Getz.

1984 - Present - Mike Pomper. Question No. 2: We have information on Fears, Graham, Getz and Pomper. But we have no information on Autry, Boyle and Sigler. If you recall anything about any of those three owners -- Autry, Boyle or Sigler -- we'd appreciate it if you could send that information to us: State Line Tribune, Box 255, Farwell, Texas, 79325.

Mrs. Crume recalled that the Siglers came from Oklahoma and had a large family, but that's about all she could remember.

We're hoping that some longtime residents reading this column might recall some of those folks or persons who are their descendants. And if you don't want to take the time to write, just call me at 806/481-3681.

I'm curious, for example, if the "Autry Brothers" are related to some of the Autrey's in Texico. And who was R.B. Boyle?

Nothing like a good mystery, I

It was fun meeting with Mrs. Crume last week. She is married to Vance "Kater" Crume, whose late brother Paul was a famous columnist for the Dallas Morning News. The Crumes are now retired.

Mrs. Crume remembered the only special edition ever put out by the Tribune -- back in 1927 for the infamous Hassell murder trial. She was sent out hawking the papers on the streets of Farwell. A copy cost

She recalled that the original Tribune office was in the Haynes Grocery building at Second Street and Ave. C. It was moved to its present site by Hop Graham when he bought the paper because he was installing 'linotype machines back then and the first building's floor wasn't strong enough to support them. So Graham made a deal with the Capital Freehold Land Trust to

Here's what a Watch program is all about

Frances Kube provided this information about what a Neighborhood Watch program is about:

The Neighborhood Watch program was initiated in the City of Farwell in 1983 by the Farwell Development Corporation. Window stickers and metal highway signswere purchased from the group's treasury, and the stickers were distributed free of charge to residents for display on their homes, as are the ones you will find enclosed. The program was set up with a captain or chairman for each block in the city. It was hoped that there would be block meetings and block parties so that neighbors would get to know one another better.

National Neighborhood Watch is a program sponsored by the National Sheriff's Association, and supported by local law enforcement agencies to reduce crime, and to make America's neighborhoods safer places to live and play.

Law enforcement officers cannot significantly impact crimes of opportunity, such as residential burglary and vandalism, without help from the citizens. By taking steps to protect their persons, homes and property, watching over that of their neighbors and reporting suspicious and criminal activity, citizens can help their law enforcement agencies effectively reduce neighborhood crime. This is what Neighborhood Watch is all about.

President Reagan has said, "Let me commend the Neighborhood Watch Program. We're seeing positive results with Watch Programs all over the country, from Seattle to Las Vegas to Jackson, Mississippi. And what we're really witnessing is a reaffirmation of American values. A sense of community and fellowship, individual responsibility, caring for family and friends, and a respect for the law."

Attorney General William French Smith announced, "Another important factor in the drop in crime is the increased vigilance of the individual citizen acting within his or her neighborhood or community in such groups as Neighborhood Watch or community crime prevention groups. As each person becomes more actively involved in protecting his neighbor's rights and property, we take another step forward at the grass-roots level in developing effective programs to fight crime."

The purpose of Neighborhood Watch is to make you aware of the steps you can take to make your home more secure against crime, to show how you and your neighbors can help each other protect your entire neighborhood, and to make your local law enforcement agency more effective in its fight against crime through your involvement and participation.

A Neighborhood Watch project is the logical first step for any community organizing against crime; it requires minimal effort and gets people talking to and caring about

11 inches of snow reported

After a near-record of 52 days without precipitation, the skies opened on the Twin Cities last week. Fred Chandler of Sherley-Ander-

son-Pitman reported a total of 11 inches of snow cascaded from the skies Wednesday through Sunday of last week.

Neighborhood Watch meeting scheduled

Frances Kube and Peggy Sudderth, co-chairmen of the Farwell Neighborhood Watch program, announced at Monday's City Council meeting that a citywide meeting to discuss reactivation of the Watch program has been scheduled for 7 p.m. March 4 at the Farwell Community Center.

Interest in reactivating the Watch program developed after a Farwell resident, Colleen Stover, attended a City Council meeting late last year to seek a solution to what she said was increasing crime in the community. Her home had been burglarized.

Mrs. Kube said a questionnaire is being sent to Farwell residents explaining what the Watch program is about and asking them to respond to four questions:

1. Do you feel this letter of information and enclosed Neighborhood Watch decals (two are being sent with each letter) are sufficient at this time?

2. Would you like to see each block have a block captain?

3. Would you like to have a block meeting and would you attend? 4. If asked, would you be willing to

serve as block captain? If yes, please sign. Mrs. Kube also said that the

Farwell Development Corp., which helped sponsor the Watch program when it began several years ago, has agreed to be a sponsor again. This means that it will pay for new window decals and for eight new metal signs to be placed on city

Mrs. Kube said she has talked with Texico people about a Watch program and they may participate in the March 4 meeting.

Among the participants at the program will be Parmer County Sheriff Bill Morgan, Texico City Marshal Fred Hamner, Parmer County District Attorney Johnny Actkinson and Curry County District Attorney

Also, Clovis Police Officer Becky Raulie will show a film about the Watch program.

At her request, the council agreed to have city employees install the street signs and also to pay the cost for using the Community Center for the meeting.

Candidacies accepted for Farwell mayor

The resignation of Walter Kaltwasser as Farwell mayor, effective April 5, was accepted at Monday's City Council meeting.

April 5 is the date for the city election. Kaltwasser, who retired from farming last year, has been dividing his time between his Farwel home and a place he owns in Colorado.

Kaltwasser was first elected mayor in 1977 and has served in that post until the present.

Persons who would like to file for the mayoral post can do so at City Hall until Feb. 19, the filing dead-

However, the council will not decide until its March 10 meeting whether the mayoral post will be on the April 5 ballot.

Currently, the ballot will have three spots on it, all for city council.

The posts currently held by Elizabeth Phillips, Martin Kube and Fred Chandler, are on the ballot.

The council has two options: --It can place the mayoral post on the ballot.

--It can choose one of its own councilmen to serve as mayor until that term ends, in 1987.

The council is worried that if it places the mayoral post on the ballot and no one files for it, then a person getting just one write-in vote could be elected mayor. So the councilmen are going to check with local persons who would be eligible to serve as mayor to see if they would like to file by Feb. 19.

If no one files by Feb. 19, it is likely that the council will take the second option -- choose one of its own to fill the unexpired mayoral

Supper, lodging and feed for horses costs 75 cents to \$1

1836: TUESDAY, FEBRUARY 16. Colonel William F. Gray, a Virginian interested in buying Texas lands, and a subscriber to the Texas loan negotiated in New Orleans last month, arrived today in San Felipe de Austin, having travelled by horseback from Nacogdoches. The trip took him nine days. He immediately called on Governor Henry Smith, bearing with him letters from General Sam Houston, whom he had encountered the second day out. Houston was on his way to treat with the Cherokees, Shawnees and other Indian tribes north of Nacogdoches.

Colonel Gray reports that he was cordially received by Governor Smith, and spent an hour or two with him. He says that the Governor "expiated very freely on Texan affairs, and particularly on the state of parties." The Governor severely abused Stephen F. Austin, currently serving as one of the three commissioners to the United States, saying that "he is Mexican in his principles and policy, and that he ought to be hung!" Colonel Gray's frank appraisal of Governor Smith is that "he is a strongly prejudiced party man, too illiterate, too little informed, and not of the right calibre for the station he has been

placed in."

Of San Felipe, Colonel Gray describes it as "a wretched, decaying looking place. Five stores of small assortments, two mean taverns, and twenty or thirty scattering and mean looking houses, very little paint visible. No appearance of industry, of thrift or improvement of any kind."

The distance from Nacogdoches to San Felipe, according to Colonel Gray, is about 200 miles, with a number of rivers and creeks to cross. Some can be forded on horseback; others require ferrying, usually at 25 cents for horse and rider. Supper, lodging, and feed for the horses are usually obtained at a farmhouse for a payment of 75 cents or \$1.

He described the hardships that are all too frequently encountered by the overland traveller. On the second night out, his party planned to stay at Aldridge's farm on the Salado, but he was not home. A neighbor named Little said that he could accomodate them. "Little's whole establishment consisted of a miserable hut about 16 feet square, which was kitchen, parlor, chamber meat house, etc.," says Colonel Gray. "There were two beds, and he had a wife and four children, the youngest sick with measles. Yet here he was to lodge us.

"He gave us a supper of very course fried bacon and pork, six boiled eggs, tolerable coffee, but no cream or milk, Indian pone, with so much grease in it that I could not eat it. I asked for cold bread, which fortunately they had, without shortening."

In the meantime Aldridge came home and invited them to his house. It was also one room, but a large one. "There were here only two beds, which were occupied by himself and wife, another woman, and several children, all sick with measles," Colonel Gray reports. "A comfortable bed was spread for us on the floor, where I should have rested well but for the crying of the poor children who were very restless. A stout Negro fellow also slept on the floor near us, sick with measles. The house was so open that I could see the stars through the apertures." The cost for this night was 25 cents for the supper, 75 cents for lodging, horse and breakfast, plus 25 cents additional for mending a coat.

Sherrill bid \$14,987. Other bidders were O.D. Cole and Jimmy Meeks, both of whom submitted lower bids than Sherrill. County Judge Porter Roberts said the commissioners felt that Sherrill's bid was the "best

1843: FRIDAY, FEBRUARY 10. Prisoners of the unfortunate Meir Expedition arrived today at Rancho Salado, about 120 miles south of the Mexican city of Saltillo. The exact number of prisoners is not known, since some have died since their surrender at the Battle of Meir last December 26. At that time, Mexican General Pedro de Ampudia reported that he had captured 248, including many who were severely wounded.

After their capture, the prisoners were marched to Matamoros by way of Camargo and Reynosa, in which towns they were paraded as bells were rung and citizens celebrated. They reached Matamoros on January 9, and set out from there on January 14 for Monterrey, which they reached on January 29. On February 2 they proceeded to

Saltillo, and from there to Rancho Salado. They are being taken to Mexico City for long-term imprison-

The Mier Expedition was an unauthorized offshoot of the Somervell Expedition of last fall. After the invasion of San Antonio last September 11 by a large Mexican force under General Adrian Woll, who held the town for 10 days and then left with 52 prisoners, a vociferous demand for retaliation spread among Texians. President Sam Houston deemed it necessary to act, even though he has always opposed offensive war against Mexico. He selected General Alexander Somervell as the most likely commander to keep matters from getting out of hand, and on October 13 ordered him to establish a camp near San Antonio to recruit volunteers, but only those "with a firm resolve to be obedient to orders." Texian volunteers are nortorious for their unwillingness to submit to discipline. Since the Republic is without funds, no supplies or arms for the volunteer army were to be issued.

Eventually, on November 25, the Somervell Expedition set out for Laredo with some 750 men. Although Laredo is on the Texas side of the Rio Grande, it has always been an enemy garrison. After a difficult march of some 150 miles, they entered the city on the morning of December 8, encountering no resistance. The small garrison of some 80 men had advance notice of their coming and had fled the town, along with most of the leading citizens and their valued posses-

That night the Texans camped outside the city. The next morning a

number of them went back and began to pillage everyhing they could lay their hands on, especially horses, mules, food, and specie if they could find it. That afternoon, when General Somervell discovered what had happened, he put a stop to it and demanded that everything be

returned. This created much dis-

satisfaction. The next morning, December 10, General Somervell announced that those who wished to, could return to their homes, and 187 men availed themselves of this permission. They left under Colonels J.L. Bennett and Jesse L. McCrocklin. Most of them were militiamen from Montgomery County, and they arrived home around the middle of last month.

The remaining army made a difficult march through mud and cactus toward Guerrero, some 50 miles down-river. On December 14 there was a brief brush with Mexican forces. On December 16 they crossed the river and entered Guerrero without resistance, demanding supplies and 100 horses to replace those they had lost. When these were not forthcoming the next day, they demanded \$5,000 instead. The town brought in only \$381, claiming that they had been stripped by a Mexican army that was billetted there a short time before.

On December 19, General Somervell received reports of large concentration of Mexican troops nearby, and issued an order for his small army of slightly more than 500 men to return to Gonzales to be disbanded. This brought to a head the growing dissatisfaction of most officers and men with their lack of action and lack of loot. A mass meeting was held, and 305 voted to

separate from Somervell to continue their expedition. The others joined Somervell, and most reached San Antonio by January 8, thus ending the Somervell Expedition.

The splinter group, now without official authorization, elected as their commander Captain William S. Fisher, who had served as Secretary of War in President Houston's first administration, but who had lately fallen upon hard times. On December 22 they crossed the river near Mier, and entered the town without resistance. They demanded provisions and clothing, and took the alcalde back to their camp across the river as a hostage. Their demands were not fulfilled, and after waiting two days, they learned from a captured Mexican that General Pedro de Ampudia of Matamoros had occupied the town with a large force.

The Texians immediately determined to engage him in battle. It was Christmas morning, and by late that afternoon, they had crossed the river, leaving behind some 42 or 43 men who were sick or lame. They entered Mier after dark, under a constant exchange of rifle fire, and reached a street leading to the square, where enemy artillery was located. They occupied houses in the town, breaking openings from one house to another to approach the square, and by daylight they were close enough to silence the artillery with rifle fire. By late afternoon some 12 Texians had been killed and many wounded, including Captain Fisher, who was shot in the hand. They had killed several hundred Mexicans, but still faced a force of some 2,000.


General Ampudia sent out a captured Texians with a white parley flag and demanded their surrender on terms that were threefold: that they would be "treated with the consideration which is in accordance with the magnamious Mexican nation;" that there would be no reprisals against Texians who had previously been captured in the-Santa Fe Expedition and had been released on condition that they would not again bear arms against Mexico; and that the Texians must give up their arms. Captain Fisher

thought they were being offered prisoners of war status, and accepted the terms. The 42 or 43 left across the river were not included.

However, once the Texians surrendered their arms, they were not treated as prisoners of war. Their belongings were plundered by Mexican soldiers, leaving them only

(Continued from Page 1) with the clothes they had worn into battle. They got little food, and were threatened with being shot. They started a long march to Mexico City on December 31, first going out of their way to Matamoros. Now, after six weeks of extreme hardship, they have reached Rancho Salado, and still have more than 400 miles to go.
