Whereever I've lived, whether it was Illinois, Indiana, Virginia, Nebraska, New York or Texas, there have been times when I was out for my evening constitutional when some unfriendly "woof woofs" were heard. And there was a dog nipping at my heels.

Maybe we should have a "War on

The interesting part of all these wars is that they happen again and again. We have fought the Japanese only once, in World War II, but I guarantee that we can see a War on Trash at least twice a decade.

And if a war peters out without a successful conclusion, not to worry. It will be repeated with the next government to come into office.

I'm sure all this negativism doesn't hold water all the time. Every reader surely has memories of successful wars. Why there even was a "War to End All Wars" once, back in 1914. Remember that one?

Personally, I would prefer that government officials not go to war so often, but rather battle the problem instead. I can live with a "Battle Against Dog Poop in the Streets," like a New York news-

Constitutional Amendment 7 -Proposing an amendment to Article 12 of the Constitution of New Mexico to expand and to enhance the

control and management of the

State Board of Education.



Constitutional Amendment 10 -Proposing to amend Article 3, Section 1 of the Constitution of New Mexico to provide for a workmen's compensation body.

Constitutional Amendment 11 -Proposing an amendment to Article 5, Section 1 of the Constitution of New Mexico to limit state executive officers to two consecutive fourvear terms in a state office, for terms beginning January 1, 1991.






Money was collected for shares sold, and it provided the capital outlay. Stock certificates were issued, and stock was traded during the week on a voluntary exchange.

## A white flag brings a message unoffending Mexicans, not war-

A white flag from the enemy brought the message that General Montoya wished to confer with Colonel Molano. The conference lasted almost an hour, with Molano sending back word through Lopez that Montoya had agreed to pay the Federalists \$2000,000 to depart, but that Molano was demanding \$250,000. Actually, Molano was merely delaying action until expected reinforcements for the Centralists could arrive. When they came in the early afternoon, they increased the Centralist army to more than 1,000.

Colonel Lopez now claimed that Molano was being held prisoner, and ordered an advance. He proposed that the Mexicans and the Texians fight separately, and drew up a battle plan that would have sent the Texians into a deep gorge to be slaughtered. Upon perceiving this, they halted and decided to follow Lopez, who by now had rounded the hill. Here he halted his soldiers and told them that it was suicide to fight such an overwhelming force, and that the only alternative was to go over to the enemy. Firing his gun into the air, he shouted, "Death to Texas! Long live Mexico! Follow me, soldiers, and save yourselves!" He bolted to the enemy, followed by most of the soldiers. Colonel Jose Maria Gonzales and some of his unit refused to join them, and took to the mountains instead.

Seeing themselves thus abandoned, the Texians decided to fight to the bitter end. Holed up behind the walls of a nearby hacienda, they were subjected to a prolonged barrage of cannon fire. About 4 p.m., hearing no response, General Montoya assumed that most of them were killed. He ordered an attack, cheered on by the crowd of spectators in the rear.

Jordan told his men to hold their fire until the enemy was in close range. Almost every shot took its toll. Column after column advanced, faltered and fell under the murderous fire. At length the enemy because disorganized, panic followed, and they fled in wild disorder, joined by the men, women and children who had come to see "los diablos Tejanos" receive their

The Texians counted some 408 Mexicans killed and left on the battlefield, with but few wounded. They themselves suffered three killed and nine wounded, two of whom died later. They captured a large quantity of guhs and ammunition, plus the enemey's two can-

Before the enemy could regroup, the Texians retired and started for the Rio Grande under cover of night. At a mountain pass they were attacked by a group of volunteers from Saltillo, who were put to flight after an exchange of fire. No Texians were hurt. Lost in the dark and passing through a cornfield, they heard cavalry approaching. They waited until the riders were within 20 paces, then fired into the darkness, bringing down some 40, and the others fled. One Texian was killed in this encounter

That morning at a rancho they got accurate information regarding their route, and the next day they found the road to Monclova. They finally reached Laredo today, after being harrassed during the entire route by enemy cavalry, who, however, maintained a respectful distance and inflicted no casualties.

During the nine-day journey, one Texian straggler was captured by the enemy, and another took off into the mountains alone and has not been heard from. On the third day out they were joined by three of Gonzales' men who had refused to join the enemy, and last Thursday, when they reached Candela, they encountered Colonel Gonzales himself. He was making his way to Laredo, where he lives. With news of their approach, Colonel Seguin, who is currently stationed there, sent out a small contingent to escort them into town.

Colonel Jordan is now preparing a full report to General Canales, who at present is maintaining headquarters at Camargo. Upon looking through a trunk on one of the pack mules brought from Saltillo, he found Colonel Molano's entire correspondence with the Centralists. fully revealing the extent of his treachery.

1837: SATURDAY, NOVEMBER 4. Texians who have been held prisoners in Matamoros arrived in Galveston today to their freedom, aboard a ship especially chartered for this purpose by the Mexican government. They were released by order of Mexican President Anastasio Bustamente.

Most of those released were captured by the Mexicans on April 17 of this year as passengers and crew of the Texas war schooner Independence when it was taken by the enemy. They have been held since then in what President Sam Houston has termed "cruel and rigid confinement."

The release of the prisoners tends to allay fears that Mexico is preparing to launch a major attack, even though President Bustamente, in an address to his troops on September 28, said that they would soon be called upon "to gather new laurels on the fertile fields of Texas." Some 3,000 troops are reported to be assembled at Matamoros under General Vincente Filisola, but they are said to be poorly clothed and equipped.

The attitude of Texians is one of watchful waiting, without fear. They generally believe that they can counter odds of 10 to 1, since Mexican soldiers are often ill-trained, and many are convicts serving out their terms in the army.

1837: TUESDAY, NOVEMBER 7. President Sam Houston today submitted to the Texas Senate a message listing the "misdemeanors" which have caused him to demand the impeachment and court-martial of Secretary of the Navy Samuel

Rhoads Fisher.

A major charge against Fisher is that he neglected his duties by sailing on the Texas naval schooner Brutus from June 11 to August 27 as it plied Gulf waters in search of prize vessels. With her was the Navy's only other vessel, the Invincible, thus leaving the Texas coast unguarded. The two warships also attacked a number of small Mexican towns along the coast, "plundering, burning, and destroying the property of defenseless and nations," according to the Presi-

Houston also charges that Fisher proposed using the Navy to obtain the release of prisoners being held at Matamoros, when he was fully aware that the President was attempting the same thing by negotiations and exchange. According to Houston, the Secretary "betrays a temper and hostility of feeling incompatible with the respect due the Executive and the confidence that ought to exist between them."

Although not listed among the misdemeanors, it may be that a major cause of the President's dissatisfaction with Secretary Fisher is the fact that Texas currently is without a Navy, since both the Brutus and the Invincible were grounded and wrecked off Galveston Island on August 27, the very day of the Secretary's return, during an off-shore engagement with two enemy vessels.

Secretary Fisher is known to have a number of supporters in the Senate, and it is unlikely that it will vote for his impeachment or courtmartial. No doubt he will be encouraged to resign instead, since "the breach between him and His Excellency is such that it could not be for the interest of our common country that he should retain the station."

1840: SUNDAY, NOVEMBER 8. General Antonio Canales, commander-in-chief of the Republic of the Rio Grande, yesterday abandoned the Federalist cause and concluded an armistice with Centralist General Mariano Arista. The capitulation was initiated by Canales.


The so-called Republic of the Rio Grande has thus come to an end.

In the capitulation, the Federalists have agreed to turn over their armament, including a 4-pound cannon, and four armed ships partially paid for, reported to be moored at


this time in Corpus Christi Bay. The lives, liberty and property of all Federalists who surrender are guaranteed, and all officers and soldiers who were formerly in the regular army of Mexico are restored to their former rank, or they can apply for a discharge if they prefer. Whether Canales will retain his rank as general is not known. He

was formerly a lawyer in Guerrero, and a colonel in the Mexican army.

Exempted from the capitulation are the Texians who have been fighting with the Federalists. They may either join the Centralist forces, or cross to the Mexican side of the Rio Grande to receive the pay due them, and return home. However, since the armistice begins with a statement that its purpose is to protect Mexican citizens from the "danger of exposure to the vengeance of the foreigners who menace them," it seems unlikely that many Texians will test the sincerity of this offer.
