

'The most harrowing experience of my life'

Curtis Smith of Farwell had the most harrowing experience of his life while fighting rampaging fires in Northern California this month.

Smith joined expeditions of firefighters from throughout the Western states to battle wild fires that devastated large parts of California, Oregon and Washington early this month.

The National Forestry Service had put out word asking for help in fighting the fires, and for equipment. The Service had partially funded Farwell's WEPS unit and also the Lazbuddie unit.

In agreeing to help, Smith had to make a 14-day commitment to the Service. He and other volunteers were paid by the Service.

So Smith left Farwell at 3 a.m. Sept. 2 in the WEPS unit along with two firefighters from Plains. They met in Amarillo at 5 a.m. with others. The caravan of nine trucks features 5 West Texas and 9 East Texas firefighters.

The going was slow. Several trucks were old and broke down frequently. But Sunday night they arrived in Northern California, near Redding, to begin their work.

Smith explained that fighting forest fires is unlike fighting a house fire. Forest fires get so hot that just throwing water on them is to no avail. What firemen must do is to create fire lanes, which are bulldozed, to stop giving the fires "food" to continue. And they set backfires, which also burn up the ground so that when the wild fire meets up with them, there aren't enough ingredients on the ground to keep the wild fire raging.

Driving down the California roads that Sunday, Smith and the others thought they were not going to be needed. "Guys

were yelling out that the fires were out and we should go home."

But the fires broke loose again Monday and the men who were traveling home had to do an abrupt about-face.

On Monday, Smith's Texas group set on camp. Then at 8 p.m. they went out for their first shift - 27 straight hours.

Smith and 7 other Texans were assigned to patrol a fire lane, to make sure the wild fires didn't breach it. Also, they set back fires to help.

The next day, at 3 p.m., the fire jumped the lane and the Texans found themselves trapped on a ridge.

"It was scary," said Smith. "Flames were shooting 300 feet high and running 30 to 40 miles per hour. A tree would go up in flames in 3 seconds. The first time I heard the fire, I thought it was a jet plane; it was the fire."

What had happened was that the fire had come around Smith's group, like a pincer movement.

So the firefighters watched as the fires swirled closer. Then they made a break for it in their trucks through an area that had just burned. "It was the only way out," said Smith. "The way we came in was on fire. It was the most harrowing experience in my life."

But they weren't out of the "woods" yet.

"We drove into another area where it was so smoky that you couldn't see past the windshield. You sort of felt your way down the road. You had to keep the windows up because it was so hot.

"We got to a spot where the wind blew the smoke away and we were joined by a group of about 20 other men and women who had been trapped, too. They had a bulldozer so

we used it to forge a path and we followed them out."

Smith explained that forest fires are quite different than prairie fires. In Texas, you can run from a fire. But a forest fire can surround you - since it is composed of hundreds of small fires pushed by small breezes.

At one point, the forest fire had jumped a 90-foot fire lane. Meanwhile, they kept working. Although it was dark, they had to watch for new fires caused by fall-out. At 3 a.m., they returned to camp for rest.

On Tuesday night, the Texans were back setting back fires, which worked well. Firemen and women were stationed 20 feet apart and worked for 12 hours.

That work continued day after day as winds kept fanning fires. It wasn't long before all the firefighters had deep circles around their eyes and smudges from burning cinders.

"One guy said that if you imagined what Hell was like, this was close to it," said Smith.

After several days, the fires were under control. They were called "100% contained" (meaning backfires surrounded all the fires) and "80% controlled" (meaning the fires were manageable).

Now, the mop up operations began. Firefighters drove through burned area looking for smoldering logs to douse. One day, Smith helped guard the heliport - 37 helicopters were being used.

Smith said the Farwell unit performed capably and had no problems. He returned to Farwell Sept. 16.

Smith wanted to thank those persons who helped his family and his business while he was away.

Bork should be approved

Just as many of you did, I spent several hours last week watching the Senate Judiciary Committee's televised hearings on the proposed U.S. Supreme Court appointment of Robert Bork.

Utterly fascinating. When the topic is philosophically challenging, it's interesting to see which individuals rise to the fore. And which ones sink.

I believe that Iowa constituents of Sen. Grassley must have wondered what he was doing in the Senate. On the other hand, Wyoming voters must have been well-pleased with the common sense approach of Sen. Simpson.

Bork, as you know, is a strict Constitutionalist. A conservative judge on the U.S. Court of Appeals in Washington, D.C., he's drawn the ire of liberal groups throughout the United States.

In a word: politics. Currently, the lineup of the Supreme Court is roughly 4-4 between conservative and liberal approaches. The numbers are not quite correct because conservative justices often will vote for a liberal cause, and liberal justices for a conservative cause. But in recent years, we have seen several 5-4 votes on important social issues.

If Bork is approved by the Senate (this column was written last weekend while his hearings were still being held), it would mean that the Supreme Court could easily tilt 5-4 toward a conservative path.

Frankly, liberal opponents don't have much to hope for even if Bork is turned down. I'm positive President Reagan will nominate another conservative, and another, until one is approved. And if Bork is denied, the Senate will be hard put to veto a second nominee, regardless of his stature.

The point I'm planning to make in this column involves the current process in approving a Supreme Court nominee. I don't think there is any question that Judge Bork is more than well-qualified to sit on the High Court.

He has written articles and books that are used as the basis for many judicial decisions throughout the land, ranging from anti-trust to the Constitution. He has not had one decision reversed while on the Court of Appeals changed by the Supreme Court. He has served as U.S. Solicitor General. He is a brilliant man with outstanding thinking techniques. But he's a conservative.

In my opinion, judgment should be made by the Senate on the qualifications of a nominee. That's idealistic, I know.

Kube heads group fighting demolition

The Bordertown Heritage Foundation was formed by concerned individuals wanting to save the Santa Fe Depot in Texico. The group met Sept. 21, 1987 to elect officers: Pres. - David Kube, V. Pres. - Ann Cooper, Sec. - Susan Scioli, and Treas. - Vernon Luce.

Others present at the meeting were: Raymond Martin, Vernon Luce, David Kube, Doug and Susan Scioli, Ann Cooper, Jess Richardson and Virgil Fiske.

Plans were made to relocate the Depot, add a basement and use it for a public library, Railroad museum and a civil defense shelter. Cost of this phase of the project would be approximately \$200,000.00. Payment will be made as work progresses. As soon as enough money is donated to relocate the Depot, the Foundation will apply for a community Block Grant to cover the cost of renovating, landscaping and etc.

This building will be beneficial to Texico and Farwell as a tourist attraction and there is a need for a community shelter and library.

Bruce Ryberg, representing Ryberg Movers of Denver, Colo., attended the meeting to answer all questions concerning the moving. He also showed pictures of other moving projects done by his company, of special interest were the pictures of the Sterling, Colo. Depot, which was much larger than the one in Texico and was moved successfully.

Texico man arraigned on murder charge

Joseph Phil Dionne, 49, of Texico, has been arraigned by the Magistrate's Court in Clovis on an open charge of murder.

Clovis Police said Dionne allegedly shot Richard W. Lasner of Clovis who later died.

Bond has been set at \$25,000.

On an open charge of murder, the defendant may later be charged with first degree murder, second degree murder or manslaughter when a grand jury is convened.

Pragmatically, the Senators keep their eyes open to what is politically expedient. Let's take Sen. Biden of Delaware, for example.

Biden is running for President. He's in a large Democratic field and thus has to stake out a territory for himself. You can't do that unless you make waves and take a particular stance which guarantees you backing. Biden is using the Bork nomination toward this end.

Yes, he has been very fair during the hearings. But when the chairman of the committee announced before the hearings even start that he will oppose the nomination, what does that say about fairness?

Damn the qualifications, it's the political end that counts, eh, Biden?

There was a time in U.S. history when Henry Clay of Kentucky (was it 1844?) could say he would rather be right than president. Today, the cry of avaricious senators is that they would rather be president than right.

It's a game, you see. Regardless of how well qualified a conservative nominee is, there are liberals who will oppose him at all costs. (And I'm sure if the nominee was liberal, the conservatives would be fidgeting, too.)

Well, it shouldn't be. What should matter is that qualified people are put on the nation's highest benches - and in all governmental positions.

Instead, we have to deal with political wimps using situations like this to further their own egotistic aims. It's exasperating.

Even if Bork were liberal, I would publicly say he ought to be appointed to the Supreme Court. He's probably more qualified than half the current sitting judges on that august body.

Instead, we are treated to assinine questions about his speculative, professorial views from 1962 - a quarter century ago. Way to go, Senate Judiciary Committee; keep making a mockery of your work. And this fine man is reduced to having to deny false allegations about his

Farwell had 6 penalties for 60 yards; Plains 5 for 55 yards.

For Farwell, Jeff Actkinson ran 9 times for 40 yards; Damon George, 10 for 40; Joe Jaime, 18 for 78, and Ruben Ortega, 2 for 12.

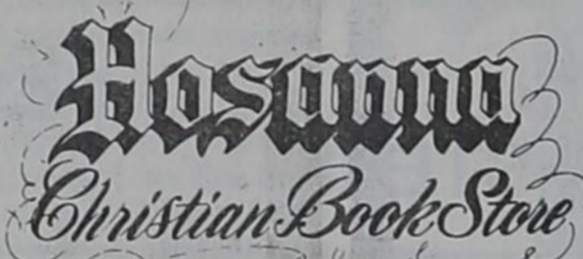

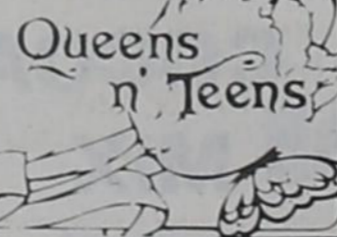

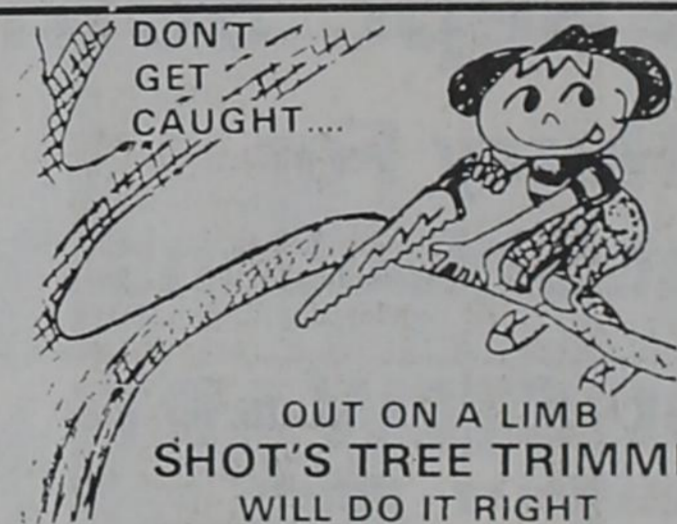

The program will feature talks by students about some of the activities they have participated in this year.

Geneva Garcia and Robin Pierce will talk about their experiences at Business Awareness Week at New Mexico State University in Las Cruces last June.

will also speak. They are: Kayla Thornton, Leslie Steward, Codie Burch, Michelle Verner, Monia Ann Potts, and Lisa Harrison.

The students will talk about some of the experiences they had by participating in these programs - often these are experiences that they would not have had if the school had not made the opportunity available.

They will also talk about what they went through to be picked for the experience. Miss Garcia and Miss Pierce, for instance, had to fill out applications to be considered for the Business Awareness Week. The applications were

signed by Mr. Shaw who had to prepare a transcript of their grades to accompany the application.

The girls also had to answer essay questions about why they wanted to attend the Business Awareness week. A committee of influential New Mexico businessmen then selected the applicants who would attend the meeting.

The teachers and administrators at Texico High School want to give recognition to students who have excelled in vocational education, and they want parents to know what opportunities are available for their children. They also want parents to know what students must do to be considered for some of the opportunities available to them in vocational education.

Texico Elementary to offer enrichment program

Texico Elementary School will begin offering an enrichment program for students who score high on standardized tests and also for students recommended by teachers because they exhibit talents which are not tested - such as painting or singing. It is not strictly limited to the students with the highest test scores.

The elementary teachers will give up one of their conference periods once a week for about a month. They will meet with a small group of students to enrich and instruct the students. Topics for instruction will change frequently. The groups of students will change so that many students may benefit from the program.

The enrichment program is voluntary for both the teachers and the students. The program is designed to augment what the students learn in class without becoming repetitious or boring. The idea is to challenge the talented students.

Some of the suggested topics to be covered in the en-

richment program are: play production, art, creative writing, photography, baking, making pinatas, exploring leisure activities, and computer literacy and programing.

Students who participate in this program will miss one regular class period per week. They will be expected to keep up with their regular assignments. They will have to learn to budget their time in order to participate in these activities.

"We hope that this program will give the students a boost by making school interesting while encouraging higher levels of thinking and problem solving," says Special Education director Paula Leighton.

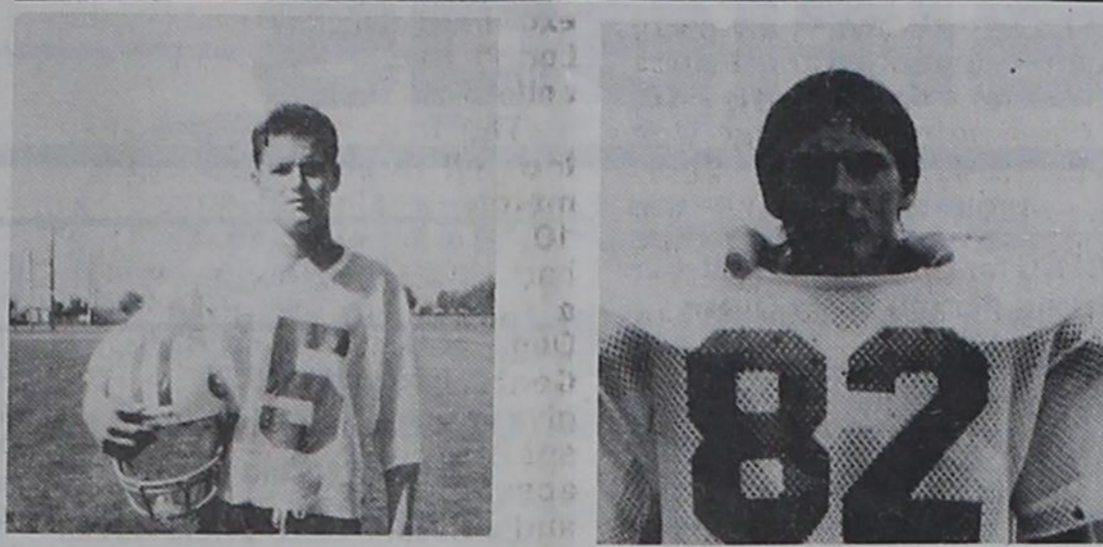
