## Twin Cities & Vegas

A travelogue today, folks: It was time for our annual 3 day vacation (I envy those folks who can take off for longer periods) and we decided on a visit to the Entertainment Capital of the World (as the natives say) - Las Vegas.

It had been 15 years since we deplaned in Vegas and, wow, was it different. Back then the city had 150,000. Today, there are 650,000 permanent residents and 250,000 to 300,000 visitors on a given weekend.

The changes were obvious. Places like Caesar's Palace and the Stardust looked like they had doubled. "Big" isn't appropriate; "gigantic" might be closer.

First of all, I want to make it perfectly clear that we didn't go there to gamble. We went to see the shows and enjoy the food.

However, a horrible thing happened. Just after arriving at our hotel, my wife and I were attacked by bandits. Life in the big city, I guess. The odd thing was that these bandits all had one arm each. But they didn't let that handicap stop them from forcefully abstracting money from us. As I said, it was horrific.

One of the things that sets Vegas off from towns like Clovis, for example, is the food. Great food is offered at outrageously low prices as come-ons for their casino business.

Among the items we saw: 16-oz. Porterhouse Steaks for \$4.95; broiled lobster in the shell (2) for \$8.95; all you can eat breakfasts for \$1.29; shrimp cocktails (up to 3/4 lbs. of shrimp) for \$1.19, and half-pound hot dogs with soft drink for 99 cents.

One thing had changed: 15 years ago the "Westward Ho" offered free champagne from a faucet. That was gone.

Another change was that the number of "big names" wasn't prominent. The majority of shows featured musical or dance revues, or magic acts. For example, in 1973 Elvis was playing - live. Today, the big show features an Elvis impersonator. Another show featured a host of impersonators, including Buddy Holly, Louis Armstrong and, of course, Elvis. Yet another show had female impersonators.

And watching folks gamble (yes, it's an addiction) was a course in itself. We saw one fellow at the blackjack table plunk down \$400 at a time. He lost \$2,000 within 2 minutes. Then he walked away. If it had been me, they would have had to carry me away.

Of course, we all know that every gambling game is rigged in favor of the house. Anyone who goes there will lose money if they gamble. Period. It amazed me to see people there who actually thought they were going to beat the house.

But as I said, we went for the 30-cent slices of pizza and the revues.

I would like to say that I did see one major instance where the Twin Cities and Vegas had something in common. At 7, the lights go out in each place.

My next-door neighbors, Toby and Norma Booth, will be leaving soon. Toby has taken a teaching job in Eagle Pass, Texas, near the Mexican border. It's the area where Norma is from. Toby formerly taught and coached at Farwell, and also was a Lazbuddie principal. We wish them well.

While we were out of town last weekend, a possible candidate stopped by, and although I didn't meet him I want to mention that he visited Farwell: John Odam.

# Texico Mayor Hadley resigns

John R. Hadley, mayor of Texico for the past 10 years, has resigned his post and is moving to Clovis.

He officially tendered his letter of resignation Wednesday. "This letter will inform you that I am no longer a resident of Texico and therefore am unable to fill the position of mayor. ... Please accept this as my formal resignation," he wrote.

Hadley has been in a legal situation involving his Texico home. Due to it, he and wife Evelyn moved out of the home Sunday and have leased an apartment in Clovis.

Hadley had lived in Texico for 62 years. "I enjoyed the job of mayor and I hate to leave," he said.

"And I want to thank all our friends who helped us move."

The Hadleys searched for an apartment in Texico but were unable to find one to their liking.

Hadley said they could have stayed in the Texico home for 18 more days but on advice of attorney they decided to leave Sunday.

At Tuesday's City Council meeting, the council, with Bryan Kube as mayor pro tem, asked City Attorney Duane Hamar to research how the post is to be filled. No other actions were taken.

It appears that it's up to the council to appoint a new mayor. They can pick one of their own members or a qualified resident. If they pick one of their own members, then the new mayor nominates a

replacement on the council. Both the new mayor and new councilman then will be on the next election ballot.

At the council meeting, a representative of Alpha Lot (see story on Farwell City Council for details) spoke about what his company is capable of doing. The council indicated they would check the work he did in Farwell and perhaps ask him to come back to Texico to see what work was needed.

Councilman Butch Tharp again brought up the problems of Garwood Avenue needing repair work. Kube will contact Eastwood Construction.

The council met in executive session with Marie Esparza on a personnel matter.

# Farwell High principal Lynn Burton resigns

The Farwell School Board Tuesday accepted the resignation of high school principal Lynn Burton.

Burton, a former Farwell band director, will take a band director's post at Estacado High School in Lubbock. He begins his new position Aug. 15.

The Burtons will move to Lubbock as soon as they find a house there.

David Reynolds, principal at Fort Davis, Texas, Secondary School (grades 6 - 12) has verbally accepted the post as Farwell High principal.

He has 22 years of experience in education. He and his wife have an 18-year-old son. They need a home to rent; persons who can help should contact the Farwell superintendent's office.

Also, the board hired Craig Zinck as the new band director. He formerly was band director at Spearman, Texas, and Clayton, N.M., but has been out of the educational field for the past 7 years.

Zinck replaces Norris Samuelson. Samuelson's resignation has not been formally accepted yet, pending a report from Burton and Samuelson on some missing equipment.

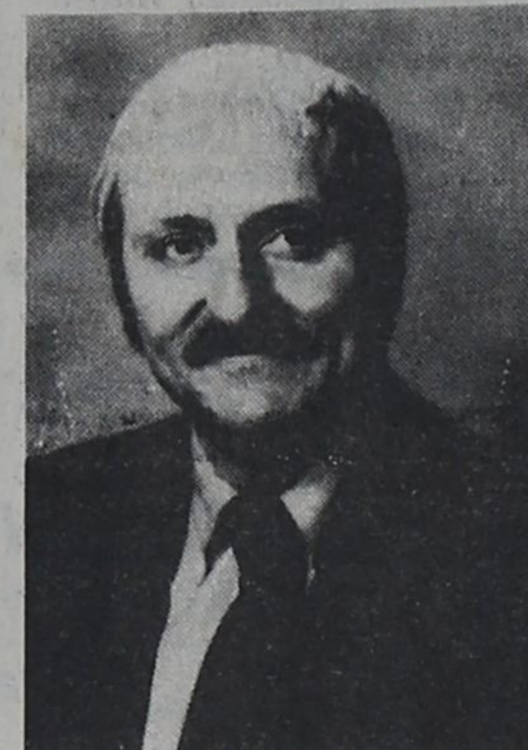
Burton earlier had reported to Supt. John Grigsby that several items were taken to Lubbock by Samuelson for summer repair and were stolen from a vehicle. Burton said the man from whose vehicle the equipment was taken didn't have insurance to replace them.

In other business, the board: - Continued its discussions of ways to renovate the home economics cottage.

- Will have a special called meeting later to discuss facility renovations, such as new roofs on school buildings.

- Set the tax rate hearing for Sept. 6. The tax rate will be set at its Sept. 13 meeting.

- Approved a 1988-89 budget of \$2,402,014, up from the current \$2,278,000. The bulk of the \$120,000 is due to state-mandated salary hikes. However, the tax rate is expected to remain the same due to two reasons: some taxable values (pipeline and farmland) have gone up, which will result in an extra

\$45,000, and the board will use \$75,000 in its reserves.

The school system will have \$345,000 in reserves by Sept. 1 but this total will decline quickly because it also will be used for expenses the next two months, since tax money won't arrive until November.

- Received two bids for milk, from Bell Dairy, Lubbock, and Borden, Amarillo. The board okayed switching to Bell since its bid was lower.

- Heard Grigsby report that a pre-kindergarten program may be offered. Last spring's survey indicated too few students would participate but more have arrived since. A new survey is being taken.

- Okayed buying gas tank protectors for school buses.

- Tabled the proposed AIDS curriculum.

## Interested in forming a Farwell PTA?

There will be a meeting to discuss the formation of a PTA for Farwell Elementary at the Farwell Community Center at 7 p.m. on Aug. 18.

The regional vice president of PTA, Diane Pierce, will be here from Amarillo to speak. She will offer assistance in the formation of a PTA.

"We hope we will find a lot of interested people. We need 20 members to form a PTA, and I believe we have close to that number who have said that they will join," said Pam Halverson. "Several people are very enthused about this idea."

Mrs. Halverson indicated that her past experiences with PTA had been a very positive experience. PTA enabled her to know what the school's goals were, and what she could do at home as a parent to help her child.

"We had a program for volunteers. I used to go for one hour a week to help a teacher with some things. I really enjoyed it, and I learned a lot about the school that

way," she said. Some PTA's sponsor carnivals or fundraisers to finance school projects. The work done by parents often enables schools to buy library books, playground equipment, or equipment that they would not have through normal funding.

PTA programs often explain to the parents what resources are available to help their children. Often, parents notice problems before others do, but sometimes they do not know where to turn for help.

"Our children are the most important thing, and their education is really important to us," said Mrs. Halverson who will have children in kindergarten and third grade this year. "Other parents I know feel the same way," she said.

"Parents need to know what's going on at the school, and they need to work together with the teachers. Also, teachers need to know that parents care," she said.

**Salary raises okayed**

The Parmer County Commissioners Monday voted salary raises for three county officials.

The salaries of the county treasurer and district clerk were raised from \$15,365 to \$16,902. This raise places these two salaries in line with the county clerk and county tax assessor.

Also, the county sheriff's pay was increased from \$19,097 to \$20,500.

The three pay raises take effect in 1989.

In other business, the commissioners increased its payments for rural fire protection to the four county fire departments from \$3,500 to \$4,000 a year, effective in 1989.

The commissioners made a change in its ambulance subsidies. Previously, \$800 was awarded to Friona and \$300 to Farwell and Bovina. The new rate, effective in 1989, gives \$375 to Friona, Farwell, Bovina and Lazbuddie.

Commissioner Ray McGehee noted that the Lazbuddie fire department has been upgrading its ambulance service.

Two bids were received for tractors. The bid of Castro County Commissioner Curtis Smitker, of \$17,500, was accepted.

The county bought miniblinds for some of its office from Twin Oaks Psi Design, Farwell, for \$2,142.

Starting June 1, 1988, hunters who were born after Sept. 1, 1971 need to take a mandatory hunter education course before they can be licensed to hunt.

This year, hunters whose birth date falls between Sept. 2, 1971 Aug. 31, 1973 must successfully complete the course to hunt in Texas.

By Sept. 1, 1990, hunters born Sept. 2, 1971- Aug. 31, 1974 must successfully complete the course to hunt in Texas.

By Sept. 1, 1991, hunters born Sept. 2, 1971- Aug. 31, 1975 must successfully complete the course to hunt in Texas.

By Sept. 1, 1992, hunters

born Sept. 2, 1971- Aug. 31, 1976 must successfully complete the course to hunt in Texas.

By Sept. 1, 1993, all hunters who are at least 12 years old must successfully complete the course to hunt in Texas.

Hunters born before Sept. 1, 1971 do not need to take the course. Neither do hunters who have been certified in voluntary Texas Hunter Safety Education Programs.

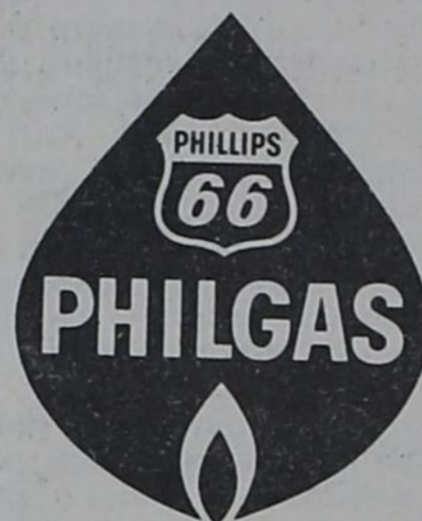
Hunters who have been certified through other states' resource agency may not need to take a Texas course if they have taken a course that is comparable to the Texas course. They will need to check with the Texas

Parks and Wildlife Hunter Education Section to determine whether a comparable course is acceptable or not.

Hunters 12 years old and under must be accompanied by a licensed hunter 17 years old. Hunters under 12 may attend and receive recognition of attendance in a hunter's safety course, but they must retake the course after turning 12.

Hunters must carry proof of certification with them at all times while hunting with all firearms and archery equipment.

Failure to comply may be punishable by a fine of not less than \$25 nor more than \$500.

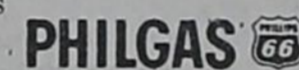

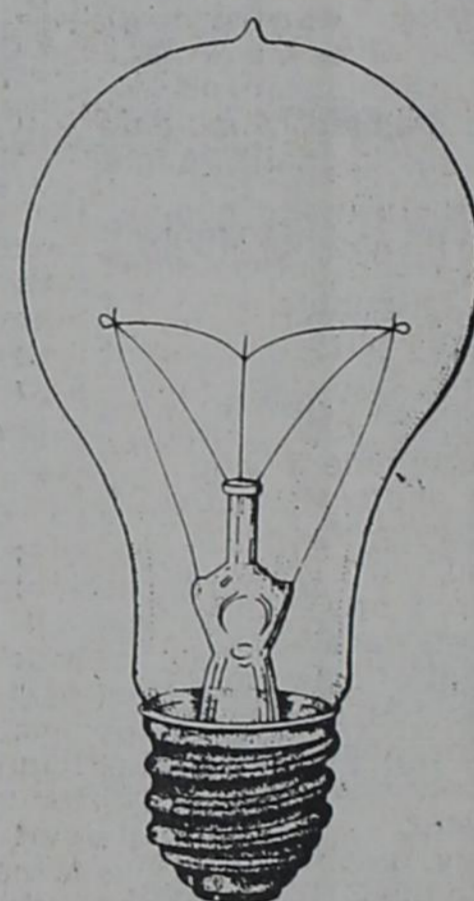

According to the American Cancer Society, one out of ten women in the United States will develop breast cancer sometime in her lifetime. It is currently estimated that over 37,000 women die each year as the result of breast cancer.

Ninety percent of breast cancers are diagnosed by women or their physicians finding a lump in the breast. Women who are diagnosed with a lump large enough to feel have a 50 percent five year survival rate. A woman who is diagnosed as having breast cancer by mammography, before a lump can be felt, has a 97% five year survival rate and a 90% 10 year survival rate.

A mammogram can detect a cancer this small, even before it can be felt.

Appointments may be made by calling 238-1116. The mobile breast cancer detection unit will be in

Bovina at City Hall, 205 North St., on Friday, August 19th, from 9 a.m. to 7 p.m.

The American Cancer Society has established guidelines for mammography in asymptomatic women. (Women who have no symptoms of disease). Those guidelines have been adopted by the American Academy of Family Physicians, American College of Obstetricians and Gynecologists, and the American College of Radiology. Those guidelines are:

1. 35 - 40 years of age - one baseline mammogram.
2. 40 - 50 years of age - a mammogram every 1 - 2 years, depending on breast type and risk factor.
3. 50 years of age and over - an annual physical examination and annual mammogram.
4. Asymptomatic women under 50 years of age with significant high risk

factors should be examined at appropriate intervals. These risk factors include previous breast cancer and family history of cancer.

5. A symptomatic woman should have a mammogram at any age when she experiences a mass, nipple discharge, skin changes or unexplained breast pain.

A screening mammogram is an x-ray of the breast using extremely low dosages of radiation (usually comparable to dental x-rays) and is designed to find every early cancers.

A female technologist who is highly trained in mammography will perform the examination.

The charge for the screening mammogram is \$50.00. The unit accepts cash, check, Visa, MasterCard and American Express.

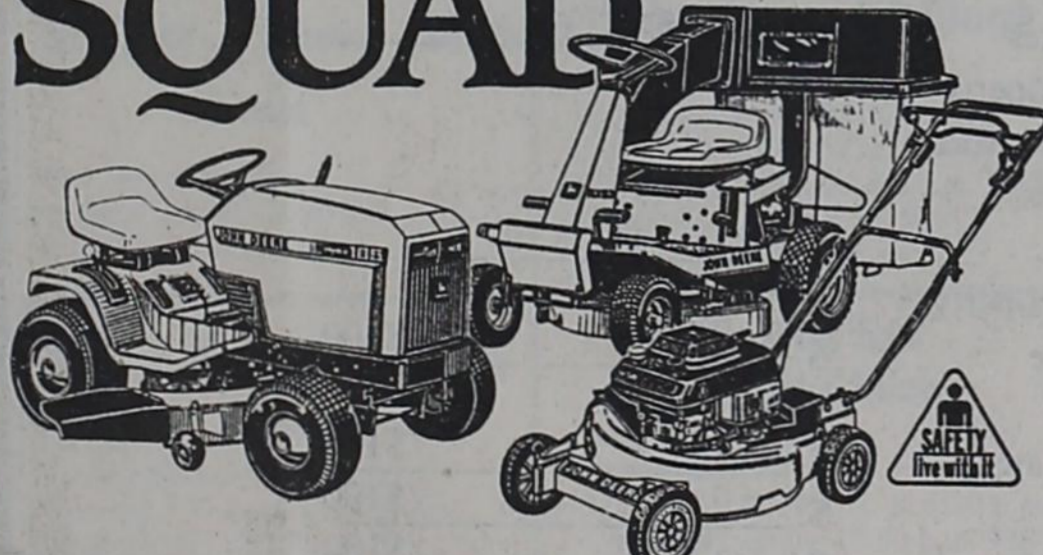

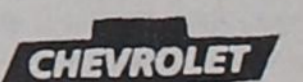
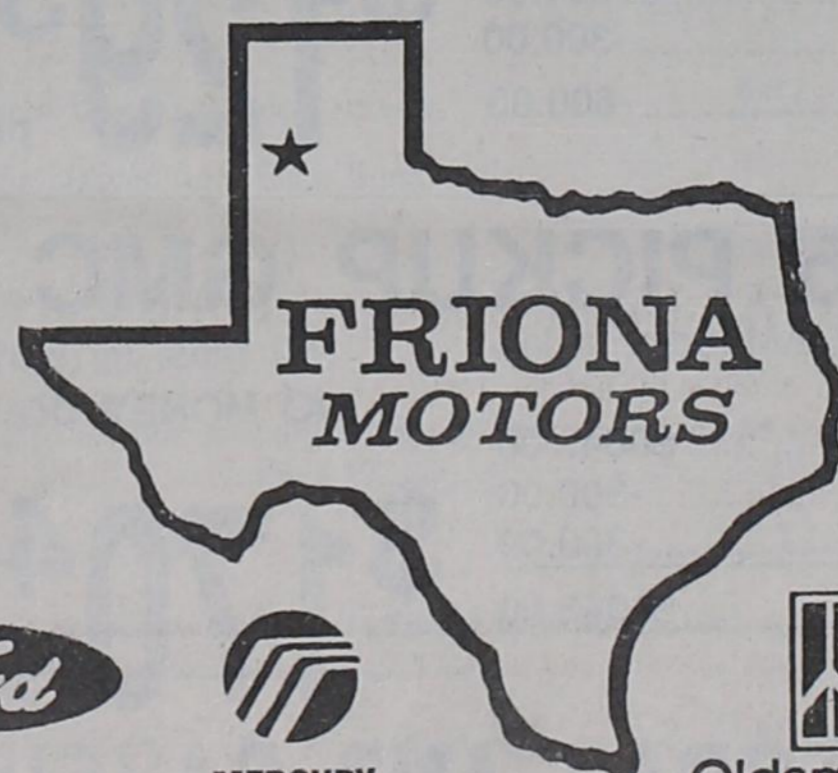

# Farwell council approves 1989 budget

The Farwell City Council Tuesday approved a tentative budget for 1989 which is close to the current one. Some extra funds will be needed but the council indicated they likely will use funds in their Certificates of Deposit to cover them. A very slight tax increase (no more than 3 percent of .008 cents) also might be in the offing. The council is looking at an extra \$4,500 for a used pickup truck (or rebuilding the current one) and \$6,000 for a new pit for burning. On the other hand, \$28,000 is budgeted for street repairs and a total half that is expected to be sufficient next year.

Discussing the CD's, councilmen stressed that it is important to keep a financial cushion. Yet, at the same time, there's no need to keep too many funds in CD's while raising taxes.

In other business, the council discussed complaints of junked cars. A few months ago, letters were sent to owners of vehicles noting the city ordinances and asking them to remove the vehicles. Some were removed. The council instructed City Clerk Cynthia Thigpen to send registered letters as a follow-up. Mayor Chris Gikas reported on the newly-formed Panhandle Conference of Mayors, a coalition of mayors. Gikas was elected secretary-treasurer of the group. The Amarillo mayor is president. Gikas said they approved a \$5,000 budget for the first year, with assessments to cities made on a population basis. Farwell's fee is \$20, and the council voted to pay it. Gikas said the group's aim is to act cohesively on legislation affecting the Panhandle, and also supporting each

other's needs. The council was shown a demonstration by Alpha Lot Service of Amarillo on its method of using hot asphalt and rubber compounds to fill street cracks. The demonstration took place on Ave. B at Fourth Street. The council was very impressed by the demonstration. Alpha Lot filled 160 feet of cracks with the compound. They charge 50 cents per lineal foot (with a groove into the street) or 40 cents a lineal foot without it. Afterward, the council estimated that by using this method they could save up to 60 percent of its annual street repair costs. What was particularly important was that some streets have had so much seal coating that they are built too high. By putting more seal coat on them would cause drainage problems. The method of filling just the cracks might solve the city's problem. Gikas asked Alpha Lot to send a letter noting other Texas communities that have used the process so Farwell can check with them before going ahead with it. Also discussed was the need for a security officer. The top candidate who had interviewed recently for the post took a job with the Portales police. Gikas said a qualified law enforcement person is needed and ap-

pointed a committee of councilmen Martin Welling, Martin Kube and Curtis Smith to further check on it. Gikas said state law prevents a deputy county sheriff from handling the city's police work. But there are other options involving the county and the committee will investigate them. Fire Chief Joel White appeared before the council to further discuss his department's need for a vehicle to transport personnel to training classes in Lubbock and

Amarillo. White suggested a Suburban holding 6 to 8 people would be fine. The price would be around \$20,000 (including fire department equipment). The council tabled action until 1989 models are out. The personnel policies handbook was discussed. City Attorney Charles Aycock will be asked to review the benefits section and clarify them according to what benefits are available to permanent employees.

## Blanton talks about large wasps

Mike Blanton, Extension Agent Entomologist for Parmer and Bailey Counties, reports that in recent days he has received several inquiries regarding extremely large wasps in area yards.

Wasps of this group are commonly called "cicada killers" or "ground hornets". They are about 1 1/2" long and are one of the largest species.

Cicada killers are a beneficial insect. They are usually more of a nuisance than a threat. They will usually only sting if they feel threatened. If they nest in a place where they are a problem, any home use spray for wasps and flies will usually take care of them. Or, a vigorous dose of Sevin may be used near the hole.

They are active in July and August. Both male and female wasps may be encountered on flowers and in nesting areas. Males exhibit territoriality and investigate all


intruders vigorously. Territories may be 100 square feet in size in the vicinity of an emergence hole. Mating occurs when a newly emerged female flies through a territory.

The burrows angle into the soil for a distance of .3 to 1.2 meters ending in a number of branches and cells. Each branch may terminate in 2-3 loosely grouped cells. Burrowing entrances are left open during provisioning and may not be closed until the job is complete.

Depending upon their size, 1-4 adult cicadas are provisioned per cell. They are usually paralyzed by a single sting in the membrane at the base of the front leg. Eggs are laid on the last cicada in a cell. As many as four females may provision a single nest simultaneously, although only one of them make the initial excavation.

## Legislation to be topic

Educational meetings concerning the new agricultural "right-to-know" legislation will be held by the Texas Agricultural Extension Service. These meetings are for the benefit of the farm producers.

One meeting will be held on Aug. 15 at 9:30 a.m. in the Friona Community Center and another will be held at the Farwell Community Center at 7:30 that evening.

Texas Legislature passed the Texas Agricultural Hazard Communication Law (right-to-know legislation) in 1987. The purpose of this law is to provide farmers and agricultural workers with important information about pesticides used on Texas crops, the health effects of these pesticides and ways to minimize pesticide exposure to themselves and their families.

The law concerns the following:

- agricultural employers who themselves or through labor agents hire migrant or seasonal workers and whose gross annual payroll for those workers is \$15,000 or more

and who annually use or store 55 gallons or 500 lbs. of any one pesticide (active ingredient).

- agricultural employers who themselves or through labor agents hire permanent agricultural workers whose gross annual payroll is \$50,000 or more and who annually use or store 55 gallons or 500 lbs. of any pesticide.

- agricultural workers who plant, cultivate, harvest, or handle an agricultural or horticultural commodity in its unmanufactured state or who handle a chemical covered by the law.

- entities which normally store pesticides in an amount in excess of 55 gallons or 500 lbs. are subject to the Emergency Reporting Requirement.

The law requires agricultural employers to be responsible for the following:

- provide workers with relevant crop sheets and ensure that they are read aloud to workers at least once each work season.

- inform workers about relevant pesticide re-entry intervals,

- maintain Workplace Chem-

ical Lists and Material Safety Data Sheets and make these available to workers or their representative upon request,

- provide other basic health and safety information, approved by TDA, to their workers on the first payday of each work season,

- provide emergency information to workers, local fire chiefs, medical personnel and designated farmworkers representatives upon request.

The emergency reporting requirement applies to persons or entities which normally store more than 55 gallons or 500 lbs. of pesticides at a location within one-quarter mile of a residential area. Those covered by this clause are required to notify their local fire chief of the name and phone number of a responsible person who can be contacted. Upon request by the fire chief, one must provide copies of the Workplace Chemical Lists and the Material Safety Date Sheets and allow inspection of the storage area.

Penalties for noncompliance will be enforced by the Texas Department of Agriculture and penalties will vary depending on the nature of the violation and may include administrative fines of up to \$500, civil penalties of up to \$5,000 and criminal penalties of up to \$25,000 per violation.

## Area cotton is in bloom

Parmer County Agricultural Extension Service Agent-Entomologist Mike Blanton reports that the cotton in our area is in bloom, and that some small bolls are visible in some of the larger cotton. The cotton is coming extremely well.

Cotton should be treated for aphids when there are an average of 25 aphids per leaf. Yield losses may occur if it is not treated.

He reports that area corn is doing well, but producers should be aware that catches of southwestern corn borer moths have increased dramatically. He predicts that moth emergence will be great-

est the first two weeks of July.

Spider mite populations are also on the rise. If corn must be treated for corn borer and spider mites, he suggests adding dimethoate.

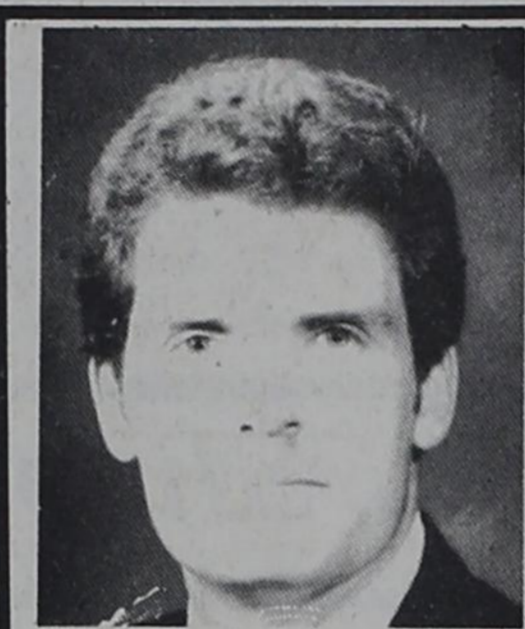

It is not the intent of the Cooperative in this filing to change (either by increase or by decrease) the rates currently being charged to Texas members. However, this filing does reflect changes in rates authorized in the Cooperative's local exchange tariff that is currently on file with the Public Utility Commission of Texas. Also, if the Commission accepts the proposed filing, the Commission will no longer regulate monthly charges for extension wiring and certain equipment leases.

The proposed monthly access line rate for Private Pay Telephone Service is \$17.50 in the East Glenrio, Farwell and Pleasant Hill exchanges and \$16.50 in the Bellview exchange. The Cooperative is including in its tariff service connection charges that have been charged since 1983 to its Texas members. Through this filing, the Cooperative is also revising its tariff to reflect the elimination of monthly charges for extension wiring and the sale to customers of telephones and certain other equipment previously leased from the Cooperative.

The proposed changes will not cause the Cooperative's revenues to increase.
