

## What's your feeling?

The classified page is one of the best-read parts of a newspaper, whether it be weekly or daily.

Most items involve folks seeking something or selling something. And most of the classifieds in the Tribune are from folks in the Texico -Farwell area. But some come in the mail from national companies.

We try to only run classifieds that seem legitimate. There are some we get - with good checks - that we don't run; the checks are thrown away. For example, if they promise you \$500 a week for licking stamps - well, that doesn't cut it, as far as I'm concerned.

Some classifieds that come from national companies offer lists of products or jobs or whatever. If someone wants to buy a list of jobs available in the United States, well, I guess that's okay. But I got a request to run a classified ad last week that was a first for me. Frankly, it's probably legitimate - and legal for me to run (I checked with the state press association). But I felt there were ethical or moral questions involved. So what I have decided to do is get your views. # Grigsby suggests **budget cutbacks**

The Farwell School Board Monday accepted the resignation of board member Vick Christian.

Grigsby received no pay raise this year though he was entitled to one through the state. This was his own decision.

Also, as part of the original contract Grigsby signed when becoming Farwell superintendent, the board agreed to give him a \$300 a month car allowance. Recently, in order to save money, the board bought him a car and cancelled the allowance.

- Accepted the 5 cent per meal increase in school lunch prices suggested by cafeteria director Linda Moss. Milk prices will increase from 15 cents per carton to 20 cents per carton for extra milk.

Mrs. Moss cited the increase in food prices, and the decreased availability of surplus commodities as the reason for the increase in lunch prices.

Grigsby gave each board member this list and the projected dollar savings if each item were eliminated. The board will decide where the cuts will be made.

> The community they served, though, was decidedly rural. "Every kid there came off a ranch," he said.

> Some parts of the traditional curriculum had little relevance to the children whose parents chose to live the ranching life far from the city. For instance, "Bicycle safety, which is something that we normally teach at the elementary level was almost a joke, because most of these kids rode horses instead of bikes. What we needed was a book on how to saddle or brand a horse."

The unique school system was one of a handful of nontraditional schools in New Mexico. The entire school

had 3 teachers - one for kindergarten - second grade; one for grades 3- 5, and one for grades 6 - 8. They also had a bus driver and a maintenance person.

"One of the key reasons I applied for this job as the principal at Texico Elementary was that our daughter Lorissa will be entering 9th grade this year. If we had stayed in Peñasco she would have gone to high school in Artesia. She would have had to leave at 7 each morning, and return at 4 p.m. She would have spent at least 2 hours a day on the bus." Participation in after school activities would have been nearly impossible.

On his first day on the job, Pate had very favorable impressions of Texico Elementary. Even before he had met all of the staff members, he said: "Just looking around you can see that this is a good solid school."

He noted the cleanliness and orderliness of the building. And he noted that there was evidence that several teachers were using a variety of materials in their lessons.

"You can tell just by looking around the school that the teachers had input on the software and materials in the classrooms. That's a sign that this is a progressive school system. When the teachers have input, things tend to be more open and honest," he said.

1989 Property Tax Rates in \_\_\_\_\_\_ Farwell ISD

This notice concerns 1989 property tax rates for <u>Farwell ISD</u>. It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's *effective* tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's *rollback* tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

## Farwell landfill burning to end this month

"We have to stop burning at the landfill by Aug. 30," water department Supt. Dee Hammit told the Farwell City Council Tuesday.

He indicated there may be a lapse of a few months before state officials begin levying fines on individuals who burn trash behind their homes, but the city will definitely have to stop burning trash at the landfill by Aug. 30.

Mayor Chris Gikas said he had talked to the mayor of Hereford at a meeting of the Panhandle Mayors Conference. "We are all faced with the same problems," he said.

Hereford will have to spend more than \$50,000 to upgrade its incinerator to meet new federal guidelines. Gikas suggested that Hereford and Farwell might work out an agreement so that Farwell could use Hereford's incinerator for burning tree limbs and grass for a fee.

The Council adopted a bud-

get for fiscal year July 1, 1989 - June 30, 1990 which reflects no drastic changes for the new year. The budget does not include changes due to the cost of a garbage truck or containers, nor does it include the cost of police service because the council does not have final costs of these programs have not been computed.

Wayne Hughes of the Panhandle Regional Planning Commission reported to the council about the enhanced 911 emergency answering service. When a person dials 911, the dispatcher would have the person's telephone number and address on video screens almost immediately. The computer operated system could also be updated to include additional information if the residents requests it.

He reported that in Parmer County Friona Police Chief Niece would answer 911 calls for the entire county.

The council asked Hughes to meet with the Farwell Fire Department and possibly the Bovina Fire Department before they made up their minds about signing a contract with PRPC for the enhanced 911 emergency system.

Hughes indicated that he would meet with interested parties when it could be scheduled. He added: "I understand fully that your existing 911 system already works." He indicated that the enhanced system through PRPC would cost less in the long run because part of the funding for it comes from the state of Texas, and it would give emergency responders more information than the current system does.

Joe and Cara Castillo requested a variance to tear down an old house and install a 14' x 70' mobile home on property located at 502 Seventh St., Farwell. The council directed them to get the permission of the residents who live in the area.

The council granted building permits to Wesley Davis to build a storage building at 308 8th St., and to Billie Foster to build a storage shed at 405 5th.

The council voted to send Gikas to a mayor's conference in Austin in September. They also voted to send the city clerk Cynthia Thigpen to an insurance workshop in Lubbock on Aug. 17. and to a workshop on retirement in Austin

## Where did all the kimonos go?

(Continued from last week)

And Mary Lou adds two last traffic tidbits: one is that stop signs are the same red and white that U.S. drivers see, but the Okinawan signs are shaped like an upside - down triangle. The other is that since distance is measured in kilometers rather than miles, the shortened form "klicks" is used in the same way that Americans say "miles." For example, on narrow roads, a car might travel approximately 63 klicks per hour instead of approximately 38 miles per hour.

When the family was not actively sightseeing, they spent their time visiting, watching television, and shopping.

Shopping on the island can be both Usual and unusual. Armed services personnel may purchase items at any of the commissaries or PX's located on the five military installations. And, of course, each base contains at least one convenience store, called a shopette. For anyone who wishes, there are plenty of small Okinawan stores, though Mary Lou found that items in them are guite expensive. Okinawa even boasts a mall, which is really more like a

closed off block than the giant complexes in many American cities. Though most stores are owned by Nationals, to Mary Lou's surprise, a good number are owned by immigrants from India.

Merchandise, particularly clothing, is usually exactly like that found back home. Of course, there is the occasional kimono shop and the like to remind one she's not in Clovis, New Mexico or Lubbock, Texas. Mary Lou tells of one such establishment where "ready made" kimonos were located near the front. A raised section at the rear of the shop displayed elaborately embroidered fabrics, in case the customer preferred a costlier custom made garment. The floor of the raised area was covered by woven matting and patrons were expected to remove their shoes before setting foot there. In fact, Mrs. Zinck remembers such areas in a number of stores. She says that any floor covering is the signal to take off one's shoes, then replace them when leaving that special part of the store.

One other aspect of Okinawan shopping was the music playing in every single store Mary Lou entered. It was always American, and always the most current hits. The difference? . Although sometimes in English, the lyrics might just as easily be Japanese.

Exactly how does a person pay for his selections in Okinawa? What currency is customarily used? The question had never really occurred to Mary Lou until her trip. She discovered that a few shops will accept American dollars, and that some will take VISA or Mastercard. But she laughingly explains that Carl Malden's TV commercial for American Express ( "Don't leave home without it.") is way off base there, for , to her knowledge, only one place of business, a photo developing shop, accepts that particular credit card. The usual form of currency is the Japanese yen, and each day before the family outing Michael, Mary Lou's son, stopped by the base bank to exchange American dollars for yen. Possibly the most challenging part of shopping was trying to keep up with the buying power of the American dollar on any given day. Since the rate of exchange varies each day according to the international market, one American dollar may purchase more or less than it did the day before. At the time of Mary Lou's arrival, the U.S. dollar was worth 138 Japanese yen. At that particular rate, 500 yen equalled \$3.60 in American money. During Mrs. Zinck's visit, the rate of exchange hit a high of 146 yen per dollar. Mary Lou had no idea what style of dress to expect of island residents, but discovered that the Nationals' clothing is generally casual, and much like their American counterparts'. she specifically points out that Okinawan girls



wear the same mini skirts and brief tops that one can see almost anywhere in the U.S. Likewise, businessmen are seen in dressy slacks, shirts, and ties or suits. Not once during her visit did she see an island woman in a kimono.



## **'Cicada killer' arrives here**

A very large wasp, the "cicada killer" is making its annual summer appearance on the South Plains, says Mike D.

Blanton, Parmer and Bailey County Entomologist. This wasp is the largest in our area, being about 1 1/2 " in length.

This wasp is much more interested in stinging cicadas than people. They can often be seen dragging or flying and carrying paralyzed cicadas back to their nests.

At suitable nesting sites, the wasps excavate a tunnel into the soil at an angle for a distance of one to three feet. The main tunnel ends in a number of branches and cells. The burrows may be dug during the day or night. The excavation will often result in a large mound of dirt. The burrow entrances are left open during provisioning of the nest and may never be closed except when the wasps' entire job is completed.

Depending upon their size, from 1 - 4 cicadas are provisioned in each underground cell. The female lays an egg on the last cicada she places in a cell. As many as four females may provision a single nest simultaneously although only one of them made the initial excavation.

The wasp larva which hatches from the egg has a cicada meal waiting. After consuming the cicadas provisioned in a cell, the wasp larva remains underground until the following July when the adult wasp emerges again to repeat the cycle.

Cicada killers are not aggressive and seldom attack humans. The males are not capable of stinging. Only females can sting.

Cicada killers are considered beneficial insects because they prey on cicadas. However, they can be present in sufficient numbers as to be a nuisance. For control you may use one of the outdoor aerosol sprays containing pyrethrum or dust the nest entrance with sevin. Clovis.
