



LIVE CATTLE: Rumors and fears broke the market oday. The fear of terrorism and the chance that the elecion is so close now that we may not have a President until davs or weeks later? 

Segovia had a QB sack for minus 2 yards. A pass to Edwards gained 10 and a 1st down at the Mustang 5. Mitchell scored from there at 10:55. The Logan McFarland kick gave Farwell a 7-6 lead.

Heinzman returned the kick to the Mustang 27. McFarland had a QB sack for a 5-yard loss. Casas then threw a great pass to Segovia for 19 yard, and a tackle by Colby Norton prevented this from being a long gainer.

Casas kept for 10. Jeff Torbert ran for 14, tripped up by Tabb. Casas hit Alfie Espinoza with a 17-yard TD pass at 6:40. A 2-point pass to Ortiz put Bovina up 14-7.

Logan Clemmer then caused a QB fumble, picked up by Vasquez for a 35-yard TD and a 26-14 lead at 3:15.



Bovina's Ortiz had a big kick return. Clemmer had 2 good tackles for Farwell.
























Texico blanks Jal to win district championship

The Texico Wolverines (9-0, 3-0) defeated the Jal Panthers (6-3, 2-1) 35-0 to become the district champions for the third season in a row. The Wolverines have won 21 straight games dating back to last year and have outscored their opponents 392-54 this season.

Texico plays in the state quarter-final on Saturday at home at 2 p.m. mt vs. Capitan.

The game was tight in the first half as the offense struggled to get going after two TDs were called back because of penalties, and a fumble halted another drive. At halftime the score was 7-0.

The second half started off similar to the first as Jal held the Wolverines to 3 and out on their first series. But, the second series was a different story. Texico took only two plays to go 72 yards for the score and the offense had arrived. The Wolverines scored on all their remaining possessions.

The defense played well and just got stronger as the night went along. They held Jal to 2 first downs in the second half and 7 for the game. They were able to stop the Panthers only scoring threat just before halftime when a 50-yard pass put them at the 17 yard line. But, that was as close as they got after a run went no where and three pass attempts fell incomplete.

Jal received the opening kickoff and started on its 35. The Texico defense forced punt after a tackle for a 1yard loss by Chris Phillips and a stop by Braden Vaughan that pushed them back another 5 yards. Phillips received the punt on the 30 and raced through the crowd all the way into the end zone but a penalty brought the ball back to the Texico 21.

The Wolverines moved the ball to the Jal 14, highlighted by a Vaughan to Tony Clements pass on 3rd and 10 that went for 17 yards and several big runs by Johnny Serrano. On 4th and 4 at the 14, Serrano ran into the end zone but another penalty called it back.

On 4th and 14, Texico was stopped. Jal completed a 40-yard pass and got a 1st down before good plays by Aaron Vaughan and Logan Brown forced them to punt.

Blake Smith broke loose for 28 and another 11 before a Wolverine fumble bounced into the arms of a Panther who raced down field. An illegal block brought the ball back to the Texico 42. Jal went nowhere as Brown made a tackle for a 1-yard loss and Aaron Vaughan read the pass play and tackled the receiver for a 10-yard loss. Another punt gave the ball back to the Wolverines with 9 seconds to go in the 1st quarter.

Texico punted after getting one 1st down. The Panthers got two 1st downs before they fumbled on the


Lazbuddie Junior High lost to Happy, 54-27.


