

Last year's expenses totalled \$2,877.78. The net profit for BTD was \$67.17.

Pomper expressed satisfaction with the small net profit. He noted that it's the committee's goal not to end up in the "red" but be as close to zero as possible.

The BTD committee keeps a bank account of \$2,000. With interest and other proceeds, the account as of April 1 was \$2,253.02.



### **Texico FFA teams compete at state**

The Texico FFA Meats Judging team placed 3rd out of 27 teams at the State FFA judging competitions in Las Cruces March 31- April 3.

It was one of five judging teams from the Texico FFA Chapter to participated in the state competition.

The Meats Judging team included Derek Dictson, Dara Jenkins, Chad Cochran and Joni Pate. It scored 96.72% of its questions and judging criteria correctly. This team had to take a written test relating to meat selection, storage, cookery, nutrition and safety. They also had to judge different cuts of meat and meet many other specifications.

The Land Judging team made up of Dara Jenkins, John Stephens, Michael Coffman and Chad Cochran placed seventh in the state with 90.32% of its contest requirements correctly met. This team had to analyze four pits on land class factors and land treatments.

The Horse Judging team consisted of Brett Littlejohn, Blake Littlejohn, and Clay Lewis. The team had to judge three classes of quarter horses, mares, and yearlings. They also had to complete two sets of oral examination with the judges. The team placed thirtieth in the contest with 86.88%.

The Ag Mechanics team included Kip Taylor, Richie Pierce,

Members are asked to advise the business office of any recent and/or future address changes in order that the cooperative can process any capital credit refunds on a timely ba-





The death of Jesus of Nazareth was unlike any other death. Even the words of this dying man were extraordinary.

After Jesus was nailed to the cross and the cross was placed in an upright position, He prayed for pardon and forgiveness for His enemies. A Roman soldier remarked, "Usually we are cursed to death in hell."

A conversation took place between Jesus on the center cross and the thief who was crucified on His right. The thief apparently recognized in Jesus more than criminal traits as he asked to be remembered by Him in His kingdom. The thief received the answer, "Today you shall be with Me in paradise."

Great concern was expressed about the darkness which prevailed for three hours, from noon to three in the afternoon.
