The hearing, open to the public, will be held at 7:30 p.m. in the school cafeteria.



The Farwell City Council was surprised Tuesday when it received a letter from the man it had hired last month as police chief that he has changed his mind and decided he didn't want the job.

After an extensive search, the city council had picked James R. Colwell, of Amarillo, to be the city's first police chief in about a decade. Colwell has had extensive law enforcement experience and had served as police chief in rving, Texas.

Colwell's letter read:

FARWELL, TEXAS

"Dear Mayor Gikas,

"I regret to inform you that I will not be your Chief of Police. I have spent some time arriving at this decision. I apologize for the time it has taken. I have weighed the needs of my

Once again, I truly appreciate all the help so many folks have given in obtaining background info about the deceased servicemen.

In writing the past several months about the planned memorial to Parmer County servicemen who died in wartime, it brought back memories of the first investigative reporting I ever did back in 1970.

It involved a serviceman who died in wartime. The situation affected me personally since it had been less than a year since I had been in the Army. Here's what happened:

I was living and working in Michigan City, Ind., a city the size of Clovis and about 4 miles from a state line -Michigan.

The boy involved was from New Buffalo, Mich., which was on the state line just like Farwell is. The boy had lived about 100 yards inside Michigan.

The boy was killed in combat in Vietnam.

A few days before he died, the boy had written a letter back to his folks in New Buffalo, asking that, if he were killed, he could be buried in a special circle in the Michigan City cemetery devoted to servicemen who had died in wartime.

There was room in this special area for more bodies. But the circle had been set up by the local American Legion post - and its by-laws said that only Indiana servicemen who died in wartime could be buried there.

So the local American Legion post refused to honor the dead boy's last request, even though he was a graduate of the Michigan City, Ind., high school.

There was a hullabaloo Texico

I felt compelled to write this letter to you following our phone conversation last Friday. As you remember, I called to ask you where you had gotten the \$43,000 figure as the amount give to the Friona Fire Department from Parmer County last year. I don't believe it is fair, either to the City of Friona or to your readers to simply say, "Gee, I'm sorry, did I print the wrong figure"? Since you didn't ask me what the correct figure might possibly be, I thought this letter might straighten out some facts.

The City of Friona Fire Department received \$26,000 from the County last year. This was a one time payment to help purchase a fire truck. A \$22,000 down payment was made on this truck and the City is now obligated to pay the remaining \$23,620 that is still due. This year we will again receive our usual \$4,000 allowance.

Since our fiscal year began on October 1, 1992, \$50,689 has been spent to operate the Friona Fire Department. Since 84% of the total fire calls are outside the city limits, it is only fair that the County should pay its share of the expenses incurred to fight these fires. It has been said that, since we have to have a fire department anyway, that it really doesn't cost that much more to fight the County fires. The fact is that it takes a lot less money to fight a fire in town than it does a three day burr fire, ten miles in the country. The fact is that we have three trucks that are solely used for country fires. We have no use for tanker trucks in town; we have fire plugs. We continue to pay for the upkeep, insurance and general operation of these vehicles. The average age of these trucks is 26 years. They need to be replaced in the near future. Using our meager \$4,000 a year from the county, it would be, quite frankly, a very long time before there would be enough money in the "kitty" to replace even one truck.

With our present situation, the citizens of Friona are virtually paying for a fire department for the country residents. Since these residents pay their taxes to the county, not this city, it is the moral and legal responsibility of the county to provide their fire protection, not this city.


The city council has offered to meet with the commissioners to discuss this problem, but have yet to receive a definite answer. This is not a new issue; nor is it an issue confined primarily to Parmer County. The City of Friona, along with numerous other cities in the Panhandle have made repeated attempts over the years to deal with this issue in Commissioner Court.

The city council, along with myself, have a responsibility to protect the interest of the citizens of Friona. That is our primary goal in this matter. It is our hope that the County Commissioners will remember that they also were elected to serve the interest of these same citizens.

Editor's note: According to statistics from the Parmer County Treasurer's office, Friona's fire and ambulance services received \$39,000 last year from the county commissioners.



Colwell had been the council's first choice for the Farwell post. Now the council instructed Mayor Chris Gikas to offer the job to it second choice, a Littlefield area police officer. If he turns it down, the job will be offered to the council's third choice, a Plainview police officer.

In other business, the council:

- Voted to ask Texico Mayor Doyal LaRue, and Texico city councilmen if they so choose, to attend its May 10 meeting to discuss the possibility of Texico using the Farwell animal pound.

The Farwell city council meeting is being held May 10 because Gikas will be gone on vacation later in the month.

Farwell officials had checked into a statement made earlier this year that Texico had used the Farwell pound in the past but didn't pay for that privilege. It turned out that Farwell employees had volunteered some work toward picking up animals - and that Texico didn't owe any money to Farwell.

- Voted 4-1 (Royce Bethel opposed) to increase the fee for animal pound retrieval from \$7 plus incurred expenses to \$15 plus incurred expenses.

Water Supt. Dee Hammit said the fee needed to be raised because too many folks were paying the \$7, taking the dog home and letting him run loose again.

In cases where a citation is issued, if the animal owner is known, Muncipal Judge Willie Dannheim has been issuing fines of \$10 to \$15. Gikas asked Dannheim to double those fines if a second citation is issued the same animal owner, and double again for a 3rd citation.

About 10 animals are picked up a month in Farwell.

- Approved a building permit for the Parmer County Sheriff's Office for a 12x20 storage building adjacent to the county jail.

 Heard a complaint about an abandoned house on First Street across from the city barns. Taxes are being paid on the building so nothing was done.

- Heard Mike Pomper, Border Town Days chairman, report that because BTD had a small surplus last year, the committee will pay for the whole cost of the 4 portable toilets this year. The city has picked up the tab the past few years.

Pomper also asked if the city would repair the basketball hoops on the courts at the city park. The council voted 4-1 (James Chadwick opposed) to repair them. The court was donated by ESA Sorority to the city two years ago.

Pomper also will work with Hammit to put new flag holders higher up on the gazebo and get lighting for inside the gazebo.

- Received a request from Paula Wilson, Friona city manager, that Farwell pay a share of the 911 dispatcher operated for Parmer County through the Friona police department.

She noted that the county contributes \$5,000 toward the emergency service and Bovina gives \$2,400. She presented statistics showing 20 calls a month were coming from Farwell.

The council told Ms. Wilson that it would seek more information before making a decision.

Later in the meeting, after Ms. Wilson had left, Gikas and councilman Pat Howard both expressed the view that the 911 service should have stayed with the Parmer County sheriff's office instead of being allocated to the Friona police department.

a limited summer school program.

The program will be directed toward math and language arts - such as reading, writing and English. There is no fee.

The program is basically for students who have been having trouble with these subjects during the regular school year.

Summer school will be held three days a week, but those days haven't been decided on yet. Quite a few students are expected.

Transportation will not be provided.

In other business, the board:

- Accepted the resignations of teachers Judy Howard, **Rex Cumpton and Charles** Turner.

- Approved six students transferring in next fall - 2 from the Muleshote district and 4 from the Bovina district. No students are transferring out.

- Ratified textbook selections.

- Heard a report from School Supt. Richard Boothby, noting that Farwell Schools have \$138,233 in the Parmer **County School Improvement** Fund. Boothby plans to get approval from the Parmer **County Commissioners to use** this money toward the building program.

 Rejected all bids from general contractors for the building program. This clears

the way to use a construction manager. The board will meet with John Cole, who they hired as a construction manager on the building project, April 20 at a special meeting.



 Americans spend an estimated \$500 million each year on allergy treatments. Although there is no cure, there are a number of ways to fight allergies.

 Over-the-counter medications and prescription medicines are the most common forms of treatment. Immunotherapy, or injection therapy, is both expensive and time-consuming, so it is generally used only in severe or chronic situations.

 Avoidance, in principle, is the simplest therapy. Once the allergen has been identified, the sufferer can try to avoid it.



Letter To The Editor

Dear Editor:

On Saturday, May 1, voters have the opportunity to help solve the problems plaguing Texas public schools by voting "yes" on three proposed state constitutional amendments. As a school superintendent, I support all three amendments, but I am particularly concerned about the passage of **Proposition 2.**

All three amendments are critical public education issues. Proposition 1, authorizing redistribution of ad valorem taxes, is the first step toward solving the school finance equity crisis. Proposition 3, authorizing \$750 million in state bonds, will help fund desperately needed facilities to accommodate the growing number of Texas school children. But Proposition 2, which prohibits future unfunded state mandates, is more than just an education issue; it's an issue of fairness.

As a local school superintendent and fellow property taxpayer, I have experienced firsthand the financial effect of unfunded state mandates on our school district and property tax rates. For years, the Legislature has handed down rules and regulations to Texas schools without providing the necessary level of funding to pay for them. As a result, school superintendents, like me, have been forced to turn to you, the local taxpayer, to foot the public education bill by continually increasing your property taxes.

Last school year alone, Texas districts spent at least \$1.5 billion by only eight of the hundreds of state requirements handed down by lawmakers, many of which were paid for by increases in your property tax. It's time to put a stop to this buck-passing. Texans cannot allow state lawmakers to continue passing mandates they believe are important enough to require but not important enough to fund.

Proposition 2 puts the burden of funding back where it belongs, on the Legislature in Austin. It will help ease the local tax burden by making the state pick up its fair share of the bill for public education.

Proposition 2 is also a step toward future education equalization and only affects mandates enacted after Dec. 31, 1993. It is not retroactive, and mandates such as class size limits and the teacher salary schedule will not be affected.

Proposition 2 will help ensure that the basic needs of all Texas school children are adequately funded. School districts will still be required to comply with federal health and safety requirements, such as those concerning special education and environmental hazards.

Proposition 2 is your opportunity to stop the Legislature from passing the tax buck back to the local property taxpayers and to send lawmakers a message: Texans will not perpetuate inadequate school funding and increasing property taxes. We will not allow the state responsibility of finding funds to help pay for them.

Don't misunderstand me. I encourage our lawmakers

The students who made a real effort to live with their handicap received a party. All the students agreed that


