

# **Here's how Parmer County** invests its funds

Recent news media reports have focused on financial problems in Orange County, Calif. due to their investment policies. And this has caused counties throughout Texas to review their own financial investments.

Parmer County Treasurer Anne Norton says Parmer County is in solid financial shape and the future of the county investments are in stable environments.

"Currently, the county investments are in interest bearing NOW accounts and Certificates of Deposit at Friona State Bank," Mrs. Norton reported. "We are in a two year banking contract with them and the accounts are earning competitive interest rates. Our contract is up with them as of April 1, 1995 and bids will be taken as of Feb. 27 for a new banking contract that will commence as of April 1, 1995 and end March 31, 1997."

The county's investments are not anything to be taken lightly. The monies earned are the lifeblood to the operating of all county offices. All decisions for investment are handled by the Parmer County Commissioners, the County Judge and the County Treasurer. The Treasurer is deemed the investment officer, but makes no independent investment decisions. All options are laid out before, discussed and approved by the Commissioners Court.

"We view the investment decisions based on the safety and liquidity of the investment," Mrs. Norton said, "we try our best to invest the taxpayers' money wisely and to increase revenues for operating the county."

One recent example of keeping the taxpayers' interests in mind was the move to pull all investments from the state backed TexPool. In January, the decision was made to withdraw Parmer County funds from this due to some bad publicity that the organization was receiving.

TexPool is an investment service that was set up as a result of the 1989 Investment Act passed by the Texas State Legislature. It operates under the Texas Treasury Safekeeping Trust Company and is run by the Office of the State Treasurer. It is a service for local governments including school, water, hospital and appraisal districts, counties, cities and various municipal urban districts. Its function is to consolidate all the money it receives from these entities and invest them as a whole group in order to gain higher interest rates. It is the only pool operated by the state for local government purposes. "It was a sound investment group for Parmer County and no one has ever lost any money with it, but due to some long term investment problems that it ran into, we decided to withdraw the county money from it and invest it into a more local base. The state of Texas backs every dollar that is in TexPool and guarantees your money, but we still thought it better to stay out for awhile," Norton stated.

# It will cost you

The Tribune received a news release from the U.S. Postal Service recently that I wanted to share with you: \*\*\*

"The U.S. Postal Service is hiring for full time and part time employment. Hourly salaries start at \$25 an hour. For employment information, call 555 1212"

Have you seen advertisements like this one in your local newspaper?

Postal inspectors warn that if you should call these promoters for "employment information," you are probably going to get clipped.

In most instances, you find out that you are going to have to pay about \$30 to receive information of dubious value. They may lead you to think

you are talking to someone from the U.S. Postal Service, but no postal jobs will be offered.

Frequently, the con artists promoting this service offer to provide you with training which is supposed to help you pass a required entrance exam. Further, graduates are often promised placement in postal service jobs upon successful completion of the training. Naturally, this training will cost you money for tuition and books.

Postal inspectors say that other promoters offer job opportunities that guarantee that you will be placed on a register with the U.S. Postal Service from which new hires will be selected. Inspectors say beware of any "opportunity" to get postal job information which is going to cost you money.

Here at the Tribune, we receive classified ads each year from agencies outside our area.

\*\*\*

Other counties within the state have not fared as well as Parmer County with their investment decisions. Tom Green County and Taylor County are examples of counties that have had millions of dollars lost because of long term investments

on market sensitive investments or "on book" losses in investment portfolios.

We discard the ones that seem to be scams. I've torn up a lot of good checks over the years that come with those potential ads.

But it's very hard for me to believe that you can earn \$1,000 an hour stuffing envelopes. If that's true, sign me up.

I realize that this policy is very different from some other publications that run all sorts of what I consider scams. That's the way it is.

But I've always had a problem with ads that offer "information." They are legitimate in that they do as they say offer information. The catch (Continued on Page 2)



Feb. 14 was a day to remember. We began it with much TLC by having Hug Day.


Staff got enjoyment watching residents getting hugs from staff, visitors and other residents. Several residents really worked hard trying to get the most hugs.

# **Bill opposed**

Eastern New Mexico Rural Telephone officials announced their opposition to New Mexico House Bill 934, which proposes changes such as voting by proxy or by mail, and restricting members from voting for directors in districts other than the specific district where the members live.

The legislation applies only to cooperatives with over 5,000 members - and ENMR is the only co-op in New Mexico it would apply to.

ENMR officials said "there is particular concern that these changes could significantly impact the vested ownership rights of the members without the opportunity of informed consent. It was the members themselves who previously disallowed proxy voting for this very reason. No counsel from ENMR's board of directors, management or staff was sought in advance of the introduction of the proposed legislation.

"No reason or justification is cited for the proposed changes. The board of directors, management and staff of ENMR are firmly opposed to the change. They are asking all members to pleace contest their elected representatives to voice their opinion."

On Feb. 16, firemen were called at 5:24 p.m. 6 miles east on Hwy. 60 but no fire was found.


On Feb. 18, a grass fire was fought at 504 7th St. at 2:25 p.m.
