Texico council looks into annexations

The Texico City Council on Tuesday decided to have a public meeting to discuss possible annexations at its southern boundaries.

The meeting will be held on Sept. 3 at 6:30 p.m. at the Texico Community Center.

The council has received a \$70,000 state grant to chip seal parts of Elva Avenue and Avenue F -- the southern boundary of the city. Avenue F will be chip sealed from South College to the State Line Road.

Councilman Rick Queener suggested that since the project will be beneficial for county folks living on the southern edge of Avenue F, they might consider coming into the city.

It also was noted that state funds were not given for curbs and gutters for the street project.

In other business, the council:

-- Moved ahead with plans to build new city hall and city shop buildings. Lease-purchase agreements are being checked into. Mayor Marie Christian said they won't need to seek bids.

-- Heard Marie Esparza criticize the city ordinance dealing with variances.

At the last meeting, the council had approved a variance for Bill Autrey to put in a trailer at 612 Hamlin. Six letters were

Bawdy house ordinance rules may be revised!!!

On Saturday, the Texico City Council will begin a lengthy series of workshops to update its entire city ordinance.

The public is invited to all these sessions. The first meeting will start at 8 a.m. mt at the Texico Community Center.

On the agenda are Ordinances 1 through 60 -- some going back as far as 1909. Each councilman, and the city attorney, were given responsibility for studying 10 ordinances before the meeting and give recommendations for changes.

Drought takes toll on Parmer County

The drought has taken a serious toll in Parmer County.

Parmer County Extension Agent Cody Hill went over the statistics for 1998 with the Tribune this week, and the picture he painted wasn't very pretty.

After receiving information from the local Farm Service Agency, here's how Hill sums up this year's farming picture (with all statistics being estimates):

CORN

Hill estimates a 20 percent decrease in the crop from a normal year.

Thus, a farmer who made 10,000 pounds last year, probably will have around 8,000 this year.

About 92,200 acres were planted, up about 1,000 from 1997. All are irrigated acres

Virtually all the corn is coming up because it's been irrigated. But due to higher water costs, lower corn prices and a lower yield, this won't bring a smile to a farmer's face.

COTTON

In a normal year, the average yield is about 1 1/2 bales per acre.

This is just an average, because some farmers will get about 3 bales per acre.

This year, farmers are looking at between 1 and 1 1/2 bales per acre, but Hill is optimistic and hopes the figure will be closer to the latter.

Parmer County has 78,000 irrigated acres in cotton, up from 68,000 in 1997. The county also has 1,400 acres in non-irrigated cotton this year.

MIL0

County farmers planted about 23,000 acres of milo (half was irrigated) this year, down from 26,000 last year.

Hill said less milo was planted because farmers felt they could get better prices with corn.

He expects about 15,000 acres to be harvested, and that the milo will be "small size."

GRAIN SORGHUM

Due to the drought, Hill estimates the yield will be about 25 to 30 percent less than normal.

VEGETABLES

Hill expects the yield to be down about 20 percent from 1997.

LIVESTOCK

The cattle herd in Parmer County is down about 30 percent, according to FSA estimates, said Hill.

Overall, Hill knows that some farmers won't be able to overcome the drought's effects to stay in business.

But he points out that some farmers have other businesses, like running cattle (although cattle prices are not great now), and perhaps these will cushion the blow.

Some farmers will have to reduce the size of their operations.

County taxes going up

The Parmer County Commissioners on Monday approved a budget proposal that would increase total tax revenues by 8.01 percent.

The proposed tax rate is for .3919 cents per \$100 assessed valuation. This includes the general fund, .3005 cents, and the farm to market fund, .0914 cents.

The current rate is .3732 cents per \$100 assessed valuation. This includes the general fund, .2862 cents, and the farm to market fund, .0870 cents.

A public hearing on the proposal to increase the tax rate is planned for 10 a.m. in the county courthouse courtroom on Sept. 2.

Then, the commissioners will approve the budget and formally set the tax rate at 11 a.m. on Sept. 14.

The proposed tax hike is under the "rollback" limits. If a tax hike in Texas is above the rollback limits, residents can then vote on whether to roll it back.

The proposed budget calls for 3 percent pay raises for county employees.

In other business, the commissioners:

-- Will seek bids on a new electronic polling machine for the county clerk's office.

Special ballot will be used for elections, then put into this machine for quicker tally results.

-- Discussed a new mutual assistance agreement between Parmer County and the city of Friona. This is for insurance purposes to help lower the city's "key rate."

sent out to nearby property owners -- two were returned in favor of the variance, one was opposed (Mrs. Esparza) and three were not returned.

According to the city ordinance, if a letter is not returned, that means the property owner favors the variance. Thus, the majority supported the ordinance.

Mrs. Esparza said she owns two houses in the immediate area.

Mrs. Esparza, and anyone else, was invited to attend the council workshop that will deal with ordinance changes. The council plans to review all its ordinances, in numerical order. The workshop to deal with the zoning ordinance hasn't been set yet.

-- Again tabled a request by Abel Navarrete, of Clovis, to rezone property to allow for a mobile home park at the southwest corner of Griffin Street and Wheeler Avenue. He wants to have five trailers at the site.

The council wasn't sure that would meet with the fire code and will ask Fire Chief Lewis Cooper to check into it before a decision is made. The council also will inspect the area on Saturday.

-- Will advertise the city's attorney's job, as it does periodically.

-- Gave approval to the request of city marshal Kelley Brophy to hire a 20-hour-a-week clerk.

-- Okayed a grant request to get 41 trees, have them planted, and put in a drip irrigation system for them. The cost to Texico would be \$1,000. Trees will be planted at KKR and Lions Parks.

-- Heard Brophy report that the state is happy with the increased number of traffic citations Texico is handing out, at the DWI roadblocks and saturation patrols. More DWI roadblocks have been approved by the state for Texico.

-- Approved asking Clovis to change the animal confinement agreement they have. Currently, Texico pays \$25 per dog brought to Clovis. Since November, 68 dogs were sent. Texico is proposing that it pay a flat \$2,000 a year fee (80 dogs would be the break-even point for Texico).

2 Friona men indicted

Two Friona men were among five persons indicted by a Washington County grand jury involving a "pig-napping."

Friona High School agricultural science teacher Hollis Dean Harris and Randy Ray Campbell, 46, were indicted for "engaging in organized criminal activity -- theft of swine -- less than 100 swine and less than \$20,000" by a Washington County, Texas, grand jury on Aug. 19.

The case began in February at the Houston Livestock Show swine auction. Cammy Jean Cornelius, 17, of Agua Dulce, Texas, showed a prize winning swine and auctioned it off to the Port City Stockyard in Brenham, the Washington County seat. The swine never made it to the stockyard.

Cornelius then allegedly entered the swine in the San Angelo Stock Show, where it won grand champion honors and it went through another auction.

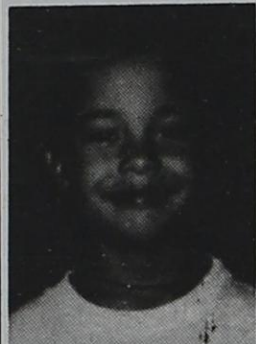

These permits will authorize the expansion and operation of an existing beef cattle feeding operation from a maximum capacity of 29,500 to 50,000 head. This facility is located approximately one and one-half miles south of Farwell, on the east side of State Line Road in Parmer County, Texas. No discharge of pollutants into or adjacent to the waters of the State is authorized by these permits. The facility is located in the drainage area of the Double Mountain Fork Brazos River in Segment No. 1241 of the Brazos River Basin. The proposed facility will also emit the following air contaminants: particulate matter, unburned hydrocarbons, sulfur dioxide, carbon monoxide, nitrogen oxides, and odors. All waste and wastewater will be beneficially used on agricultural land. A person who may be affected may request a hearing.

Vick Christian, of Farwell and Glen Neie, of Texico are the local coordinators. While it is organized through their efforts and Hamlin Methodist, the Backyard Mission organiza-

Backyard Mission was started by a former junior high teacher and coach named Laurie Foster in Lubbock. She began it as a means of ministering to those in need throughout the year instead of the traditional once-a-year mission trip. It currently has a base of over 200 volunteers throughout Lubbock and the surrounding area.

The Farwell/Texico chapter of the mission has done several projects for residents in need since its inception two years ago. The main emphasis is to "keep people warm and dry by doing free home repairs, using volunteer labor and buying materials with donated money. It also gives Christians the opportunity to put their faith into action by serving their neighbors.

Through word of mouth and direct contact, those involved with Backyard Mission identify people (or families) in need and want repairs on their houses, but are unable to provide for the need themselves. Work teams and/or organizations interested in doing a project can also contact the local coordinators and they will meet with them to set a work date and the various different projects that are available. Once a date and location have been set, the organization/work team will purchase the needed materials or can provide the money needed for the project. Then the work can begin on the chosen project with all the volunteer workers in line.

Farmers to receive some tax relief

Deputy Agriculture Secretary Richard Rominger said recently that most U.S. farmers will pay less federal income tax under the Taxpayer Relief Act of 1997. The Act will also make it easier for farm families to transfer the family farm across generations.

The details about the effects of the Act are provided in a new report "The Taxpayer Relief Act of 1997: Provisions for Farmers and Rural Communities." The report is published by USDA's Economic Research Service.

The new law is the tax provision of legislation to balance the Federal budget by 2002. It is expected to generate a net tax reduction of \$95 billion over five years for all taxpayers. Several general and targeted tax relief provisions will significantly reduce Federal taxes for farmers and other rural residents.

"Farmers are very interested in this law, largely because they are more likely than other taxpayers to report capital gains or to owe estate taxes," noted James Monke, an ERS economist and co-author of the report.

The greatest tax saving for farmers comes from the reductions in capital gains taxes. The capital gains provisions are expected to expand agricultural investment and support farmland prices, although tax laws are only one of many factors that determine asset prices.

Tax relief specifically designed for farmers gives them additional flexibility to deal with income fluctuations, including using deferred payment contracts, income averaging and deferring the gain on weather-related livestock sales.
