Poorly handled

I'd like to comment today on those recent allegations of sexual misconduct made by a woman against Dallas Cowboys' stars Erik Williams and Michael Irvin.

It was reported Saturday that the Dallas police had dismissed the case, saying the woman's allegations were false and she could be charged with filing a false re-

What really bothers me about this incident is what I consider the highly UNprofessional conduct of the Dallas police department.

The Dallas police held a press conference to discuss the allegations, leading to all sorts of big Page 1 stories -and all this before any charges were filed.

The police should have worked quietly behind the scenes on their investigation. Instead, they created a media circus through their persistent "leaks" and pronounce-

Let's put it into perspective: It's the policy of the State Line Tribune never to print criminal accusations against a person -- unless police file charges.

But that common sense policy was not adhered to in newspapers throughout the U.S. in this case.

Normally, I would say it was the lowest form of journalism. But in this case, after the police hold a press conference, newspapers have no choice but to report it.

What the police should have done after the allegations were made (or a hoax perpetrated?) was to have NO

comment. Period. After they received calls from inquiring press, they should have had a stock an-

swer: NO comment! Then, if the press wanted to blow it out of proportion,

that's the press's problem. We're having a real problem in this country when specula-

tion funs rampant after any yo-yo opens his or her mouth. Remember the Olympics' bombing? How that poor se-

curity guard took a real beating from the FBI and the news media.

Does it sound similar to the Dallas case? You betcha.

That security guard was never charged -- yet how many times did you see him on TV amid stories of his being investigated? Lots.

I read recently that one TV network already has coughed up \$500,000 to him because of their erroneous reporting.

Good.


We all know that the criminal justice system is highly imperfect. There's nothing that can be done about that. What is, is.

But police and news media throughout the country need to take a second look at how they handle allegations.

There's a very wide abyss between allegations and charges. But when allegations are reported publicly, a highly unprofessional act, they take on the same significance of charges.

And that goes against the grain of our basic American belief in the innocence of the individual until being con-

victed. We need to return to the

Parmer County producers needs 4-10 inches of water

Parmer County producers within the High Plains Underground Water Conservation District No. 1 need 4 to 10 inches of water from precipitation and/or irrigation to bring the 5-foot root zone soil profile to field capacity before spring planting, according to pre-plant soil moisture survey data.

"We found that 10 percent of the Water District service area will need from 2 to 4 inches of moisture to bring the soils to field capacity. About 40 percent of the area will need 4 to 6 inches of moisture, and 45 percent will need 6 to 8 inches of moisture. About 5 percent of the area needs 8 to 10 inches of moisture to refill the soil profile," said Gerald Crenweige, USDA-NRCS soil scientist.

Soil moisture readings are taken by lowering a neutron probe into a permanently-installed aluminum access tube at each of 299 monitoring sites within the 15-county water district service area. Each site is chosen based upon the soil type, the variations in the saturated thickness of the Ogallala Aquifer which indicates potential well yields, and typical farming operations in the area.

Plant available soil moisture varies according to the previous crop produced at the site. Historical data shows that above-average crop yields are more likely when the 5 foot zone soil profile is at or near field capacity at planting.

Rain gauge readings taken at soil moisture sites in Parmer County indicated an average of 13.01 inches of rainfall during

Here are precinct fund totals

With the start of a new year, and with two new Parmer County commissioners on board, the Tribune thought it would be a good idea to let county folks know how much monies are in each precinct's funds.

The funds that each precinct has can be used for any precinct business, such as employee salaries, equipment, machinery, fuel, supplies, etc., explained county treasurer Anne

All funds are maintained by the county treasurer.

Parmer County has four precincts -- Pct. 1, John Tannahill, representing the Friona area; Pct. 2, Tom Ware, the Bovina area; Pct. 3, Jerry Davis, the Farwell area; and Pct. 4, Raymond Lazbuddie, the Lazbuddie area.

Here's a rundown on how much each precinct has, as of

Cash on hand is maintained in the Farm to Market Fund and the Lateral Fund. The Lateral Fund consists of money that comes from the state each October based on the number of road miles in each precinct. Here's a look at the current cash on hand each precinct has:

Pct. 1 (Tannahill) -- \$29,013.21.

Pct. 2 (Ware) -- \$35,867.20.

Pct. 3 -(Davis) - \$49,595.88.

Pct. 4 (McGehee) -- \$32,082.89. In addition to the cash on hand, precincts also have Certificates of Deposit and Tex Pool investments. Tex Pool is a statewide investment group that many governmental entities

are members of, including Parmer County.

The only precinct to have current Certificates of Deposit is Pct. 4 (McGehee). He has two CD's. One is for \$50,000 and is earning 4.54 percent interest. The other is for \$225,000 and is earning 5.11 percent.

Two precincts have Tex Pool funds -- Pct. 1 (Tannahill) and Pct. 2 (Ware). Pct. 1 has \$155,000 in the fund and Pct. 2 has \$175,000 in the fund.

Thus, when you add cash plus CD's plus Tex Pool investments, here's a breakdown on how much each precinct has:

Pct. 1 (Tannahill) -- \$184,013.21.

Pct. 2 (Ware) -- \$210,867.20 Pct. 3 (Davis) -- \$49,595.88.

Pct. 4 (McGehee) -- \$307,082.89

Gas rate increases suprise customers

Area residents have been up in arms over the recent gas rate increases that have gone into effect for gas usage. Texico is serviced by PNM Gas Co. out of Clovis and Farwell is serviced by West Texas Gas, Inc., out of Midland.

The rate increases are in two separate areas - cost of the actual gas, as purchased by the gas companies and the cost of service. The cost of service increase has been caused by the total consumption of natural gas by consumers. This fact has been and continues to be a very sore spot with many natural customers.

The gas companies are somewhat caught in a catch-22 situation when it comes to the cost of the gas. In the past, local gas companies were able to negotiate contracts for gas supply that ranged from 2 to 15 years. These long-term contracts assured gas companies and their customers of a stable cost of gas.

But, the owners of the gas and oil well heads (the source of the gas supply) saw that this was not to their profit advantage. They began to shy away from long term contracts and have now forced gas companies into the situation of short term contracts. These contracts are now committed for only 3-6 months and, in very few instances, a year.

"These short term contracts cause everyone, except the well head suppliers, problems because it inevitably causes gas shortages during severe cold spells," said James Barfield, the West Texas Gas representative in Farwell. "We understand that customers are upset about the increases."

Barfield said the reasons for the cost of service increases are due to the increased labor and pipeline services for in-

creased gas usage and flow.

Anytime gas usage increases it causes gas companies to increase the labor force for maintenance and supervision of the pipelines, converters and the whole supply system to the customers," said Barfield.

Cost of service is carefully calculated on a scale of usage that is based on gas consumption at a per thousand cubic foot rate, or MCF. Any gas usage in the range of 0.1 MCF is billed at a rate of 0.0786. Each additional MCF that is used

up to 3.9 is then billed at a rate of 0.7860. The next step of service billing is under Step 2. Any usage of 4.0 MCF is billed at a rate of 3.1440. Each additional MCF up to 24.9 is billed at a rate of 0.5610. Step 3 service billing is based on usage of 25.0 MCF at a rate of 14.9250 plus

0.4610 for each additional MCF used. To make this billing calculation more clear, here is an ex-

A Farwell city resident's meter is read by the gas company. It shows a usage of 15 MCF. This falls into the Step 2 category of service billing which is 4.0. The billing for this is 3.114 (\$3.11.4 cents). Now subtract 4 from 15 and you get 11. This number is the additional MCF - thousand cubic feet of gas that has been used. You must then multiply 11 by .5610. This gives a total of 6.171 (\$6.17.1 cents). The sums of 3.144 and 6.171 are then added to get a service billing of 9.315 (\$9.31.5 cents).

This total is then added to the meter charge of \$6.50 for the total service billing.

West Texas Gas and PNM Gas both use this type of billing rate for their service billings.

Barfield wants his customers to know that his office door is open and he is available to them to help them understand the billing rates and procedures. The office is located behind Farwell City Hall on First Street. The phonenumber is 481-3849 and Barfield is there from 8 a.m. to 5 p.m.

For New Mexico residents serviced by PNM Gas Services, they are invited to call two company officials to register their complaints concerning their gas bills. The numbers are (505) 827-6918 for Albert Ibarra and (505) 827-6967 for Barbara Rael. All calls will be taken and PNM will take all complaints into consideration.

PNM's rate increases will also be the focus of a State Public Utilities Commission hearing set for Jan. 22 in Santa Fe. The company has received thousands of complaints concerning the skyrocketing gas bills and prompted PNM officials to hold a press conference last week in Albuquerque to explain their reasons for the drastic increases. This also prompted Public Utitility Commission officials to hold the upcoming hearing to investigate the rate hikes.

According to an article in the Clovis News Journal dated Jan. 9, 1997, Wayne Shirley, chairman of the Public Utilities Commission was quoted as saying "if the PUC finds the utility is imprudent in the way they purchase gas, then we can adjust the bills." If this is the case, customers would be credited on future natural gas bills.

Gas company officials and representatives are completely understanding of the situation that their customers are in
