Football contest is under way!

The annual fall past-time -- the Area Merchants Football Contest -- begins its 41st season today. The entry blank is on the back of this newspaper issue; more entry blanks are available at the Tribune office, 404 3rd St., Farwell.

In order to have a strong chance at the grand prize, it's vitally important to enter every week. So be sure to fill out your entry blank and get it to the Tribune office by 5 p.m. Friday (today). Entries sent by mail must be postmarked by that time, also.

And, remember, we do take your ballots over the phone. Area farmers really appreciate this service. Just call 481-3681 with your picks -- before 5 p.m.

Although the Tribune's football contest normally has high school, college and pro games each week, we had to leave off the pro games this first week because the pro season hasn't started yet -- and exhibition games just don't cut it.

Why did assessments go higher?

Have you wondered why tax assessments are higher in Parmer County this year?

Here's the explanation from Curby Brantley, of the Parmer County Appraisal Office.

The county office uses "net to land" to determine assessments. "Net to land" refers to "what the land is making."

To sum up, you take the yield of the crop and get average prices from Texas A&M, then deduct typical expenses.

To be more exact, here is how it works:

You take the crop yield and multiply it by the price (gotten from Texas A&M statistics). This equals the "gross."

You then multiply the "gross" by 25 percent (typical rent) to get the "gross dollars to land."

Then you deduct the "typical expenses" multiplied by 25 percent (typical rent) to get "net to land."

That is how you get the assessment for a given year. But when the Appraisal District calculates assessments, they use a 5-year average.

Each year, they drop the oldest year and add the newest one.

For example, for this year, they dropped 1992 and used 1993 through 1997.

Next year, they will drop 1993, and add 1998.

And this brings us to why this year's assessments are higher than last year.

It's because in 1992 the Parmer County cotton yield was low. But in 1997 the cotton yield was high.

So the higher 1997 figure was used in the mix this year, replacing the lower 1992 statistics.

**Here's a look at county precipitation, water volume statistics**

Precipitation is the largest reoccurring/renewable water supply for the Llano Estacado Regional Water Planning Area.

It provides about 60 percent of urban landscape water demands and irrigation water demands. It provides all the water for surface water resevoirs and all the water for range land and dryland crop production. Precipitation also provides water for wildlife and natural recharge to the aquifer.

Members of the Llano Estacado Regional Water Planning Group are now evaluating the total water resources for the 21-county region as required by Senate Bill and Texas Water Development Board rules.

Precipitation records for the years 1945 to 1997 were obtained by the High Plains Water District staff from the National Weather Service reporting stations within the Llano Estacado Regional Water Planning region.

The average annual volume of water received from precipitation from 1945 through 1997 in the 12,988,090 acre area of the Llano Estacado Regional Water Planning area was 19,940,077 acre-feet. Of this amount, less than one percent of the total becomes runoff that escapes the area in streams, draws or rivers. The remaining runoff is trapped in playa basins or surface water reservoirs used for public water supply and/or recreation. The approximately 14,000 playa basin in the region are the focal point for natural recharge to the aquifer.

Parmer County received an average of 16.69 inches of rain a year for the 52 year span from 1945 to 1997. The 10

year average (1985 to 1995) rainfall was 20.57 - a deviation of +3.88 from the 52 year average. The deviation acre-feet per year over the Aquifer is 176,669.

Parmer County also currently had a volume of 9,305,617 for the 1985 Acre-Feet and a volume of 7,843,473 for the 1995 Acre-Feet measurement. This is a 10-year change of minus 1,462,144. The average annual change in Acre-Feet for the 10 year span is minus 146,212.

The projected water supply for the Llano Estacado Region table plots out the estimated volumes of water in storage for the region for the next five decades. Parmer County has an estimated 7,112,403 for the year 2000. For the decades to come the figures are 2010 - 5,796,477; 2020 - 4,612,144; 2030 - 3,546,244; 2040 - 2,586,933 and 2050 - 1,723,554 respectively.

Mrs. Powell was born and raised in Coalhill, Ark., but she says that she is no kin to Bill Clinton. She is the oldest of her five sisters and has two older brothers, and she was the only one that could sew in her family.

Her dad worked in a saw mill and made roads during the Depression. In Mrs. Powell's own words, "We were as poor as Job's turkey." Everything they needed they made or raised, from their goose feather beds to their clothes. They raised all types of birds, except ducks.

Mrs. Powell married in 1934 and the couple had six kids -- three boys and three girls. They moved to Texico 50 years ago to work for a pump company and have been living here ever since.

When the pump company closed down, they went into business for themselves. Mrs. Powell's husband passed away 10 years ago from a heart attack and Mrs. Powell has been by herself ever since.

When Mrs. Powell first started sewing she didn't use patterns. If she saw a dress that she liked, she would go home and make a pattern out of newspaper. Then she would sew it together by hand.

Each quilt is made from start to finish by hand. There are no machines used on the quilt at all. She uses to be able to make a quilt pretty quickly, but since she broke her hip last summer she has slowed down and it takes her about two weeks to make a quilt now.

She is in the process of making a quilt for each one of her kids and one for her grandson who helps her out. She used to make quilts for money when that was necessary.

In any event, Mrs. Powell has been making quilts pretty much all her life and I don't think she is going to stop now.

## Financial Focus

Many people limit the study of their investments to watching market values fluctuate. But if you want to know WHY your stock or mutual fund performs the way it does, check out its semiannual or annual report.

First, look for the report to shareholders. This is a "state of the company" address by the CEO or president explaining to you, a shareholder and owner of the business, events that influence your company's performance in the past year.

This report typically relates economic and political conditions to your investment, attempts to explain why the market reacted the way it did, and compares your investment's performance to that of similar investments.


Reports to shareholders not only review past and current conditions, they also discuss circumstances that may affect your investment's future performance. These valuable discussions allow you to evaluate the reasoning and thought process of management.

In a mutual fund report, the statement of investments provides a detailed list of financial holdings, organized by asset category: common stocks, corporate bonds, government securities, etc. These categories are further divided by industry. Here you can see the names of all the individual securities, the number of shares held and the market values at the end of the reporting period. This section reveals exactly what you own and illustrates the diversification you enjoy from your investment.

Similarly, company annual reports include a section called "Products and Subsidiary Business." Here you can see the diversity of your company's products, and you may even discover profitable subsidiaries you might not have been aware of.

Finally, look for the performance summary. This section provides the dollars and cents on company performance and investment value. Mutual fund annual reports offer an easy-to-read summary of their average annual and cumulative total returns over different time periods. Typically, there's also a line graph comparing your fund's performance against one of the widely accepted benchmark indexes.

Annual reports are a must-read for any investor serious about financial success.

Loving took to the air now. They hit a 38-yard pass. Soboleski had a good tackle. Minshew recovered a fumble at

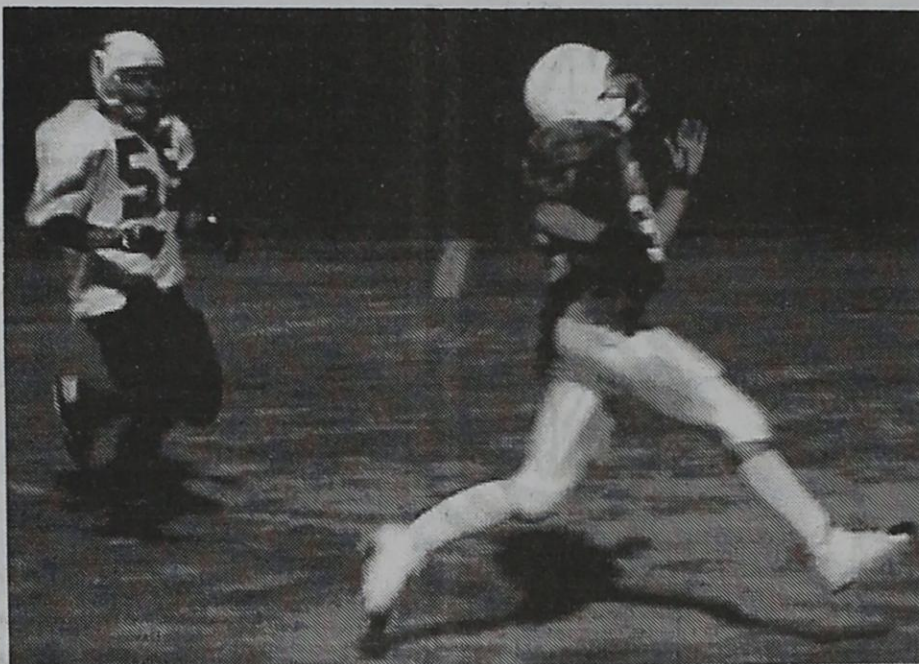

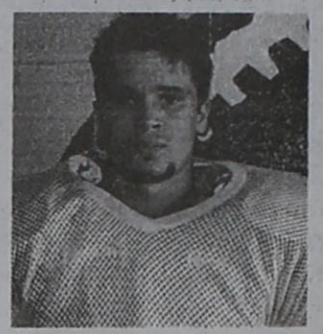
Texico gave it a shot in the waning seconds but was intercepted at the buzzer.

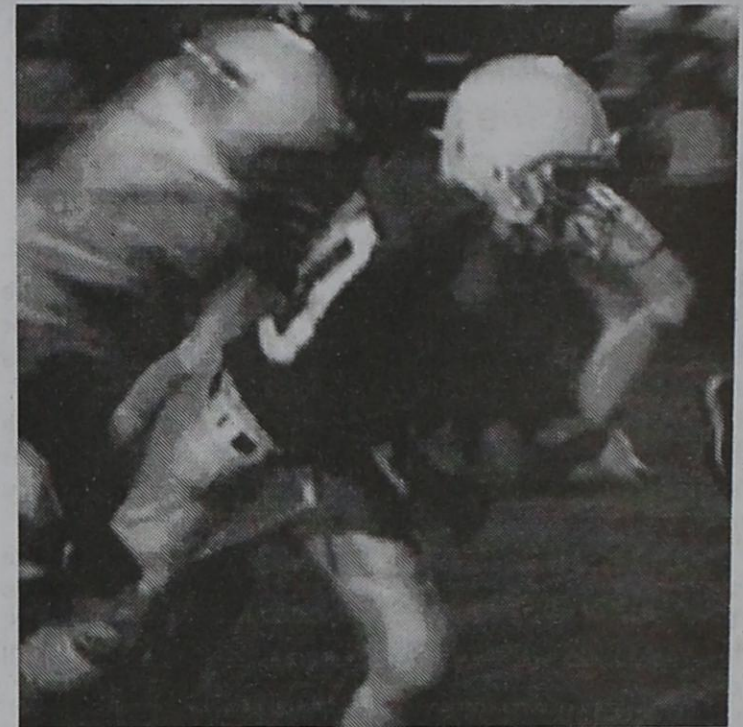

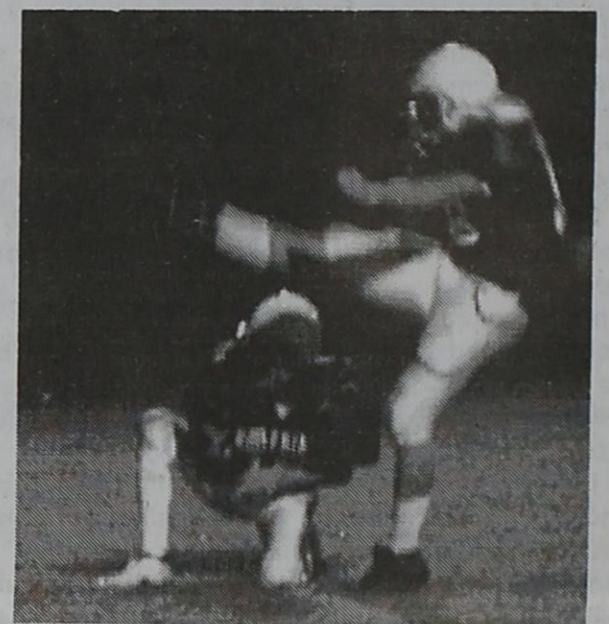

APPLICATION. EL CID LAND & CATTLE, INC. and DON OPPLIGER, P.O. CONTESTED CASE HEARING. The TNRCC may grant a contested case hearing on this application if a written hearing request is filed within 30 days from the date of newspaper publication of this notice. The Executive Director may approve the application unless a written request for a contested case hearing is filed within 30 days after newspaper publication of this notice.

To request a contested case hearing, you must submit the following: (1) your name (or for a group or association, an official representative), mailing address, daytime phone number, and fax number, if any; (2) applicant's name and permit number; (3) the statement "[I/we] request a contested case hearing;" (4) a brief and specific description of how you would be affected by the application in a way not common to the general public; and (5) the location and distance of your property relative to the proposed activity. You may also submit your proposed adjustments to the application or permit which would satisfy your concerns.
