Dean Stovall --

Steer End Repeats On All South-Plains Squad

Dean Stovall, Steer end, tops a list of five repeaters on the Avalanche Journal's All South-Plains Class A football team. According to Walt Alexander, Avalanche Journal sportswriter, Stovall is "tops" in Class A.

Stovall, who is playing his second year as a starter on the Steer squad, and who was named to the South-Plains Class A defensive roster as a sophomore, caught 38 passes for 874 yards and 12 touchdowns, plus returning four punts 212 yards and four additional scores, finishing with 96 points.

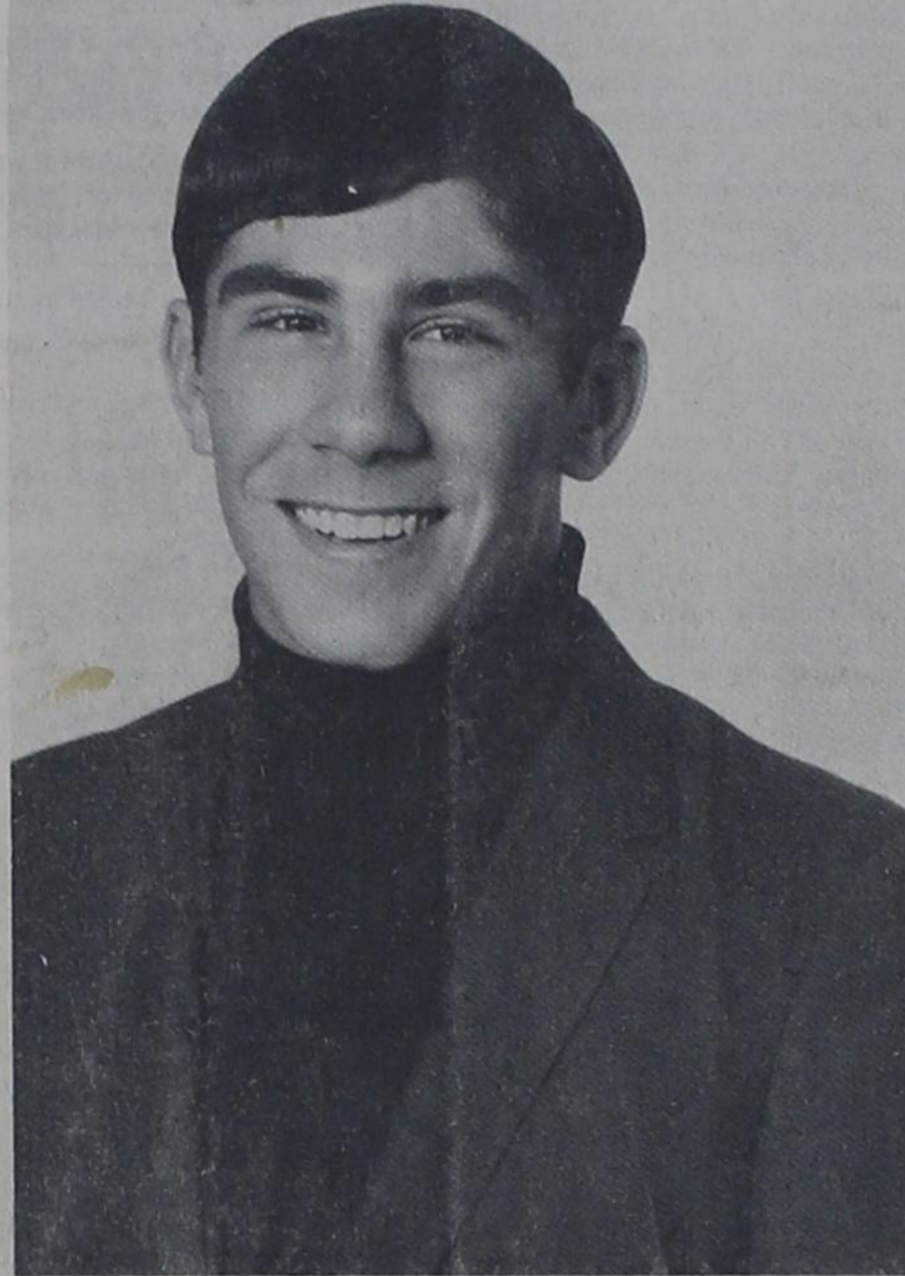
On defense, Stovall, who weighs approximately 165 lbs., picked off nine passes, returning those 292 yards. He also averaged ten tackles per game

during the season, thus becoming the only boy in the area to be named to both the offensive and defensive units.

Stovall, a junior, has been playing football most of his life and has participated in school sports since he was a seventh grade student. He is a son of Mr. and Mrs. Harold Stovall.

Honorable mention on the offensive squad went to Charles Bowery, tackle, and Al Phillips, back. Defensive honorable mention positions were listed for Robert Haseloff and Charles Bowery, linemen; Kyle Sheets and Denny Lunsford, linebackers; and Danny Prince, secondary.

Bovina boys listed for honorable mention included Bobby Redden and Stuart McMeans.

Registration Deadline Set January 31

Citizens wishing to vote in elections during 1969 must register before the deadline on Jan. 31, according to the county tax assessor-collector, Hugh Moseley.

Those 21 years of age and older will be eligible to vote this year if proper application for registration is made. No one over 60 is exempt.

A husband, wife, son, daughter, father or mother may register for another, but must be a qualified voter himself.

Although 1969 will not be a major election year, Moseley points out that city, school, county and possible bond elections will be held this year.

Farwell Steers brought home a third place trophy from the Hale Center basketball tourney held last weekend, Jan. 2, 3, & 4. In winning the award, the Steers defeated Cotton Center and Sudan and were defeated in the semi-finals by Happy.

that the team played exceptionally well and looked "just great" in the performances; although they were hampered slightly by illness. Next outing for the team will come this weekend when they host the annual Farwell Invitational Tournament, beginning Thursday.

Kyle Sheets topped Steer scorers in the Cotton Center-Farwell game by pouring 16 points through the basket. Dennis Ensor and Greg Hargrove each had 10 points. Hargrove led rebounding with 7, and Ensor followed with 6. Final score in the game was Farwell 57-Cotton Center 26.

Final score in the Happy-Farwell game was 56-54 with the Steers on the losing end. Kyle Sheets again led scoring with 15 points followed by Dean Stovall and Dennis Ensor with 13 each. Al Phillips led rebounding with 12, followed by Stovall with 10.

In the consolation game, Farwell defeated Sudan 72-54 with Dennis Ensor contributing 21 points and Kyle Sheets finding the basket for 20. Al Phillips and Dennis Ensor each had 12 rebounds while Dean Stovall contributed 8.

Flu Subsides, Students Return To Classes

According to information from the office of A. D. McDonald, Texico school superintendent, the flu epidemic which was causing many absences in the school prior to the holidays, has subsided to some extent. He indicates that this week no more than 10% of the students have been absent; and prior to the holiday period some 20% of the students and many of the teachers were absent due to the disease.

At this time, no teachers have been absent since school reconvened Monday morning. In Farwell High School, most of the students are back in school with only three absences noted in the entire high school division on Tuesday. Prior to the holidays, at least 10% of the students were absent due to illness.

James Craig, principal of Farwell Junior High school, reports that absences in that school since the holidays are at a minimum, with no more than five students absent on Tuesday; some of these students are out of town and not ill.

In Farwell Elementary school, where several teachers were absent due to illness prior to the holidays and also several students were out with the disease, Principal Jack Williams reports that there is evidence that the worst of the flu siege is over, since all teachers are on the job and many students have returned to classes. He stated that several of the present absences among students were not due to illness, but to the fact that students have not returned to town following the holidays.

Gives Bus To Scout Troop 179

Troop 179 Texico Boy Scouts were recently recipients of a 36-passenger bus, when members of Texico Fire Department bought the 1960 Ford bus from N. W. Peyton and donated it to the troop.

The troop, a little over a year old and guided by Ernest Foreman, has 17 members. When it was organized last year, only five boys were members of the troop.

The bus, which is presently being remodeled inside and out by the troop, will be used for all out of town expeditions. Interior of the bus will be remodeled to hold luggage and make room for necessary facilities needed in traveling, and the outside of the bus will be repainted with the name and number of the troop. The bus

was formerly used as a school bus.

Texico-Farwell now has two active scout troops.

'Farm Bureau Week' Proclaimed

County Judge Archie Tarter has designated the week of January 13-18 as "Farm Bureau Week" in Parmer County. The county Farm Bureau organization will have a special enrollment drive during this period as part of a statewide effort to push Farm Bureau membership in Texas over the 110,689 figure achieved in 1968.

Parmer County Farm Bureau ended its 1968 membership year with 537 member families.

The official proclamation called for citizens "to give due recognition to this observance honoring Parmer County Farm Bureau."

Earlier, Gov. John Connally proclaimed the same period as "Farm Bureau Week in Texas."

Harry Hamilton of Friona is president of Parmer County Farm Bureau. Membership chairman is Bill Brandt of Friona. Other Parmer County members will be working on the membership drive.

The committee chairman said every farmer and rancher in the county is needed "as a member and leader" in Farm Bureau.

"Each of us in agriculture has too great an outlay in our business not to do all that we can to protect our investment in capital, time and labor," he declared.

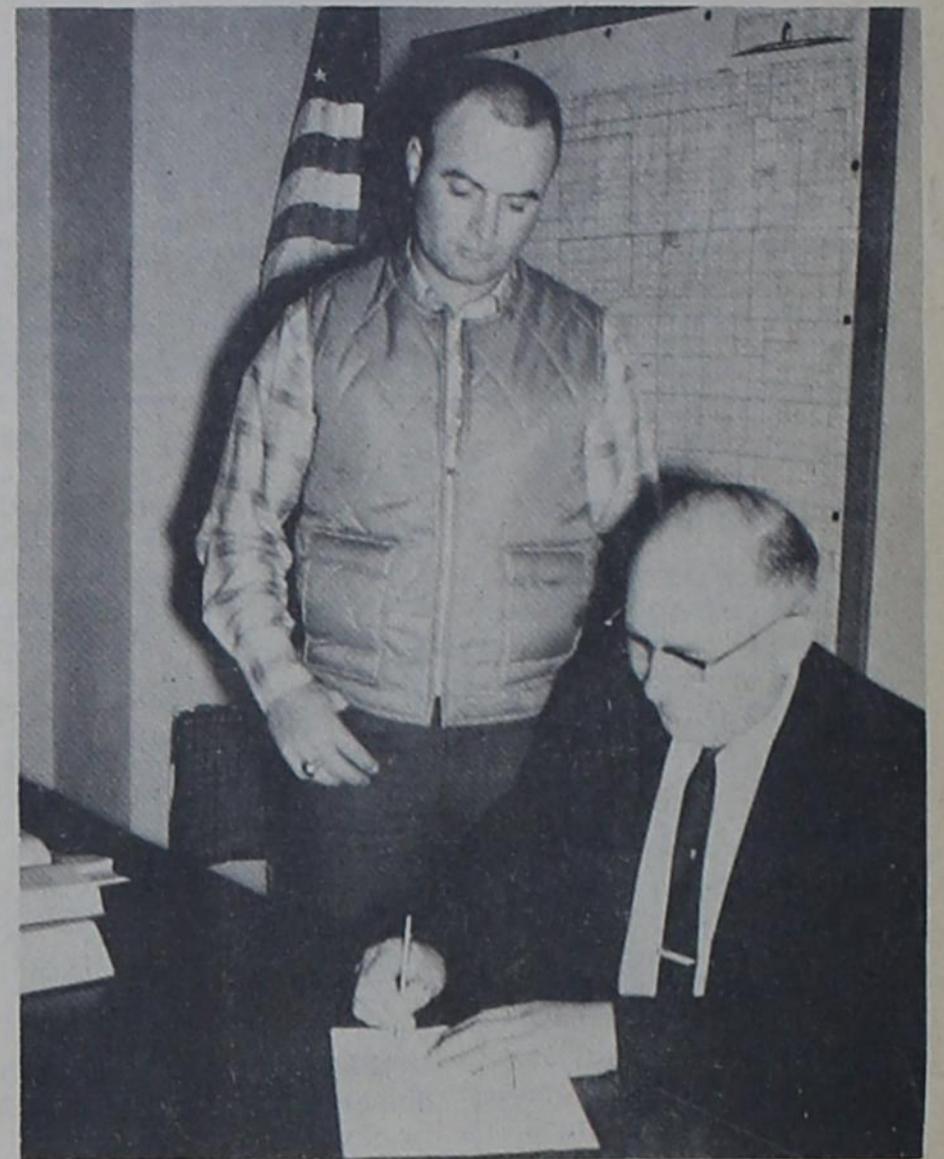
The text of the proclamation issued by Judge Archie Tarter reads:

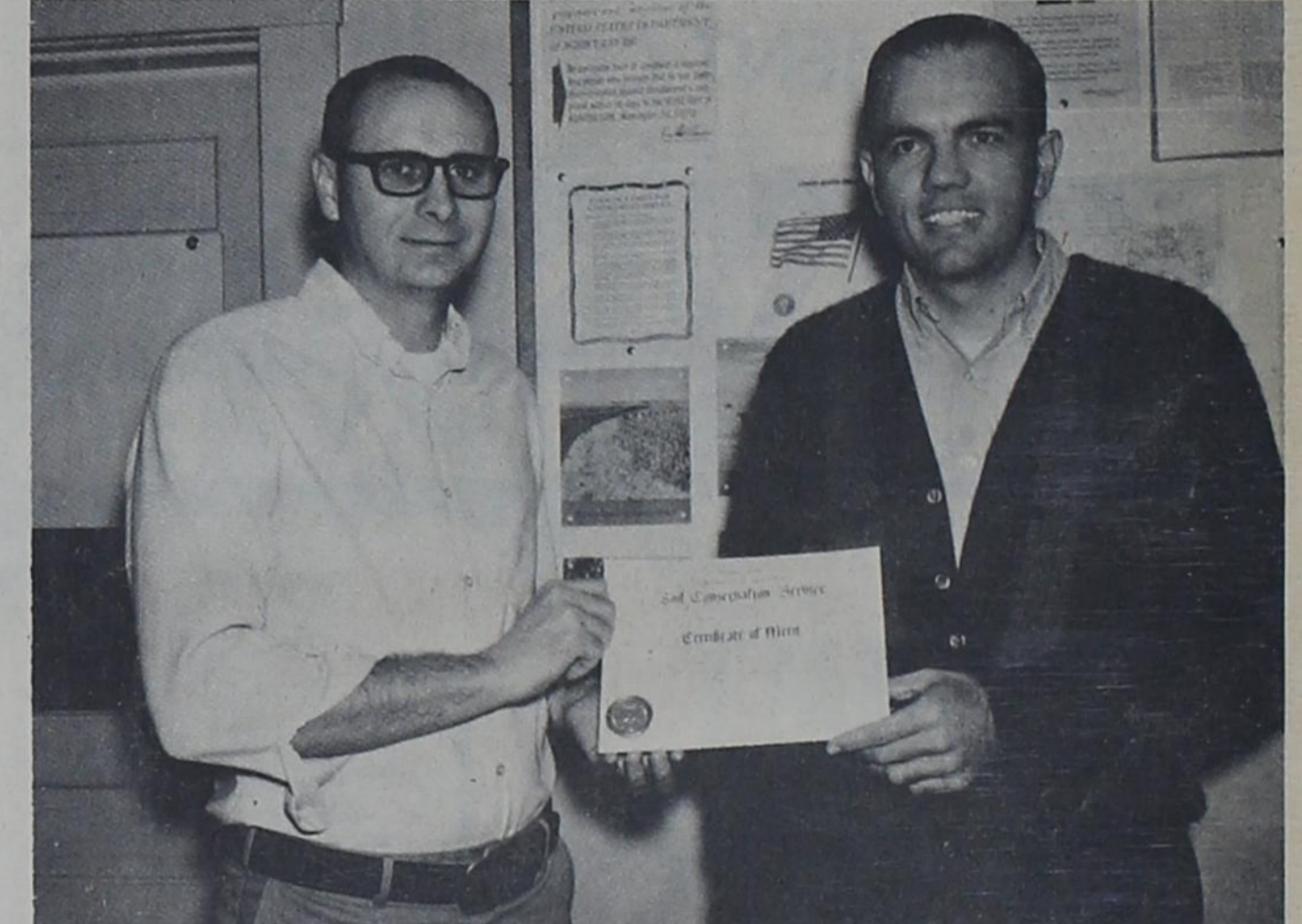
Rabies Identified In Adjoining County

The New Year is always a time of making resolutions and grand resolves to better in the future. In a few instances this probably works out all right. In one particular instance, we can count on the old ways of life continuing; this is the United States Congress.

We see where this august body has admitted to their ranks Adam Clayton Powell, the Congressman from New York. Mr. Powell has been excluded from the recently adjourned Congress for some of his past actions and he also has had his share of legal difficulties. We understand most of his legal problems have been resolved and apparently his moral problems have been overlooked by his constituents. This has left him free to reapply for his Congressional seat.

Congress apparently feels that if a person works out his legal difficulties and is accepted by his constituents, then he should be admitted to the Federal lawmaking body. We do not feel this way.

One of the more specious arguments for seating Powell was the fact that his district voted for him and they were entitled to representation. Now, I do not have any objection to a district voting for whom they please, and feel that they in the district are entitled to express their desires, but I do object to a district electing a person of Powell's history to be in a position whereby he may vote on laws that directly affect me.

This sad state of affairs is difficult to resolve in our broad form of Democratic government. The only visible solution is for the other members of Congress to exercise their trust of office in a high and irreproachable manner. This apparently has not been done by the majority of our present Congressmen, inasmuch as they seem willing to let Powell join their company.

As we have written before, it is only the willingness of the people to obey the law that allows laws to work. If the integrity of our judicial system comes into question, we are further down the road to anarchy than we realize. Under the circumstances, we feel this seating action by Congress pushes us further down the road to violence and national chaos.

One of the very popular pastimes is the phrasing of thoughts and ideas in a rather startling fashion. We find these literary gems on bumper stickers, lapel buttons and wall plaques in offices. In view of our rather stuffy and moral attitude concerning our lawmakers, we are reminded of a wall plaque we came across recently.

It was titled "Nobody is Perfect" and reads "Each one of us is a mixture of good qualities and some perhaps not so good qualities. In considering our fellowman we should remember his good qualities and realize that his faults only prove that he is, after all, a human being. We should refrain from making harsh judgement of a person just because he happens to be a dirty, rotten, no good 'son-of-a-gun'."

A bumper sticker making the rounds in Houston has a rather pointed message. It reads, "DRIVE CAREFULLY -- Dr. Cooley is waiting." Dr. Cooley is the resident heart transplant genius in that town.

Grain Sorghum --

2,500 Lbs. Per Acre Lost To Greenbugs

Incidental research data gathered by High Plains Research Foundation scientists in a grain sorghum irrigation study may have pinpointed the amount of losses suffered by High Plains farmers due to greenbug infestations this year.

According to this data, grain losses at the Foundation exceeded 2,500 pounds per acre due to greenbug infestation during a two-week period from July 24 until August 6.

Dr. Tom Longnecker, Research director, said the discovery came almost by accident and was one "fringe benefit" of the continuing irrigation data research projects conducted annually by the Foundation.

Explaining how the data was collected, Researchers Jim Valliant and Dennis Mooney and all sorghum in this study was irrigated at the seven-leaf stage during the week of July 1. On July 24, part of the area was irrigated pre-boot before it was sprayed for control of greenbugs. The other area was spray-

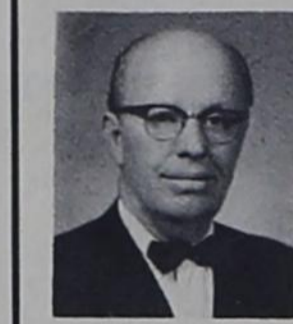

nuts. Spread over cake and serve.

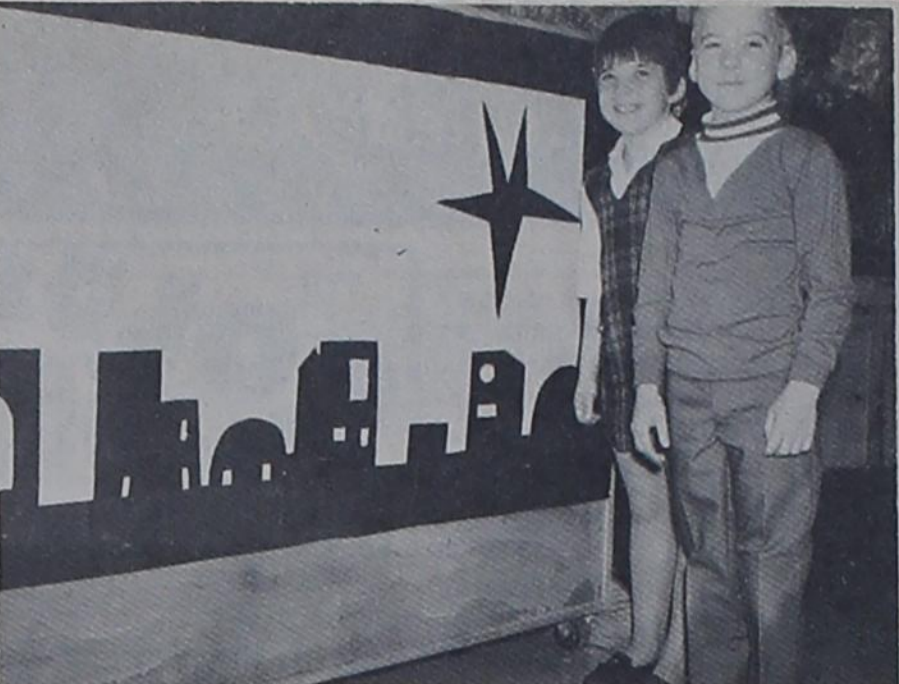
MARSHMALLOW PUMPKIN PIE

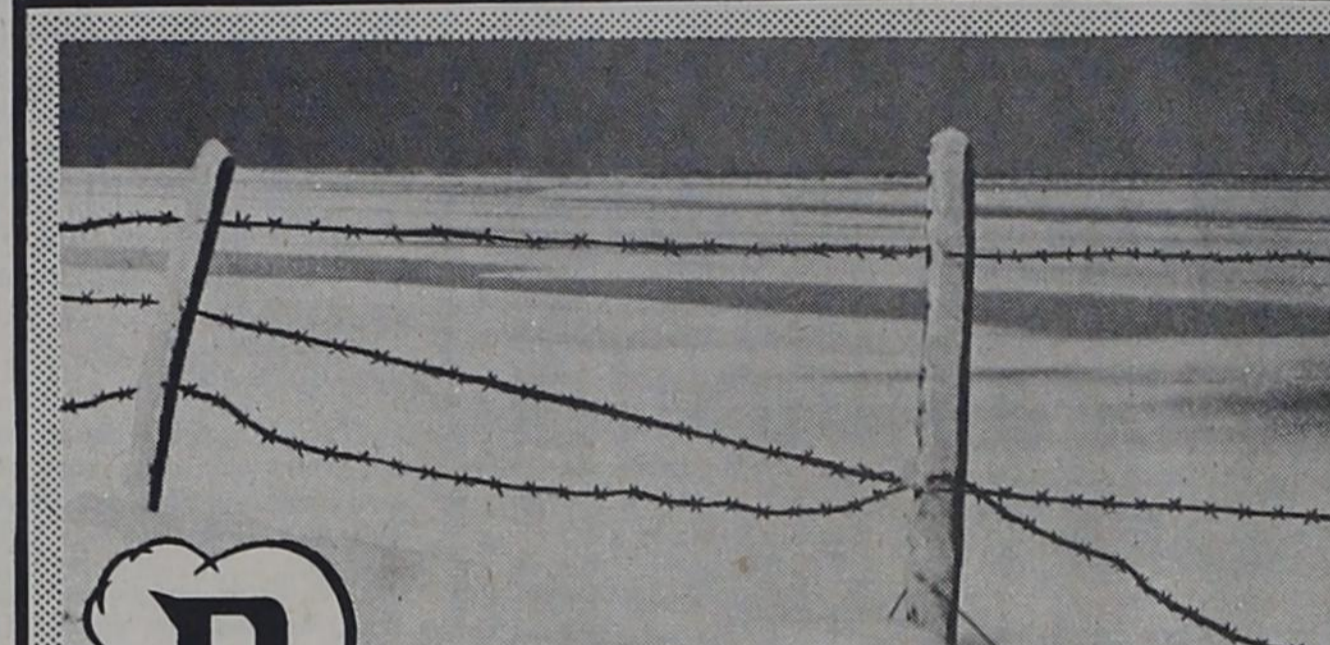

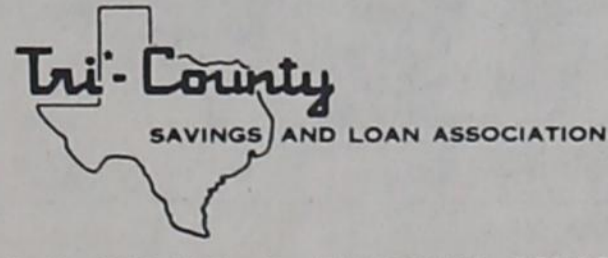

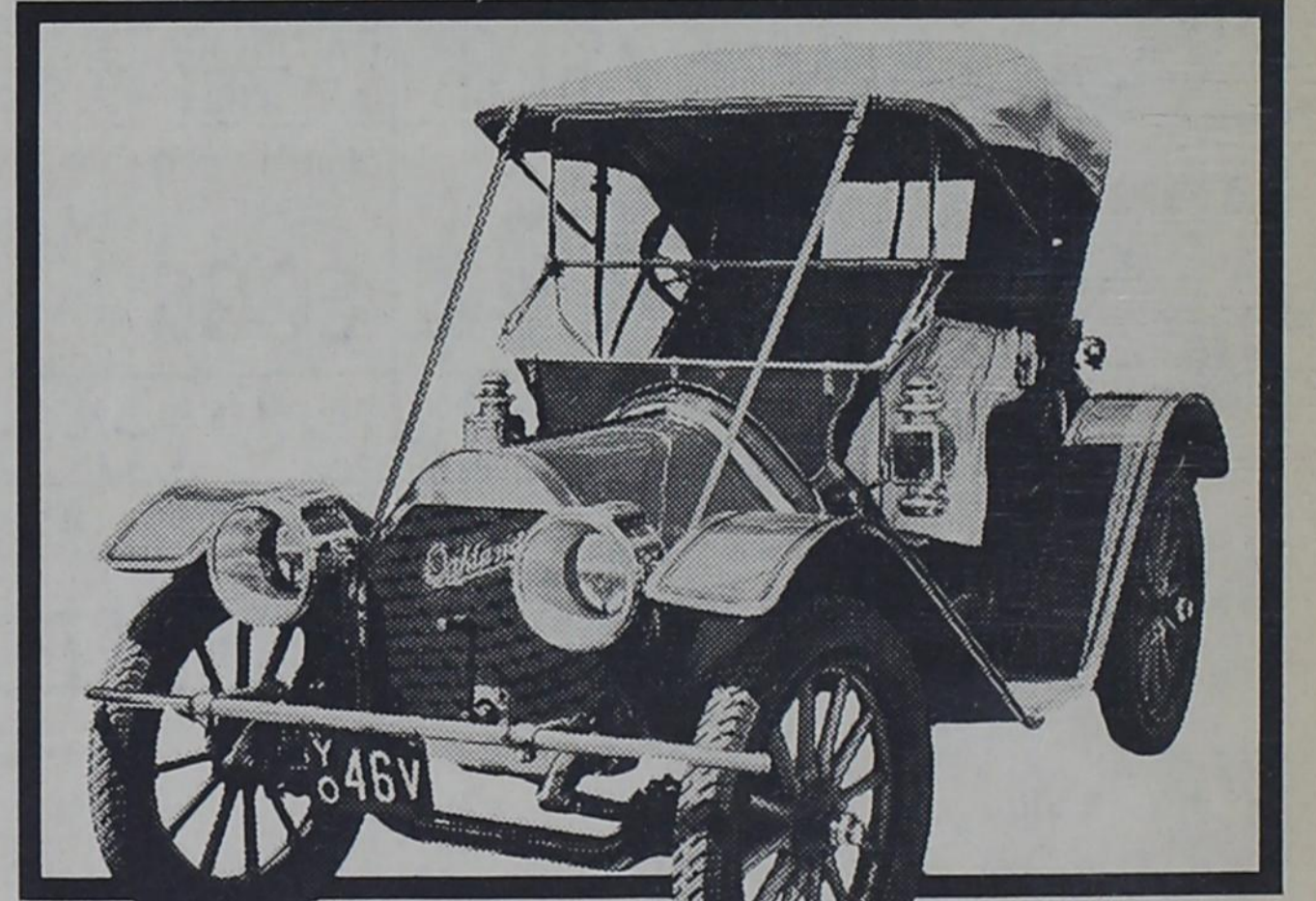

NURSERY NEWS

By Alvin Woodburn

We will continue on the subject "Will pine trees grow in Clovis?"

The Limber Pine is adapting real well, provided the source is below 9,000 feet in elevation. That is, a tree grown below that elevation will adapt here readily, where others might not. The Limber Pine and the Pinon compliment the so-called desert or rockscape theme, where their twisted characteristics make them so popular.

The Foxtail is another mountain pine that grows here nicely and is quite attractive when used in landscape work.

We know of two or three Slash Pine that have been planted here on a trial basis. After three years, they are doing fine. Of course, three years may be a long time for a child waiting for Christmas, and only a little less to some more mature people, yet it is a very short span in the course of events that lead to the pine tree's development in the first place.

Who knows but what the Georgia Pine will adapt here under certain conditions. The use of Sulfasol and winter watering has done more than any other thing we know of to adapt the pine in a growth pattern that we prefer.

Most of the older pine in Clovis were planted in the late Thirties or early Forties. Thus, the trees you see around the area are really not too old. They have done well in the 30 years and, being human, we are prone to think that length of time encompasses all possible variances in our weather and the other components that make up our climate. At least, after that long a period, we think it is
