





## Vandiver gives cotton update

From Monti Vandiver. Parmer County Extension Agent-IPM:

The Northwest Plains cotton crop is up in the air. Cotton yield is typically limited by environmental factors. 2004 is no exception but drought, hail, and blowing sand has not made a widespread impact thus far.

Heat unit accumulation will, in most cases, be the limiting factor of yield and

quality of the 2004 cotton

The crop got off to a great start, "Mother Nature" supplied plenty of moisture and adequate temperatures to build a plant with tremendous yield potential. Little cotton in the Northwest Plains was ever moisture stressed with the exception of the first two weeks of September.

pushed cotton into maximum production. temperatures were warm but less than perfect and August was a bust as far as cotton production goes. This is not to say the 2004 cotton crop will be a failure but it is not likely to meet earlier expectations.

Irrigated cotton stands to be most disappointing while dryland cotton yields should be very good. Open weather with warm temperatures and sunshine will give an opportunity to get harvest aids applied. Harvest aids will not accelerate cotton maturity but will open bolls and dry the plant in preparation for harvest.

Maturity can only be enhanced by good growing conditions and time. It is very likely that cotton is as mature as it is going to get. Harvest aid decisions

amount of boll opener and defoliant needed. quicker the crop can be harvested the more weather related risk a producer can avoid.

While irrigated cotton may not yield what it looked like it might 60 days ago, the overall cotton crop has the potential to be a good one.





Farwell wins Battle of the Cattle

The Farwell Steers are 1-1 in district after putting away the Hart Longhorns last Friday at home, 21-12.

The game wasn't that close as the Steers had a 21-0 lead halfway into the 4th quarter.

The game opened with Farwell's ball on its 26. Colby Norton caught a 10-yard pass from Robbie Tabb but Farwell was held. Derrick Chandler boomed a 47-yard punt to the Hart 33.

Joel Chavez had a good tackle and Hart punted. Tabb had a great punt return, behind two good blocks, and raced to the Hart 29. But incomplete passes stalled the drive.

Hart hit a long pass to

McFarland intercepted at the Farwell 17. Rowdy Mitchell ran for 9, and Tabb kept for 16 more. A pass to McFarland gained 14. Then Mitchell raced for 15 more, behind a great block by Hugo Vasquez.

But Farwell's drive was stopped and Hart took over. McFarland had his 2nd interception on a tipped ball caused by pressure on the QB by Chavez and Roper Fulcher. But Farwell lost a fumble at its

On defense, Norton had a strong tackle, then broke up a long pass and Hart was held. But Farwell lost another fumble, and Colton Sudderth made a

the Farwell 32. Logan TD-saving tackle at the McFarland intercepted at Farwell 16.

Tabb intercepted in the Farwell end zone after Fulcher pressured the QB. On the first play, Tabb raced around end for 92 yards. Mitchell then scored from the 3 at 9:21. The McFarland kick made it 7-0 at 9:21.

Logan Clemmer made an excellent tackle of the kick returner at the Hart 28. Vasquez had a QB sack for -7 yards. Roper Smith broke up a pass and Hart punted to the Farwell 9.

Mitchell ran for 10, then McFarland, at QB, kept for 52 yards. Matthew Edwards ran for 9, then for 10. Mitchell scored from 3 yards out just 37 seconds before halftime. The McFarland kick made it 14-

Vasquez had a great tackle of the kick returner as the half ended.

Hart started the 3rd quarter in Farwell territory after a long run. Fulcher had a good tackle and Hart was held at the Farwell 34. Edwards ran for 53 yards. Mitchell scored from the 20 at 8:18. The McFarland kick made it 21-0.

Vasquez had another big hit, tackling the kick returner at the Hart 26. Edwards recovered a fumble at midfield.

Vasquez ran for 23 yards, shedding 3 wouldbe tacklers, but lost a fumble at the Hart 27. On

defense, Mitchell had a good tackle. Hart hit a long pass to midfield. Then Mitchell made a big tackle on a screen play -- he was the only defender in the area and the runner had 4 blockers.

Farwell took over near midfield. Vasquez ran for 18 and Edwards for 8 before Hart intercepted at its 8 as the 3rd quarter ended.

Edwards recovered a fumble at the Hart 30. Farwell was stopped. On defense, Mitchell and Chavez combined on a QB sack. But Hart hit a long pass. Norton's big hit broke up a potential TD pass. Fulcher had a QB sack. But on 4th and 10, Hart connected on a 35-yard TD pass at 5:58. The run for extra points failed.

## **Gurley takes issue** with District Attorney

Mr. Pomper,

On Tuesday, Oct. 12, 2004, you called my office to inform me you were publishing a "Notice of Claim" written on behalf of the First Baptist Church of Friona. After our conversation, I wondered how the State Line Tribune obtained a copy of legal correspondence addressed to a Parmer County official.

Imagine my surprise upon being advised that a copy of the letter was delivered to you by the District Attorney/County Attorney's office. "Notice of Claim" letters are usually confidential and not generally published. Publishing such a letter could threaten possibilities of settlement. Other "Notice of Claim" letters have been received by Parmer County, some within the last two months. These letters were NOT published in your newspaper, nor was there any mention of the receipt of these claims.

Was the District Attorney/County Attorney's office acting in the best interests of their client, Parmer County, when they delivered this letter to the State Line Tribune for publication? There is no benefit for our county in the publication of this "Notice of Claim."

I believe the primary reason the letter was given to you by the District Attorney/County Attorney's office was purely political -- merely an attempt to raise questions about my write-in campaign for Parmer County Attorney. The result of the publication has been to cause your readers to ask why I am suing Parmer County. I have NOT sued Parmer County. The motivation of the District Attorney/County Attorney's office in releasing the letter to your newspaper had nothing to do with representing the interests of Parmer County in a fair and just manner.

Due to incumbent Charles Aycock's early filing and later withdrawal from the primary and Jeff Actkinson's very last minute filing for a place on the ballot, I was unable to get on the ballot. As a result, I am a write-in candidate for Parmer County attorney in the general election. 

LIVE CATTLE: Futures prices have been trading inside \$2-3 narrow range over the last few weeks with little ndication of the next direction. Cash cattle traded higher this week at \$86 which is about what the market had been expecting with the October contract closing at \$86.92 on Friday. A close above \$89.55 basis the December contract would turn long term charts higher.

FEEDER CATTLE: November Feeders were ale to retest contract highs this week, but failed to break out above this level. Prices are still very stable and short term trends are up. The spread between fed cattle prices and feeders is not likely to narrow for several more months. If the spread were to narrow, demand for feeders would rise, which would probably widen the spread again. Numbers will need to reach levels in which there is an ample supply to meet any feed lot demand.

CORN: After dropping to new contract lows on Tuesday, the market has shown some strength back to the upside. The USDA surprised traders on Tuesday when production estimated jumped up to 11.6 billion bushels. There were reports of strong commercial interest below \$2.00 which helped to support prices, but it will take a close above \$2.11 in order to turn short term trends high

SOYBEANS: The market opened sharply lower on Tuesday morning following the USDA announcement that production estimates would be raised above the 3 bilion bushel mark. World supplies are now expected to be more than ample. The market could not rebound like wheat and corn.

WHEAT: Although the market opened lower after the USDA report on Tuesday, prices were able to rebound and close sharply higher on the day. Short term trends turned higher on Tuesday and the market stopped at about a 50% retracement level on Friday at \$3.20. Many analysts believe that we may have seen the largest ending world stocks number for the remainder of the year.

COTTON: The market broke some important support levels at 46 cents on Tuesday after the USDA raised production estimates to over 21.5 million bales. Although the market was expected to close at limit down that day, prices were able to rebound and move higher over the next couple of days. Friday's close was weak, but above \$48.75 would turn the market back higher.

The Texico City Council met in a regular session on October 12, 2004, and decided that reasonable notice to the public as required in Open Meetings Act (NMSA 1978, Section 10-15-1 to 4) would be as follows:

Unless the business before the City Council dictates otherwise, the City Council conducts open meetings to take formal action on the second and fourth Tuesdays of each month at 6:30 p.m. However, when that Tuesday is a City holiday, that meeting will be held on the next business day.

The City Clerk and staff were authorized and directed to publish an annual schedule of regular meetings as legal advertisement in State Line Tribune.

The game started well for the Colts when Rolando Garcia returned the opening kickoff for 40 yards. The Colt offensive line then helped Jonathan Roldan score the game's


The Colt defense played well, holding the Wolverines to just 6 points.


The second Colt TD was scored by Peter Hiebert, on a 97-yard run. Roldan finished off the drive by scoring the 2-point conversion.

-- Carter told the board about a recommendation from Texas Comptroller Carole Keeton Strayhorn wanting school years to be compressed from the current 180 days to 175 days.


She noted that many youths work at tourist centers during the summer, and she believes that the school year starting after Labor Day is feasible (and the school year ending later in May than current-

## Ordinance revised for dealing with animal slaughter

The Bovina City Council on Oct. 12 approved an addition to the city ordinance dealing with the slaughter of animals and slaughterhouses.

Basically, here is what the addition says:

If you want to slaughter a pig, for example, you can do it on your own property as long as something like blood from it doesn't flow off your property.

But if any remains, or blood, go onto another's property, or the city's property, then the slaughter is considered a nuisance and it's illegal. You will be fined up to

The council said it recognizes that it's a Hispanic tradition to slaughter pigs and thus will allow it -- as long as it stays inside your property.
