



# Farwell student code of conduct changed

The Farwell School Board on Tuesday discussed setting a tax rate.

A public hearing on the budget and for the tax rate will be held at 6:45 p.m. on Aug. 30 at the school administration building.

The board learned that the assessed valuation within the school district is up. A small tax rate, a penny or two, may be in the offing.

In other business, the board:

-- Received the resignation of elementary teacher Cindy Cargile, who is moving to Lockhart, Texas.

-- Hired Carolyn Sloan as a 3rd grade teacher and Shana Glover as a 5th grade teacher.

-- Heard Supt. Mike Read say that more fire alarms need to be installed.

-- Made some changes in the student code of conduct including:

1) No "mohawk" haircuts, although military style haircuts are okay.

2) No "skin types" pants.

3) No holes in pants above the knees.

Other changes approved include:

1) 7th and 8th grade students can be exempt from 3 semester tests, using the same criteria as the high school.

2) Class rank in the high school will include more honor class requirements.

3) Student Council members must have no grades below a 70.

# Lazbuddie voting poll moved

The Parmer County Commissioners met on Monday with county appraisal district manager Curby Brantley.



In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The program is operated in a building leased from the City of Bovina. This lease was okayed again at the meeting.



Tired of wasting time redialing busy signals? Just dial a two digit code, and repeat dialing will redial the last number you called for up to 30 minutes, and will ring YOU when the line becomes available.

# To use Repeat Dialing:

1. After you receive a busy signal, hang up the phone. 2. Pick up the phone and dial \*66. If the line is still busy, the number of the last call you dialed will be called back for 30 minutes. 3. As soon as the line becomes available,

your telephone will ring with a different ringing pattern to alert you. Simply pick up the phone, and the number that was busy earlier will be ringing.

To turn off repeat dialing: If at any time after you have dialed \*66, you decide you don't want to call the busy number back, pick up the phone and dial \*86 to cancel your request.
