## **Cattle stealing** a major problem

1839: FRIDAY, SEPTEMBER 13. The stealing of cattle is a problem of major proportions along the southern frontier of Texas, according to a report submitted today by Lieutenant John Browne, Assistant Quartermaster, to Secretary of War A. Sidney Johnston.

"When I arrived in Victoria, I found it filled with a set of men who have given themselves the title of 'A Band of Brothers,"' he reports. "1 soon found that what they said was The place is nearly deserted--the Indians continue to deprecate upon the citizens, and the public buildings are in a dilapidated situation, not suitable for occupancy and the archives. These reasons, with the want of mails, render it utterly unsuitable for the purposes of government and the safety and convenience of our citizens.

"For these reaons I have selected Washington as the most eligible point for the location at this time."

## -----**Cumpton wins 1st** football contest

The 28th annual Merchants Football Contest began last week, starting the 12-week season with two contestants guessing correctly on 11 of the 12 games.

Since one game ended in a tie --Clovis and Amarillo at 6-apiece -- it was unlikely that any entrant would get all 12 right; they would have had to have picked that tie.

Rex Cumpton, Farwell High School head football coach, was the first place winner by virtue of being closer to the tiebreaker than the second place winner -- Farwell High's English I class.

The tiebreaker was the Farwell -Springlake-Earth game, won by the Steers 26-0. Cumpton was 13 off the tiebreaker; the English I class was 19 off the tiebreaker.

Cumpton received a check for \$10 for winning the first contest. The second place check was for \$5. The number of participants in the football contest keeps increasing. For the first game there were 370 entrants. Last year, there were 312 who started; and in 1984, there were 282 who entered. In 1983, it was 233. By contest's end last year, a total of 604 persons entered, as more folks join in each week.

We can no longer be complacent. We also are fighting for survival, but we can survive and more, suceed, but it is going to take the concern and effort of all its citizens. Everyone should do as much of

their shopping as possible at home for several reasons.

1. Local sales keep those dollars at home where they turn over and over again, providing jobs and income for many persons. Those who complain about the town needing more jobs and better pay, and who then shop out of town, are only contributing to the very problem they're complaining about!

2. Local sales tax comes back into the city budget to help it provide and maintain essential services. Shopping out of town decreases the amount received by the city for use on those essential services.

3. A steady volume of local sales helps to assure that the local merchants will stay in business and be able to offer a greater and better selection of merchandise. Shopping away from home only means they offer less and less, or perhaps, close altogether.

4. Local prices are generally competitive with those elsewhere, and usually beat others when you consider the cost of gasoline and service out of town.

5. Ours is a fine community to live and raise a family in. One reason is a good school system. A system supported by tax dollars from local tax base. If local businesses close and property values decrease that tax base will be eroded and the schools will have to suffer or taxes will have to increase.

6. Lost jobs, sales tax, and tax base can only mean that the quality of life here will decline and our young people will be forced to go elsewhere as they seek careers and livings. Studies have shown that 75 to 80 percent of new jobs come from expansion of existing businesses. Building up our local businesses by patronization should be a number one priority.

Some of our merchants are trying to be competitive, trying to be generous, and trying to be of service. They have long ago realized the importance of the local economy to the quality of life and have invested heavily in it, in some cases everything they have.

law. They are all in the cow stealing business, and are scattered over all this frontier. They pretend to say that they only steal from the enemy, but I am convinced to the contrary, that they steal from the Texians as well as Mexicans."

The report continues: "While I was in Goliad, about 20 of this band assembled in front of a public house and declared that in three days they would visit Carlos Rancho and burn it down, and kill all the Mexicans belonging to it.'

Those involved, according to Browne, include the customs house officer for Copano, a former Army lieutenant, and even Judge Allen of Carlos Rancho, he says, "is silently involved with them." Carlos Rancho is on the San Antonio River, where it is crossed by the trail between Victoria and Refugio. Browne charges that the customs house officer headed a party that drove in some 400 head of cattle. "The owners know well where their property is, but dare not proceed to recover it," he says.

"The government can have no idea of the deplorable condition of the citizens on the San Antonio River," he continues. "The constant dread of being murdered obliges them to receive the robber as a friend. They dare not say a word in their defense."

**1842: SATURDAY, SEPTEMBER** 10. President Sam Houston today ordered six wagons and teams to be sent to Houston City from Washington-on-the-Brazos to transport the government's archives and public property from Houston to Washington, which he has selected as the new seat of government, rather than returning the government to the previous capital, Austin. He states that officers of the government are being notified of the new capital.

"I have resolved to locate it at Washington until a final action of the nation can take place relative to its establishment," he explains. "The emergencies which brought it to this place (Houston) have, in part, ceased; but the objections to Austin yet obtain as a place of security of the national archives. The inconveniences and insecurity of having it there seem to increase.

1842: MONDAY, SEPTEMBER 12. At daybreak Sunday morning, a Mexican force of some 1,200 men under General Adrian Woll attacked San Antonio and took control of the city after brief resistance by Texians firing from the Sam Maverick house.

It is known that with General Woll are a number of former Texians who have deserted to the enemy. These include San Antonio's former mayor, Coloner Juan N. Seguin, who yesterday led a contingent of Mexican troops into San Antonio's Plaza de las Armas, meeting no resistance. Another is Colonel Vincente Cordova, former alcalde of Nacogdoches before independence, and leader of Cordova's Rebellion there in August, 1838. He is much wanted by the Texians, and has had several narrow escapes.

The action occurs just as Texian fears of a major enemy invasion have subsided, after the departure of General Rafael Vasquez, who took San Antonio last March 5 and held it for two days. Colonel Sequin left with General Vasquez at that time, fearing to remain because of insistent rumors that he had supported the invasion. "I have been the object of hatred and passionate attacks of some few disorganizers," he said, "a foreigner in my native land."

He hid out in South Texas for several weeks, and on April 18 resigned as mayor, giving as his reason "the disorderly state in which this unhappy country finds itself at the present time." He finally decided to seek asylum in Mexico. He went to Laredo, where he was imprisoned by the Mexican commander. On orders of General Mariano Arista, commander of the Army of the North, he was transferred to a Monterrey prison while Arista checked with Mexican President Antonio Lopez de Santa Anna regarding his disposal. It was agreed to permit Seguin to prove his loyalty to Mexico by fighting against the Texians, and he was sent to join General Woll's invasion force, then preparing to cross the Rio Grande at Presidio del Rio Grande, about 75 miles up-river from Laredo on the Mexican side.

night discussed at length what to do about city eyesores, such as abandoned vehicles, piles of wood and junk stored outside.

At the last meeting, City Marshal Dave Wheeler had asked for instruction on how to determine which eyesores should be viewed as being in violation of city ordinances. Councilman Butch Tharp was asked to view them and report back.

Tuesday, Tharp showed several Polaroid pictures of eyesores around the town. He said he was amazed at the number of wrecked vehicles he saw and suggested the city go after this problem.

Councilman Doyal LaRue then suggested warning tickets be given to residents if they don't clean up their act. Wheeler said he could hand-deliver letters to residents. But Councilman Steve Chancy said he opposed letters that just say

clean up your property. But ne supported them if the problem constituted health or safety hazards.

The main points of contention during the discussion involved "what's one man's treasure is another man's junk" and also the fact that if some violations of city ordinances are being ignored -- then is it fair to enforce them against others?

The council decided to send letters with the water bills encouraging all residents to clean up their properties. In favor were LaRue, Bryan Kube and Tharp. Chancy was opposed.

"Let's be diplomatic at first," said LaRue, in suggesting the action that the council voted for.

In other business, it was noted that bids have been advertised for the water well project by engineer Ralph Vail. Bids will be opened in about to days.

Vail had planned to meet with the council last Friday. But he arrived after the council had gotten together so he met only with Mayor John R. Hadley and City Attorney Duane Hamar.

Hadley and Hamar signed the contract with Vail, of Santa Fe.

At Tuesday's meeting, Kube expressed displeasure with some of the bid specifications.



#### Texas

The Mexican army approached San Antonio through the hilly country from the northwest, and was not detected by Texian scouts, even though Mayor John W. Smith was warned last Friday, September 9, by Antonio Parez, a leader of the loyal Mexicans, that an invasion army was en route. The rumor was

discounted as being caused by a party of raiding bandits, not uncommon in the area. Nevertheless, the citizens arranged to assemble at the Maverick house in case of alarm, to make a stand if necessary.

Woll's army surrounded the city before dawn yesterday morning. The Mexicans started the attack when they heard the Texian reveille, thinking it was their own. Heavy fog made fighting all but impossible. When it cleared, the Texian saw the overwhelming odds they were facing, and accepted a truce, explaining that they thought

they were fighting a marauding band of thieves. They wished to surrender as prisoners of war, but Woll insisted that they surrender "at discretion," that is, unconditionally. Nevertheless, he has guaranteed them their lives, saying that he was "moved by a spirit of humanity and in order that they might recognize Mexican generosity." They are also permitted to retain personal belongings.

The Mexicans took 62 prisoners, but are releasing 10, consisting of five Mexicans who have promised future loyalty, two merchants who did not bear arms, two youths, and a man who is too sick and lame to march. Of the remaining 52, many were participants in the court session of the Fourth Judicial District which has been in session in San Antonio. These include Judge Anderson Hutchinson; District Attorney C.W. Peterson and his assistant French S. Gray; lawyers Samuel A. Maverick and William E. Jones, who are both members of Congress; and Judge James W. Robinson, who was Lieutenant Governor of the Provisional Government of the winter of 1835-36. The prisoners are being kept in close guard in the Maverick house. Anglo-American women and children remaining in the city have not been molested, nor have the native Mexican families, most of whom seem to support General Woll and his troops. Some eight Anglo-Americans made their escape, including Mayor Smith, who has reached the town of Seguin, 37 miles northwest of San Antonio. He has sent and express messenger of Colonel Mathew "Old Paint" Caldwell at Gonzales, urging him to assemble forces at Seguin as soon as possible.

Captain John "Jack" Hays, with a small force of rangers, was reconoitering outside San Antonio on

In the past, the wiring would get wet when it rained. This sometimes interrupted service. The new wires will be buried in a cable, so they should not be bothered by weather.

The new wiring will eliminate any party lines in Farwell. All service will now be private.

The quality of toll service should also be upgraded.

The Public Utility Commission of Texas had stipulated that rate

changes could not be made until this service was completed. The rates were set at the same rates which were charged at the time ENMR purchased the equipment to serve Farwell in 1980.
