The dam, northeast of Highway 145, is needed in the event of a major flood. The shaft is bent on its gate. Someone with the expertise and equipment to fix it is needed.

And like all community service groups, they sure could use new members.





- Discussed last year's street paving project by Appian Construction, Hereford. Mrs. Christian said Appian is in Chapter 11 bankruptcy. Appian had been paid 95 percent of what it was owed, with 5 percent withheld because the state wouldn't approve the work.

# Cotton harvest completed early

#### By Judy Pomper

This year's cotton harvest went faster and smoother than usual, according to local gin workers.

"We're about 15 days early," said JaDon Gallman of the Farwell Gin. He mentioned good weather and the quality of the cotton as the reasons why the harvest moved so smoothly.

"If you have more trash and more immature cotton, that slows down everything," he said.

Cotton bolls are harvested after the first frost when the bolls have opened and the fiber inside has had a chance to dry out. If there isn't a frost early enough, some farmers use chemicals to kill the leaves and force the cotton bolls and open up and dry out.

The cotton is then harvested with a cotton stripper which separates the cotton from the stems and leaves. It is stored in the field in modules about the size of a semi - trailer. Then it is hauled to the gin where the cotton is separated from the remaining seeds, leaves and other "trash."

Then it is wrapped in bales, and taken to a compress where it is classified and stored until it is sold.

Gallman estimated the harvest this year to be a little more than normal this year.

"The price is holding well," he added.

At the Lariat Gin, Leman Stancell offered the opinion that the harvest was a "lot better than last year, and a little better than most times."

Finishing the harvest a little early gave him a little time to put his feet up and relax. (Of course he will still be busy running the parts store in Lariat, but at least he will now have only one job to do instead of two.)


Stancell offerred the opinion that "everybody was surprised by the extra good quality (cotton) from this country."

Yaunda Martin of Lariat Gin noted that they had to work fast and furious, but they got the job done. "I've never had as busy a year as I have this year," she said. "We just sailed through harvest. The weather was just perfect," she said.


Normally there are several real windy days that keep the farmers from their work and several rainy ones that really slow down the progress of the harvest.

"Selling cotton isn't like selling other crops," said Martin. She explained that farmers don't get paid for their cotton immediately after they haul it to the gin. First it is ginned, and then hauled to the compress where it is classified and stored.

All of the cotton that a farmer has harvested is averaged together. "Each bale weighs 480-500 lbs. - each weighs different and each is classified different," said Martin.

The final check the farmer receives depends upon the average of the total cotton crop the farmer has brought to the gin.

"It may be one to three weeks after the cotton is brought in before you can sell it," said Martin. "It's a long drawn out process, and it just takes time."

According to Martin one thing that remains the same is, every year is different."





The four main points made by community representatives were:

They have also received grants from the Texas Forest Service to purchase fire - fighting equipment and the Texas Department of Health to purchase medical supplies.

"We couldn't have gotten this equipment without their help," said Glen Schueler.

The truck was acquired at no charge to the Department by applying to the Texas Forest Service under the Federal Excess Property program. Equipment acquired under this program is designated for fire control use. A fire department is responsible to insure and maintain the equipment under contract with the Texas Forest Service. Rhea Hollene has received help from the Texas Forest Service programs since their start in January 1992. They have received a 5,000 gal. tanker, 1977 Dodge 4x4 pickup, cost share of \$1431.33 for a Pump Unit for the pickup, Cost Share of \$241.81 for Dry Hydrants. They have also purchased new bunker gear at wholesale prices under the Fire Safe Fund program.

Schueler said Rhea-Hollene applied to the Forest Service for another grant to purchase fireproof clothing for the men on the force. They then used the money to purchase the gear from the Forest Service at wholesale prices.

"They said it would buy gear for 4 - 5 men and we bought gear for 8 - 9 men through the Forest Service," he said.

Rhea Hollene has also gotten the equipment to hook up dry hydrants to irrigation wells, turning them into instant fire hydrants in the middle of the country.

According to the Rhea firefighters, Texas Forest Service funding has been cut by the last two Texas legislatures and Congress. TFS can't help all fire departments with needed equipment when funds are continued to be cut. When this happens costs for needed equipment has to come from other local sources.

Rhea-Hollene asks that local folks write or call their state and U.S. Representatives and Congressmen to let them know how much you appreciate this funding.

Rhea-Hollene fire fighters have also received notice of funding from the Texas Department of Health to enable them to purchase \$638 worth of first response medical supplies. When they get the funding, the department plans to purchase an oxygen inhalator unit and bag resuscitators.


#### A Procedure for Success




