Farwell Schools earn very high test scores

The Farwell School District earned very high scores in the recent Texas Academic Excellence Indicator System, reports high school counseor Weldon Killough. The public hearing to discuss the test results was held Monday at the superintendent's office.

Texas gives its schools four ratings, in descending value: exemplary, recognized, academically acceptable and academically unacceptable.

Farwell Schools received "exemplary" status for the junior high school and high school, and recognized status for the elementary school.

Last year, Farwell High was the only one of the three campuses to gain the exemplary status. Farwell will receive \$1,500 from the state (\$500 per school) for its excellent rankings.

"I'm very proud of our scores," said Supt. Richard Boothby. "And I want to thank our principals, teachers and staff for their outstanding work to gain these high ratings."

Killough said special mention should be made of the three campus coordinators "who did a great job" -- Patsy Camp, high school; Kay Ray, junior high, and Robin Gregory, elementary.

"There's a lot of work that goes into achieving these scores," added Killough. "The teachers did a great job."

Farwell High School Principal noted that Farwell receives calls from schools throughout Texas asking advice on improving their scores and wondering how such a small rural school can achieve such excellent scores.

Accompanying this article is a graph listing Farwell's averages. Here are the totals, and comparisons to last year: reading, 92.2 percent, compared to 92.6 percent in 1996; writing, 97.5 percent, compared to 98.0 percent last year; math, 94.4 percent, compared to 91.2 percent last year.

Lazbuddie School scores high on TAAS

Lazbuddie Schools missed by a sliver of receiving exemplary status from the state on the 1997 TAAS results.

School Supt. Phil Warren reported that all scores were over the 90 percent critera, except for math, which was 89.4 percent.

By that .6 percent miss, Lazbuddie received recognized status, one step below the highest, exemplary.

Lazbuddie reports its scores as one campus. Here are the latest results, plus those from 1996:

Reading -- 92.3 percent, up from 88.7 percent in 1996.

Writing -- 94.1 percent, up from 86.8 percent in 1996.

Math -- 89.6 percent, up from 80.4 percent in 1996. How do those results com-

Texas offers pre-pay college tuition fund

Parents today are bombarded with horror stories of the skyrocketing college costs they must soon face to provide their children with a decent education.

It is a well-known fact that costs multiply tremendously each generation. Based on current trends, it has been predicted that by the time a baby born today reaches age 18, the cost of college tuition and fees will quadruple.

However, the state of Texas offers a program to answer this growing problem. Called the Texas Tomorrow Fund, the new Texas Prepaid Higher Education Tuition program offers a unique way to pay for children's future college tuition and fees by locking those costs in today.

The program allows parents to make long-term plans for their children's higher education costs that still fit into today's household budgets. By enrolling in the program before the specified date, parents enter into a contract which provides them the option of systematically saving for their children's college at current costs.

The Texas Tomorrow Fund allows parents to prepay their children's college tuition and required fees and lock them in today. As long as the child has not finished high shcool, parents can prepay 1, 2,3, 4 or even 5 years of college in a single lump sum, annual lump sum payments or with several affordable monthly payment plans.

The contract covers the tuition and required fees at any state-supported college and university in Texas and can give students a big boost toward covering costs at a private or outof-state school.

The Fund is flexible and offers a variety of plans and payment options which can be switched later if the student's needs or financial situation changes. The most common plan chosen is the four-year senior public university under the payment option of monthly installments.

The Texas Tomorrow Fund is undoubtedly something to be considered as parents plan for their children. Cash awards of \$500 to \$5,000 per schools were given on the school enrollment statistics. A total of \$2.5 million is being awarded to schools this year under TAAS.

Gregory to be next Farwell sup't

The Farwell School Board met Monday and the decisions it made indicate that Farwell High School Principal Larry Gregory will become the new Farwell superintendent following the retirement this summer of Supt. Richard Boothby.

Under state law, the board could not simply name a new superintendent. It has to post the name(s) of candidate(s) being considered for the post for 21 days, then vote on it.

Last month, the board had voted to conduct a superintendent's search.

But on Monday, the board voted 4-3 to rescind that decision and just post Gregory's name for the 21 days needed.


The three board members who voted to oppose rescinding the search were not voting against Gregory, but were

PUBLIC NOTICE

Southwestern Bell Telephone Company (Southwestern Bell) filed an application with the Public Utility Commission of Texas (PUC) to charge an additional 26 cents per month per line to recover costs for providing Expanded Local Calling service (ELC) to certain Texas Customers.

The 26 cents per month surcharge would not be billed to customers who receive ELC. However, customers who receive ELC and pay less than the maximum \$3.50 a month residential ELC charge or less than the maximum \$7 business ELC charge will have to pay the additional 26 cents per month charge.

Expanded Local Calling was created in 1993 by Texas legislation that requires telephone companies to provide toll-free calling between small towns that share a community of interest such as a school or hospital district. The legislation allows telephone companies to recover costs not paid through customer charges by applying a surcharge to all other customers in the state who do not receive the ELC service or who do not pay the maximum ELC rate. The maximum monthly ELC rate allowed under state law is \$3.50 per line for residential customers and \$7 per line for business customers.

Southwestern Bell estimates that the 26 cents per month per line charge will recover the \$27 million annual cost of providing ELC service that is not recovered from ELC rates.

If approved by the PUC, the monthly statewide surcharge of 26 cents per line per month will begin with the April, 1998 billing cycles, with an agreement to refund all or part of the charge if the PUC does not approve it.







### **GOD LOVED ONE: HATED ANOTHER**

"Jacob have I loved, but Esau I hated" (Rom. 9:13). Does this mean that God is a respecter of persons? Certainly not. Peter. "Of a truth I perceive that God is no respecter of persons" (Acts 10:34). Paul: "Is there unrighteousness with God? God forbid" (Rom. 9:14). The potter has right to make one vessel to honor and another to dishonor; but it must be remembered that the clay is not passive; it is not inert.

God's love for Jacob and hatred for Esau was not expressed until after the children were born (cf. Malachi 1:2f). The statement means that God approved of Jacob and disapproved of Esau.

God elected Jacob not for eternal salvation, but for leadership of Israel. God purposed and approved of Jacob to be the leader of the Jewish nation. This is clear from the Genesis record. God spoke to Rebecca. "Two nations are in thy womb, and two peoples shall be separated from thy bowels: and the one people shall be stronger than the other people; and the elder shall serve the younger' (Gen. 25:23). The Almighty God knows everything. He looked upon two unborn children and chose (elected) the younger to become head of his chosen people, the Israelites. God made His choice, knowing that Jacob could be entrusted with this vital role. Thus he loved (approved) Jacob. "The elder shall serve the younger" (Rom. 9:12). This is a reversal of the usual order. There is no indication that Esau ever served Jacob in a personal way. But the nation of Esau (Edomites) did serve the Israelites (1 Chron. 18:13). This points up the fact that God's election, in this context, was election of a leader for a people, a nation. Isaac willed that Esau should be chosen; Esau ran for the venison (Rom. 9:16). Neither Isaac's will nor Esau's running could change the purposes of God.
