What we have to do is remove the Saddam's and Ghaddafi's from this planet. We must be aggressive.



"As a community, we have all been deeply affected by the events that have been occurring in our nation last week. We would like to help our nation in this time of need. We will be taking donations to send to the victims and their families in New York.

" If you would like to help, it would be greatly appreciated. There will be donation boxes at the Farwell elementary and high schools. We will take donations every week and send the money to the American Red Cross on Fridays. From there, your donations will be forwarded to New York.

"In this time of need, your donations will not only be greatly appreciated, but they will also be very helpful."

The tragedies in New York City and Washington D.C. last week hit very close to home for several area

Tiffany Boehnning of Lazbuddie had a very anxious day of waiting to hear from her brother, Air Force Lt. Col. Curtis Reynolds, who works in the Pentagon.

Their mother, Pat Angeley, of Muleshoe, reported that Curtis' office with the Air Force was located in the part of the Pentagon that was hit. However, due to the recent remodeling at the Pentagon, all of the Lt. Colonels' offices and meetings had been moved to an air base located 20 miles south of the Pentagon.

The original 888 persons missing that was first reported represented the number of personnel that would have been in that particular part of the Pentagon under normal circumstances. The rosters for that section indicated the people to be in house, but the majority of the personnel had been temporarily relocated due to the remodeling.

"We are just extremely grateful that Curtis was not there," said Pat. "We truly understand what a close call

it was for our family."

Pam and Jerry Monk of Farwell were anxious to hear from their daughter and son-in-law, Leslie and Todd Reves. The couple live in Fredricksburg, Va., about 60 miles south of Washington. Todd is an attorney at an independent Maritime Law firm in D.C.

Todd had just driven by the Pentagon about five minutes prior to the plane crash. The parking lot where he parks is at the Ronald Reagan building located next

to the Pentagon. "He normally takes the train into work, but had driven in Tuesday," said Pam. "He wasn't able to get home that night until very late, so he was in D.C. that whole day."

Todd was in the Army for three years and worked in the military Secret Service. According to Pam, he sees this situation from a very unique perspective and has been able to shed some light on this act of terrorism for

Todd is also brother to Hayley Christian, of Oklahoma Lane, and Roxanne Holt, of Muleshoe.

Another close call was for a good friend of mine. Bill Winter, of Dallas, who works for a U.S. municipal bond brokerage firm that was headquartered in the World Trade Center on the 105th floor of the north tower. Bill had gotten to his Dallas office early Tuesday morning to hold a tele-conference with his boss in New York City and other offices around the nation.

They were all on the phone when the plane crashed into the building.

"I heard everything for about 3 minutes and then the line went dead," said Bill. "We still don't know who made it out, if any, from our company. I was supposed to be at that office on Friday for a big meeting, too. To say that I'm shaken up is putting it lightly. We are all just really worried about our co-workers up there...we're all a big family, even though we're all across the country from each other. I talked with those people every day on

The polling place remains at Rhea Community Center, 307 FM 2013, Rhea, Parmer County, Texas. **VOTING BOX NO. 301**

The polling place remains at Farwell Community Center, 207 9th Street, Farwell, Texas.

VOTING BOX NO. 302

This polling place remains at the Oklahoma Lane Methodist Church, 645 FM 1731, Parmer County, Texas.

VOTING BOX NO. 303

This polling place remains at Bovina Ridgelea School, 1000 Hwy. 86, Bovina, Texas. **VOTING BOX NO. 401**

This polling place remains at the Lazbuddie School, 673 FM 1172, Lazbuddie, Texas. **VOTING BOX NO. 402**

CONSTITUTIONAL AMENDMENTS Special Election NOVEMBER 6, 2001

PROPOSITION 1 (HJR 52)

Proposition 1 would amend the constitution to relinquish the state's claim to certain disputed land in Bastrop County. The amendment would confirm legal title ests, to the individuals who hold a disputed title to the land. The amendment would prevent a loss of title by people who bought and paid for property that was never transferred by the state because of faulty surveys.

the ballot as follows: "The constitutional amendment providing for the clearing of land titles by the release of a state claim of its interest to the owners of certain land in Bastrop County."

PROPOSITION 2 (SJR 37)

Proposition 2 would amend the constitution to establish the process for issuing up to \$175 million of state general obligation bonds and notes to provide aid to counties for access road projects to serve border colonias. Generally, a colonia is an economically distressed geographic area with inadequate public services (such as water supplies, sewer services, or paved roads) in a county without adequate resources to provide such services. These projects could include the construction of access roads, the acquisition of materials used in maintaining those roads, and projects related to the construction of those roads, such as road drainage. The Texas Transportation Commission, in consultation with the Governor, would be authorized to determine what constitutes a border colonia
The proposed amendment will appear on for purposes of selecting the counties and projects that would receive assistance.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the issuance of state general obligation bonds and notes to provide financial assistance to counties for roadway projects to serve border

PROPOSITION 3 (SJR 47)

Proposition 3 would amend the constitution to authorize the legislature to exempt green coffee and raw cocoa held in Harris County from property taxes in order to qualify Harris County as an exchange port for coffee by the New York Board of Trade. The authorization of exemption would not apply to any other county.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize the legislature to exempt from ad valorem taxation raw cocoa and green coffee that is held in Harris County."

PROPOSITION 4 (HJR 1)

Proposition 4 would amend the constitution by setting the term of the fire fighters' pension commissioner at four years. The constitution currently provides that the duration of all offices not otherwise fixed by the constitution may not exceed

PROPOSITION 5 (SJR 32)

Proposition 5 would amend the constitution to allow a municipality to donate outdated or surplus equipment, supplies, or other materials used in fighting fires to purchase of needed equipment." to that land, excluding any mineral inter- an underdeveloped country. Current state law does not allow anything of value belonging to the state or its political subdivisions to be donated to another

PROPOSITION 6 (HJR 45)

Proposition 6 would amend the constitution to require the governor to call a special session of the legislature so that the legislature can appoint presidential electors when the governor determines that it is reasonably likely that the outcome of the election for a presidential candidate's electors will not be clearly determined in time for the appropriate electors to meet before the federal deadline to cast their votes. Under current law, when the people vote for a particular candidate for president, in reality they are voting for that candidate's electors who will meet to cast their votes for president. If the electors are not determined by the certification date, no electoral votes may be cast for the state. The proposed amendment ensures that the state's electoral votes will be cast.

PROPOSITION 7

Proposition 7 would amend the constitution to authorize the Veterans' Land Board to issue and sell up to \$500 million of additional general obligation bonds to finance additional home mortgage loans to veterans. Additionally, the proposed amendment would authorize the Veterans' Land Board to use assets from the land and housing assistance funds to create, operate, and improve veterans' cemeteries.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the Veterans' Land Board to issue up to \$500 million in general obligation bonds payable from the general revenues of the state for veterans' housing assistance and to use assets in certain veterans' land and veterans' housing assistance funds to provide for veterans cemeteries."

PROPOSITION 8 (HJR 97)

Proposition 8 would amend the constitution to allow the legislature to authorize the Texas Public Finance Authority to issue and sell up to \$850 million of general obligation bonds. The proceeds of the sale of the bonds would pay for con-The proposed amendment will appear on struction and repair projects or for the purchase of needed equipment by the General Services Commission, the Texas Youth Commission, the Texas Department of Criminal Justice, the

Proposition 9 would amend the constitution to authorize the legislature to provide for filling vacancies in the legislature without an election if only one person is a qualified candidate in the election to fill the vacancy. Under current law, a special election must be held to fill a vacancy in the legislature even if there is only one qualified candidate.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the filling of a vacancy in the legislature without an ty." election if a candidate is running unopposed in an election to fill a vacancy."

PROPOSITION 10 (SJR 6)

Proposition 10 would amend the constitution to authorize the legislature to exempt certain items of personal property from property taxation by political subdivisions of the state if the property is warehoused temporarily in a location in Texas to be assembled, stored, manufactured, processed, fabricated, or repaired and then forwarded to another location inside or outside Texas. The proposed amendment would authorize a political subdivision that imposes ad valorem taxes, at its option, to tax this type of property after a local public hearing on

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to promote equal tax treatment for products produced, acquired, and distributed in the State of Texas by authorizing the legislature to exempt from ad valorem taxation tangible personal property held at certain locations only temporarily for assembling, manufacturing, processing, or other commercial purposes."



PROPOSITION 15 (SJR 16)

Proposition 15 would amend the constitution to create the Texas Mobility Fund, which would be administered by the Texas Transportation Commission. The Fund would finance the construction, acquisition, and expansion of state highways and would pay a portion of the costs of public toll roads and other public. transportation projects. PROPOSITION 17 (HJR 53)

Proposition 17 would amend the constitution to allow the state to relinquis claim to certain state land and to clear title defects for persons who claim title to those lands. The proposed amendment would apply to land whose owners have disputed title to the land, but for which no patent from the state, giving clear title to the land, was ever issued. Among other requirements, all of the taxes due on the land must have been paid. Under current law, there is no procedure allowing the state to settle title disputes without a constitutional amendment for each piece of land in dispute.

The proposed amendment will appear of the ballot as follows: "The constitutional amendment authorizing the legislature to settle land title disputes between the state and a private party.'

PROPOSITION 18 (SJR 49)

Proposition 18 would amend the constitution to authorize the legislature to create a program to consolidate and star dardize the collection, deposit, reporting, and payment of criminal and civil court fees. If the legislature creates such a program, any new fees imposed by the legislature may not take effect before January 1 of the following year, unless an earlier effective date is approved by a vote of two-thirds of the members of each house of the legislature.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to promote uniformity in the collection, deposit, reporting, and remit ting of civil and criminal fees."

PROPOSITION 19 (HJR 81)

Proposition 19 would amend the constitution to allow the Texas Water Development Board to issue up to \$2 billion of additional general obligation bonds. The Board issues bonds to pay for water supply projects, water quality wastewater facilities, and projects for economically distressed areas. Current law limits the amount of bonds that the Board can issue.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the issuance of additional general obligation bonds by the Texas Water Development Board in an amount not to exceed \$2 billion."

But we have to remember that most Arabs and Moslems are good, decent folks just like you and I. It's the extremists, and the thug leaders; that have to be eliminated.

What happened then was then. Now is now. And now is the time for all Americans to unite to defeat a common enemy -the terrorists who seek to bring violence to our shores.



Farwell raises water charges

Farwell Council on Tuesday hiked the basic rate for water usage by customers from \$7.60 a month to \$20 a month, effective Oct. 1.

The big increase is needed to help pay for the land acquisition for new water well sites.

Attending the session were the engineer for the project and representatives of the Panhandle Regional Planning Commission.

With the help of the PRPC, Farwell has received a \$250,000 state grant.

Also, the city is planning to issue notes over a period worth 5-year \$375,000.

Those amounts are necessary to buy land east of the city and build wells there.

Mayor Jimmie Mace said the goal is to have four new wells pumping by April.

So the city is proceeding with the land purchase and wells' construction to ensure water for the ctiv's future.

At the meeting, a progress report was made on the purchase, easements. legal descriptions, etc. The city is dealing with several property owners.

In other business, the council:

-- Heard that Duncan Disposal was raising the fee they charge the city for trash pickup a bit.

The city charges customers a little more than Duncan charges it.

So it appears that the city will not raise its rates -- \$15.90 for residents, and \$17.90 for small businesses and non-residents.

Those amounts are still higher than what Duncan will charge the city, effective Oct. 1.

-- Discussed a problem with alcohol being served at functions at the Farwell Community Center. The city's rule is that alcohol cannot be served.

Also, a problem with trash thrown outside after some functions was cited.

decisions were made. The question was: how do you enforce the alcohol and trash issues.

-- Adopted a tax rate of .4696 cents per \$100 assessed valuation, up 3 percent over this year.

-- Okayed revising the weeds and junk ordinance to include more items, (Continued on Page 13)




