Kidnapping charged

It started Sunday when Jarrod Franse looked outside of his Farwell house and saw someone looking into his pickup truck.

When he went outside to see what was going on, two guys jumped into the truck.

Franse was unable to open the door as they began driving the truck away, so he hopped into the back, reported Parmer County Sheriff Randy Geries.

The driver tried to "shake" Franse out of the truck, but failed. Meanwhile, Franse yelled at some folks along the street to call 911. One did.

The sheriff's office was on the lookout for the truck but unable to sight it.

But about 80 minutes later, the two guys baled out of the truck near FM1524 deep in Castro County.

Franse got to a nearby farm house and called the Castro County sheriff's office.

Parmer County sheriff's deputies also showed up, with their drug-sniffing dog.

The dog found one of the two suspected hijackers in a circle of feed -- an 18-year-old Clovis man.

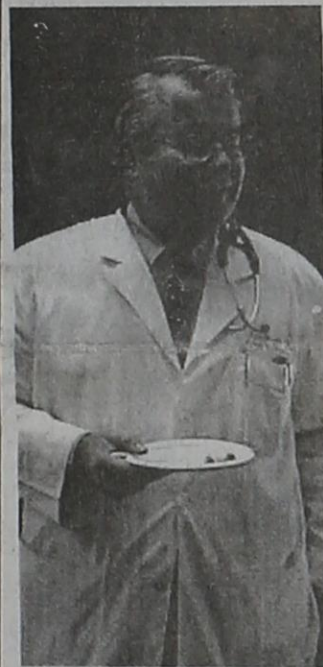
Then, Geries said, in the wee hours of the morning, a 16-year-old Clovis juvenile, without shoes (he had run out of them), went to a nearby farmhouse and turned himself in.

Joe Roldan, 18, of Clovis, was charged by the sheriff's office with aggravated kidnapping and unauthorized use of a motor vehicle. The case is pending before the grand jury.

Commissioners approve county redistricting plan

The Parmer County Commissioners on Monday approved a proposed precinct redistricting plan.

As expected, it basically makes changes in the City of Friona.

The county's four precincts needed to be redistricted due to the 2000 census and Voting Rights Act.

The 2000 census showed Pct. 1 (Kirk Frye) losing 70 persons; Pct. 2 (Tom Ware) gaining 226; Pct. 3 (Ed Corn) losing 22; and Pct. 4 (Raymond

McGehee) losing 134. A formula was used to calculate the deviation between the four precincts. Because it was over a certain percentage, the redistricting must get U.S. Department of Justice approval.

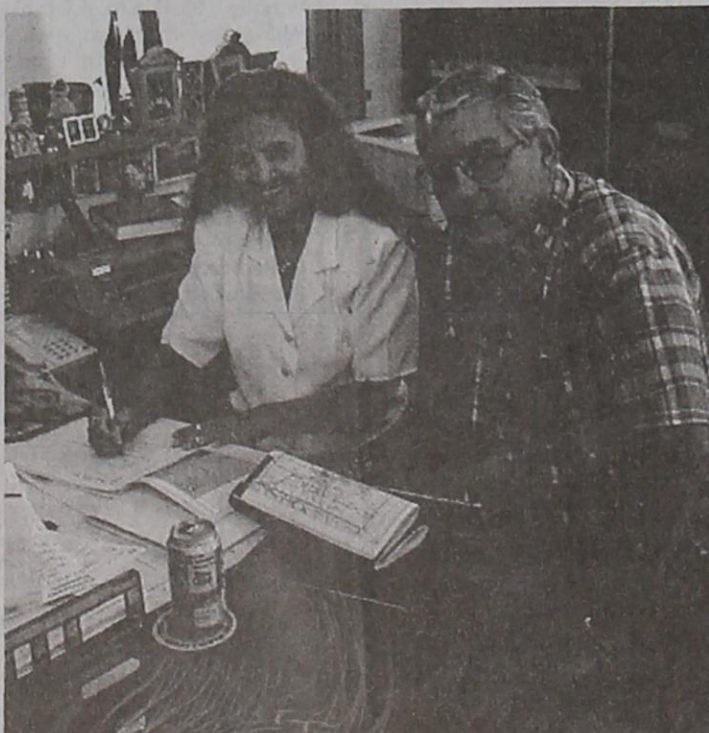
After final approval is given this plan, then the county will send out letters to all county residents informing them of which precinct they are in. Other decisions made by the commissioners were:

the least amount of people," said Ware. "And still abide by the legal requirements."

Federal guidelines mandate that at least one precinct in Parmer County maintain a majority of minority (Hispanic) voters. This guideline was met.

Thus, although the commissioners, aided by an advisory committee which met with them on Monday, favor the plan, it still must be okayed by the federal government. This approval may not be received until next year.

Here are the plan's major changes:

** Pct. 3 -- (Corn's precinct) -- This precinct added six blocks in the city of Bovina, mostly at its southeast and western edges.

The major change for the Bovina folks added to Pct. 3 is that they will now vote at Ridgelea School.

Also, the Oklahoma Lane voting area has been expanded to include the western half (roughly) of FM3333.

This means that these folks will no longer vote at the Farwell Community

Center, but at the Oklahoma Lane voting box. The folks have asked for this because it means a much shorter drive.

** Pct. 4 (McGehee's precinct) picked up two areas in the city of Friona -- an area north of Highway 60, and an area off Grand Avenue.

These areas previously were in Pct. 1 (Frye's precinct). These folks will now vote at the Friona Fire Station.

** Pct. 1 (Frye's precinct) picked up an area mainly west of Highway 60, that had been in Pct. 2

(Ware's precinct). So instead of voting at the Friona Community Center, they will vote at the Calvary Baptist Church.

The commissioners have scheduled four public meetings on Aug. 29 for persons to discuss the proposal:

9 a.m., Friona State Bank community room.

11 a.m. -- First Bank, Bovina branch, community room.

2 p.m. -- Lazbuddie School.

4 p.m. -- Parmer County Courthouse community room in Farwell.

COTTON: December Cotton prices were able to reach short term targets this week and have so far held support around \$38.30. There is still an outside chance to see a bounce back toward the \$41.00-42.00 area, but overwhelming supplies are likely to take prices lower on the next drop?

CORN: December Corn closed above the \$2.30 level this week which turned short term trends higher. There is some resistance at \$2.38 and then \$2.47. Thursday had a great close. Friday gave some of that gain up. Need to see prices back above \$2.33 next week.

WHEAT: December Chicago Wheat turned short term trends higher this week. Prices project upwards to the \$3.00 level over the short term. Support levels around the \$2.83 must hold trends intact. Long term prices project towards the \$3.10 and \$3.35 area.

SOYBEANS: Soybeans have yet to turn trends higher, but a close above \$4.93 basis the November Soybeans would be enough to give prices a boost. Soybeans are still weary of good rainfall throughout the Mid West. A break below \$4.73 would push prices lower.

LIVE CATTLE: October Live Cattle prices broke major support this week below \$73.90 and prices have traded back towards the \$73.00 level. Cattle usually trade down into Labor Day, but we were hoping to see support hold since prices broke hard into early August. Down into Labor Day.

FEEDER CATTLE: October Feeders also broke their support levels at \$89.50 and have since traded lower. Only support now is \$88.65. A close below this level would most likely push prices even lower. Short term targets would be into \$87.75 area. Short term trends have turned down again.

Corn arrives very early

Lonnie McFarland, at the Sherley-Anderson grain elevator in Lariat, reports that the first load of corn arrived on Aug. 20 -- the earliest he ever remembers.

It was brought in by Steve Kaltwasser, who received the \$50 check for being first in.

The corn had a moisture content of 19.8 and the test weight was 56.7.

McFarland said some farmers are planting a variety of corn that has an early maturation.

Gary Haseloff won the \$50 from the Sherley-Anderson-Pitman grain elevator in Farwell for bringing in the first load of corn on Aug. 27.

Fred Chandler reported that the moisture content was about 21 and the test weight was 55.

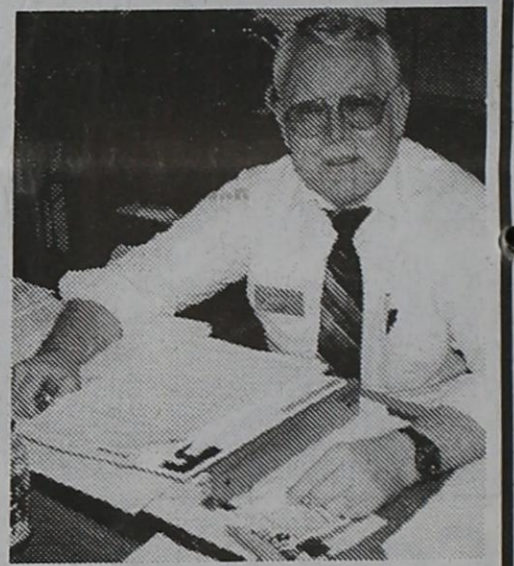

Texas bill passed adding \$225 to vehicle fee if you buy it out of state

Texas State Sen. Teel Bivins, whose district includes Parmer County, formulated Senate Bill 5 that would require vehicles brought into the state to have the Vehicle Identification Number (VIN) verified and pay \$225 prior to the vehicle being registered and titled in the state.

This bill was passed by the state legislature in May and will go into effect Nov. 1, 2001.

Any out of state or country registered vehicle presented for inspection on or after Nov. 1, 2001, to be titled and registered in the state of Texas is required to have

the new Form VI-30 completed -- and pay the \$225 fee.

The only exceptions to this are vehicles owned by military personnel or their dependents. They must then provide a copy of documentation verifying their military status to the inspector.

This bill has the Clovis and Portales car dealers up in arms, as well as the area certified inspector, Robert White, who owns Tri County Tire in Farwell.

"This new law is absolutely ridiculous!" White stated in an interview Tuesday. "I don't know what he's (Bivins) trying to do."

"What they (the legislators) don't realize is the majority of folks that live on the borders of these neighboring states shop with the dealers who are the closest to them and that's over the state border into Clovis, Portales and the larger towns closest to them," White commented. "This doesn't just affect us right here, it affects two neighboring state lines and the Texas residents that live along these borders. It even goes over into Kansas for those living in the top of the Texas Panhandle that buy vehicles in Kansas."

But new vehicles are not the only concern with the passage of this bill. Any and all vehicles brought into Texas for inspection, registration and title are to be charged the \$225 and have the VI-30 form completed. This only translates to higher costs for the consumers of new and used automobiles.

It is also a lot of paperwork to keep up with in addition to the standard inspection paperwork. And it's not something that will make an inspection station a lot of money either.

"I'll get \$5 off of each \$225 inspection," White said. "Plus, several more sheets of paper to keep here in the office and to mail off."

Also effective Nov. 1, 2001 will be an increase in the fee for commercial vehicle inspections. It will increase to \$60 for both windshield and trailer inspections.

As of Tuesday morning, nothing had been set up yet.

Chamber members are unhappy about this bill becoming legislation. Farwell City councilman Don Geries plans to bring up the topic at the next

city council meeting.

Bivins' district includes Parmer County.

In other business, the Chamber:

-- Said that an apple retail outlet was being built on 9th Street where apples are being processed by Top Of Texas.

-- Asked Cynthia Thigpen to check on getting Border Town Days banners up for next year's BTD.

There is a problem with the alignment of the poles along Avenue A and a place has to be found for the banners.

-- Plans to have ribbon cutting ceremonies for the owners of Farwell Hardware (Steve Meeks) and Hughes True Value (Pablo Lucio).

-- Waiting to hear on how much it would cost to buy a sound system that would be used at the Farwell Community Center and for Border Town Days.

Once the price is established, groups will be asked to donate to the purchase.

The BTD Committee has indicated it would help toward the purchase.

PCG seeks boll rule deviation

From Plains Cotton Growers Inc.:

With a record-setting July heat wave in the books and little or no rainfall during the key months of June and July, most observers are saying the dryland cotton crop on the Texas High Plains is finished except for the counting of the casualties.

With such a poor outlook it seems that making the case that the dryland cotton acreage remaining on the Texas High Plains has done all it is likely to do and has significantly reduced yield potential would be easy.

The situation seems to be pretty clear. The 2001 non-irrigated cotton crop has taken it on the chin following a dearth of rainfall in June, July and August.

Most observers agree that the end result will likely be the same, a large percentage of the dryland crop currently in the field will never make it to harvest. With such low yield prospects and the economic reality of historically low prices entering the equation, most

fields will not have enough yield potential to allow the grower to breakeven on the cost of harvesting the crop.

Plains Cotton Growers has been pursuing a deviation to allow growers to request and receive appraisals using a modified Boll Count method in lieu of the Stand Count method typically employed until mid-September.

The PCG request would not only allow the grower to get an appraisal based on the harvestable bolls in the field, it would also include a change in the factor used to calculate how many bolls it takes to make one pound of cotton.

The regular table assumes 350 bolls per pound while the modified table would utilize a 450 bolls per pound factor as determined through Texas Cooperative Extension and Texas Agricultural Experiment Station studies conducted in 1998.

Getting the deviation in place, however, is proving to be a formidable challenge.

The reality is that a key player in the decision to find relief for growers is taking a much different view of the crop.

It appears that insurance companies servicing cotton policies on the Texas High Plains see a crop that is drastically different and much better than what growers and Extension personnel are describing.

In fact they have apparently taken the stance that the High Plains' remaining dryland crop is, in fact, good enough that it does not merit any special consideration for the effects of the ongoing drought.

One potential sticking point for growers is the possibility of being charged Texas Boll Weevil Eradication Program assessments on cotton standing when the two newest zones, the Northern High Plains and Southern High Plains/Caprock, begin diapause operations September 3.

PCG has noted that the ability of growers to get adjustments on their crop and make timely decisions to take the acreage to harvest or fail it out could mean a savings of \$6 per land acre in eradication program fees.

With no deviation in place, growers who feel strongly that their crop will eventually be failed after a boll count appraisal should contact their crop insurance agent and ask if they have the option to leave representative strips in the field that can be adjusted at a later date.

If they leave strips they need to then contact the TBWEF zone office to request that the fields be remapped to include only the standing strips.

According to the TBWEF, growers in the two new zones who leave such strips, and who also totally destroy all other cotton in the field, will only be billed for Eradication assessments on the smaller acreage left in the strips.

The TBWEF policy works with growers to provide some small measure of relief by providing a method to only pay assessments on the modest amount of cotton that would have to be treated by the TBWEF for boll weevil in 2001.

Texico trash pickup fee increased

The Texico City Council on Tuesday received word from Duncan Disposal, which handles the city's trash pickups, that its fee was being increased 3 percent, to \$9.71 per household per month.

Under the contract, Duncan is allowed to raise its rates according to the Consumer Price Index each year. So the hike follows this guideline.

There are about 350 households in Texico. Currently, the city is charging each household \$8.50 a month for trash pickup. When the contract with Duncan was established years ago, the city's rate (charged homeowners) was set so that there was a surplus for the city. But now, with the deficit, the city likely will increase the rate it charges. Also, a special council committee has been set up to look at the city's water and sewer rates, with the likelihood that these will be raised, also.

In other business, the council:

-- Heard councilman Oran Jay Autrey report that the apartment complex project set for the Burrows property "is a go." He said the city needs to put in the water and sewer lines they promised, and the council gave the go-ahead to street Supt. Clarence Smith to buy the materials. Also, Police Chief Kelley Brophy said part of the

property needs to be cleaned up by the property owner.

-- Heard Smith report that water pressure on State Street needs to be improved, and they will look into the problem before the city pool reopens next summer.

-- Heard that there's a large pot hole at the south end of Anderson Street. But this is railroad property and the city has no jurisdiction over it. It's not a public roadway.

-- Allowed Brophy to buy two radars and a fax machine, plus to set up a secured fax line. The line will cost \$3 a month from Roosevelt County Rural Telephone Cooperative.

-- Approved a fence permit for Mary Foster, 519 State St.

-- Heard Autrey report that the city is still waiting for the state recommendations on the city's plans for a new City Hall. The city has been waiting for months.

-- Heard Autrey report he is drawing up specifications for a cemetery well.

-- Heard that one new street light has been installed and the city is waiting for others to be put in, too.

-- Had an executive session for personnel, called by Autrey.

Parmer prohibits wild animals

The Parmer County Commissioners on Monday approved an order prohibiting the keeping of wild animals in the county.

Previously, this rule has been maintained by the state wildlife division. But now they have given an unfunded mandate to individual counties -- take care of it yourselves.

Outlawed are:

Lions, tigers, ocelots, cougars, leopards, cheetahs, jaguars, caracals (a

wildcat of southern Africa and Asia), servals (a wildcat of Africa), hyenas, bears, lesser pandas, binturongs (a catlike mammal), wolves, apes, elephants, rhinos, bobcats, coyotes, jackals, wolverines and non-human primates and any hybrid of any aforementioned animals.


