## Three Companies Are Defendants In Anti-Trust Suit

AUSTIN.—Three companies, all with Texas offices, were made defendants in an anti-trust suit filed in 119th district court at Ballinger by the attorney general's department.

The state's petition alleges conspiracy to furnish and sell diesel engines and equipment to various cities to the exclusion of all other brands except Fairbanks-Morse and further control municipal elections and determine plans and specifications for building on construction in Jasper, Angleton, Sonora and Winters.

Along with his diploma he received a pair of Aerial Gunner's wings and a promotion in grade at brief graduation exercises held at Harlingen Army Air Field. After a delay in route to visit relatives, he will join an aerial combat team, unless retained at Harlingen to serve as a gunnery instructor.

He was prepared for his place in America's stepped-up air offensive by a comprehensive six weeks course in every phase of aerial gunnery warfare. Besides learning to fire every type weapon from camera guns to deadly caliber .50 Brownings, he studied turret manipulation, aircraft identification and learned to tear down and assemble machine guns while blindfolded. He climaxed the course by firing on towed targets from Texan training planes, medium bombers and Liberators.

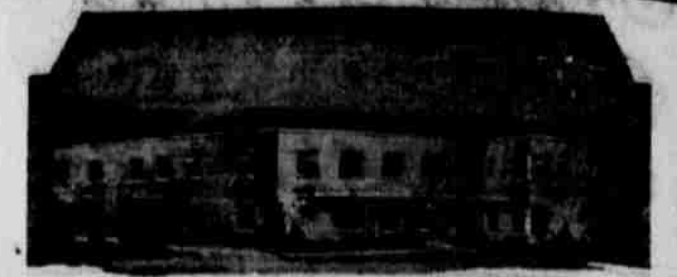

development for Lamb County. There is a prominent possibility of oil activity . . . and with oil development comes men and their families. The advance group is already here. What are we going to do with these people? We can't just shrug our shoulders and say: "Well, no houses is their hard luck."

**Housing Shortage Retards Growth**  
We cannot afford to stunt the growth of Littlefield. And a housing shortage will dwarf our development more quickly than most any other condition.

Included in any program of increased housing should be a number of three-room and four-room 100 per cent modern apartments. They could be built as individual units or could be constructed as a multiple development. The latter plan would take less material. Some or all of these apartments should be available for rent furnished.

Day in and day out people come into the Leader office inquiring about a place to live. We do our best for them, but the housing situation in Littlefield has become so acute that we can do practically nothing for these people.

We repeat:  
What can be done about the housing shortage in Littlefield?  
Surely there is a solution to the problem!

life. But in our zeal to win the war we must be on the alert to prevent permanent usurpation by ambitious, and possibly unscrupulous politicians, of the temporary dictatorial powers granted them in the emergency.

"The reconstruction period that will follow the close of the war will be serious times, and to make the change from war production to peacetime pursuits will require careful planning in order to avoid a collapse of our industrial and agricultural economy; unwise interference by theoretical experts with the natural economic laws could seriously hamper, or prevent, an orderly readjustment of our post-war problems.

"In the beginning I wish to emphasize that I am making this race strictly on my merits and not on the demerits of any opponent that I may have. It is my sincere wish that no mud-slinging will be indulged in this campaign, and that no foreign, inane or purely controversial issues will be injected. This is no time to be haggling over impertinent questions, and it is my promise that such things will not be indulged in by me.

"I was born and raised on a stock farm in Caldwell county, Texas. I am a graduate in agriculture from Texas A. & M. College, class of 1911. I managed a ranch in Bailey county from 1916 to 1918, and afterward served Lubbock and Randall counties as Agricultural agent for seven years. For the past 15 years I have been farming in Floyd county, owning, living on and operating my farm. Since this is an agricultural country and its problems are principally agricultural, I believe a dirt farmer who is otherwise qualified can render valuable service in our legislature. Since my entire life has been spent in agricultural work I feel that I can render that service.

"I believe firmly in government strictly within the limitations of our constitutions, both state and national. I believe in government of law and not of man, in "government of the people, for the people, and by the people." I am opposed to government by bureaus, boards and commissions with powers of law, court, and jury. It is my firm belief that if the constitution is to be amended that such amendments shall be enacted as provided in the constitution.

"I believe in the adequate support of our government in all of its necessary functions, but I am opposed to overlapping and duplicating boards and bureaus, and to those that perform no useful service to the public.

"I believe in the independence of the legislative, executive, and judicial branches of government, and that there shall be no encroachment on the powers and prerogatives of one branch by another.

"I believe in free and untrammelled courts, subject only to the limitations of the constitution, in order that justice may be done without bias or prejudice, and strictly within the purport and provisions of the law as interpreted by the courts.

"I believe in the uniform enforcement of all laws so long as they remain on the statute books, with equal rights to all and special privileges to none, and the repeal of useless and unjust laws.

"I am for the adequate support of our educational institutions, both the common free schools and the institutions of higher learning, and our eleemosynary institutions, the blind, the deaf and dumb, and the insane.

"I am for the adequate support of the needy aged, the blind, the crippled and underprivileged children, but I am opposed to trying to create and maintain an Utopia for any class of our citizens. Self support and self preservation are still the first laws of nature. Industry

and frugality must as ever be encouraged among our citizens, if we are to maintain a free, independent, and solvent government.

"I am for a safe, sound, economical, and businesslike administration of our government, free from waste and extravagance. With the increasing demand upon our earnings to pay the cost of the war and to retire our national debt, state and local expenses must be held to a minimum in order to meet our obligations and to maintain a sound financial structure.

"I am a firm believer in State's

and individual rights with a minimum of interference and supervision necessary to proper governmental functions; also, in the good old American system of free enterprise that has made of America the greatest and richest country in the world, subject only to necessary protection against monopolies and the oppression of the weak by the strong.

"This is my first time ever to offer for elective office, and I have made no promise to any individual, clique, or clan, and, if elected, I promise to represent my district and my state as a whole to the very best

of my knowledge and ability.  
"On account of the gasoline and rubber shortage I know I will be unable to make an extensive campaign and, therefore, must depend upon my friends and others who would like to see me elected to assist in presenting my candidacy to the citizens of the district. Your vote and influence, I assure you, will be deeply appreciated.

came to this country at the age of 20 years, and is a World War I Veteran, who has also seen service in England, Tunisia, Sicily and Italy in the present conflict, delivered an interesting address on the splendid work done in European countries by the Red Cross.

Capt. Kenim came to this country during the last war, after his home was bombed and his brother and sister killed. He joined the service as soon as the United States entered World War I, and served overseas. He operated a business in Philadelphia for some years, but again entered service following the Pearl Harbor attack. He is back from the European war area about six weeks, where he served on a Liberator B-24 four-engine bomber, and in his talk Friday night described two missions he had taken part in. Capt. Kenim's crew of a B-24 Liberator has received presidential cita-

tion for their anti-sub work in the European theatre of war. Capt. Kenim read the citation

with which the Silver Star was presented to James P. Shaw in the Sicily campaign. Mr. Shaw is a Red Cross director, and risked his life repeatedly, aiding in the rescue of American soldiers, after a direct hit on a landing craft.

The captain related his observance of the wonderful work of the Red Cross in England; and of the Angels of Mercy, many of whom were killed in service in Tunisia, Sicily and Italy.

He said, "While our boys are over there, let's do all we can for the Red Cross, because they're doing all they can, for them."

A-C John Kokes, who came to this country from Czechoslovakia at the age of 14, was taught his first flying in Chicago, joined a Czech squadron of the RAF at Montreal, Canada, at the age of 18, served 11 months overseas over enemy country, from a British airbase, and now qualifying for an American pilot, stationed at the Lubbock Army Airfield, gave a very interesting address on his experiences in Europe and his work.

A-C Gerald Jaquess, also of Lubbock Army Airfield, a son of Mr. and Mrs. L. W. Jaquess of Earth, and a brother of Mrs. L. M. Brandon, Executive Secretary of Lamb

County Chapter of Red Cross, also gave a splendid talk on the many services rendered the servicemen by the Red Cross both at home and abroad.

Red Cross workers from all over the county were present. All communities were represented with the exception of Hart Camp, which community reported a play being held at the school, at which time the Hart Camp committee planned to contact the people of that community, and hoped to make considerable progress that evening on the securing of their Red Cross quota.

Mr. Shaw gave instructions on the Red Cross campaign to the committees and their assistants, on the breaking down of the various communities and offering suggestions, and the assignment of workers to contact all people over the county.

Mrs. Roy McQuatters, chairman of Red Cross War Fund for Spade Community, and Mrs. Elmer Bentley, J. R. Kuykendall and T. S. Tyler, assistants, were given recognition for the splendid work done. Spade community up to Friday night had subscribed over \$1,000 of their \$1,334 quota. They started their campaign Monday of last week, due to the fact that the Chairman is obliged to be absent from her home on

the week of March 20, when the drive gets underway over the county.

Mrs. L. M. Brandon, Executive Secretary of the Lamb County Chapter, was highly commended for her splendid work, and many services rendered by her to the servicemen since she has been in office.

W. H. Lyle, Sudan chairman, expressed his views, and pledged continued help in securing Spade quota in the 1944 drive. W. Cheaher, Littlefield, was credited with the idea of collecting funds for this drive by passing a box in the Palace and Ritz Theatres, of which he is manager, and these persons contribute in patriotic accord.

Recognition was given Mrs. C. McFall, operator of the Ashland Hotel, for the way in which her staff handled the large crowd, and for the appropriate decorations of the banquet room.

## To Give Aviation Cadet Mental Test Here Thursday

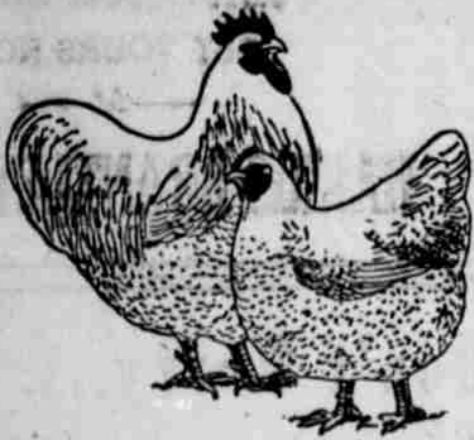

# REHABILITATION SCHOOL TO BE HELD AT LUBBOCK MARCH 21

The American Legion will hold a Rehabilitation School in Lubbock, Texas, at 9:30 a. m. on Tuesday, March 21, 1944, according to District Commander of the American Legion, O. K. Woodall, of Littlefield.

Commander Woodall says "the purpose of the school is to acquaint the men and women who have been discharged from the Armed Forces of the present war with the benefits they are entitled to from the United States Government."
