
Section 2 of Ordinance 3 reads in part as follows: No person shall park any vehicle except on the right side of the street and against the curb, and in LEAVING THE PARKING POSITION SHALL ONLY BACK SUCH VEHICLE FAR ENOUGH TO CLEAR SUCH OTHER VE-HICLE AS MAY BE STOPPED OR PARKED, AND IMMEDIATE-LY PROCEED ON THE RIGHT SIDE OF THE STREET.

Section 2 of Ordinance 35 reads in part as follows: It shall be unlawful for any automobile or other vehicle to be operated on the streets or ways of the City of Littlefield at a greater speed than 20 miles per hour.

Section 3 (b) of Ordinance 35 reads in part as follows: It shall be unlawful for vehicles to be driven or stopped abreast.

Section 3 (h) of Ordinance 35 reads in part as follows: Unless in an emergency or to allow another vehicle or a pedestrian to cross its path, no vehicle shall stop or stand in any public street or way in the City of Littlefield, except when parked at the curb as above described, nor shall any vehicle stop so as to obstruct a crossing or a sidewalk, nor within 10 feet of a fire hydrant.

The penalty for violation of any of these regulations is a fine of not less than \$1.00 nor more than \$200.00 and the Police Department has been instructed to see that all these regulations are enforced.

# THE ATTENTION OF ALL **CITIZENS IS CALLED TO THE FOLLOWING:**

Section 4 of Ordinance 13 reads in part as follows: That it shall hereafter be unlawful for any person, persons, firm, corporation, or association of persons to burn or cause to be burned any trash, scrap or waste lumber, boxes, paper, shavings, rubbish or any other matter or substance of any kind, in or upon any lot, tract, block, or parcel of ground within the business portions of the City within 25 feet of any building, and not then without having same confined within a wire screen or metal container or within some similar and safe basket, container or enclosure.

The penalty for violation of this ordinance is a fine not to exceed \$100, and the Police Department has been instructed to see that it is compiled with.

Qualified officers who have served for long periods in the same grade will be promoted on the first day of their terminal leave period under a policy announced today by the War desired to bring is to be had by the Department. This policy will benefit many officers who have been unable to secure promotion because of lack of authorized position vacancies.

The ruling applies to first and second lieutenants who have served in one grade 18 months, captains and majors who have been in grade 24 months, and lieutenant colonels in grade 30 months. In computing the necessary service, 50 per cent ad-

National Guard officers will be informed that a selection of commission in the ORC will provide for automatic termination of commission in the National Guard; should they select commission in the AUS, they will be notified that such commission is temporary and terminates automatically at the end of the emergency plus six months and will not affect National Guard status. Officers presently on terminal leave will be promoted quickly as promotions can be processed before reverting to inactive status.

All officers now on terminal leave and others who believe themselves eligible for promotion under the above provisions can contact local Army Recruiting Stations for additional information.

Heretofore, the veteran was re quired to start to school within two years after discharge or the end of the war, whichever is later. This is changed to four years, and instead of being compelled to complete his course of study in seven years, this has been extended to nine years after the end of the war.

Considerable change is made in the loan provisions of the GI Bill.

The maximum guarantee on real estate loans is raised from \$2000 to \$4000. However, guarantees are still limited to 50 per cent of loan, and guarantees on non-real estate remain at \$2000. Maturity of all non-real estate loans is set at 10 years. The amortization period on real estate loans is fixed at 25 years unless the real estate is a farm, in which case the period of amortization can be as long as 40 years.

The term "reasonable normal valne" has been a confusing and difficult requirement in making appraisals of the value of property. Under the new law, the term "reasonable value" is substituted, which will liberalize the act.





### CHAPTER III The Gas Is Conditioned for Transporting

In the previous chapter we saw how natural gas travels from a well through a meter house, through a field gathering line, and through a compressor station where it was squeezed into smaller space. Now what happens to it next?

Before starting on its long journey, the gas passes through a Gasoline and Dehydration Plant adjacent to the field compressor station. This plant removes gasoline and moisture from the gas to increase the efficiency of the pipe line system. If the gasoline were not removed, it would condense out in low spots in the pipe line and decrease the line's capacity. If the moisture, which is produced in vapor form with the gas, were not removed, it would, under certain pressure and temperature conditions, form "hydrates" which are similar to slushy ice. When formed, these hydrates accumulate in the pipe line, regulators and other facilities and restrict or stop the flow of gas.

The most important piece of equipment at the Gasoline and Dehydration Plant is the highpressure absorption tower, 75 feet tall and

weighing 123,000 pounds, which is used in our sketch to represent the plant. Actually, the plant consists of several buildings, steam boilers, heat exchangers, stabilizers, dephlegmators, generating plant, compressors, many pumps, and other auxiliary equipment, all quite complicated and scientific. The gas itself passes through only the absorption tower where the gasoline is removed by the use of absorption oil and the moisture is removed by the use of diethylene glycol, a liquid chemical which has a strong affinity for water. The absorption oil and the diethylene glycol are purified and used again, in continuous cycles.

Another advantage gained by drying or "dehydrating" the gas is that internal corrosion of the pipe line is held to a minimum, thereby reducing the roughening of pipe walls and the formation of scale and dust.

After passing through the Gasoline and Dehydration Plant, the gas flows into the highpressure pipe line. This is the main transmission line which brings the gas across the country to your city and other cities, passing through one or more additional compressor stations on its way.

West Texas Gas Company owns and operates five compressor stations; one at the gas field. called the Turkey Creek Station, the McSpadden' Station near Canyon, and the Plainview, Tahoka and Littlefield Stations. McSpadden Station is now being enlarged, and when this work is completed we will have in service 20 compressor units with a total rating of 4540 Brake Horse Power.
