Defeating the Brownfield Cubs, 53-13 at Brownfield Friday night, the Littlefield Wildcats achieved their eighteenth consecutive victory. The defending class A state champions were in command from the very beginning, utilizing a lightning offense that struck with awesome power. In outclassing their 4-A opponents, the potent Wildcats compiled what may be a high school record by rushing for a total of 613 yards. Their smooth machine was oiled into top condition, with Fullback Gene Renfro and Halfback M. C. Northam supplying the fuel. The two combined for 575 yards, each reeling off long gains with surprising consistency.

Little Hope Of Change In Cotton Picking Crisis

A very serious problem is facing the cotton farmers over the South Plains and the whole country in general, inasmuch as under the Child labor provisions of the Fair Labor Standards Act as amended in 1949, as applying to any crops or products that go directly or indirectly into interstate or foreign commerce, a farmer cannot work any person under 16 years of age during school hours. This, however, does not apply to farmers using their own families

in the gathering of the crops. Farmers Baffled Over Employment Regulations of Young Cotton Pickers

South Plains cotton farmers are finding themselves in a quandry over new regulations governing the employment of young cotton pickers. The new rulings, if violated, can result in dire consequences. For the benefit of the area's thousands of cotton farmers and farm owners the following is an explanation of new rulings as laid down by the U. S. Department of Labor: 1. Do the child-labor provisions of the Fair Labor Standards Act as amended in 1949 apply to agriculture? Yes, they apply generally to FARMERS WHOSE CROPS OR PRODUCTS GO EITHER DIRECTLY OR INDIRECTLY INTO INTERSTATE OR FOREIGN COMMERCE, as in the case of a farmer who sends his products outside the State or delivers his product to a canner, processor or dealer who he knows will send it outside the State, either in its original form or as an ingredient of another product. For example, tomato growers who send their tomatoes to a cannery within the same state are covered if the canned tomato product made from their tomatoes goes out of the State. The Act does not apply to a farmer if he sells only to dealers
