sponsored. Today this law protects the average citizen of Texas from ruthless swindlers.

"When your State Senator, I shall continue to do all in my power to carry out the mandates of the people by supporting those measures needed and wanted by the citizens of the 30th Senatorial District.

Today the aged people, the destitute and under privileged children, the needy blind, and teachers' retirement obligations have not been taken care of. My record proves I voted and actively supported all efforts in the last legislature for immediate payment of these social security obligations.

I will never quit the fight until justice has been done our needy aged, according to the overwhelming mandate of the people of Texas in 1935. As your State Senator, I shall continue to support all reasonable, adaptable and fair plans that will pay the social security bill.

If one man's vote could pay our social security debts the old people, the needy blind, the destitute and under-privileged children and retired teachers would today be fully taken care of, as reflected by my vote, when your State Representative, in the last legislature.

Financing of the teacher retirement Act has my pledged support. I believe the state should make immediate provisions to match dollar for dollar the payments made by teachers in this fund; and I shall continue working and voting, so we may have a prompt solution of this problem.

I have always favored an increased truck load limit for Texas. The present 7000 pound load limit is discriminatory and inadequate; and prevents the small trucker from making an honest and decent living upon the money he has invested. The present law also hinders the best interests of our agricultural pursuits—such as the marketing of products by the farmer and rancher I shall continue to work and vote for an increased truck load limit in Texas, as I have on every occasion as your legislator.

The citizens of Texas have long wanted to know just where and how their tax dollars are being spent. For that reason I am for a publication law requiring that records, showing disposal of public funds in city, county and state offices, be published at regular intervals in the local newspapers; so the people may know how their tax dollar is being spent. Only dishonest public officials would dare oppose this bill.

As State Senator I will favor an occupation tax to protect our small towns against peddlers and fly-by-night businesses that drain money from our people without contributing one penny to the financial welfare of the community, its schools or institutions. This tax would not be levied against hometown concerns but against the ped-

dlers and "boomers" who are today taking unfair advantage of your home town and mine.

One of my first concerns as your state senator shall be to take action that would assure this district of adequate rural school aid money. I intend to keep a watchful eye on the spending of any tax dollar and do everything in my power to see that it is spent wisely and placed where it will do the most good.

I believe it is the bound duty of State to foster a "back to the farm" movement; and make a sincere effort to give our citizens who have been driven from the farm to cities and towns, an opportunity to return. This can be done as proved by the Federal Loan Bank at Houston, by setting up a State Land Bank, with authority to loan money at low interest rates to be financed by sale of bonds by the bank.

No man should be allowed to walk through the door to the Texas Senate Chamber who is not in harmony with, and working for the best interest of labor and agriculture. I favor legislation that sponsors, gives encouragement to, supports and fosters improvements in labor and agriculture.

Sound economy in government shall be my watchword as your State Senator. Our State needs proper administration and men in the legislative halls with backbone enough to fight for the people's rights, without regard for their own personal interests or desires.

I seek a natural promotion whereby I can serve you in an even greater capacity as State Senator; and pledge that my efforts and actions will always be governed by the will, problems and needs of the citizens of my district.

### Warships Leave For Unknown Destination

The United States was believed Saturday to have dispatched a number of neutrality patrol warships to the general vicinity of French Martinique in the Caribbean to investigate reports that a French naval detachment there is awaiting a British ultimatum.

The American vessels—five destroyers—were said to have been dispatched from the Virgin Islands to observe the Martinique situation at first hand. Reports from St. Thomas, Virgin Islands, said that the ships left Friday for an unknown destination. St. Thomas is about a day's run from Martinique.

50 enlisted men and two officers. Parade to be staged. A parade will be staged on main street, before the equipment will be demonstrated at the local baseball park. J. S. Hilliard and T. Wade Potter will welcome the group to Littlefield and will give short talks on the need for preparedness in the United States.

Lt. G. T. Coleman, officer in charge of the Lubbock area army recruiting office, will accompany the group to Littlefield.

The officers with the group will attend the regular luncheon of the Rotary Club as guests of J. H. Ware.

**To include machine guns**  
The unit will include three armored scout cars, each equipped with one 50-calibre and two 30-calibre machine guns, a motorcycle equipped with machine guns, four Garand rifles, which will be exhibited for the first time in this section of the state, and other equipment.

The present recruiting drive of the United States army calls for an increase of 5,000 men by September 1, and Lieut. McDonald stated that he will interview young men who wish to enlist today, until 10 o'clock this morning. Boys who join the army today will be placed in the unit here, and will participate in the demonstration.

**Vacancies for recruits, Lieut. McDonald said are in the coast artillery in California, field artillery, Fort Bliss; air corps in Brooks Field, San Antonio; infantry in Salt Lake City medical corps in Fort Bliss and Fort Sam Houston; Cavalry in Fort Bliss Legion to cooperate**

The local unit of the American Legion is cooperating with Lieut. McDonald in getting eligible young men interested in joining the army.

The unit arrived in Lubbock Tuesday morning, and are encamped on Texas Technological campus where they will stay each night while they are in this section, and meals will be prepared on two of the most modern field kitchens in the army.

Similar demonstrations to be staged here have been presented at Lamesa, Tahoka, Brownfield, Seagraves, Seminole, and Denver City. The unit will go to Muleshoe, Morton and Levelland today. Friday they will go to Crosbyton, Falls and Floydada. Saturday and Sunday will be spent in Lubbock.

tightly closed. Mr. Lionberger attributes some of his success in keeping the meat to the fact that the barrel is kept in the basement of his home, where an even temperature materially aids the "keeping quality" of the meat.

Before he started using cottonseed oil, Mr. Lionberger reports that he tried wrapping the meat in several layers of paper and putting paste over the entire exterior of the paper. He also used salt and oats and other things in an effort to keep the

cured meat, but found that none of these methods kept out insects or prevented the meat from becoming hard.

"For that reason, I believe that cottonseed oil is the answer to our meat storage problem here in West Texas," he commented.

That meat should be thoroughly cured or smoked before storage in refined cottonseed oil is pointed out in the Texas Extension Service recommendations. Meat should be covered about one inch with the refined cottonseed oil after it is tightly packed in the container, which may be a crock, steel drum or wooden barrel. The container should be covered. About four gallons of refined cottonseed oil are required for the storage of 100 pounds of cured meat.

## State School Appropriation Increased To \$2,424,000

Lamb county will receive \$2,424,000 more from the state this year than it did last year, according to State Supt. Woods. This is based on the action that the county will take to increase the number of students in the county as it had last year.

Woods said the action of the state board of education in raising the per capita from \$22 to \$24 was another step toward increasing the educational facilities in the state.

Woods will mean according to state Supt. Woods that each school will receive 50c more per pupil for each school district than ever before.

Woods has led the fight for increased state per capita appropriations to schools since he went into office. The per capita appropriation was first elected in 1916, and it has been raised by year until the \$22.50 has been established.

Woods pointed out that in-state assistance to schools, more efficient management, improved teaching methods, and being largely responsible for the raising to 18th educational rank in the union from the rank of 36th which it held in 1916.

It is not expected that the additional per capita appropriation will increase state expenditures as a whole, Woods pointed out, since the scholastic population has decreased in some localities.

## Applications For Making Mattresses May Total 200,000

### 61 Counties Receiving Cotton Had Made 20,509 Mattresses On June 26

Preliminary reports from Texas counties indicate that applications for mattress making materials under the Department of Agriculture's program for reducing the country's surplus cotton may aggregate 200,000 when all records are finally tabulated in the state office of the A. and M. College Extension Service, June 29 was the final date on which low-income farm families could file applications for cotton and ticking.

One hundred and ninety-seven counties have reported 180,281 applications as of June 26, according to Mildred Horton, vice director and state home demonstration agent of the Extension Service. Already 17,000 bales have been ordered from the Federal Surplus Commodities Corporation, according to reports filed in the state AAA office, indicating that at least 170,000 families have been certified to participate by county agricultural conservation committees.

Sixty-one counties which have received cotton had made 20,509 mattresses on the same date, Miss Horton said.

dealt with political interference.

"In other words," he said, "the Washington and Berlin government do not seem to be in agreement on the interpretation of the Monroe doctrine."

The views advanced today by the president threw no direct light on his attitude for Asia. Presumably, however, the position of the United States on that score was covered by Secretary Hull when he said yesterday that the Monroe doctrine did not resemble those in other areas which seem to be only the pretext for conquest.

Early said Mr. Roosevelt had mentioned this morning "the complete absence of any intention whatever on the part of the United States to interfere with territorial questions involving adjustments in Europe or Asia."

"The government of the United States wants to see, and thinks that here should be," Early continued, "an application of the Monroe doctrine in Europe and Asia similar to its interpretation and application for this hemisphere."

"The United States is not out to acquire territorial possessions of others. It does not, in this way, want any territorial expansion. Should victorious Germany lay claim to territorial possessions of the countries it has conquered—territorial possessions in this hemisphere—we interpret the Monroe doctrine in this way.

"The United States does not take for itself any of the islands or other possessions hitherto held by any of the conquered nations.

"But the United States very sincerely believes—and maintains the position that the administration or ultimate disposition of such islands and territorial possessions should be and is properly a question to be decided by and among all of the republics of this hemisphere—all of the Americas—not by the United States alone."

Projecting that policy to other continents Early said that in the case of French Indo-China, for example the United States believed that all the Asiatic countries should confer and reach a decision.

## Suggests Europe, Asia Apply Principales Of Monroe Doctrine

President Roosevelt suggested Saturday that Europe and Asia apply the principles of the Monroe doctrine as a means of reaching agreement on the disposition of possessions of conquered nations.

He took the position that European, Asiatic and American nations should get together in their respective spheres and settle problems involving territorial possessions among themselves, instead of allowing a conquering power to make the decisions.

The president relayed his views to reporters through his secretary, Stephen Early, following a 30-minute talk with Secretary Hull last night on the implications of the exchange of notes, involving the interpretation of the Monroe Doctrine, between Germany and the United States.

Backing up Hull's pronouncement that the United States would continue to enforce the doctrine, Mr. Roosevelt let it be known through Early that should Germany law claim to any French, British

or Dutch possessions in this hemisphere, the United States would make no effort to take them over.

Rather all the American nations would be asked to decide whether they should be placed under a mandate or held in trust in some manner until they could be returned to their present owners.

The president thought European and Asiatic nations should make similar joint arrangements.

A reporter told Early that, in a note delivered to the state department yesterday, Germany apparently had taken a parallel stand by stating that the Monroe doctrine's principle of non-interference could be legally valid only if Americans did not interfere in Europe.

Early replied that he was speaking of physical transfers of ownership of territories, and that as he understood it, the German note

### Interest Rates On Federal Land Bank Loans Are Reduced

Lamb County Farmers Save \$52,600 Result Of Legislature

Farmers in Lamb County will save about \$52,600 a year as a result of legislation just enacted by Congress affecting interest rates on Federal Bank and Land Bank Commissioner loans.

The temporary rate of 3 1-2 per cent on first mortgage Land Bank loans will be continued for two years ending June 30, 1942. During this period the interest rate on first and second mortgage Land Bank Commissioner loans will be reduced from 4 to 3 1-2 per cent. Land Bank and Commissioner loans were originally written at contract rates averaging about 5 per cent.

At present about 1000 Lamb County farmers have Land Bank and Commissioner loans outstanding aggregating \$3,511,150. The difference between the contract rate and the temporary rate thus effects a substantial saving for farmers.

In a statement from Washington, A. G. Black, Governor of the Farm

Credit Administration said that the saving to farmers through the reduced interest rate will have the same effect as an addition to the farmer's net income.

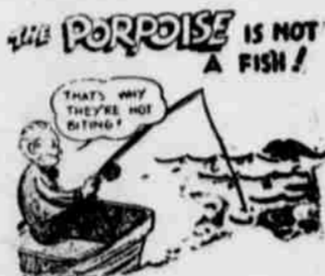
"The ultimate purpose of the reduced interest rate on Land Bank and Commissioner loans is to help farmers keep down their fixed charges and thus leave more income for the retirement of debt principal, or to meet necessary operating and living expenses," Governor Black said.

Money saved on interest charges will thus be reflected in increased purchasing power, benefitting both

industry and agriculture, and also will help in a measure to raise farm living standards and safeguard farm ownership."

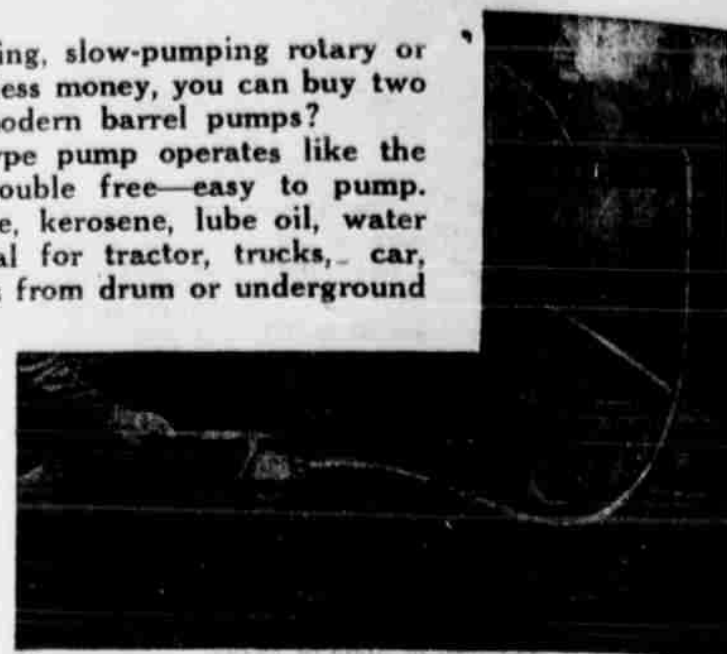

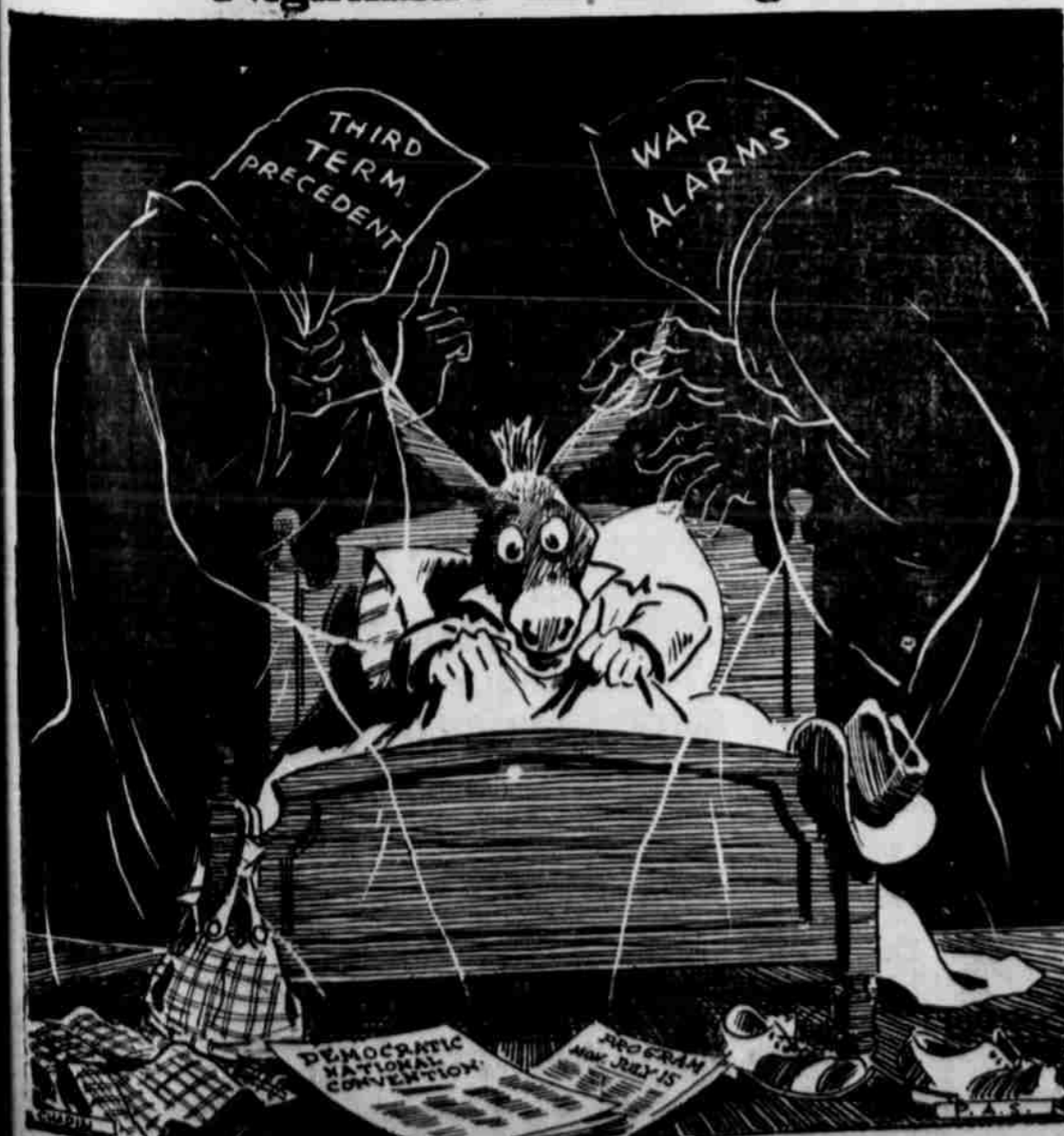

Rock Of Gibraltar In No Peril By Air

Air attacks now being directed against Gibraltar could cause some damage to British warships at anchor in the harbor if the bombing were sufficiently intensive, but the rock fortress itself is in no peril from the air. During recent aviation raids, British destroyers stationed at Gibraltar put out to sea where space and movement give them greater immunity. Their policy is to return to the rock when raiding ceases.

The inability to harm Gibraltar from the air and the small chance of damaging shipping anchored close to the sheltering cliff would no twarrant a major attack. Nor could enemy aviators impose serious inflictions on troops and civilians. Shops, residences, and military barracks are along narrow thoroughfares at the base of the rock, which towers 1,400 feet high. Accuracy

from the air has not reached the point where deliberate hits could be scored by bombs aimed at such confined targets.

The narrowness of the Gibraltar terrain, however, though providing protection from the air, seriously interferes with the port's utility as an offensive air base. There is lack of adequate landing space for airplanes at Gibraltar would require use of airplane carriers.

The Gibraltar dockyard would be under distant artillery fire if Spain became hostile, making Gibraltar vulnerable as a British repair station. But an artillery bombardment would not affect the rock itself within whose sides are innumerable chambers for big guns. To capture Gibraltar an invading force would have to cross a low sandy isthmus half a mile wide and one and one-half miles long leading from Spain to the rock. The devastating fire that could be brought to bear on this exposed position would make any attack hazardous in the extreme.

The guns of Gibraltar could repel any possible assault from the sea. The last time an attempt was made to capture Gibraltar was by the French and Spanish in 1782. The besieging fleet marked a great advance in warship construction with the ships' sides six to seven feet thick. It was thought this armor would defy any size cannon ball, as it did early in the engagement. But later the British began using red hot shot, then an innovation and the attacking fleet was put out of action.

As long as Gibraltar is in British possession no shipping can enter or leave the Mediterranean from or to the Atlantic ocean without Britain's consent. Great Britain's blockade of the European continent is greatly facilitated by this fact, which will have an important bearing on the outcome of the war if Hitler's threatened invasion of the British Isles fails.

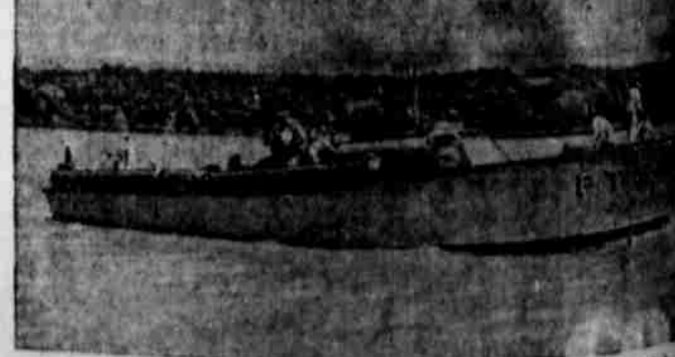

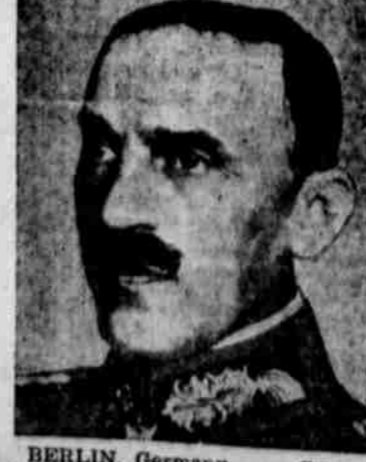

## District Entitled To About \$10,000 By Att.-Gen. Ruling

Secured Through Efforts Of Co. Supt. Boles And Deputy State Supt.

Littlefield Independent School District will be entitled to participate in the provisions of the equalization fund, and will receive approximately \$10,000 for transportation aid, according to an announcement made this week.

According to the transportation laws in Texas, a school district that includes a town that exceeds 3600 in population does not receive transportation aid, and after the census reports for Littlefield were 3791 inhabitants, school officials believed that the local district would not be eligible for the fund.

Ruling Secured However, through the efforts of F. O. Boles, county superintendent, and E. Esten Day, deputy state superintendent, a ruling was secured from the attorney general whereby the local district would be eligible for the transportation aid. A portion of the letter sent to Mr. Day by the state department of education is quoted below:

"Enclosed herewith you will find a copy of the Attorney General's opinion to the effect that a school district having over 100 square miles is entitled to participate in the provisions of the equalization fund, although located within the boundaries of a city or town having more than 3600 inhabitants!

Reports are that it would have been necessary for taxes to be increased in the local district, if such a ruling had not been made by the Attorney General.
