Jana Velasquez, a senior at Wheeler High School, was among a group of Cheerleaders from all over the United States selected as a UCA All Star Cheerleader to perform in the Lord Mayor of Westminsters New Year's Day Parade in London, England. The group of over 1000 cheerleaders from the U.S., spent six days in London touring the area and performing in the parade on New Year's Day. Jana won the honor to go to London through try outs at cheerleading camp this past

Jana's group consisting of girls from Texas, New Mexico, Oklahoma, Kansas, Arkansas and Louisiana departed from Dallas on December 26th, arriving in London the morning of the 27th. Upon arrival they checked into the Tower Thistle Hotel where Jana met her two roommates who were from the Dallas area. While in London the cheerleaders were sponsored and escorted by staff members of the Universal Cheerleaders Association.

During the six days in London they toured many London landmarks such as the Houses of Parliament, Big Ben, the Tower of London, St. Paul's Cathedral, and Westminster Abbey. they also toured Windsor Castle, Oxford University and Stratford-Upon-Avon, William Shakespeare's birthplace.

On New Year's Eve they attended The Victoria Palace Theater for a performance of the hit musical "Buddy". Then on New Year's Day they participated in the mile and one half long Lord Mayor of Westminsters New Year's Day Parade down London's Regent Street, ending with performances at Royal Albert Hall.

State ASCS, SCS Leaders Warn Area Producers Of Stricter Enforcement of Program Compliance

sure they are complying with the conservation provisions of the 1985 bill.

That was the message delivered in a meeting at Lamesa Friday morning by the top state officials with the USDA's Agricultural Conservation and Stabilization Service and Soil Conservation Service.

Sponsored by the Lamesa Cotton Growers, the meeting filled the Forrest Park Community Center with over 200 farmers and ASCS and SCS employees and committee members from some 22 counties throughout the region. The meeting drew individuals from as far as Sweetwater, Pecos and

Persons attending were told at the outset that they were going to get an unpopular message from the panel which included Donnie Bowman, director of the state ASCS office; Wess Oneth, SCS state conservationist; Darrell Davis, chief of conservation in the state ASCS office; Pat Henson, SCS assistant state conservationist and Lamesa resident Jerry Harris, chairman of the state ASCS commit-

Henson told the group that the SCS and ASCS must follow federal legislation and rules to the letter and that they simply have no more flexibility to grant farmers leniency in complying with conservation provisions of the farm program.

"We have gone as far as you can go and you needed to be aware of that," Henson warned.

Harris said that environmentalists with the League of Conservation Voters believe the ASCS and SCS personnel will not be doing their job properly unless they find 25-30 percent of the farmers out of compliance.

"Many people would like to judge us by the how many people are ruled out of compliance, said Oneth. "They don't think it is enough."

"If the SCS doesn't get the job done, there's some people waiting in the wings to do the job for us," Henson

said of the pressure facing the agency. All of the speakers advised the farmers to do everything possible not only to be sure they are following their conservation programs exactly but also to be sure all the necessary paperwork showing that compliance is

properly filed with the ASCS and SCS. They strongly urged farmers to check with the agencies before taking any action on their farms that might possibly affect their compliance with conservation programs.

The consequences of failing to meet their conservation plan requirements are severe, the farmers were warned.

Failure to be in compliance on even one tract of land will mean the persons responsible will forfeit all government farm program benefits not only on that individual tract but on every piece of land they have in the program.

Bowman and the others repeatedly noted they have no authority to change he rules and can only pass concerns expressed locally on up the chair of command of the officials in Washing-

During an hour-long question and answer session following the initial hour of presentations, most of the discussion focused on the April 1 plowup date for high-residue crops in this region and on requirements regarding rotation of crops.

Oneth and Henson noted the conservation requirements are all based strictly on proven research and that research cited by Parrish has not been completed. The federal rules, they said, simply do not allow state officials to give local committees and authority to grant changes except in specific

Explaining the compliance rules during his presentation, Henson said that weather-related variances are allowed on a case-by-case basis.

ance-which must be approved at the highest levels—farmers must have met SCS specifications, must have had a conservation practice fail and be losing soil to erosion, must re-apply their conservation practice the following year and be spot-checked by the SCS, and must carry out an emergency tillage as needed.

Henson said the SCS is responsible for determining whether producers are applying and maintaining the conservation practices set out in their required conservation plans.

Each year a certain percentage of all farm tracts-officials were not sure whether it will be three or five percent-will be selected through the ASCS computer in Kansas City to be spot-checked for compliance.

Producers will be notified in advance if their farms are selected for review, Henson said.

On-farm status reviews also must be conducted on any farm in which the SCS receives a complaint on a simple comment indication that farm may be out of compliance.

Noting the reviews will be conducted when the critical conservation practice should be in place to control erosion, Henson said officials will be checking farms in this region during March to determine if crop residue requirements on the surface are being

Henson said any farms who have any questions about what their plan requires should contact their SCS office to be sure they understand all

aspects of the plan. Any appeals of SCS decisions which have a serious impact on the farmer or landowner-such as failing to meet the conservation requirements—may be appealed in writing within 15 days

Appealable items, said Henson, include: designation of land as highly erodible, designation of wetlands, disapproval of a conservation plan, improper use of SCS policy in developing a plan, Conservation Reserve Program (CRP) designation, and SCS determination that the approved conservation plan is not actively being

TAX DEFERRAL AVAILABLE FOR ELDERLY **TAXPAYERS**

Texans aged 65 or older can postpone paying delinquent and current property taxes on their homesteads by taking advantage of a tax option called over-65 deferral. The elderly homeowner simply signs a deferral affidavit at the Wheeler County Appraisal District office.

This special form of tax relief can also halt a lawsuit already filed to collect delinquent property taxes on an older Texan's homestead. To stop a delinquent tax suit, the over-65 homeowner files the deferral affidavit with the court in which the suit is pending.

Once a homeowner files an over-65 tax deferral affidavit with the appraisal district, no taxing unit can initiate or pursue a suit for delinquent taxes as long as that person lives in that homestead.

Tax deferral for the elderly only postpones paying delinquent taxes on the homestead; it does not cancel them. During the deferral period, taxes and delinquent interest continues to add up. When the elderly taxpayer no longer owns or lives in the home those accrued amounts become due. Taxing units can then sue to collect all the deferred tax and interest.

While a penalty may not be imposed on the delinquent taxes during the deferral period, the filing of the deferral affidavit will not forgive penalties which were already due. Also, an additional penalty associated with referring the account to a delinquent tax attorney may be charged if taxes remain delinquent more than

90 days after the deferral ends. Forms for filing a tax deferral affidavit are available at your appraisal district office. The signature on these forms must be witnessed by a notary public. For further information call 826-5900.



In a bookstore, I recently saw a table that had several stacks of books on it. On the table was a sign that said: "Free Book-Help your-

After I took a book, I watched with interest the reaction of other people to the offer. Some people simply took as I had. Other people had different responses. For example, a man apparently read the table of contents to see if it was a book that he wanted. A lady did not believe that the book was free and offered to pay for it. Other people were highly skeptical of the offer, suspecting a "gimmick". Still other people totally ignored the offer.

God makes a similar offer to people. He offers salvation to people as a gift which means that it is not earned or deserved. The New Testament says: "-The free gift of God is eternal life in Christ Jesus our Lord." (Romans 6:23) But like those books in the bookstore-God's free gift-must be accepted by faith. COPING WITH TODDLER FOODJAGS

Foodjags begin to occur when preschoolers start to experiment and explore independence. Suddenly, they reject a favorite food or want the same food over and over again. When this happens, it is easy to react by demanding that the child eat other foods. A better approach is to serve small portions of a variety of tasty and healthy foods, including the favored food in an equally small portion. Don't bribe, threaten, force or argue. Wait until you finish the meal to quietly remove what your child has not eaten without a fuss. As you repeat this, your child will come to understand that mealtime is for eating rather than gaining attention for not eating.


