LATE FREEZE DAMAGES CROPS

Following the receiving of two nice rains to give the crops, gardens and shrubs the moisture they needed to grow and produce, the temperatures dropped with several hours well below freezing.

One or maybe even two cold nights in April with the temperature near or just below freezing may not be that unusual, but two days with the temperatures not above feezing and three nights in the twenties and teens may mean an end to wheat, grass and fruit.

The damage to crops will not be known for another day or two, according to county agent Don King. He will report his finding to the *Times* as soon as damage can be determined.

Some of the flowering fruit trees had already been hit with minor frosts and property owners had hopes that some would survive. The late blooming trees definitely suffered from the hard freeze. Some of the landscape and nut trees may also have been damaged.

The measure of moisture for Thursday morning was 0.15 inches was followed with 1.98 inches measured on Friday. The top of the gage was frozen over Friday morning as a trace of sleet lay on the grass.

Temperatures climbed back into the sixties Tuesday with a promise of a return to spring.

April 22 To Be Observed As Post Office 'Earth Day'

April 22 will be Earth Day. The Postal Service wants you to think about helping the environment by recycling. You may ask why recycle? It saves forests, energy, water and reduces garbage. Recycling one ton of office paper saves 17 trees. It takes 60% less energy to manufacture paper from recycled stock than from virgin materials; every ton of recycled paper saves 4,200 kilowatts of energy, enough to meet the energy needs of at least 4,000 people. Making paper from recycled paper stock uses 15% less water than making paper "from scratch;" recycling one ton of paper saves 7,000 gallons of water, enough to supply the daily water needs of almost 30 households. Every ton of paper not put into a landfill saves three cubic yards of landfill space. Most of all it helps preserve the environment for your children.

We shouldn't need to wait until April 22nd. We can start anytime. More than 1 million tons of wastepaper, cardboard, plastics, cans, and other material were recycled by the Postal Service last year.

Dear Editor:

April 13-19, 1997 is National Volunteer Week, and I would like to take this opportunity to publicly thank the people I believe are some of the most dedicated volunteers in our community, the volunteers of Golden Spread Hospice.

Most people know that hospice provides a very special kind of care for terminally ill persons and their families, but it's less known that if it were not for volunteers, our hospice could not function. Even the federal government recognizes the importance of volunteers in the delivery of hospice care by requiring that Medicareapproved hospices utilize volunteers from their community. Volunteer duties may include, but not be limited to, Administrative: Office support, flower delivery, public speaking, fundraising, community education, answering the phone, working health fair, etc.

Direct Patient Care (Hospice training course required): Meal preparation, sitting with patients, reading or other companionship, and family support, during the illness and after the death.

Hospice care is provided through an interdisciplinary, medically directed team. This team approach to care for dying typically includes a physician, a nurse, a counselor, a member of the clergy, and a home health aide. While our hospice employs paid professionals, we also rely on volunteers to provide assistance at all levels of skill

Nationally, about 100,000 people serve as hospice volunteers and last year, they gave well over 5 million hours of their precious time to serve terminally ill patients and families!

Locally, several people have donated their service to our hospice during the time we struggled to make hospice service a reality to the surrounding communities. Now that we have our license, more volunteers will be needed as we begin to care for more and more patients and families.


In a number of ways, volunteering for hospice differs from other community work. For instance, hospice patient-care volunteers are required to undergo a standardized training program before being allowed to work directly with a patient or family.

No task is too big or too small for our volunteers, but often the most important thing they can do is just "be there" for patients-to reassure them they are not alone, to hold a hand, to offer a smile, or just listen. It is not

Extension Update By Joan Gray, CEA-HE WHAT TO DO WITH A POISON

VICTIM Some say curiosity got the better of the cat, don't let curiosity lead your

child to poisonous substances. The Poison Prevention Council aims to educate communities on what to do if a poisoning occurs.

If you suspect that your child may have swallowed a potentially harmful product, you should look for warning signs.

Sometimes the child may vomit or appear drowsy and sluggish. Be sure to check the child's mouth and teeth for any remainder of the substance. Burns may appear around the child's lips and mouth from corrosive items or the scent of the product may cling to the child's breath.

If a child has ingested a chemical, follow the first aid instructions on the label of the product and then seek medical advice. The local Poison Control Center, emergency department or a physician can advise an adult on the toxicity of a substance and the recommended treatment.

If a child has swallowed some type of medicine, call the Poison Control Center or a physician immediately. In the event they are unreachable, call the local emergency number (911 in most areas) or the operator.

Emergency numbers should be posted next to the phone before an emergency arises.

When contacting the Poison Control Center or other emergency personnel be prepared to give the facts of the situation. Have the label of product available to read to the expert.

- Tell the expert:
- -The victim's age.
- -The victim's weight. -Existing health conditions or problems.
- -The substance involved: was it swallowed inhaled, absorbed

through skin contact, or splashed into the eyes.

-Your location, and how long it will take you to get to the hospital. If chemicals or household products have been swallowed, offer the victim a small amount of water. If medicines have been swallowed, do not give the victim anything by mouth until advised by a physician or the Poison Control Center.

Always keep on hand a one-ounce bottle of ipecac syrup for each child under age five in the home. Use only when advised to do so by the Poison Control Center, emergency department or physician.



Volunteers Are Vital Component of Hospice

As the nation observes National Volunteer Week, April 13-19, Hospice of the Panhandle, which provides for persons with limited life expectancies and their families, recognizes five special Wheeler-area citizens who have given their time and talents through the years. "We are so thankful for all the Wheeler-area volunteers who have served Hospice of the Panhandle for many years," says Sherry McCavit, executive director of the local not-forprofit organization. Active Hospice of the Panhandle volunteers in the Wheeler area include Patricia Bradstreet, Bonnie Davidson, Christie Jones, all of Wheeler; the Rev. Alberta Helton of Allison, and Maurita Stribling of Mobeetie. "While it is common knowledge that Hospice of the Panhandle provides a special kind of care for terminally-ill persons and their families, it is less widely known that without volunteers, this organization could not function," explained McCavit. The United States government recognizes the importance of volunteers in the delivery of hospice care by requiring that Medicare-approved hospices, such as Hospice of the Panhandle, utilize volunteers from their community for at least five percent of the total client hours spent by all paid hospice and contract staff, McCavit said. Hospice cares for terminally-ill patients with the goal of providing relief from pain, control of symptoms, and support for their family. Hospice seeks neither to hasten nor prolong the dying process and addresses the physical, emotional, social and spiritua: needs of patients and their families. Volunteers are an integral part of the Hospice team which includes a physician, nurse, social worker, therapist, spiritual caregiver, home health aide and homemaker. Hospice of the Panhandle, located at 800 N. Sumner in Pampa, relies on its 110 trained volunteers from throughout the northeast Texas Panhandle to provide direct care to patients and families as well as assistance at many levels of administration. "Volunteering for Hospice differs from other community work," McCavit says. "For example, Hospice patientcare volunteers are required to undergo an extensive 30-hour training program before being allowed to work directly with a patient or family. We encourage all our volunteers to go through this training. Afterwards, each volunteer must find the place where they fit best-whether it is with patients or in administration. "Often the most important thing our volunteers can do is just 'be there' for our patients-to reassure them they are not alone, to hold a hand, to offer a smile, or just listen," she added. "It is not easy work, but the personal rewards are enormous. The strength and courage of patients provide a constant source of inspiration. Our volunteers tell us they usually feel they gain more than they have ever been able to give."







Jonathan Swift, an English clergyman and poet, wrote his famous book,

Gulliver's Travels in 1726. This book immediately became very popular and has continued to be one of the best known satires in the English language.

In his book, Swift describes Gulliver being washed ashore on the land of Lilliput. As he sleeps on the shore, he is discovered by the people of Lilliput who were onetwelfth the size of normal people. To capture Gulliver, these little people tied him down with little threads. Each thread could have easily been broken by Gulliver, but together they formed a rope that he could not break.

Gulliver was not the first nor the last person to be captured by little threads. There are several things in life which seem little or insignificant, but many people have discovered that these little or insignificant things were much stronger than they realized.

With such statistical evidence, it is completely inconceivable to me that adults would encourage the use of alcohol by teenagers. Such people must not realize that medical and health authorities are warning that the use of alcohol poses a heightened danger to teenagers. For example, Dr. Larry D'Angelo, chairman of the department of adolescent and young adult medicine at Children's Hospital in Washington D.
