


The term hospice stems back from medieval times when it was used to describe a place of shelter for sick and weary travelers on a long journey

Hospice is a special kind of care designed to provide support for people in the final phase of a terminal illness. Hospice seeks to enable patients to carry on an alert-pain free life and manage other symptoms so that their last days may be spent with dignity and quality of life at home or in a home-like setting.

Hospice treats the person, not the disease. Because hospice feels that spiritual pain and emotional pain are just as real as physical pain, a team of specialists are used to help the patient and family with whatever they are facing at any particular time.

Hospice considers the entire family as a "unit of care" and works to meet not only the needs of the patient of the family. Hospice offers palliative care or symptom control, rather than curative treatment.

Emphasis is on quality of life, rather than length of life. Hospice strives for the patient and family to make the most of each day that they have together, something that we all should

Those faced with a limited life expectancy can sometimes be the fortunate ones in that they come to realize what's important and what matters; whereas others let time slip away thinking that there will always be another day to do and say the things that need to be done or said.

Hospice care is designed for the home, but that does not mean that a patient cannot go to the hospital if the need arises. Patients can also be residents of nursing homes and be in the hospice program of care. The nursing home is considered as their home and hospice cares for them as if they were in their own home.

Hospice also provides respite or "time off" for caregivers if the need arises. Hospice offers help and support to the patient and family seven days a week, 24 hours a day. Bereavement care is provided for a year to the survivors. Medicare, Medicaid and some private insurance companies will reimburse for hospice care, but no one is ever denied hospice care because of inability to pay.

The modern hospice can be traced back to the Irish Sisters of charity who established the Saint Joseph's Hospice in London in 1905. But most often recognized is Dame Cicely Saunders who in 1968 began to really emphasize pain and symptom control rather than curative measures. The first Hospice in the United States was in Connecticut in 1974.





BELTS, BAGS, BOOSTERS & KIDS: Buckling up kids from 3-12 Finding the best way to buckle up a toddler, preschooler or school-age child can be confusing. "Almost half of the chilren, between 3 and 12 years of age, ride without the protection of a child safety seat or safety belt," according to Janie Harris, passenger safety education specialist with the Texas Agricultural Extension Service.

Child Passenger Safety Week is Feb. 9-15. The national Occupant Protection Month is during February. Under Texas law, drivers may be

stopped and ticketed if a child in their vehicle is unrestrained or if they are not using their safety belt. Fines are \$25 to \$50 plus court cost fees.

What is the best way to protect children in a motor vehicle?

The rear seat is the safest place for all children. In any vehicle, passengers in the rear seat are safer than in the front. Those in the rear are farther from the point of impact in serious headon crashes.


If your vehicle has a passenger air bag, the rear seat is the only safe place for children. A child under age 13 and about five feet tall is not safe riding in the front seat. Even if your child is correctly buckled up, there is a high risk of serious injury or death when the force of the air bag is unleased.

If you have absolutely no way to avoid putting a child in front, the tallest child should be the one selected. Take these steps to reduce the risk. Move the seat as far back as possible. Make sure the child uses the full

restraint system and does not lean forward. Never put a infant in a rearfacing safety seat in front. A restraint with two shoulder straps

and a shell is generally more protec-

tive than a booster seat or a safety belt. A child should use a convertible or toddler seat as long as it fits.

Use the seat until the upper weight limit for the safety seat is reached, usually 40 pounds, the child's shoul-

The child slouches and neither lap or shoulder fit in correct position.

Booster seats are designed to improve the fit of safety belts. When a booster seat is used, the lap and shoulder belt ride in the correct position. The belt positioning booster is recommended for use with a lap/ shoulder belt. The belt-positioning booster seat raises the child up so that both shoulder and lap belts fit better. The shield booster seat should be used when you have a lap belt only for restraint.

The lap belt should fit low and tight across the top of the thighs, not up on the belly.

The shoulder belt should cross the shoulder, not the throat or face. Many children are too short for the belt to be comforable, so they misuse it in dangerous ways.

It is very hazardous to put the belt under the arm, which can lead to lifethreatening internal injuries. Putting the belt behind the back increases the risk of serious head injury. Some vehicles have built-in shoulder belt guides or height adjusters to help the shoulder belt fit better.



If your vehicle has seats with low backs and only lap belts, you will have to make a choice. You can continue booster seat use to reduce the known risk of serious injury from poor belt fit, or you can use the lap belt alone to limit whiplash.

If you decide to stop using the booster, be very particular about lap belt fit. Make sure your child always sits straight and keeps the lap belt tight and low over the thighs.

Other tips include:

Avoid calling booster seats "baby seats."

Remind children that astronauts, pilots, and race car drivers buckle up. Carefully read and follow safety seat, booster seat and vehicle manuals.

Insist that everyone in your car buckles up - no exceptions. Set a good example - buckle up



# Wheeler City Ordinance #169

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WHEELER, TEXAS, MAKING IT UNLAWFUL FOR ANY PERSON TO FAIL TO RETURN MATERIALS BORROWED FROM THE WHEELER PUBLIC LIBRARY WITHIN THIRTY (30) DAYS AFTER THE MATERIALS ARE DUE PRO-VIDING FOR A PENALTY NOT EX-CEEDING \$200.00, AND FOR THE SEVERABILITY OF ANY PORTION THEREOF.

WHEREAS, the books, pamphlets, periodicals, papers, audio visual materials, and works of art of the Wheeler Public Library are important, intellectual, recreational, and cultural resources of the community and essential to the public welfare, and

WHEREAS, the Wheeler Public Library has experienced significant losses of these valuable materials from the failure of patrons to return them, and

WHEREAS, funds would be better spent upon expanding the library rather than merely replacing public materials retained by those who refuse to return overdue materials; now therefore;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WHEELER:

SECTION 1. Definitions. In this ordinance:

a."Book Card" means the identifying card assigned to

an item of property by the Library staff for control purposes.

b."Library card number" means the identifying number

of the card issued to each patron of the Library authorizing such person to check out library materials.

SECTION 2. A person commits an offense if he knowingly or recklessly fails to return any property, including but not limited to books, pamphlets, periodicals, papers, audio or visual recordings works of art, or other property which has been borrowed from the Wheeler Public Library, within thirty (30) days after the property is due to be returned.

SECTION 3. The introduction into evidence of the orginial, or

a true and correct copy, of the "book card" assigned to such prop-

erty, bearing the due date for return

library card number is assigned, according to the records of the Library did borrow such property.

SECTION 4. The introduction into evidence of a copy of a written notice that any Library property is overdue, together with evidence that said notice was deposited in the United States Mail, postage prepaid, addressed to a person, is prima facio evidence that said person has knowledge that such property is overdue.

SECTION 5. A person violating Section 2 of this ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two hundred dollars (\$200.00). Each day that such violations continues as to each separate book, pamphlet, periodical, paper, audio or visual recording, work of art, or other property shall constitute a separate offense and shall be punishable accordingly.

SECTION 6. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses, and phrases of this ordinance are separable, and if any phrase, clause, sentence, paragraph, or section of this ordinance shall be declared unconstitutional or invalid by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality or invalidity shall not effect any of the remaining phrases, clauses, sentences, paragraphs or sections of this ordinance.

SECTION 7. That it is hereby officially found and determined that the meeting at which this ordinance is passed is open to the public as required by law and that public notice of the time, place, and purpose of said meeting was given all as required by Article 6252-17, Vernon's Annotated Civil Statutes, as amended.

SECTION 8. The City Clerk is hereby directed to publish the caption of this ordinance in the official newspaper one time within ten (10) days of final passage hereof. This ordinance shall take effect ten (10) days after such publication.

On motion of Councilman Rose, seconded by Councilman Simmons the above and foregoing Ordinance was passed and approved on this the 20th day of March, 1995 by the following vote.

# Protect your rights! "Render" your taxable property by April 15th.

A "rendition" is a report to the appraisal district that lists all the taxable property you owned or controlled on January 1st of this year. The rendition form is available at your local appraisal district office... or you may draft a similar form.

# Who must file a rendition?

You must file a rendition if you own tangible personal property that is used to produce income—such as the inventory and equipment used by a business.

## Are there any advantages to you?


The advantages of filing a rendition are:

- You give your opinion of your property's value. If the appraisal district believes the value is higher, it must notify you in writing of the higher value and explain how you can protest that value to the appraisal review board.
- You record your correct mailing address so your tax bills will go to the right address. If your bill is mailed to the wrong address, the law still holds you responsible for paying your taxes on time or paying extra charges for late payments.
- You can also file a "report of decreased value" to notify the appraisal district of significant depreciation of the value of your property in 1996. The district will look at your property before assigning a value in 1997.

# What's the deadline?

The last day for filing 1997 renditions is Tuesday, April 15. Call your appraisal district for the last date the rendition may be postmarked, if mailing. You can get an extra 15 days if you ask for it in writing by the April 15 deadline.



The Double Wedding Ring quilt top is considered an intermediate level project. Participants will use laser cut templates and rotary cutting techniques to construct the quilt top. Class size is limited to ten students, therefore, participants need to pre-register by 5:00 p.m. on Monday, February 24, 1997, by calling Joan Gray, County Extension Agent, at 806-826-5243. The class fee is \$35.00 due on February 24. Educational programs conducted by the Texas Agricultural Extension Service serve people of all ages regardless of socioeconomic level, race, color, sex, religion, handicap or national origin.


