


Pictures from the Past

Don W. Redding died Thursday, May 22,1997, at Amarillo. Memorial services were at 2 p.m. Monday in Allison United Methodist Church at Allison with the Rev. Bill Wilson officiating. Arrangements were under the direction of Boxwell Brothers Funeral Directors of Amarillo. Mr. Redding was born at Terrell. He married Josephine McDonald in 1941 at Albuquerque, N.M. He had been a longtime Springer, N.M., resident, moving to Wheeler two months ago. He was a rancher and was involved in the construction business. He was a former member of New Mexico Mounted Patrol.

Rochelle Rives graduated from the University of Texas at Austin receiving a BA from the School of Liberal Arts on May 17, 1997. 

During those years, he was a musician and country song writer and singer, working with many well known area bands and country music stars from Nashville. He had his own radio country music show many years, from KHUZ and KBBB in Borger. He and his wife performed on Panhandle Barn Dance as a duet singing country songs on KGNC TV from Amarillo and gained fame as Rusty and Sweet William during the 1950s. Rusty is a fiddler, a guitarist, plays piano and harmonica, and is a cowboy yodeler. He is also a cowboy poet and a member of several cowboy poet organizations and western music organizations. He is currently a regular performer at the Big Texan Steakhouse Opry, the Cowboy Poet Breakfast, Barnes and Noble Booksellers, all of Amarillo TX. He is also an artist, having received awards and honors in this field of endeavor. He is now doing cowboy cartoons for several news letters and the Fritch Eagle Press. He recently received an award from the academy of Western Artist for Outstanding Excellence in the Western Arts.

The art work chosen best depicted the theme of this years Heritage Day, "Wagon Trails." Wagon Trails celebrates the wagon trails, specifically the military road from Dodge City and Fort Supply and the Jones and Plummer Trail, the commercial wagon trail. These "wagon roads" were open between 1875 and 1890. Over these two wagon trails, million of pounds of goods and supplies were freighted into Wheeler County from which civilization was first brought to the Panhandle. On the return route buffalo hides in the beginning and later the cones of the buffalo were shipped to Dodge City for sale. Freighter and merchants like Robert Wright, Charles Rath, W.M.D. Lee, and P.G. Reynolds, made their fortunes from the businesses served by the wagon trails.



Property Tax Protest and Appeal Procedures

The law gives property owners the right to protest actions concerning their property tax appraisals. You may follow these appeal procedures if you have a concern about:

- * the value placed on your property
- * any exemptions that you may apply to you
- * the cancellation of an agricultural appraisal

* the taxable status of your property

* the local governments which should be taxing your property

* any action taken by the appraisal district that adversely affected you.

Review by the Appraisal Review Board

If you can't resolve your problem informally with the appraisal district staff, you may have your case heard by the appraisal review board (ARB)

The ARB is an independent board of citizens that reviews problems with appraisals or other concerns listed above. It has the power to order the appraisal district to make the necessary changes to solve problems. If you file a written request for an ARB hearing (called a notice of protest) before the deadline, the ARB will set your case for a hearing. You'll receive written notice of the time, date and place of the hearing. The hearing will be informal. You and the appraisal district representative will be asked to present evidence about your case. The ARB will make its decision based on the evidence presented. You can get a copy of a protest form from the appraisal district office at 101 E. Texas, courthouse square, Wheeler.

Note: You shouldn't try to contact ARB members outside of the hearing. The law requires ARB members to sign an affidavit saying that they haven't talked about your case before the ARB hears it.

Review by the District Court

After it decides your case, the ARB must send you a copy of its order by certified mail. If you're not satisfied with the decision, you have the right to appeal to district court. If you choose to go to court, you must start the process by filing a petition within 45 days of the date you receive the ARB's order. If the appraisal district has appraised your property at \$1,000,000 or more, you must file a notice of appeal with the chief appraiser within 15 days of the date you receive the ARB's order.

Deadline for Filing Protests with the ARB*

Usual Deadline

The 1995 deadline is July 1st. (or 30 days after a notice of appraised value was mailed to you, whichever is later).

Late protests are allowed if you miss the usual deadline for good cause. Good cause is some reason beyond your control, like a medical emergency. The ARB decides whether you have good cause.

Late protests are due the day before the appraisal review board approves records for the year. Contact your appraisal district for more information.

Special Duties

For change of use (the appraisal district informed you that you are losing agricultural appraisal because you changed the use of your land), the deadline is before the 30th day after the notice of the determination was mailed to you.

From The Minister's Desk:

Jim Martin, the minister of the Crestview Church of Christ in Waco, recently wrote an article that needs to be read by every disciple of Jesus. This article was entitled, "Can We Survive The Moral Fuzziness?" and it said:--

"Freedom is never free. It is always costly. Next door to freedom lives responsibility. The canon consists of both the book of Romans with its declaration of the gospel of grace and the book of James with its call to responsible discipleship. In Scripture, God is a God of steadfast love. Yet he is also a God of judgement. Our salvation is totally dependent on God's grace and yet obedience to Jesus Christ as Lord as is an essential expression of our faith."

"Perhaps it is this balance that is missing in today's church. After all, many of us seem to live with a moral fuzziness. Some good Christian people have difficulty locating ethical and moral boundaries. Perhaps we have become intoxicated moral expectation." by an endless thrist for more tolerance. For some, tolerance has become an excuse for spiritual carelessness. Certainly we are to forbear with one another in love. However, for some, tolerance seems to mean that sin just isn't that big of a deal anymore. We may find find They have a big barn they put the ourselves tolerating more and more until we lose our moral boundaries in this fog of uncertainty. We then

churches not draw lines where God has not drawn lines. Not every ethical concern will have a black and white answer. On the other hand, the church must be salt and light in a world of moral confusion. This is difficult to do when our vision is blurred by moral fuzziness. While there are some positive trends in our world today, moral certitude is not one of them. Whether it be a changing attitude toward homosexuality, the subtle promotion of an NC-17 film (Showgirls) into thousands of mainstream theaters, or the erosion of marriage commitments, there is cause for great concern. There is cause for concern in the church as well. It is one thing to offer forgiveness and hope to teenagers (or anyone else) who have been involved in immoral behavior and then repent. It is guite another matter for Christians to passively shrug their shoulders in the face of sexual immorality or drunkenness and say, "Kids will be kids. They are all going to do this. "Perhaps these are hearing a fuzzy

"Our response to the grace of God must result in a holy, radical life-style. Some issues will always be a matter of opinion. Other moral concerns are clearly addressed in Scripture. Regardless, we are called to live with moral discipline. The willingness to abstain, to say "no", or to deliberately choose the path that you believe Jesus would take reflects a moral discipline worthy of a







"Now these calls are equivalent to local calls, and all customers in the towns having the new Expanded Local (ELC) must now dial all seven digits, both for local calls and ELC calls," explained Mr. Ferguson.

Remember, there is no need to dial "1+" when calling Miami. Dialing instructions are listed below:

Customers are not required to take any action to take advantage of the new service offering. Once extended calling is operational it will no longer be necessary for customers to dia. "1+" before the number when placing calls between these communities, but you must dial all seven digits for locai and ELC calls.

Be sure to reprogram your fax machine, PBX, or key system equipment and your SmartCall (R) services from GTE to accommodate the simpler numbers.

Your monthly per-line charge will not change as a result of ELC to Miami. The total monthly bill of \$3.50 for residential customers and \$7.00 for business customers in Mobeetie will remain the same. The charges will be listed as "EXPANDED LOCAL CALLING/SURCHARGE" in the tax portion of the telephone bill. More information will be provided to affect customers in their monthly telephone bill as the service becomes operational.

This is a result of balloting which took place in the Mobeetie telephone service area under the rules of Senate Bill 632 and the Public Utility Commission Rule 23.49 (c). Under those guidelines, certain communities were allowed to petition for extended toll-free local calling to nearby communities.



PHYSICIAN: Your physician may remain responsible for directing your medical care while you are a Hospice patient. However, you and your physician may decide to transfer your care to the Hospice Medical Director, who is available to manage your care or provide consultations on pain and symptom management.

SOCIAL WORKER: A Hospice Social Worker, who is experienced in meeting the needs of Hospice patients and families, will visit you as part of the Hospice program. The Social Worker may help you identify community resources that can offer additional support at home, assist with financial matters, and discuss alternative care sites if needed.

CHAPLAIN: The Hospice Chaplain is available to serve your spiritual needs, whatever they are and however you choose to define and understand them.
