Of course, unlike the government, private distributors are compelled to seek efficiency or sacrifice a slim margin of profit. Some of the large chains have developed distribution to such a fine art that they are able to op erate on profit margins of less

than one per cent of sales. They do it because they have learned to handle mountainous volumes o goods with a minimum of waste motion. And they try to have what consumers want at the right place and at the right time.

The job of distribution is doubly difficult at the present time, part y because they must fight an up hill battle to convince governmen regulators such as the OPA that excessive red tape and unneces sary rules are anathema to effi cient distribution, a fact that ha nearly wrecked the government' distribution of surplus property. --From Hockley County Herald
