From The Minister's Desk:

Like many other people, I have been deeply concerned about the rapidly increasing cost of health insurance. For this reason, I was very intriqued by a newsletter that I recently received that was entitled, "Caring and Sharing"

This newsletter outlined a alternative to health insurance for disciples of Jesus. Rather than pay costly premuims for health insurance, disciples of Jesus can subscribe to the "Caring and Sharing" newsletter which monthly lists the medical expenses of its subscribers. Then the subscribers who have not had any medical expenses for the month can mail an assigned amount of money to the subscribers who have.

While I was intriqued by this newsletter and its suggested alternative for health insurance, I was a little confused by the qualification that subscribers had to meet. The newsletter said that subscriber had to be "-faithful Christians who do not forsake the assembling of themselves with other saints, who abstain from the use of alcohol, tobacco, illegal drugs, and who do not engage in immoral sexual practices."

As I thought about this qualification, I concluded that its concept of faithfulness was too limited. The Bible teaches that there are some other characteristics that faithful disciples of Jesus must not have. For example, I John 2:15-16 says: "Do not love the world, nor the things in the world. If anyone loves the world, the love of the Father is not in him. For all that is in the world, the lust of the flesh and the lust of the eyes and the boastful pride of life, is not from the Father, but is from the world."

Notice[®] carefully verse 16. This verse lists three general characteristics that faithful disciples of Jesus must not have. These three characteristics are:-

1. "-The lust of the flesh-." This characteristic consists of such sins as adultery, drunkenness, fornication, and homosexuality. These highly visible sins are clear-cut violations of the will of God and disciples of Jesus who wish to faithfully serve God will not commit these sins.

2. "-The lust of the eyes-." This characteristic consists of such sins as greed, materialism, love of money, and covetousness. These sins are not as visible as the sins that compose "-the lust of the flesh-", but they are clear-cut violations of the will of God. Therefore, disciples of Jesus who wish to faithfully serve God will also not commit these sins. But while the Bible does not make a distinction between the sins that compose "-the lust of the flesh-" and the sins that compose "- the lust of the eyes-", some disciples of Jesus apparently do. For example, these disciples of Jesus will loudly warn about the danger of alcohol, but they will be strangely silent about the danger of materialism. Perhaps their silence is caused by their materialistic lifestyle. To faithfully serve God, disciples of Jesus must not be characterized by

the "-lust of the flesh-" or "-the lust of the eyes-.'

This characteristic consists of such sins as conceit, pride, self-righteousness, and arrogance. These sins are clear-cut violations of the will of God and disciples of Jesus who wish to faithfully serve will not commit them.

It is these sins that has caused my concern about the "religious furor" that has recently swept across this community. From my perspective, this "religious furor" has produced in some people an attitude that says: "I am better than you because I do not commit the sins that you commit"; "I am more spiritual than you because I have had some religious experiences that you have not had." When I see these people, I am always reminded of the parable that Jesus told to the people who "--trusted in themselves that they were righteous and viewed others with contempt-." (Luke 18:9) In this parable, Jesus said: "Two men went up into the temple to pray, one a Pharisee, and the other a tax-gatherer. The Pharisee stood and was praying thus to himself, God, I thank Thee that I am not like other people: swindlers, unjust, adulterers, or even like this tax-gathereer. I fast twice a week; I pay tithes of all that I get. But the tax-gatherer, standing some distance away, was even unwilling to lift up his eyes to heaven, but was beating his breast, saying, God be merciful to me the sinner." (Verses 11-14)

Did you notice that Jesus did not indicate that the Pharisee's claims of righteousness were exaggeration? The Pharisee was apparently an extremely righteous man, but it was the tax-gather, the pentient sinner, who was justified. The righteousness of the Pharisee was nullified by "-the boastful pride of life-

Disciples of Jesus who wish to faithfully serve God will not have the attitude of the Pharisee. They will always guard against "-the boastful pride of life-". knowing that pride can nullify their righteous and godly lives.

I John 2:15-17 lists the characteristics that disciples of Jesus must not have if they wish to faithfully serve God. When these characteristics are compared with the qualification that subscribers to "Sharing and Caring" newsletter must have, an interesting observation can be made. This observation is that disciples of Jesus cannot faithfully serve God if they are characterized by the sins that compose "-the lust of the flesh-" and they cannot subscribe to the "Caring and Sharing" newsletter. However, they can subscribe to the "Caring and Sharing" newsletter if they are characterized by the sins that compose "-the lust of the eyes-" and "-the boastful pride of life-", but they cannot faithfully serve God.

Where do family members turn when they are faced with the problems and heartaches that come from dealing with mental illness on a daily basis?



Progress Made on Thunder Junction Park

Yesterday's Children has reached an agreement with a private investment group from England to build Thunder Junction, the Western heritage park and entertainment center planned as a source of supplemental funding for senior citizen programs in the Panhandle.

Groundbreaking ceremonies will be held at 2:00 p.m. Friday, March 24, 1995, at the site near Clarendon and Greenbelt Lake. The public is invited to attend. At the intersection of State Highway 70 and U.S. 287, visitors can take the Greenbelt Lake exit and go 3/ 4 mile north on 70. The site is on the east side of the highway.

"A private investor developed an interest in this project and its potential after visiting the Bar H Working Dude Ranch at Clarendon," said Pat Kaiser, President of Yesterday's Children.

"After negotiations and visits over several months, we have come to an agreement that we believe will be beneficial both to the senior citizens of our area and the private investors as well.' she added. "The public/private partnership we have worked toward has come together, and it's an exciting development that will also benefit the Panhandle ecomony!"

The park will be built in four phases. The first, which investors hope to have ready for this year's summer season, will be the first phase of a water park and lazy river, along with a go-kart track and miniature golf course. The New Braunfel's General Store (NBGS), which has produced the Schlitterbahn water parks, is designing and building the components for Thunder Junction's water park.

Phase II plans include four large slides for the water park; Phase III, a park. The agreement was reached on March 7-subject to completion of the land agreement-by officials of Yesterday's Children, Inc., the non-

profit group that initiated and developed the project; Thunder Junction. Inc., the private, for-profit corporation formed to develop funding for the project; and Westwood GMW Limited, the United Kingdom corporation headed by David Williams.

"Thunder Junction will be built, owned and operated by Westwood,' said Stan McClendon of Wellington, a vice-president of Thunder Junction. The legal agreement specifies several provisions that protect Yesterday's Children's investment and the integrity of its goals for Thunder Junction."

Westwood has agreed to provide a minimum annual royalty or a certain percentage of the gross park receipts-whichever is greater-to Yesterday's Children, Kaiser said. Distribution of funds to help provide senior citizen services throughout the 26 counties of Panhandle will be handled by a volunteer board.

The location has been moved from a site owned by the Greenbelt Water Authority to a 67-acre site nearby in order to tie into a sewage system already in place. Yesterday's Children conferred with Don Stewart of Economic Consulting Services, who conducted its feasibility studies, before the location change was made. A lease agreement has been made with property owner Dale Robinson.

ELECTRIC SHOCK TRE ATMENT UNDER FIRE

and Mental Retardation (MHMR) was charged with misinforming law makers on the subject of electric shock treatments in a complaint filed with the MHMR Board of Directors, and the Senate Health and Human Services Committee on Monday.

The complaint was brought by the World Association of Electro Shock Survivors (WAESS) and the Citizens

Texas Department of Mental Health psychological, it is organic. It is itself an indication of brain trauma, or brain injury."

"The deaths reported have to be detailed in terms of where they occurred, and in terms of autopsy where possible," continued Dr. Friedberg. "This is one of the failings of the reporting system currently.

Senior Texas House member, Representative Senfronia Thompson of Houston expressed her disapproval of the MHMR report. "The annual report suggests that within the group of institutional mental patients, women and the elderly are targeted for a treatment that we aren't even certain is safe. That is not right." Representative Thompson's statements referred in part to the fact that the FDA has kept electric shock devices in the pre-market approval stage, categorizing them with experimental and hazardous devices. A recent court ruling in her district, by State District Judge Scott Link ordered a hold on experimentation on psychiatric patients in the Harris County Psychiatric Center. Reports indicated drug experimentation had been carried out on in-patients. The World Association of Electro Shock Survivors and the Citizens Commission on Human Rights of Texas claimed a combined victory in 1993. with the passage of Senate Bill 205 The bill outlawed the use of electric shock treatments on children 16 or under, and required an informed consent form be signed by each recipient prior to receiving treatment. It also required that MHMR turn in an annual report to the Governor, Lieutenant Governor, and Speaker of the House of Representatives on various facts involved in the use of electric shock by State or private psychiatric facilities. The Bill was sponsored by Senators Mike Moncrief, Judith Zaffirini, and Chris Harris. Leading up to the passage of the bill, the Senate Health and Human Services Committee had heard many hours of testimony from past recipients of electric shock who claimed it had damaged their memory or their brain functions. The president of the World Association of Electro Shock Survivors is Diann'a Loper, a lobbyist who had worked for six years with lawmakers before "coming out" in 1993 as a Shock Survivor. "I have never told any of the Legislators I worked with that I had been a victim of electric shock when I was a child. Because of the treatments, as verified by neurologists, I now have epilepsy, and have had to work twice as hard to overcome my treatment induced impairment to be successful in my line of work. Last session, when I came out and told the Senators at a Committee hearing that I had received electric shocks and been damaged by them, the legislators responded as if one of their own had been abused. I was very proud to see that they took up the cause with me and the rest of the World Association of Electro Shock Survivors, and passed the strict regulations on this damaging procedure." Jerry Boswell, the director of the Citizens Commission on Human Rights of Texas, said "I am very consive or depatterning" electric shock cerned that the Texas Department of Mental Health and Mental Retardation is not complying with law on this reporting system. Electric shock treatment is the most damaging treatment I am aware of. Deaths, redefinitions of types of treatments, these things are uncalled for and must cease. This looks like an attempt to whitewash the treatment to the legislature."

Acts include "rolling while balancing candelabras", "swinging water meteors" and the comic antics of acrobats in the "Chinese lion dance"

Yao Jin Fen and Qin Ming Kiao, two of China's foremost magicians and members of the acrobatic troupe, received awards of merit in 1985 from the U.S. based Academy of Magical Arts.

The London Piano Duo, David Nettle and Richard Markham, are Britain's foremost piano team. They participate regularly in major events such as BBC's Royal Albert Hall Proms and Bath, Harrogate, Berlin and Schwieswig-Holstein Festivals. They present classical and lighter music that ranges from Rossini to The CaCommission on Human Rights of Texas (CCHR), who claim that MHMR violated a 1993 law requiring annual reporting of the use of electric shock treatment by psychiatric facilities in Texas.

Electric shock is a controversial psychiatric procedure in which electricity is passed through the brain causing a convulsion similar to an epileptic fit. Psychiatrists claim the convulsion is therapeutic, and assists certain individuals in overcoming severe depression. However, critics of the procedure note that most treatments employ a greater electrical charge than is necessary to induce a convulsion, and claim that any effect achieved is the result of damage to the brain, similar to head injury in a car crash. In fact, the primary complaint about electric shock by recipients is that they experience memory loss, an adverse event commonly associated with neurological damage or injury.


The complaint alleges that MHMR did not provide Texas lawmakers with autopsy reports on individuals who died within 14 days of the treatment, did not provide a breakdown of electric shock usage by facility, and did not provide a breakdown of electric shock recipients by age, and that all these items were required by the new law. The complaint also points out that in none of the categories in the 1994 annual report do the number of recipients match the total number of recipients for the year. Further, the two groups allege that they received two annual reports for 1994, and that one report showed 6 deaths for the year, but the official report of Texas lawmakers showed only 5 deaths for the year. The groups are demanding better accountability from MHMR.

The groups found that whereas the 1993 Statute called for MHMR to keep track of patient's reports of memory loss, the department instead issued the Annual report with the psychiatrist's determination of level of memory impairment. The groups complain that it is equally interesting that psychiatrists are responding instead of patients on whether their memory has been damaged.

In addition, the complaint alleges that in 1993, some psychiatrists were reporting the use of "regressive" electric shock treatments, a procedure in which the individual is reduced through a series of shocks to an infantile state, unable to control his bodily functions. The groups claim that MHMR changed the definition of regressive electric shock in order to eliminate the reports of its use. They cite a letter from Dr, William Reid, the Medical Director of MHMR to Texas psychiatrists dated January 25th, 1994, in which he states he had difficulty believing that "regres-
