The game proved to be a defensive struggle as neither offense could muster any momentum. Memphis would finally break this scoreless tie in the 2nd quarter, as they would capitalize on a Mustang turnover to take a 6-0 lead. Memphis would make this score hold until late in the 4th quarter as both defenses would control the tempo of the

## game.

In the 4th quarter, the Cyclones were knocking on the door hoping to add to their lead, but the Mustang defense, as they had done the previous week, made a tremendous goalline stand and would take over on their own one yard line. It was at this time late in the 4th quarter, that the Mustang offense would wake up. Wheeler would mount a last minute drive which would enable the Mustang to possibly win the game. The drive would take 9 plays and cover 99 yards as Justin Chapman would hit Donnie Phipps for a 11 yard touchdown to tie the game, but a mistake in the kicking game would leave the score tied at 6-6 with 53 seconds to play. The Mustang drive was highlighted by two big plays as Finsterwald hauls in a 32 yard pass from Chapman to move the ball to around midfield, followed by a 28 yard run around left end by Chapman.

Memphis would elect to run out the clock and play overtime.

The Mustangs would be on offense first in the overtime period. They would drive the ball from the 25 yardline to paydirt as Caleb Finsterwald got the final 1 yard over left tackle for the TD. The extra point was missed and the Mustangs had their first lead of the game at 12-6. Memphis would get their opportunity from the 25 yard line, but after gaining one first down, the Mustang defense would rise up to the challenge as Finsterwald intercepts a pass in the endzone as the QB hurries his throw as Donnie Phipps puts a crushing blow on him.

And the Mustangs win their first game of the 2000 season, as the defense, lead by Bret Goad, kept the game in reach. The Mustangs will host Dalhart this Friday at Nicholson Field.

Charles Kuntz presented the receipts and disbursements and discussed same.


Harrison Hall discussed the American Legion building. He presented the floor plans for the building, if the city was still interested in the building.

from the federal Institute of Museum and Library Services (IMLS), the Mobeetie Jail Museum will have the funds to implement collection management improvements in the area of record keeping for artifacts and temperature control of the Jail and Lodge. This will benefit the community in that the life of the objects in the collection will be extended and a duplicate set of information regarding the provenance of the objects will be stored offsite in a safe place. According to Museum Director, Melba Corcoran, "this grant of \$7500.00 over the next 2 years will mean that several areas of concern for the collection can now be addressed. 
# **Main Street Block Party** Saturday In Canadian

The annual water use in the Panhandle region projected water use for the year 2000 in the 21 county equals 1.718.402 acre-feet IO 559,943,010,102 gallons. This is enough water to fill the Louisiana Superdome 599 times or to fill Lake Meredith to its average contest almost 5 times. If you could stack water it would cover a football field with a stack of water 325 miles high. The water in our region is four-percent surface water and 96 percent groundwater. The projected total water use for 2000 is 89 percent for irrigation's, Municipal 5 percents, livestock 3 percent, Power generation 1 percent, and manufacturing 2 percent and mining 1 percent.

The water management strategies for irrigation to reduce demands due to prohibitive cost of obtaining additional supply are use of PET data for increased efficiency, change in crop varieties (short vs. Long Season), change irrigation equipment changes (row to sprinkler and etc.), change in crop types, conservation tillage and precipitation enhancement.



# **Panhandle Marketing & Tourism Council**

The Panhandle Marketing and Tourism Council held their monthly meeting at the Mobeetie Jail Museum. President Joann Harwell was in charge of the meeting, Mr. Baroque catered the dinner, which was eaten under the arbor. The group moved into the Lodge Building for their meeting. Joann Harwell turned the meeting over to Brett Cruse from Texas Historical Commission. He gave an up date on the battle sites in the Panhandle in which they did the fieldwork.

The fieldwork is almost completed. He reported that the project started in 1998 as a project between Texas Historical Commission and Panhandle Plains Museum. They received a grant from the National Parks Service for the 125th Anniversary of the Red River Wars to do an interpretation. The military did such a good job of removing the Indians out of the plains that the battles did not gain as much signification as the other battle sites such as Custard's battle. Now our job is to put these finds into a tourism attraction by enlightening the people to the facts.

In 1998 they started their first season of work. The first site was Adobe Walls. They were going to evaluation the site and how it would fit into the over all program. The second site was Lyman Wagon Battle Site in Hemphill County. They found the artifacts and how they formed a pattern that showed where the wagons were circle and where the Indians were located.

The Third was the Battle of Buffalo Wallow. The marker had been placed there in 1925-1927 by the Panhandle Historical Society. They did not find enough artifacts to find out if it was

Texas. They have found some very good artifacts. They only covered about 40 percent of the territory. It is located in Armstrong and Briscoe Counties. This was all they could do for 1998.

The second phase was in 1999. They had raised enough money to have another season in the fields. They returned to Armstrong Co. They found that the battle site was 13 miles long and from 2 1/2 to 6 miles across. They hit the high points. Miles had reported that he split his troops into 3 columns. They have located the three columns. They have proved where the charges came from. They have proved Miles account in his reports.

Miles had stated that there were 400- to 600 Indians and they were well armed. They don't think this was correct. They had only identified 19 weapons for the Indians and 60 for the military. They found less than 100 cartiages for the Indians and 800 for the military. This shows that the Indians were not as well armed. The Indians were using Spencer's 56-50 and 56-52. One reason to think the Indians were saving their cartiages was that the cartiages had not been manufactured in 8 years. So they were about out of ammunition. After finishing this site they moved to Mobeetie where they were looking for what they call the Battle of Sweetwater also known as Prices Running Battle. Within 30 minutes after getting to the site they had found 30 cartiages identified as military. They found over 800 artifacts both military and Indian. The report said that the Mountain Hazier that he had wasn't used because his shell got wet. So it was thought that he didn't use the hazier but the report also said he had the canister with him. They found that there were canister shots there.

At this point they don't intend to do any more fieldwork. They decided they need to wrap up this phase of the project. They have over 3,000 artifacts. Now they need to decide what to do with these items.
