The meeting was called to order at 7:00 p.m.

1. Motion by Wanda Hefley to approve the minutes of the previous meeting. Seconded by Wade Hathaway. Motion unanimously.

2. Motion by Richard Meadows to pay checks #4793, #4797, and #4806. Seconded by Wanda Hefley. Motion carried. Voting for were Wayne Zybach, Richard Meadows, and Wanda Hefley. Abstaining due to nepotism were Mike Meadows, Wade Hathaway, and Bob Finsterwald.

3. Motion by Mike Meadows to pay the balance of the bills. Seconded by Bob Finsterwald. Motion carried unanimously.

4. The Board appraised Carl Baker, Superintendent.

5. Motion by Richard Meadows to extend the contract of Carl Baker, Superintendent, for one year beyond his current contract date. Second by Mike Meadows. Motion carried unani-

Adams and Constable Joe Montgomery where the tires were shot out on the vehicle. The charge against Diehl. normally a Class A misdemeanor. was enhanced to a state jail felony as a result of a prior Louisiana conviction for a similar offense.

After his guilty plea, Judge Emmert sentenced Diehl to a maximum two (2) years confinement in a state jail facility and fined the defendant \$1,500.00. The defendant was also ordered to pay restitution in the amount of \$776.00 to a trucker, whose tires were punctured by spikes laid across Highway 83 in front of the Wheeler County Jail; the spikes were intended for Diehl. Diehl avoided the spikes by exiting on Highway 152 at the stoplight in Wheeler. Diehl was placed on five (5) years probation through the Wheeler County Probation Department.

"The 31st District Attorney's office will not tolerate this type of dangerous and careless behavior which puts human life and property at risk," said District Attorney Richard J. "Rick" Roach. "We hope this case will send a message to anyone, who might be disposed to avoid arrest in the future. It is tough enough on our law enforcement personnel without the added risk of high speed chases."

The Wheeler County Commissioners met in regular session on Monday, January 22, 2001. Nine items were on the agenda.

The hourly payroll was received and approved.

Seven people are to be contacted, who will be willing to serve on the County Historical Committee. The names will be presented at the next meeting of the commissioner's court for approval.

Luke Horton, an employee of Precinct 1, will receive a pay raise of \$52.02 per month pay adjustment effective January 1, 2001. His probation period ended Jan. 1

Art Taylor, Justice of the Peace, Pct. 2, requested the county to purchase a software program to do the reports necessary for his job. The commissioners approved the purchase of the program at a cost of \$5,695. The program costs \$3,995, maintenance will be \$900, and training is \$800 per day.

A Salary Grievance Committee of nine people will be selected from the individuals now serving on the grand jury. The nominations will be submitted for approval at the next meeting of the commissioner's court. County Judge Jerry Hefley will serve as nonvoting chairman.

Sheriff Jimmy Adams met with the commissioners and informed them of the need for a new radio console at the dispatch. The department is no longer able to purchase repair parts for the radio console now in use. A new radio console will cost from \$10-11,000. 

Dear Editor,

The Washington Post recently published an article quoting physicians, patients, a nursing school dean, even a hospital nursing director addressing the lack of safe care in the hospitals today and urging, almost insisting, that just to get basic care and be safe in the hospitals you need to have either a family member or hire a sitter 24 hours around the clock. The article can be found on the internet at: http:// /washingtonpost.com/wp-dyn/articles/A27485-2001Jan6.html. It is both a sad and frightful realization that our hospitals, which should be a safe refuge for the sick, are now a threat to the sick. Because it is so emotionally upsetting to think that the healthcare system in America is unsafe, it has long been swept under the rug and not addressed.

It is a well known fact that we are in the height of the most critical nursing shortage this country has ever faced. Almost every nursing journal that you pick up today has an article regarding the shortage. It is also a known fact that there are certain steps that an organization can take to help alleviate the profound effects the nursing shortage has on its institutions. Because most of these steps involve money, money which most organizations are not willing to spend, it will take an out cry from both the healthcare profession and the public to change the system. When this out cry came from the healthcare profession and public in California, Gov. Grey Davis signed into law Bill AB394 mandating minimum nurse-patient ratios such as in the critical care units one nurse can have no more than two patients, and on the medical surgical floors one nurse can have no more than 4 to 5 patients.

Lower reimbursement rates from managed-care plans and government programs have pressured the hospitals to cut expenses and trim staff, but to what point do we cut to sacrifice the safety and/or lives of not only the patients but also the staff? It is the almighty dollar more important than the safety of our patients and the staff caring for them? Are you all aware that many times in the critical care units one nurse has three patients and on the medical-surgical floors, where the patients are much sicker now than in the past, those nurses have sometimes 12-15 patients? Let me ask you another question, are you aware that according to the Institute of Medicine analysis that as many as 98,000 Americans die each year of medical errors that occur in the hospital? Documented study after study has proven that there is a direct correlation in medication errors to poor staffing levels. Many of those errors could and would be avoided if we, as nurses, actually had time to look, listen, touch, feel and see how each patient is doing. As a nurse, I can tell you that is our sincere interest and genuine concern for good patient care but is is impossible to do so when staffed at the current nurse patient ratios. Continuously, we work short staffed many times without the sup-

plies needed to do basic care for the

supportive measures. We work "12 hour" shifts, which more often than not are 13 to 14 hours. We are constantly scrutinized for the overtime we have each day however, we are required not to work mandatory overtime shifts. We are on our feet on concrete floors most of that time, many shifts not even having the time to break, for food or to go to the bathroom. We are subjected to all kinds of ridicule by irate doctors, patients and families, not to mention the life threatening job related exposures, such as HIV and Hepatitis, that we are subjected to on a daily basis. I, myself, was recently exposed to the HIV virus, through no fault of my own, An irate HIV positive patient spit in my eye and I had to practically jump through hoops, plead, beg, have an initial out of pocket expense of \$900.00 (which was recouped the following day) and then become irate myself to get the prophylactic treatment for the exposure initiated. And to make matters worse, because the prophylactic medication made me so sick, I was off work for two weeks. The hospital did not pay for the time off, it had to be taken out of my paid time off bank as well as my extended illness bank. What other profession do you know of (other than the Police Department-God bless all of you police men and women) who are

I find it ironic, that while in the midst of this critical nursing shortage, and we are being told that efforts in both recruitment and retentions are at an all time high, we, as nurses, are being treated with such reckless disregard, It is no wonder that nurses are leaving the profession by the hundreds and that the nursing school enrollments are down. If the problem is not addressed, not only by the healthcare profession but also by the public, the trend will only continue to decline. It is imperative that the public become aware of this potentially life threatening situation and the negative impact it will have on the care, or lack of, that you or your loved one will receive. I urge all of you out there to document your concerns, address them to the hospital administrations, hospital boards as well as your local con-

The current issue facing the City of Wheeler is not the quality of the available (leased rights) water but rather, the quality. To satisfy the Texas Natural Resource Conservation Commission primary drinking water regulations for nitrate concentrations, the City has to blend water from the two production wells since the nitrate concentration in one of the wells exceeds the MCL of 10 mg/l. The practice of blending water from the two wells limits the amount of water taken from the larger of the two production wells, in effect reducing the production capacity of the well. The wells are currently operated on timers to allow adjustments to well run times to achieve the necessary water quality. It is expected that these issues will directly influence the decisions of the City regarding possible purchase of the leased groundwater rights and/or renewal or extension of the current

Nitrate levels in the two existing water wells (leased rights described above) have been steadily increasing since 1983. It is assumed that these levels will continue to rise, eventually rendering the water in the existing two wells non-potable. Should this occur an alternate source of water will have to be found, or the current water wells would require posttreatment to reduce the levels of nitrate to below the drinking water standards prior to distribution. Recent exploration (year 2000) for water has revealed a potential source of acceptable groundwater located to the north of the City, but quantity is undetermined. For the purposes of Senate Bill 1 planning, it is assumed that the City will drill two new wells having a capacity of at least 175 gpm each in the vicinity of Wheeler. Water rights of sufficient quality and quantity will have to be obtained to construct the two new wells. The transmission distance necessary to get water from a quality (low nitrates) water source is assumed to be less than 15 miles. Short term needs in Wheeler will

be met with additional groundwater supplies. However, long-term supplies may originate from an alternate source. The Panhandle Water Planning Group, at the request of the City of Wheeler and the Wheeler County Surface Water Board will recommend that a previously identified potential surface water reservoir, Sweetwater Creek Reservoir, be eligible to receive funding to conduct feasibility studies to evaluate the potential yield in light of the requirements of the Red River Compact, cost, interstate coordination issues, potential environmental impacts and potential areas or municipalities which could be served by the reservoir. This potential surface water reservoir may provide an alternate source of water (long-term) if groundwater of suitable quality cannot be located or treated to meet primary drinking water standards.

The quantity of the groundwater currently available to be purchased is apparently adequate to supply the City until the end of the planting period. Reliability is moderate to poor depending on nitrate concentration levels and potential movement or expansion of the nitrate contamination in the aguifer. The cost of the water is estimated at \$1,116 per acrefoot/year (\$3.45/1,000 gallons), assuming water does not have to be treated e.g. reverse osmosis or other membrane type treatment works, or that water does not have to be hauled. Should it become necessary to treat the water to remove high nitrate levels, the cost per thousand would rise proportionately.

The development of a new well field for Wheeler involves a pipeline approximately 15 miles long the the construction of at least two wells having a capacity of 175 gpm each. The degree of environmental impact should be low, assuming the pipeline and well field can be located/routed to avoid environmentally sensitive areas. The construction of pump station(s) and storage tank(s) should have not to minimal environmental impacts. However, an assessment of environmental impacts should be performed prior to implementing the water management strategy.

The increased demands on the Ogallala will continue to deplete the storage in the aquifer. It is also expected that the nitrate levels will continue to rise, rendering portions of the aquifer non-potable. This issue may compel the City of Wheeler to look towards additional sources of water.

Assuming acceptable quantities and quality of water can be found and transmitted via pipeline to the City, the impact on agriculture is expected to be minimal, although converting to alternate crops requiring less water may be necessary to reduce the depletion of the Ogallala. Agricultural land located in and around the transmission system will be minimally affected as the pipeline should be designed with a sufficient amount of cover to allow deep plowing.

Other relevant factors that may affect the development of water rights include groundwater district rules affecting production limitations and

property line setback requirements for locating wells. In addition, the groundwater quality issues may limit, the City's choices for developing new

### Time To Start Plowing For C.R.P. Land Planting

Producers, who are schedule plant a cover crop this coming fall need to begin plowing up their land. Producers will need to plant their cover crop into a smooth, firm and clean seedbed to establish a suitable cover crop. A cover crop is mandatory when planting a native grass mixture
