February 22, 2001, 7:00 P.M. The Wheeler County Water Supply District Board met Thursday, February 22, 2001 at 7:00 p.m., to meet with Wheeler County Citizens. Those in attendance were County representatives, Bobbye C. Hill, City of Wheeler representative, Harrison Hall, City of Shamrock representative Wendell Morgan, City of Shamrock representative, Sonny Hiburn, and City of Mobeetie representative, Joe VanZandt. There were 45 Wheeler County citizens, four Oklahoma residents, C. E. Williams, Manager of the Underground Water District and Jarrett Atkinson, Coordinator of the Regional Water Plan, and Tom Gooch, representative of Freese and

Meeting was called to order by Harrison Hall, President.

Minutes were read by Bobbye C. Hill, Secretary and approved.

Jarrett Atkinson presented models of groundwater designed by Panhandle Water Planing Group and the Underground Water District and answered questions from all in atten-

Tom Gooch representative of Freese and Nichols presented his company plan for the Sweetwater Creek Reservoir; the feasibility study. the permitting process, the cost, and the time frame for the permitting process. He answered questions from all in attendance.

Will Smith Signs Letter Of Intent To Attend Sam Houston University

There are few high school players in the area that can equal Will Smith at the offensive line.

The Willis offensive lineman, who stands well over 6' and weighs in at 310 pounds, will graduate in June and signed a scholarship Wednesday to attend and play football at Sam Houston State University.

The multi-talented athlete, who made numerous all-district and allcounty appearances in football, will almost certainly be able to move into a starting role much quicker than most players.

Smith, who was a state competitor at the 4-A level in the shotput competition, combines the best of what coaches look for in an offensive line-

"He's definitely been an individual I knew was a college prospect," said Smith's head football coach at Willis, Stan Labay. "He's got size, quickness and speed to be a prospect."

It's those qualities that made Smith such an attractive prep school player. In the last two seasons with the Wildkats Smith anchored an offensive line that helped produce a spectacular running game featuring the tandem of Fred Woods and Edward "Tankie" Clark. The pair proved to be one of the most potent running combos in District 18-4A (in 1999) and District 21-4A (in 2000)


Smith also helped to protect the Wildkats quarterbacks and quided the team to two consecutive playoff appearances. In 1999 Willis lost in the first round but they made it to the second round in 2000.

"He was a very important part of our offense," said Labay. "He is one of the top linemen in the area."

Top lineman indeed. Smith was a unanimous choice for First-Team All-District Offensive Lineman in 2000, and was also an All-Montgomery County player two years in a row.

Offensive linemen rarely get noticed in the world of football, except when they make a mistake like miss a block or have a penalty called against them. Statistically, it can be hard to judge a lineman since there really aren't numbers that belong to

But the best way to define the tal-

ent of a lineman is to observe their onfield leadership and how well they protect the rest of the offensive weapons. Both were jobs that Smith accomplished in convincing fashion. Rarely was he beaten by a stronger, or quicker, defensive lineman and his blocking skills are a big reason why the soon-to-be-former Wildkat will







A variety of homestead exemptions could lower your property taxes!

A homestead exemption lowers the property taxes on your home by lowering its taxable value. If your home is valued at \$50,000 and you receive a \$15,000 homestead exemption, your home will be taxed as if it were worth \$35,000.

Who qualifies for an exemption?

Anyone who owned a home on January 1st (and used it as their primary residence on that date) is entitled to a \$15,000 homestead exemption to lower their school taxes this year... and it doesn't matter if your home is a house, condominium, or mobile home. (Counties, cities, and special taxing districts may also offer homestead exemptions.)

Are other exemptions available?

If you're disabled—or if you're 65 years old or older—you are entitled to an additional \$10,000 school tax exemption on your home. And if you qualify for the over-65 exemption, you're also entitled to a permanent, locked-in "ceiling" on the school property taxes on your home. (The ceiling does not apply to county or city property taxes, and those entities may offer other exemptions.) The over-65 homeowner's exemptions and school tax ceiling transfers to the surviving spouse, if the spouse is 55 years of age or older at the time of death and lives in and owns the home. Over-65 homeowners also may transfer the percentage of school tax paid, based on their former home's over-65 school tax ceiling, to a new home.

Do I have to apply each year?

No. If you had a homestead exemption on your home in 2000 you won't need to reapply for 2001 unless your chief appraiser requires it. However, if you haven't received an exemption on your present home—or if you moved to a new home—you'll need to file for an exemption for 2001. If you are 65 this year, you may file for the over-65 exemption up to one year after the date you turned 65. And if you become disabled during 2000 you need to file for the disabled person's exemption.

When and where should I file?

Emergency Farm Loans Are Available Locally

Applications for emergency farm loans for losses caused by drought and excessive heat occurring July 1, 2000, and continuing are being accepted at the Farm Service Agency (FSA) offices located in Wheeler and

Wheeler County is one of fourteen contiguous counties in Texas recently named by Secretary of Agriculture Dan Glickman eligible for loans to cover part of actual production losses resulting from the heat and drought. Larry J. Goetze, Farm Loan Man-

ager said farmers may be eligible for loans of up to 80 percent of their actual losses or the operating loan needed to continue in business, whichever is less. For farmers unable to obtain credit from private commercial lenders, the interest is 3.75.

"As a general rule, a farmer must have suffered at least a 30 percent loss of production to be eligible for an FSA emergency loan," Mr. Goetze said. Farmers participating in the Federal Crop Insurance program will have to figure in proceeds from those programs in determining their loss.

"Applications for loans under this emergency designation will be accepted until July 2, 2001, but farmers should apply as soon as possible. Delays in applying could create backlogs in processing and possibly go over into the new farming season," Goetze said.

FSA is a credit agency of the U.S. Department of Agriculture. It is authorized to provide disaster emergency loans to recognize farmers who work at and rely on farming for a substantial part of their living. Eligibility is extended to individual farmers who are U.S. citizens and to farming partnerships, corporations or cooperatives in which U.S. citizens hold a majority interest.

The FSA offices in Wheeler and Clarendon are open from 8:00 a.m. to 5:00 p.m. Monday through Friday. The Wheeler office is located at 114 West Oklahoma and the Clarendon office is located at 321 Sully


