Judge McIlhany was born April 28, 1918, at Wheeler to Mortimer and Golda McIlhany. Following graduation from Wheeler High School, he earned a bachelor's degree as well as a law degree from the University of Texas. He married Dorothy Dendinger on August 20, 1955, at Dallas; she died in December 2000.

In 1948, he was elected to the Texas House of Representatives and served in that capacity for 18 years. As a member of the Legislature, he received numerous honors and awards including "The Texas Lawman Outstanding Legislator" recog-



CRP GRASS PLANTING DEADLINE IS JUNE 1

Landowners, who are scheduled to plant their native grass mix, need to do so as soon as possible. We are scheduled to plant native grass mix on about 2000 acres this spring. Most of our native grass mixes are usually seeded between December 1st through June 1st. The landowners should have their native grass mix approved by the local Natural Resource Conservation Service before planting any grasses.

Native grasses are defined as original inhabitant of that area. The native grasses are more adapted to the mixland soils and sandy soils. All of the native grass planting will require a cover crop to plant into. A lot of our cover crops are doing fairly well but there are some of our cover crops that still have a way to go. NRCS strongly recommends sowing grass into a firm and adequate seedbed.

Native legumes or forbs are also required in all of the native grass mix. Landowners have the option to plant their forbs or legumes when they plant their grass or wait until the fall to plant. If landowners plant their legumes or forbs right now they are restricted to shredding their weeds. If landowners wait until the fall of the year to sow legumes or forbs, the landowner could either shred or spray

Weed control is very important in getting a stand of grass. Farm Service Agency (FSA) will cost-share only one weed control. It may take several weed controls if it continues to rain. Weeds must be controlled to obtain and maintain a stand of grass. It is the responsibility of the landowners to control weeds on CRP land.

Your local NRCS would like for you to notify Calvin or Fred before and after grass planting. For more information contact your local NRCS office in Wheeler.

Panhandle Community Services will receive a \$83,432 Housing Preservation Grant from USDA Rural Development announced Steven A. Carriker, Texas State Director, USDA Rural Development is charged with assisting rural communities by administering programs targeted to strengthening the economy and infrastructure of rural areas, including assisting qualified applicants with some of the housing needs.

"USDA Rural Development is very pleased to be able to provide housing rehabilitation funding for rural Texans," said Steven A. Carriker, State Director. "It is our goal to ensure rural residents are afforded an opportunity to live in decent housing that meets basic health and safety standards and provides the benefits of energy efficient features.

The Housing Preservation Grant funds awarded by the Amarillo Rural Development office will provide Panhandle Community Services with the means to assist approximately 24 qualified homeowners in the Texas Panhandle with home repairs.

The Housing Preservation Grant is one of several programs in which USDA, Rural Development is able to assist residents in rural communities of 10,000 or less population with housing needs. Rural Development also provides housing assistance through direct and guaranteed housing loans under it Single Family Housing program to buy or build homes, and has a loan and grant program for repairs to existing homes of qualified applicants. All applicants must meet basic eligibility requirements.

Rural Development has also financed numerous apartment complexes in the Texas Panhandle through it Multi-Family Program. Qualified tenants may receive substdized rental assistance in an efforts to provide decent, safe, sanitary and affordable housing to many rural resi-

ORDINANCE NO 32 AN ORDINANCE OF THE CITY OF MOBEETIE, TEXAS PROVID-ING THAT THE CODE OF ORDI-NANCES OF THE CITY OF MOBEETIE, TEXAS MAKES IT UN-LAWFUL TO MAINTAIN A NUI-SANCE OF RUBBISH, WEEDS AND THE LIKE UPON ANY LOT OR PAR-CEL OF LAND WITHIN THE CITY; PROVIDING FOR SEVERABILITY; PROVIDING FOR PUBLICATIONS; AND PROVIDING FOR AN EFFEC-TIVE DATE.

BE IT ORDAINED BY THE CITY OF MOBEETIE, TEXAS Section 1

ARTICLE 1 RUBBISH, WEEDS AND THE LIKE.

"Sec. 32.1. Prohibited. "It shall be unlawful for an owner,

tenant, resident or person in charge of any lot or parcel of ground within the city to fail to keep the property owned by him, occupied by him or under his control free from weeds and grass over 10 inches in height, rubbish, garbage, brush, trash or any other objectionable, unsightly or unsanitary matter of whatsoever nature; or to fail to keep the sidewalk easement adjacent to his property free and clear of the above listed matter: from the line of such property to the established curbline next adjacent thereto or if no curb, then within 10 feet outside of the property line; or to fail to keep the alley easement adjacent to his property free and clear of the above listed matter from the line of such property to the centerline of said alley easement; or to fail to keep any house, building, establishments, lot, yard or ground owned by him, occupied by him or under his control at all times free from filth. carrion or impure or unwholesome matter of any kind.

"Sec. 32.2. Notice to Owner to Correct Violation; Abatement by

"In the event any property owner shall fail or refuse to remedy any of the conditions prohibited by Section 32.1 of this code, after the expiration of a notice allowing at least ten calendar days to do so, the city may do such work or cause the same to be done, and pay therefor, and charge the expenses in doing or having such work done or improvements made to the owner of the property, whereupon such charges shall be a personal liability of such owner to the city. Such notice may be in writing, served upon such person by an officer or employee of the city, or may be by certified United States mail addressed to such owner at his post office address. If personal service or mail service cannot be obtained, or the owner's address is not known, then notice may be given by publishing a brief summary of such order at least twice within ten consecutive days in a daily newspaper of general circulation published in the city addressed "Sanitary Improvements" "To Whom It May Concern", and such publication shall be deemed sufficient notice, or by posting notice on or near the front door of each building on the property to which the violation relates or if the property contains no buildings, by posting notice on a placard attached to a stake driven into the ground on the property, to which the violation relates. If notice to the owner of the property has been given by personal delivery or by certified mail that if the owner commits another violation of the same kind or nature that poses a danger to the public health and safety on or before the first anniversary of the date of the notice, the city may, without further notice, correct the violation at the owner's expense and assess the expense against the prop-

"Sec. 32.3 Appeal.

"A property owner may appeal the requirements of the notice to correct a violation specified in Section 32.2 by making a written appeal to the City Secretary stating that the property was in compliance with the provisions of Section 32.1 on or before the expiration date of such notice. Such appeal must be submitted to the City Secretary on or before the expiration date of the notice. A hearing shall be set before the City Council within ten days of receipt of such appeal statement, and receipt of such appeal shall not stay the action of the city to correct the conditions specified in Section 32.1. The City Council may appoint a designee to conduct the hearing and make recommendations to the City Council. Following the hearing, the City Council shall determine whether the property was in violation of the provisions of Section 32.1 and shall communicate such finding to the property owner within five days of the hearing date. If the property was found in violation of the provisions of Section 32.1, the City Secretary may proceed to correct or have corrected the violations specified in such notice at the expense of

the city, and may cause all of the actual cost to the city to be assessed on the real estate or lot on account of which such expense is incurred. If it shall be determined by the City Manager that the premises complied with the provisions of Section 32.1 on or before the expiration of such notice, then the City Council shall not proceed to perform work on the property or no personal liability of the owner shall arise nor shall any lien be created against the premises upon which such work may already have been done.

"Sec. 32.4. Judicial Actions.

"Any person who is aggrieved by a decision of the City Council may appeal such decision to a court of competent jurisdiction.

"Sec. 32.5. Abatement Expenses

to Constitute a Lien. "(A) In the event any of the work is done by the city as authorized in Section 32.2 and 32.3, the City Secretary shall file, or cause to be filed, a statement of the expenses, including but not limited to an administrative fee set by the City Council, incurred with the County Clerk, stating the legal description of the property upon which such work was done and the name of the owner of such property, if known, whereupon the city shall have a privileged lien upon the land or premises upon which such work was done for the amount of such expenditure, second only to tax liens and liens for street improvements, together with interest on such amounts at the rate of ten percent per

"(B) For any such expenses and interest, suit may be instituted and a personal judgement obtained against the owner of such property and recovery and foreclosure had in the name of the city against the owner of such property in any court having jurisdiction, and the statement of expenses so made and filed, or a certified copy thereof, shall be prima facie proof of the amount incurred in such work or improvement.

"Sec. 32.6. Emergency Abatement.

"Nothing in this Article shall be construed to preclude or restrict the city from taking emergency action to abate a condition or circumstance that poses an immediate danger to the public health, safety or welfare.

"Sec. 32.7. Additional Enforce-

ment. "Nothing in this Article shall be construed to prevent the city from commencing civil or criminal proceedings in a court of competent jurisdiction against an owner, occupant or person in charge of real property or from seeking such other remedies available at law.

"If a criminal proceedings is brought against such person for a violation of Section 21.1 of this Article and upon a finding of guilty, such person shall be fined not less than \$100.00 nor more than \$500.00, plus court costs, if a first offense, but if a second offense within twelve months of the date of the prior offense, such person shall be fined not less than \$200.00 nor more than \$500,00, plus court

"Sec. 32.8. Gender References. "As used in this Article, the masculine gender refers to the feminine and neuter genders and the singular shall include the plural and the plural shall include the singular as the context may require."

Section 2.

If any section, subsection, sentence, paragraph, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such holding shall not affect the validity of the remaining portions of this Ordinance. 


