of the summer are drawing the blinds on some of our grazing programs in Wheeler County. Lack of rain in July has caused many area cowboys concern since. this means sparce grazing in August. Sometimes a rancher is like the airplane pilot who was trying to be optimistic when the motor was missing, the runway obscure and the clouds thick. A lot of us are hoping and close on Saturday night that we get to "fight one more round" before frost draws the curtain on the last act before next spring.

This time of year gets a lot of folks thinking about fall gardens. The best snap beans, incidentally, are produced in the fall. Hot temperatures, common in our area, this time of year, lower the quality of green beans by causing fibrous and stringy pods. In contrast, when they are matured with day temperatures lower than 30 degrees, they have a low fiber content and are of a better quality for canning and freezing. It takes only 50 to 70 days from planting to harvest to produce a good crop of snap beans. Folks will want to

Of course the influence of the manure on the physical condition of the soil is not considered. The big benefit here, of course, is in the increased water holding capacity of the soil and the increased availability of the other plant foods. The plentiful supply of feedlot manure should go a long way in helping increase the fertility of poor soils but we suggest that the manure be used in conjuction with commercial fertilizers for best results since many of the nitrogen fixing bacteria that help make nitrogen avail-

BE IT RESOLVED BY THE courthouse at least 30 days LEGISLATURE OF THE prior to the election on said LEGISLATURE STATE OF TEXAS: Section 1. That Article XVII, Section 1, Constitution of the State of Texas, be amended to read as follows: Section 1. The Legislature, at any regular session, or at any special session when the matter is included within the purposes for which the session is convened, may propose amend-ments revising the Constitu-tion, to be voted upon by the qualified electors for statewide offices and propositions, as de-fined in the Constitution and statutes of this State. "A brief explanatory state-ment of the nature of a proposed amendment, together with the date of the election and the wording of the pro-position as it is to appear on the ballot, shall be published twice in each newspaper in the State which meets require-ments set by the Legislature for the publication of official notices of officers and depart-

ments of the state government. ments of the state government. The explanatory statement shall be prepared by the Secre-tary of State and shall be ap-proved by the Attorney Gen-eral. The Secretary of State shall send a full and complete copy of the proposed amend-ment or amendments to each county clerk who shall post the county clerk who shall post the

The first notice shall be published not more than 60 days nor less than 50 days before the date of the election, and the second notice shall be published on the same day in the succeeding week. The Legislature shall fix the standards for the rate of charge for the publication, which may not be higher than the news-paper's published national rate for advertising per column advertising per column
