

### Mobeetie Assoc. Art Contest

The Old Mobeetie Texas Association is sponsoring an art contest to select two pieces of art work. One selection will become a special pictorial United States Postal Service stamp cancellation for Hidetown Station that will be open for one day only on June 29, 1996, at the Old Mobeetie Texas Association Jail Museum, A second selection will become the cover of a historical booklet that will be available on June, 29, 1996 during Wheeler County Heritage Day--"Hidetown, The Turning Point." The art work chosen will commemorate Hidetown, a camp that served as a central meeting place for buffalo hunters to gather for shipping their buffalo hides to Dodge City for sale and to acquire provisions for hunting trips. Established on the Sweetwater Creek in the early 1870s prior to the establishment of Fort Elliott, hunters brought buffalo hides to be dried, baled and picked up by wagon freighters and merchants like Robert Wright, Charles Rath, W.M.D. Lee, and P. G. Reynolds, Dodge City entrepreneurs. As many as 150,000 hides were claimed to have been bought by the Hidetown merchants. The art work must be black and white, pen and ink, and 5 x 7 inches in size. The subject matter should reflect the life and purpose of Hidetown which was to accommodate the buffalo hunter who faced danger from the environment and was 19 1/2" long. Proud parents and Native Americans as they pursued the United States policy of ridding the Plains of buffalo in order to accommodate the settlement of the Roberts Lannou of Baytown, TX. Great region by cattlemen and farmers.

All entries must be received by March 25, 1996. Each entry must be Matysiak of Tyler, TX., and Mr. and accompanied by name, address and Mrs. Gordon Lannou of Baytown, TX.

### **Extension Update** By Joan Gray, CEA-HE

THE ELDERLY -- ARE THEY UN-DERNOURISHED?

Poor health and other factors that result from aging may cause some older adults to become unable to shop for groceries, to cook or even feed themselves. With these physical barriers, it is no surprise that these elders may become undernourished and unable to maintain their normal

Many fail to eat what is needed everyday to ensure that they are getting all the right nutrients. So, they find themselves taking a bag full of medicines and vitamin and nutrient supplements. Elders need to take a look at just how much vitamin preparations they take such as vitamin E supplements, antioxidant vitamins and

h hal/vitamin preparations. The Surgeon General's Report on Nutrition and Health recommends that older adults consume sufficient nutrients to provide energy to achieve levels of physical activity that maintain desirable body weight and may prevent or delay the onset of chronic disease. Older adults need sound nutritional advice and a balanced diet supplying enough calories to meet reduced energy needs.

From the National Screening Initiative report, the most frequently reported inadequate nutrient intakes were vitamins B6, B12 and D, folacin, zinc, magnesium and calcium in the elderly. Vitamins B6 and B12 and calcium requirements may actually increase with age due to decreased absorption or utilization, whereas requirements for Vitamin A and folacin may decrease.

Getting enough foods that contain the nutrients can be a problem when foods may be higher in calories but lower in nutritional value. The elderly require fewer calories since they have a decreased activity level, which can be challenging. They need to select foods of higher nutrient density per calorie. Careful selection should include a variety of healthful food choices from USDA Food Guide Pyra-

Due to reduced activity, it is difficult not to gain weight. Dietary fats and refined carbohydrates should be reduced. The elderly should increase their intake of lowfat milk and other calcium-containing foods plus breads and cereals and fruits and vegetables should be increased. Also, older adults need to drink enough liquids (six to eight cups) daily because they have less saline and digestive fluids

Older adults unable to consume adequate levels of nutrients from food sources may benefit from certain supplements prescribed by their physician. However, self-prescribed supplements in large doses may be harmful and should be discouraged. Often, those who would benefit from supplements are not the ones who take them.

### TAX DEFERRAL AVAILABLE FOR **ELDERLY TAXPAYERS**

Texans age 65 or older can postpone paying delinquent or current property taxes on their homestead residence by signing a deferral affidavit.

This special form of tax relief can also halt a lawsuit already filed to collect delinquent property taxes if the owner files the deferral affidavit with the court in which the suit is pending.


Once a homeowner files an over-65 tax deferral affidavit with the appraisal district, no taxing unit can initiate or pursue a suit for delinquent taxes as long as that person lives in that homestead.

While tax deferral postpones paying delinquent taxes on a homestead, it does not cancel the taxes nor keep delinquent interest from building up. When the elderly taxpayer no longerowns or lives in the home the accrued amounts become due. Taxing units can then sue to collect all tax and interest.

While a penalty may not be imposed during the deferral period, the filing of the deferral affidavit does not forgive penalties already due. Also, an additional penalty associated with referring the account to a delinquent tax attorney may be charged if taxes remain delinquent more than 90 days after the deferral ends.

Forms for filing a tax deferral affidavit are available in the Appraisal District office, courthouse square, Wheeler, phone 826-5900.






