on or before Sept. 1, of this year is elgible to attend Kindergarten. Any child who will be 4 years old on or before Sept. 1 of this year may attend Pre Kindergarten at Wheeler ISD.

The State of Texas requires these things for a child to be registered in public school:

birth certificate.

2. Copy of Child's immunization record.

Wheeler ISD requires a copy of the child's social securty card for record keeping purposes.

Registration packets for children who will be attending the Wheeler ISD Pre K or Kindergarten during this school year are available and may be picked up in the hall outside the superintendent's office on business days starting July 28,

Any child who will be 5 years old mated length of time needed to finish the forms is from 15 to 30 minutes; some of the information required (for example...the date of the last dental exam or the phone number of your preferred hospital) is generally kept with other personal records at home or may even require a call to your family doctor.





BRIEF EXPLANATORY STATEMENTS OF PROPOSED CONSTITUTIONAL AMENDMENTS

SPECIAL ELECTION SEPTEMBER 13, 2003

PROPOSITION 1

(HJR 68, Section 1)

HJR 68, Section 1 would authorize the Veterans' Land Board to use excess receipts in the Veterans' Land and Veterans' Housing Assistance funds for payment of revenue bonds, and use excess assets in those funds to provide veterans

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the Veterans' Land Board to use assets in certain veterans' land and veterans' housing assistance funds to provide veterans homes for the aged or infirm and to make principal, interest, and bond enhancement payments on revenue bonds."

PROPOSITION 2 (HJR 51)

HJR 51 would expand from six months to two years the period in which the former owner of a mineral interest that was sold for unpaid property taxes may buy back the

mineral interest.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to establish a two-year period for the redemption of a mineral interest sold for unpaid ad valorem taxes at a

PROPOSITION 3

(HJR 55)

HJR 55 would authorize the legislature to exempt from taxation land owned by a religious organization that is leased for use as a school or that will be used to expand or construct a place of religious worship that yields no revenue.

The proposition will appear on the ballot as follows: "The constitutional amendment to authorize the legislature to exempt from ad valorem taxation property owned by a religious organization that is leased for use as a school or that is owned with the intent of expanding or constructing a religious facility."

PROPOSITION 4

(SJR 30)

SJR 30 would authorize the legislature to allow conservation and reclamation districts to use taxes to develop and finance certain parks and recreation facilities. Also, the amendment would authorize the legislature to allow local elections for the issuance of bonds to improve and maintain parks and recreational facilities in the Tarrant Regional Water District or a conservation and reclamation district located in whole or in part in Bastrop, Bexar, Brazoria, Fort Bend, Galveston, Harris, Montgomery, Tarrant, Travis, Waller or Williamson County.

The proposition will appear on the ballot as follows: "The constitutional amendment relating to the provision of parks and recreational facilities by certain conservation and reclamation districts."

PROPOSITION 5 (SJR 25)

SJR 25 would authorize the legislature to exempt from all property taxes certain tangible personal property, which could include a travel trailer not substantially affixed to real estate and not used as a residential dwelling.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize the legislature to exempt from ad valorem taxation travel trailers not held or used for the production of income."

PROPOSITION 6 (HJR 23)

HJR 23 would authorize a qualified homeowner to refinance a home equity loan with a reverse mortgage loan.

The proposition will appear on the ballot as follows: "The constitutional amendment permitting refinancing of a home equity loan with a reverse mortgage."

PROPOSITION 7 (HJR 44)

HJR 44 would reduce the number of persons who make up the jury in a district court criminal misdemeanor case from

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to permit a six-person jury in a district court misdemeanor trial."

PROPOSITION 8 (HJR 62)

HJR 62 would authorize the legislature to permit a person to assume office without an election if the person is the only candidate to qualify in an election for that office and the election is required by the Texas Constitution. This proposition applies to state and local political subdivisions, whereas Proposition 18 applies only to local political subdivisions.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to permit a person to take office without an election if the person is the only candidate to qualify in an election for that

PROPOSITION 9 (HJR 68, Section 2)

HJR 68, Section 2 would redefine the com-

position of the permanent and available school funds by requiring during the next two fiscal years, and authorizing thereafter, annual distributions to the available school fund of a percentage of any increase in the value of the permanent school fund's total investment assets.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment relating to the use of income and appreciation of the permanent school fund."

PROPOSITION 10 (HJR 61)

HJR 61 would authorize municipalities to donate surplus fire-fighting equipment, supplies, or materials to the Texas Forest Service, which would be authorized to distribute based on need the equipment to rural volunteer fire departments.

The proposition will appear on the ballot as follows: "The constitutional amendment authorizing municipalities to donate surplus fire-fighting equipment or supplies for the benefit of rural volunteer fire departments."

PROPOSITION 11 (HJR 85)

HJR 85 would authorize the legislature to regulate the operation of wineries in Texas, regardless of whether a winery is located in an area in which the sale of wine has been authorized by local option election.

The proposed amendment will appear on the ballot as follows: "A constitutional amendment to allow the legislature to enact laws authorizing and governing the operation of wineries in this state."

PROPOSITION 12 (HJR 3)

HJR 3 would immediately authorize the Legislature to limit non-economic damages assessed against a provider of medical or health care and, after January 1, 2005, to limit awards in all other types of cases.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment concerning civil lawsuits against doctors and health care providers, and other actions, authorizing the legislature to determine limitations on non-economic damages."

PROPOSITION 13 (HJR 16)

HJR 16 would authorize a county, city, town, and junior college district to freeze property taxes on a residential homestead of a person who is disabled or aged 65 or

The proposition will appear on the ballot as follows: "The constitutional amendment to permit counties, cities and towns, and junior college districts to establish an ad valorem tax freeze on residence homesteads of the disabled and of the elderly and their spouses."

PROPOSITION 14 (HJR 28)

HJR 28 would authorize the Texas Department of Transportation to issue

notes or borrow money to fund highway improvement projects. The terms of the notes or loans may not exceed two years. The proposition will appear on the ballot as follows: "The constitutional amendment providing for authorization of the issuing of notes or the borrowing of money on a short-term basis by a state transportation agency for transportationrelated projects, and the issuance of bonds and other public securities secured by the state highway fund."

PROPOSITION 15 (HJR 54)

HJR 54 would prohibit a local retirement system and the political subdivision that finances the retirement system from reducing or otherwise impairing certain accrued benefits under the local retirement system.

The proposed amendment will appear on the ballot as follows: "The Constitutional amendment providing that certain benefits under certain local public retirement systems may not be reduced or impaired."

PROPOSITION 16 (SJR 42)

SJR 42 would amend the Texas Constitution to allow home equity lines of credit and allow refinancing of a home equity loan with a reverse mortgage loan.

The proposition will appear on the ballot as follows: "The constitutional amendment authorizing a home equity line of credit, providing for administrative interpretation of home equity lending law, and otherwise relating to the making, refinancing, repayment, and enforcement of home equity loans."

PROPOSITION 17 (HJR 21)

HJR 21 would prohibit an increase in school property taxes on residence homesteads of disabled persons.

The proposition will appear on the ballot as follows: "The constitutional amendment to prohibit an increase in the total amount of school district ad valorem taxes that may be imposed on the residence homestead of a disabled person."

PROPOSITION 18 (HJR 59)

HJR 59 would authorize the legislature to permit a person to assume an office of a political subdivision without an election if the person is the only candidate to qualify in an election for that office and the election is required by the Texas Constitution. This proposition applies only to local political subdivisions, whereas Proposition 8 applies to state and local political subdivi-

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to permit a person to assume an office of a political subdivision without an election if the person is the only candidate to qualify in an election for that office."

Tax Scam Targets Child Tax Credit

The Internal Revenue Service is warning taxpayers about a new scam targeting potential recipients of the Advance Child Tax Credit. The IRS has seen isolated instances of this new scheme. A taxpayer receives a telephone call from a person who promises to speed up the payment of the Advance Child Tax Credit checks. The catch is the taxpayer must agree to a \$39.99 charge to a credit card.

The IRS reminds taxpayers that no person or organization can "speed up" the payment of tax benefits. In reality, taxpayers do not have to take any action to get the new benefit, which features an advance payment for up to \$400 per qualifying child. The Treasury Department and IRS will perform all the calculations and automatically mail a notice and a check to each eligible taxpayer, beginning the week of July 25.

Under the new scam, the IRS is seeing the continuation of a trend that emerged earlier this year when the families of those serving in the Armed Forces were targeted. In both of these schemes, scam artists use current events to prey on unsuspecting victims. The scams also feature callers seeking credit card information to get taxpayers to pay for special benefits.

If the taxpayer agrees to the charge and provides a credit card number or other sensitive personal information, she could find a much larger charge on her account. Bu the time the taxpayers realizes something is wrong, the scam operator is long gone, possibly victimizing another taxpayer.

If you encounter this latest tax scam or suspect tax fraud or abuse in some other situation, report it to your nearest Internal Revenue Service office. When in doubt, seek help from the IRS or a tax professional. You can call the IRS tax fraud hotline at 1-800-829-0433.



The Grassland Reserve program (GRP) is a voluntary program that helps landowners and operators restore and protect grassland, including rangeland and pastureland, and other lands, while maintaining the areas as grazing

The program emphasizes support for grazing operations, plant and animal biodiversity, and grassland and land containing shrubs and forbs under the greatest threat of conversion.

Eligible land include grasslands; land that contains forbs; shrubland (including improved rangeland and pastureland); or land that is located in an area that historically has been dominated by grassland, forbs, or shrubland when these lands have the potential to serve as wildlife habitat or significant ecological value. The emphasis for fiscal year 2003 enrollment is the preservation and improvement of existing grasslands and

Program implementation is handled by both the USDA Natural Resources Conservation Service (NRCS) and USDA Farm Service Agency (FSA). Applications will be accepted by either agency on a continuous sign-up basis. The two

Natural Resources Conserva- agencies work in cooperation with the USDA Forest Service. Program funding comes through the Commodity Credit Corporation. This program is available in all counties. This is a continuous signup program, however like EQIP, there will be a ranking cutoff date. This cutoff date is August 1st, 2003.

Save Playa Lakes As communities across the western Great Plains struggle to deal with drought and declining water tables, a major, yet relatively unknown natural resource is playing a critical role in replenishing and protecting the region's water sup-

Scattered across the western prairie landscape are thousands of playa lakes. Playa lakes are the most numerous wetlands in the region, totaling more than 40,000 in eastern New Mexico, Colorado and Wyoming, western Kansas, Nebraska and Oklahoma, and the Texas Panhandle combined. More than 95 percent of the world's playa lakes are located in the western Great Plains - they are a unique natural resource.

Playa lakes are shallow, usually round, wetlands with clay floors that lie in the lowest point of a generally large, closed watershed and collect rainfall and associated runoff from surrounding uplands. Their average size is 17 acres, and all playa lakes combined make up about 2 to 5 percent of the total western prairie landscape. They are ephemeral, or seasonal, in nature and hold water only after rainfall or runoff events. Most of the time, they are dry, which is partially why many people don't recognize them as wetlands. Playa lakes are sometimes mistakenly referred to as buffalo wallows, mud pits or evaporation pans.

But there are several good reasons why people should learn about and maintain playa lakes, one of which is the wetlands' role in recharging the Ogallala Aquifer.

Over the past several decades, researchers have gathered substantial evidence pointing to playas lakes as the primary source of recharge for the Ogallala. This is big news for western Great Plains states, which have relied on pumping the Ogallala for agricultural, municipal and industrial use since the turn of the century. Although this research has been going on for quite some time, the results are relatively unknown to the general public and even conservation professionals. Summary: As communities Ogallala formation lies beneath portions of eight states: Colorado, Kansas, Nebraska, New Mexico, Oklahoma, South Dakota, Texas and Wyoming. In 1990, it was measured to contain about 3.270 billion acre-feet of water. Use of the Ogallala began at the turn of the century, and since World War II, reliance on it has steadily increased. While in 1950 the Ogallala irrigated about two million acres of farmed land, by 1997 it irrigated 14 million acres. During this time, the Ogallala water supply has progressively declined and from 1950 to 1980 water levels dropped 9.9 feet, and from 1980 to 1999 they dropped 3.2 feet, according to the U.S. Geological Survey. With the recent advent of improved dry land farming and irrigation techniques, pumping of the Ogallala has decreased during the last decade, but still the rate of aquifer depletion far exceeds the natural rate of recharge.

According to studies conducted in the Southern High Plains region of Texas and New Mexico, natural recharge occurs throughout much of the landscape above the Ogallala but is focused through playa wetlands. When a dry playa lake receives rainfall or associated runoff, water flows into the playa basin and penetrates the clay layer through deep cracks, plant root openings and other pores in the floor. Water then flows through fissures in the cap rock layer, ultimately reaching the Ogallala formation. Cracks in the playa lake floor eventually swell shut as the clay absorbs more water, limiting or diminishing recharge through the basin. Recharge also occurs along the wetlands perimeter where clay is thin or non-existent, Landscape-wide recharge to the Ogallala in the Southern High Plains is about 11 mm of water per year, and about 9.2 mm of that - or approximately 85 to 90 percent - is focused through playa lakes, according to Dr. Warren W. Wood, Research Hydrologist for the U.S. Geological Survey. This means that 85 to 90 percent of all recharge is occurring on 2 to 5 percent of the landscape, amounting to about three to six inches per year under playa

"We've found that playa lakes are responsible for a significant majority of recharge to the aquifer, much more so than in the surrounding uplands," Wood said, "Replenishing the aquifer therefore means ensuring that playas continue to function normally and naturally."

Like the aquifer, playa lakes are also a threatened resource. Of the more than 40,000 playa wetlands in the region, resource managers estimate that at least 70 percent of those have been altered from their natural state through pitting, plowing or sedimentation. Of these, sedimentation is the single largest threat to playa lakes. Sedimentation occurs on all playa lakes that are surrounded by tilled lands. Water runoff from rain and irrigation carry soil into the wetlands, gradually filling them. Sediment build up reduces the volume of water they can hold and increases the rate of water loss through evaporation, ultimately limiting re-
