

Female Heart Attacks

Heart disease and heart attacks claim the lives of more American women than men each year, and pose a greater threat to American women than all forms of cancer combined. Unfortunately, many women do not know that the symptoms of a woman having a heart attack can be significantly different from those of a man.

Women take notice

* Be aware that the symptoms for women having a heart attack are often different from those of a man, but any of the following symptoms can occur in men and women:

★ Classic Symptoms Squeezing chest pain or pres-

Shortness of breath Sweating

Tightness in chest Pain spreading to shoulders, neck or arm Feeling of heartburn or indiges-

tion with or without nausea and vomiting Sudden dizziness or brief loss

of consciousness ★ Symptoms More Likely in

Indigestion or gas-like pain Dizziness, nausea or vomiting Unexplained weakness, fatigue

Discomfort/pain between shoulder blades Recurring chest discomfort

Sense of impending doom If you are experiencing symptoms that could be a signal of a heart attack, call 9-1-1 and get to the emergency room quickly to minimize possible damage to your heart.

Consider taking aspirin at the first sign of heart attack symptoms.

If you are experiencing symptoms that could be signaling a heart attack or if you see someone else with these symptoms, call 9-1-1 immediately and summon an ambulance. Do not attempt to drive yourself as only paramedics and trained fire department personnel have the necessary equipment to revive you if your heart has stopped beating. Give the patient one aspirin to chew, and if she or he is not breathing, start CPR. Above all, get to the hospital as quickly as possible because the longer a heart attack goes untreated, the more badly damaged your heart will be.
