# **Parkview Hospital Board Of Trustees** Meet in Regular Session On July 11

JULY 11, 2006

Chairman Dean Tipps declared that a quorum was presented and called the meeting to order at 6:00 p.m. in the Parkview Hospital Board Room.

Present were: Dean Tipps, Chairman; Thomas R. Helton, Vice Chairman; Sue Chandler, Secretary; James Batton, Board Member; R. Dale Garner, Board Member

Also present: Ann Fagan Cook, RN, BSN; Lanette Lewis, RN, Home Health Director

Jim Batton made a motion to approve the minutes of the June 2006 meetings with the correction of omission of a second to a motion. Sue Chandler seconded the motion and the motion carried unanimously.

Jim Batton made a motion to approve payment of the bills. Thomas Helton seconded the motion and the motion carried unanimously.

Ms. Fagan Cook presented financials statements, investment report and statistics. After considerable discussion regarding increasing food costs consensus was that we should consider increasing our charges to employees and visitors. After further discussion Dale Garner made a motion to increase employee cost from \$2.00 to \$4.00 per meal and visitors from \$4.00 to \$6.00 per meal effective August 1, 2006. Jim Batton seconded the motion and the motion carried unanimously. Sue Chandler made a motion to accept the reports as presented. Thomas Helton seconded the motion and the motion carried unanimously. Bad debt and charity write offs were reviewed. Sue Chandler made a motion to accept that was seconded by Dale Garner and the motion carried unanimously.

Ms. Fagan Cook presented QAPI minutes and scorecards. There was some discussion regarding the scorecards and how items are picked to be monitored. Jim Batton made a motion to approve that was seconded by Sue Chandler. Motion carried unanimously.

Bids for the service contract on the new x-ray equipment that was purchased recently were presented by Ms. Fagan Cook. After discussion regarding rates and time frames Thomas Helton made a motion to purchase the service contract for a monthly fee for 48 months. Sue Chandler seconded the motion and the motion carried unanimously.

Chairman Tipps discussed the need to set a specific date for setting the tax rate for next year. The rules that were put into place last year are still in effect for this year. The budget must be approved before the tax rate is set even though both may be done in the same meeting. Ms. Fagan Cook stated that she will be out of state on the date of the next regularly scheduled board meeting and asked if the Board could pick another date. After discussion August 4, 2006 at noon was set for the meeting.

Ms. Fagan Cook next presented an agreement with Diagnostic Management Group for providing portable Magnetic Resonance Imaging (MRI) services at our hospital beginning in September 2006. We will have to provide electrical services for the equipment which will cost around \$10,000. Ms. Fagan Cook stated that she had talked with Dr. Tony Cook from Canadian and reported that he and his partner will be interested in using this service for outpatients. After further discussion Thomas Helton made a motion to proceed with the agreement, secure the electrical service and begin as soon as possible. Dale Garner seconded the motion and the motion carried unanimously. Fagan Cook reported that the anti-trust suit has been extended indefinitely without our having to produce any records. She also discussed the need to look at business interruption insurance for our hospital. She has requested a bid from Eastern Panhandle Insurance Company and this will be presented by Noel Walton at the next board meeting. Fagan Cook also stated that the installation of the new pharmacy equipment began today and training of staff nurses will begin next week. Chairman Tipps inquired if there was any new business. Lanette Lewis, RN, Home Health Director, stated that she had further information regarding the Power Path software that we discussed at the previous board meeting. This was discussed with the Board. Ms. Fagan Cook stated that the attorney who reviewed our contract with Lewis Group for our current software approved of our plan to cancel the contract without penalty. Dale Garner made a motion that we purchase the notebooks and the new software. Sue Chandler seconded the motion and the motion carried unanimously. There being no further business Chairman Tipps declared the meeting adjourned at 7:30 p.m.



# **Xcel Seeks First Raise Since '86**

For the first time since 1986, Xcel Energy's Texas-based operating company, Southwestern Public Service Company (SPS), is proposing to raise its base rates for electric service in Texas to help offset the higher cost of doing busi-

The overall rate increase proposal will raise revenues by \$47.1 million a year, or 6 percent. The company is also proposing changes in how it collects certain fuel costs and is proposing to reconcile its past actual fuel costs for the years 2004 and 2005.

The residential rate would rise by 7.4 percent, or \$5.18 more per month for an average household using 800 kilowatt-hours (kWh). Other rate classes would see different percentage increases, but the overall increase for all customer classes, including residential, commercial and industrial, is 6 percent.

The proposals were filed today with the 81 Texas municipalities that Xcel Energy serves and with the Public Utility Commission of Texas. If approved, new base critical level, many ideas about "what should we do" are floating around, Peterson said. "But little scientific information about the consequences is available."

The decisions have serious implications not only for the many rural communities on the Great Plains, whose economic base depends on water resources from the Ogallala, but for the future and continued competitiveness of American agriculture in the global economy, Amosson said.

tions and maintenance expenses of electrical generation, transmission and distribution systems could take effect in July.

Between 1986 and 2005, the only changes in pricing have been two decreases in the base rates, plus many changes both up and down in the cost of fuel used to generate power in area generating facilities. The fuel costs are not figured into the base rate, and are passed from the suppliers through to customers without any markup for the company. Xcel Energy makes no profit on fuel expense. The most recent adjustment in fuel costs occurred at the beginning of May, when fuel costs were reduced 17.5 percent to reflect lower natural gas prices.

Consumer prices over the past 20 years have risen almost 80 percent, even as Xcel Energy lowered base rates twice. Accounting for the increases in fuel prices, the total amount customers pay has risen only about 8 percent since 1986. Adjusted for inflation, today's total electric bill is about 40 percent lower than it was in 1986

"We have worked hard to keep prices down, in spite of inflation, because our low costs are a chief economic driver in this region," said Gary Gibson, president and CEO of Southwestern Public Service Company. "But in order to fund capital improvements to our system, we must take a step toward offsetting increased costs and focus on the needs of a growing customer base."

Electric usage in the Texas and New Mexico territory Xcel Energy serves has risen by more than 50 percent since 1986, Gibson pointed out, and the company must keep up with this growth by investing in power generation, transmission capacity and a host of other system-wide improvements.

Although Xcel Energy is requesting an increase in base rates, it will remain one of the state's lowest-cost suppliers of electricity, Gibson said. The current Xcel Energy price per kilowatthour in Texas is around 8.45 cents, including fuel costs. Electric customers in the Houston area pay as much as 15.8 cents per kilowatthour.

Another aspect of the upcoming rate filing is the simplification and consolidation of more than 40 rate structures into eight well-defined classes of service that include only one residential rate.

To help customers manage costs, Xcel Energy is publicizing energy saving tips through a brochure called "60 Simple Ways" that details simple and mostly inexpensive steps customers can take to reduce home energy consumption. The brochure can be downloaded at www.xcelenergy.com, or customers may request copies by contacting customer service at 1-800-895-4999. "While we're proposing a little more than \$5 in increased costs to residential customers, it is possible for customers to save that much and more by taking steps to conserve power in the home." Gibson said.

# **Precautions For Hot** Weather Driving

Summer is here and even with higher gas prices, many drivers will be hitting the road for vacations and weekend get-a-ways. "Hot weather brings unique challenges," said Ray Palermo, director of public relations for auto insurer, Response Insurance. "It can present dangerous conditions for both the vehicle and its occupants." Each summer sees more than 7 million car breakdowns on the road and he suggests that most summer breakdowns can be easily avoided.

Before heading out be sure you check out the basics, including: oil, transmission fluid, windshield washer, battery level and strength, tire pressure (including the spare), cooling system (which should be flushed and refilled at least every two-years), belts and hoses and have a well equipped emergency kit and tool box in the trunk.

When driving in hot weather it's particularly important to keep an eye on the lights and gauges. If your temperature gauge moves up, turn off your air conditioner and turn on your vehicle's heater to its highest and hottest setting. It will be uncomfortable, but it will help draw some of the heat away from the engine. If you are stopped in traffic put the car in "park" and lightly step on the gas to help circulate coolant. If the temperature light goes on or if the gauge enters the red zone, immediately pull off the road to a safe spot, well away from traffic. Do not drive any further-not even to the next exit. Driving with an overheated engine can cause serious damage to the engine.

Do not attempt to remove the radiator cap itself. The pressurized coolant is extremely hot and will spray out with great force. Do not pour water over the radiator or engine, since a dramatic change in temperature could cause damage. After the engine cools a bit, add a 50-50 mix of coolant and water to the reservoir to bring it up to its proper level.




