



## Walter Dunn Rites Are Read In Clinton

Walter Dunn Services March 26  
Walter James Dunn was born on the family farm east of Stafford, Custer County, Oklahoma, on July 11, 1920, to Emerson and Nellie (Chapman) Dunn. As a young child, he moved with his family to a farm west of Arapaho, and later into Arapaho where he graduated from Arapaho High School in 1938. He then moved with his parents to Sayre, Oklahoma, where he began working with the T. J. Stewart Lumber Company.

In July of 1941, he transferred to the company yard in Clinton, Oklahoma, and on October 19, 1941, he was married to Wenona Latimer in Sayre, Oklahoma. They made their home in Clinton until he volunteered for the U.S. Army Air Corps in October of 1942.


Walter served in the American Theater at Randolph Field, San Antonio, Texas; Logan Field, Denver, Colorado; Tyndall Field, Florida and Pyote Field, Texas, where he attained the rank of sergeant. Upon his discharge in November of 1945, they again made their home in Clinton, where he became assistant manager of the Stewart yard. In 1946, he became the manager of the company yard in Wewoka, Oklahoma, and in 1948, was transferred to their yard in Sayre, Oklahoma. He went to work as manager of the Cicero Smith Lumber Yard in Wheeler, Texas, later being transferred to their yard in Donna, Texas, in 1968. In 1975, he moved with his wife to the Latimer family farm south of Foss, Oklahoma, where they raised cattle and Walter did carpenter and painting work. Upon their retirement in 1985, they did extensive RV traveling. In September of 2000, they moved to Elk City, Oklahoma, and in September of 2006, to Georgetown, Texas to be near their children.

Walter was a long-time member of the Church of Christ, serving as a Bible class teacher, deacon and elder in the various congregations where they lived.

He was preceded in death by his parents, one son, Kenneth, in 1945, four sisters and two brothers.

He is survived by his wife, Wenona; three sons, David Dunn and wife, Barbara, of Georgetown, TX; John Dunn and wife, Grace, of Visalia, CA and Steve Dunn and wife, Sandi, of Granger, TX; eleven grandchildren, Ken Dunn and wife, Stacy; Mark Dunn and wife, Tamara; Renee Schlachter and husband, Kevin; Jennifer Dunn; Vickie Beam and husband, Rocky; Erica Katz and husband, Robert; Michael Dunn; Chris Dunn; Jeff Dunn and Kenzie Dunn; and great-grandchildren, Ashleigh, Kennan, Ryann, Kristian, Katie, Velahni, J.T., Ken Dunn and wife, Stacy; Brody, Alex and Fabian and a host of nieces, nephews, cousins, other relatives and friends.

## Get Set Go! Walk Across Texas Starts



## Mobeetie Methodist Church Celebrates 123 Years

The United Methodist Church of Mobeetie celebrated 123 years of service with the dedication of a Texas Historical Marker, Sunday, March 25, 2007. A special worship service began at 11:00 with Rev. Todd Dyess, District Superintendent of the Amarillo District, preaching a very inspirational sermon.

The Dyson family led the congregation in several hymns and sang some special selections. Immediately after the worship service, Steve Walker's Mr. Bar-B-Que served a very tasty barbecue dinner to 208 people.

The afternoon service began with pastor, John Ulrey, reading

the list of past pastors since 1884. He introduced the pastors in attendance who were Rev. Elton Wyatt of Lubbock who is almost 90 years of age and served in 1952-53; Rev. Thacker Haynes who served this church as his first appointment in 1991-92 and was appointed to his home church in McLean where he is still serving; Gary Jahnel of Canadian who served from 1992 through June, 2001, and is no

longer in the ministry, but still does lay speaking; and Dick Irvine of near Briscoe who pastored from

His wife and three other women had been killed some time earlier in a tragic car accident on their way home from a women's meeting for the church. When he was contacted by the Sims family, it was to come do the funeral for Wilma's husband, Ralph. After 4 years, they decided to get married and join their two families; that was 39 years ago and God has been blessing their lives ever since. There were actually three other past preachers present, but they thought since he was the first senior pastor present that he should have the honor. Gary Null, with the Commission of Archives and History, had a slide presentation and some interesting information on establishment of the Methodist Church and the Methodist Conference in this area. David Murrah gave us an overview of The History of the Mobeetie UMC that he has researched and written a book about. He is actually a Baptist and his wife was Methodist, but his passion is "any" history. He is originally from Gruver. The Dyson Family Bluegrass Band closed out the events of the day with additional songs. Of course, if it was up to some people they might still be singing over there. Pastor Ulrey gave the benediction and invited all out front for the unveiling. The weather was cooler and damper, so no one tarried very long. They were invited back into the church to visit and have cake and coffee.

It was nice to see Jim and Kay Batton; Jim is looking much better after he had another stent put in downstream of the one he already has. Praise the Lord that his doctor finally got it figured out.

On February 20, 2007, Southwestern Electric Power Company (SWEPCO) filed a petition with the Public Utility Commission of Texas (Commission) requesting Certificate of Convenience and Necessity (CCN) authorization for a nominally-rated 600 MW ultra-supercritical coal-fired power plant to be located in Hempstead County in southwest Arkansas. As part of its long-term electric supply resource plan, SWEPCO has determined that it needs to obtain additional long-term capacity and energy supply resources in the near future. In an effort to meet these long-term needs, SWEPCO selected this generating unit through a competitive bidding process. The docket number and style of the case are PUC Docket No. 33891, *Application of Southwestern Electric Power Company for Certificate of Convenience and Necessity Authorization for a Coal-Fired Power Plant in Arkansas*. SWEPCO is not seeking to change its rates in this proceeding.

On December 8, 2005, SWEPCO issued a market-based, competitive solicitation for long-term power resources by way of a Request for Proposals (RFP). The RFP solicited up to 600 MW of long-term baseload resources to be available by the summer of 2011. Based on an evaluation under the criteria in the RFP, along with the oversight by the independent monitor of the RFP process, SWEPCO has selected a nominally-rated 600 MW ultra-supercritical coal-fired generating plant approximately 15 miles northeast of the City of Texarkana, Arkansas. The plant's emissions will be cleaned using Best Available Control Technologies. SWEPCO was the entity that submitted the winning bid proposal for this facility in response to the RFP. Three other entities have given notice of their intent to participate in the ownership of the generating plant, subject to the execution of construction, ownership and operating agreements, for a combined total of 160 MW. SWEPCO's ownership share is thus expected to be 440 MW.

The total estimated direct cost of the entire plant is approximately \$1.343 billion, of which SWEPCO's share is approximately \$0.986 billion. When the \$231 million of carrying costs in the form of Allowance for Funds Used During Construction (AFUDC) are added to SWEPCO's share, the total estimated cost to SWEPCO is approximately \$1.2 billion for the plant. In addition, SWEPCO estimates \$136 million of transmission investment will be necessary, together with an additional \$21 million of AFUDC on that transmission investment. SWEPCO's total estimated cost of the facility including transmission and all related AFUDC is \$1.374 billion. The plant unit will be built by American Electric Power Services Corporation (AEPSC) as SWEPCO's agent, and all AEPSC goods and services will be supplied at cost.

SWEPCO requests that its CCN be amended to include the generating plant described in this filing. SWEPCO has already made similar filings with the Arkansas Public Service Commission and the Louisiana Public Service Commission.

The deadline for intervention in this proceeding is April 20, 2007, and a letter requesting intervention should be received by the Commission by that date. band to wide band. This means the replacement of county and ambulance radios to be replaced.

At the 10:45 special meeting of the Wheeler County Commissioners' Court, bids were opened and the number of radios needed by the Sheriff's department, commissioners and Ambulance was tallied.

Commissioners Puryear and Snelgroves each requested 15 mobile and one handheld. Precinct 3 requested 13 mobile and one handheld. Twelve mobile and one handheld were needed by precinct 4. It was determined the sheriff's department required 12 mobile and 9 handheld radios. Radios were ordered for the county judge, and ambulance service. Each of the Justices of the Peace will receive a handheld radio and Ken Daughtry, Emergency Management Coordinator, will be provided with a handheld unit.

The total number of mobile radios ordered was 74 with 19 portables needed.

Hawkins Communication of Pampa submitted the lowest of the three bids received.

Total cost of the radios is \$49,424. \$24,512 comes out of the general funds with the commissioners, ambulance and sheriff's department providing the remainder from their budgets.

The meeting was adjourned. The next regular meeting will be Monday, April 9.
