He is a veteran of World War II and the Korean Conflict. While in service, he served in Europe during World War II for 27 months, and also served in Korea during the Korean Conflict. He and his family are members of the Bethel Baptist Church, and also Johnnie is Vice-President of the Mens Fellowship Bible Class.

CITIZENSHIP WILL be tested Saturday when Eastlanders voters go to the City Commission and School Trustee election polls to mark their ballots. City vote is at City Hall from 7 to 7 and the school election is at the County Clerk's office, first floor east, Courthouse, from 7 to 7. Water Board elections will also be held at the Courthouse Saturday.

Four are seeking two positions on the City Commission and three are seeking two positions on the School Board.

Guesses are that the recently - enacted "subdivision ordinance" could be a vote - decider in the city race, and that the outcome could reflect the general public's opinion of that ordinance. Some hold that the ordinance is a good general guideline for development with adequate safeguards. Others contend that it in fact could be too restrictive and hamper future development in Eastland. Some see the ordinance as a reversal in the city's long - established "spirit of cooperation" policy.

No clear and outspoken issues have emerged at the school trustee contest, but some wonder if there might not be a general feel for the accelerated implementation of music and art into the school program.

Regardless of issues or absence of issues, the citizens' responsibility is to "go to the polls and mark their ballots". Tons have been written about "what one vote can do", and surely it often seems unimportant, but taken all together, the right to vote is one of our most precious freedoms, and the responsibility to vote is just as vital as the responsibility of those who serve and who offer their services by filing as candidates.

They each one deserve our support and backing.

Saturday isn't always the best day to change from our yard work fishing clothes to go vote, but for Eastland and for our country. any day is a perfect day to express the great American privilege of voting.

USDA Proposes Food Stamp Limit

Households eligible for food stamps would have to be given a chance to purchase their coupon allotment within 45 days after the state welfare agency receives their application, under a proposal announced today by the U.S. Department of Agriculture. (USDA).

In a related development today. USDA also issued final regulations establishing permanent procedures for restoring lost food stamp benefits. The proposed amendment to

USDA's food stamp program regulations entitles households

purchase food stamps was delayed more than 15 days after expiration of the household's certification period. The proposal sets the first of the month in which the 45th day, or 15th day, falls as the day from which restorable benefits should be

calculated. Food stamp households pay a sum of money (purchase requirement) based on family size and income receiving food stamps of greater value than the amount paid. However, certain households with little or no income can get stamps without

These final regulations, and the proposed amendment on the time limit for providing food stamp benefits, are scheduled for publication in the Federal Register of Friday, March 19. Public comment is invited on the proposal. Interested per-




