A Young Man Going Places

(An Editorial)

This newspaper does not attempt to tell its readers how to vote. But we feel an obligation to point out facts pertinent to questions on which the readers will decide for themselves the stand they will take at the polls. We believe, too, that the citizens of the five counties composing the Texas House of Representatives' District 63 deserve the most effective representation they can obtain in the Legislature at Austin.

The experience of two terms in the House equips Wayne Gibbens of Breckenridge especially well for effective service. His dedication to purpose and principle day, or was efficiently wise to during two sessions has very definitely marked Gibbens as a young man with a promising future in the service

> Gibbens is serving as chairman on the finance committee of the Legislative Council, a research and billproducing arm of the Texas Legislature, as a betweensessions activity. In addition, he is a member of three other study groups, including a legislative internship program that has won recognition sufficient to be financed by the Ford Foundation.

> Twice in the past two years Gibbens has been nominated to represent the state at interstate conferences working on official matters. In the last regular session, he served on the revenue and taxation, rules, oil and gas, agriculture, and contingent expense committees.

> Gibbens has won commendation for his energy and effective representation of his district. An example of his service to his district was the successful fight he staged to keep the 11th Court of Civil Appeals from being moved to Abilene from Eastland. Gibbens faces issues. He considers the welfare of his district and state in every vote.

> A graduate of Breckenridge High School, where he won his letters as a football player, Gibbens has since graduated from Texas Tech. It is very definitely to his credit that Gibbens has used such time as he could spare and without neglecting the duties of his office to attend law classes at the University of Texas.

The mature judgment that experience has given him plus the energy of his youth have enabled Gibbens to become a real leader in the Texas house, as evidenced by this comment by Governor Connally: "Wayne Gibbens is an outstanding young man and an intelligent. effective legislator . . .
