Communist Elementary Education To Be P-TA Talk Subject Tuesday

Dr. Verna Mae Crutchfield, associate professor in speech correction and special education at Hardin Simmons University, will be guest speaker at the Eastland Elementary Parents and Teachers Association to be held Tuesday, Nov. 17.

Dr. Crutchfield recently took a tour through the communist countries of Eastern Europe with the Comparative Education Study Group, directed from Kent State University in Kent, Ohio, and co-sponsored by Delta Kappa Gamma.

During the more than 30-day

trip through Poland, Russia, Rumania, Yugoslavia, Hungary and Checkoslovakia, Dr. Crutchfield attended seminars and field trips conducted by members of Teacher's Trade Unions. "What we saw and what we heard made us do some strong thinking," Dr. Crutchfield stated during a recent presentation of a lecture on her trip.

Elementary education in the communist countries of Eastern Europe will be the subject of her lecture in Eastland.

Record Vote Tops 7,000 For County

Voting in the Nov. 3 general election topped preliminary reports of record numbers as the County Commissioners Court canvassed the vote this week.

Total vote was 7,016 which is even above the earlier reported 6,961 — which had been declared a record turnout for recent years.

Precinct totals were: Eastland, 1,480; Ranger, 1,284; Olden, 194; Gorman, 628; Carbon, 207; Desdemona, 151; Kokomo, 51; Pioneer, 75; Rising Star, 706; Nimrod, 43; Cisco, 1,806; Scranton, 47; and absentee, 344. (A record 358 absentee ballots had been mailed out, but only 344 were actually returned.)

'Syrian Yankee' Talks Eastland Student Assn

Mr. Shalom Rizk, a real American, told students of Eastland High School and Jr. High what being an American meant to him. Mr. Rizk, who grew up in the confusion and hardship of Post-WW I Syria, expressed his feeling of the privilege of being an American.

"Young Americans are full of vitamins, yet, when I speak to them, they make me feel like Fabian. There is a heavy contrast between dynamic, democratic, 20th century America and the world I knew as a child. Imagine yourself as being a young Syrian, disease ridden and illiterate, and then you would hold a high esteem for fellow Americans, and your citizenship. I felt like Cassius Clay when I was told that Syria and Lebanon both claimed me as a native of their country."

"Tuition for school then was only a few cents a month, but I had not even a penny, so I hid under an open window to try to get an education. The Schoolmaster caught me one day, and he not only insisted I join the class, but that I share his home and meals. I became intoxicated with the vision of America, given me by this teacher who had spent 7 glorious years in America. After learning to write, I was given a piece of clean, white paper and a pencil stub. These were my most prized possessions. I kept this paper and pencil for a week, afraid to destroy its beauty and cleanliness. But I finally decided to write a letter of appreciation to my teacher.

After reading this letter, he told me, in magical words, that I was an American Citizen. My family had been broken up shortly before my birth, and my father and two brothers escaped to America, and my dear mother died giving me birth. My father be-

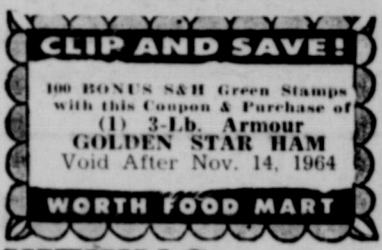

ARTHRITIS PRODUCES PAIN DEFORMED JOINTS FOR MAN

Arthritis, says a new American Medical Association pamphlet, is a general word that includes several different but related illnesses. It comes from "arthros," meaning joint, and "itis," meaning inflammation.

The most common forms are rheumatoid arthritis and osteoarthritis. They are different ailments, but each produces painful, deformed joints.

Rheumatoid arthritis is a disease of the whole body. Three times more common in women than in men, it usually begins when a person is between 20 and 35 years of age. Early symptoms may include weakness, fever, loss of appetite and loss of weight. The skin, especially the hands,

may be cold and clammy. Mental depression is common, and the patient both feel and looks below par. On or more joints become inflamed and swollen.

An attack may begin with a gradually increasing discomfort, or a sudden, dramatic, confining illness, or anything in between. Attacks may come and go for no apparent reason.

Treatment reduces the pain of an acute attack and usually increases motion. Often an attack of pain in the joint will subside by itself. It usually returns. The quack capitalizes on this tendency of the disease to fluctuate. He claims credit for the treat-

ment being used at the time, when actually it is a period of natural remission.

Osteoarthritis is a quieter, less dramatic illness. However, when it does develop in a joint it is less likely to go away. Eventually the joint is injured, the smooth lining membrane and the cartilage pads are damaged and permanent changes within the joint limit its motion and make any motion painful.

Everyone will develop osteoarthritis if he lives long enough. It begins in middle age, usually in a hip, a knee, shoulder or in the back. Overweight people whose work requires standing or walking, thus over-burdening the knees and hips, are especially susceptible to osteoarthritis. Often it is first noticed after an injury to a joint.

Management of arthritis involves skilled medical supervision over a long time, rather than periodic dosing with pain killers or going to bed when one's joints hurt. The physician individualizes his treatment. It is common to prescribe drugs to reduce pain and inflammation. Exercise and physical therapy may be recommended. Weight con-

trol may be necessary. An arthritic patient often must learn new ways to do common daily tasks. Rest is essential at all times, even in the interludes between acute attacks of pain and swelling.

A person with rheumatoid arthritis or osteoarthritis has a problem that will be with him for life. He should develop a tolerant attitude toward his disability without surrendering to it, rather than exhaust himself fighting against it.

Because the more common forms of arthritis are chronic conditions that fluctuate from better to worse to better again, they are a favorite field for the quack and the nostrum peddler, says the AMA pamphlet.

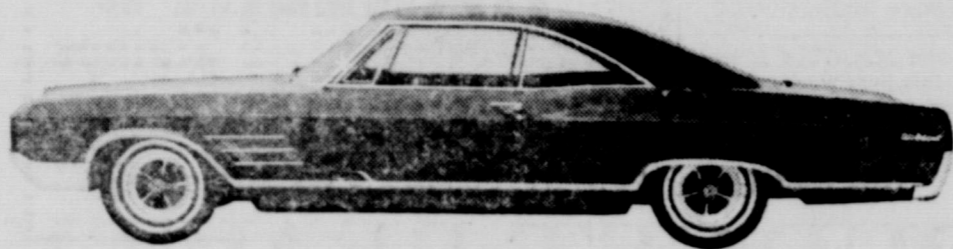

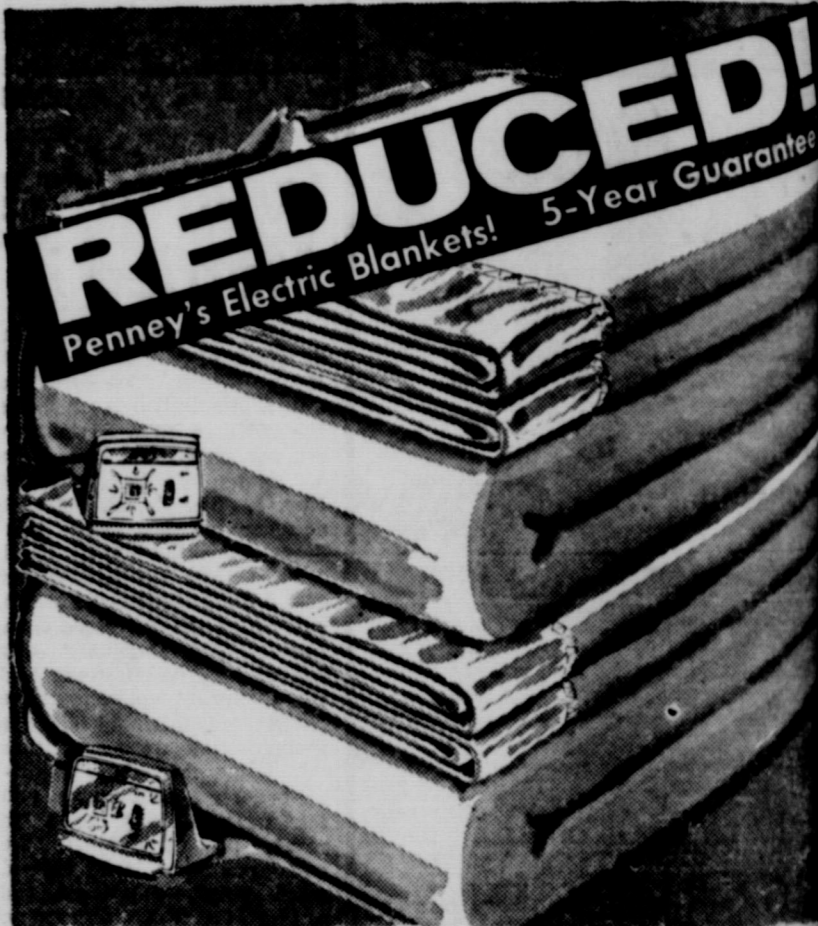

Some of the thoughts running through Pasteur's mind.

Pasteur also explored and experimented until he found a way to protect man from the dread rabies through a series of inoculations. Today we use about the same method to keep a man bitten by a rabid animal from developing the disease.

Another advance in immunology was made in 1923 when a toxin was developed to save hundreds of babies each year from a gasping death of diphtheria.

In the last 10 or 15 years we have read and watched the drama of polio vaccine unfold. Principal players in that drama were Dr. Jonas Salk of the University of Pittsburgh, and Dr. Albert Sabin, of the University of Cincinnati.

Dr. John Enders of the Children's Hospital in Boston, just recently developed a measles vaccine to save lives and impairments in hundreds of children.

These dedicated scientists did not conquer these diseases — smallpox, rabies, diphtheria, polio and measles — in the literal sense. They simply gave us a means of preventing them.

To take advantage of the paradox — a little hurt to prevent sickness or death — see your physician about an immunization schedule for your family.

A Reading-Math conference will be held Saturday, Nov. 14, in the new high school auditorium in Cisco, according to R. B. Golemon, supervisor for Eastland County Public Schools.



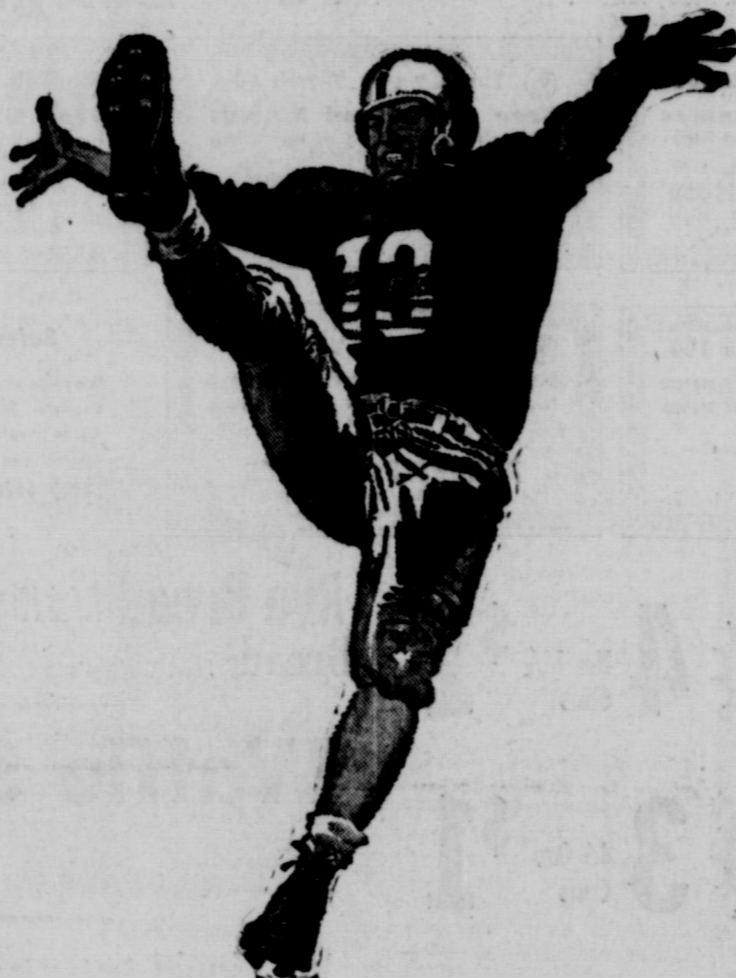

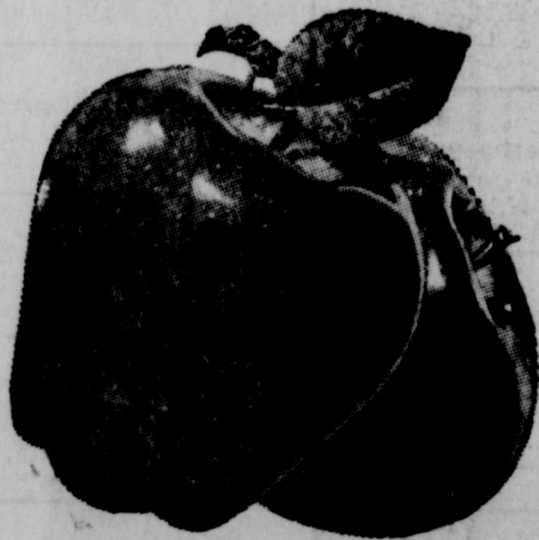
